Armed forces have 'complete operational freedom' to respond: PM Modi

NEW DELHI: Prime Minister Narendra Modi asserted on Tuesday that the armed forces have "complete operational freedom" to decide on the mode, targets and timing of India's response to the Pahalgam terror attack, as he chaired a meeting with the top defence establishment.

During the high-level meeting, which was attended by Defence Minister Rajnath Singh, National Security Advisor Ajit Doval and the chiefs of three services, Modi affirmed that it is the national resolve to deal a crushing blow to terrorism, government sources said.

Modi expressed complete faith and confidence in the professional abilities of the armed forces.

"They have complete operational freedom to decide on the mode, targets and timing of our response," a source quoted Modi as saying.

Chief of Defence Staff General Anil Chauhan was also part of the meeting, which was held amid India weighing its options for countermeasures following the Pahalgam terror attack which left at least 26 civilians, mostly tourists, dead.

Modi has vowed to pursue the

NEW DELHI: Prime Minister Narendra Modi is set to preside over the meeting of the Cabinet Committee on Security (CCS) on Wednesday morning, making it the second such huddle after the gruesome Pahalgam terror attack, which shook the entire nation and countrymen.

A total of 26 people, including a Nepali national, were killed on April 22 while they were on holiday in the green meadows of

Pahalgam's Baisaran valley. The CCS meeting is likely to take place around 11 a.m.

Defence Minister Rajnath Singh, Union Home Minister Amit Shah, Union Finance Minister Nirmala Sitharaman and External Affairs Minister S. Jaishankar, among others,

will attend the high-level meeting.

SRINAGAR: Authorities on Tuesday confirmed that all major tourist destinations across Kashmir, including Pahalgam. Gulmarg, Sonamarg, Dal Lake, and the Mughal Gardens, remain fully operational and continue to welcome visitors.

A senior official in Tourism department told news agency-Kashmir News Observer (KNO) that tourist activity remains unaffected at key locations, which are witnessing a steady influx

of visitors. "Destinations like Pahalgam, Gulmarg, Sonamarg, and other prominent sites are open and secure.

Tourists are moving freely, and all necessary security arrangements are in place to ensure their safety and comfort," the official said.

He clarified some lesser-known offbeat destinations-accounting for merely 4-5% of the overall tourist footfall—have been closed temporarily as a precautionary measure.

JKTF Organises "Education Conference" to felicitate retiring "Illegal Medical Shops" Mushroom in Bandipora, Private **Clinics Flout Norms**

BANDIPORA: In brazen violation of norms, scores of medical shops are operating illegally across north Kashmir's Bandipora district, raising serious concerns over public health and

Sources said that besides the unchecked mushrooming of unlicensed medical stores,



even ayurvedic shops in the district are openly selling allopathic medicines without proper authorization. Many of these shops are being run by individuals who are not qualified to sell

Alarming reports reveal that a majority of private clinics in the district are not registered under the Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act, 1994. Doctors engaged in private practice and paramedics conducting ultrasounds at these clinics often lack a diploma or degree in Radiology, mandatory residency training, or even a six-month certification from a recognized institute.

Experts warn that unqualified individuals are endangering the lives of patients by performing diagnostic procedures like ultrasounds, while also exploiting them financially.

Sources further said that several medical shops, particularly in rural and far-flung areas,

are being operated without registration or professional oversight. In many instances, even government employees, including teachers and PHE department workers, are running chemist shops during morning and evening hours, acting as self-styled doctors.

As per regulations, a person must hold a diploma in pharmacy and obtain a proper license to operate a medical shop. However, locals alleged that most rural shops flout these norms th impunity. Even in the town areas, many shops function irregularly without maintaining the mandatory standards.

Officials pointed out that pharmacists are required to maintain a record of medicines sold against prescriptions, and a detailed ledger must be kept for storage and sale, especially of sedative drugs like codeine. However, the absence of proper billing systems has encouraged black marketing and the sale of substitute drugs, particularly exploiting poor and uneducated customers.

Additionally, many medical shops reportedly lack essential infrastructure, such as proper storage facilities, further compromising the quality and safety of the medicines being sold.

Locals acknowledged the growing menace, particularly in remote areas where unlicensed shops have become rampant. They also pointed out that many licensed shop owners have hired unqualified workers to run their businesses, with unauthorized persons often seen prescribing medicines and issuing prescriptions.

Recently, police have also seized sedative drugs in various parts of north Kashmir. While officials have conducted raids, cancelled licenses, and sealed dozens of illegally operating shops, the shortage of enforcement staff in the district continues to hamper regular inspections

An official spokesperson said in a joint operation with the CRPF's 45 Battalion and the Army's 13 Rashtriya Rifles, arrested three Over Ground Workers (OGWs) affiliated with the banned terror outfit

Lashkar-e-Taiba (LeT) in the Hajin area. "Acting on specific inputs about the movement of suspected OGWs, a joint naka was established at Shahgund Nursery". During the naka checking.

three individuals were seen approaching from Khusarpora towards Shahgund. On

noticing the presence of security forces, the suspects attempted to flee but were apprehended tactfully by the alert personnel.

The arrested individuals have been identified as Shahzad Ahmad, son of Mohammad Khalil, Danish Ahmad Parray, son of Ghulam Mohammad Parray, and Ather Iqbal, son of Ghulam Mohammad Rafiqee, all residents of Hajin. Upon questioning, the trio confessed to being associated with the LeT as OGWs. During their personal search, the security forces recovered two Chinese hand grenades, one 7.62 mm magazine, and seventeen live rounds of 7.62 mm ammunition from their possession.

Following the recovery, a case under FIR No. 33/2025 was registered at Police Station Hajin under sections 18, 23, and 39 of the Unlawful Activities (Prevention) Act and section 7/25 of the Indian Arms Act. Further investigation into the case is currently underway.

MD JJM for pacing up execution of Water Supply projects in Kupwara

SRINAGAR, APRIL 29: Mission Director (MD), Jal Jeevan Mission (JJM) J&K, Khurshid Ahmad Shah today chaired a meeting to review the implementation of JJM in district Kupwara.

The meeting was apprised about the various components under execution through a powerpoint presentation. As per the figures, the district comprises 355 villages with 1, 56,179 rural households out of which 1, 29,755 households have been provided with Functional Household Connections (FHTC's).

In his famous poem "Shikwa", Iqbal addresses humanity's grievances and questions with God, expressing a deep sense of existential pain. Yet, in "Jawab-e-Shikwa", he transforms that grief into a call for action, suggesting that pain, when embraced with courage, leads to empowerment and change. Following the terror strike in Pahalgam, India has taken a series of measures targeting Pakistan, including putting in abeyance the Indus Waters Treaty with the neighbouring country.

Earlier in the day, Union Home Secretary Govind Mohan had chaired a high-level meeting which was attended by chiefs of three paramilitary forces and senior officers of two other security organisations, sources said. There was no official word on its agenda. (agencies)

PM Modi to

In the meeting that lasted about 40-50 minutes, Union Minister Singh is understood to have briefed PM Modi on the possible key decisions that India could take against Pakistan to "punish it for its deeds".

In the first CCS meet chaired by PM Modi on April 23, a day after the Pahalgam carnage, India took a slew of measures against Pakistan. India announced the suspension of the Indus Waters Treaty, the shutdown of the Attari border, the cancellation of visas of Pakistani nationals, the blockade of many of its YouTube channels and X handles, and downgrading the diplomatic ties with Pakistan by downsizing the already truncated staff in embassies, thereby forcing them back to their country of origin.

CM Omar

urged them to prioritise timely, effective response to weather-related challenges.

He emphasised the need to keep personnel ready and machinery in working condition to ensure the uninterrupted functioning of essential services.

"Preparedness is not just about having systems in place but ensuring that those systems work seamlessly when put to the test," Omar Abdullah noted, adding that preparedness must be proactive rather than reactive.

While commending field-level officers for their proactive planning, he called upon them to maintain a constant state of readiness and ensure grievance redressal mechanisms remain accessible and effective for public facilitation during emergencies.

Divisional Commissioner Jammu delivered a detailed presentation highlighting preparations for the upcoming summer season, with a focus on the availability of drinking water, electricity supply management, and medical emergency response strategies.

The meeting was informed that in respect of forest fire management, high-risk districts like Nowshera, Jammu and Reasi have been prioritized with 175 control rooms and awareness drives. Water supply preparedness would include vulnerability mapping, infrastructure maintenance, and deployment of tankers, while IEC campaigns to deal with heatwave effect are being conducted.

It was informed that Power infrastructure is being strengthened through transformer upgrades, pruning of tree branches and activation of emergency teams. It was given out that the Health Department has stocked essential supplies, operationalized Heat Stroke Rooms, and mandated daily reporting of heat-related illnesses.

Divisional Commissioner also informed the meeting that Schools in the summer zone will follow revised timings from May 1, and the school bag policy is in effect. Irrigation canals have been desilted, and flood control rooms activated, with mitigation plans in place for vulnerable districts, he said.

JMC has readied monsoon rescue units, upgraded drainage equipment, and deployed water sprinklers and coolers for heatwave relief, he told the meeting.

He added that BRO and PMGSY have mapped landslide and flood-prone sites, ensuring machinery is in place for rapid response.

The Chief Minister directed departments to activate control rooms, maintain buffer stocks of essential supplies, and deploy quick response teams to vulnerable areas.

He also instructed the deployment of an adequate number of water tankers in areas prone to shortages. Additionally, he directed the ACS Jal Shakti to install GPS trackers on all water tankers to ensure accountability and oversight of their field operations.

The Chief Minister also called for timely maintenance of key roads, particularly the Srinagar–Jammu National Highway, Mughal Road, and other vital routes.

possible to bring the culprits to justice and give justice to those innocents who were killed," he said However, the MP said, the government should make sure that while the culprits are hunted and

punished, innocent people are not harmed.

"For that, the Government of India and the forces here should keep in mind that no innocents like labourers, ponywalla, taxi drivers, are harmed in the process. If even a single innocent is harmed, it defeats the whole idea of justice. I request that the reaction be based on bringing justice... innocents should not be affected," he said.

Mehdi said the country's reaction to the attack

— in which 26 people, mostly tourists, were killed —
"should centre around justice".

"We are with justice, we are with that reaction. We want a united voice to be raised across the world for justice and that the people of J-K get a permanent respite from this violence. The people of J-K are the biggest losers in this irrespective of religion.

"We are the victims and we want the ways for peace to be found. The people of J-K will be the beneficiaries of peace. So, we are with the country in its reaction — be it diplomatically or through some other ways," he said.

After the April 22 Pahalgam attack, authorities in Jammu and Kashmir have launched a major clampdown against the terror ecosystem, raiding hundreds of places, detaining scores of suspects and razing homes of terrorists.

To a question about J-K Chief Minister Omar Abdullah's refusal to ask for statehood for political gain in the face of the tragedy, Mehdi said it was right as the assembly session was for called for paying tributes to the victims of the terror attack.

"It was a session to pay tributes and if he (Abdullah) thought it right not to talk about statehood, then it

is right. But, it (statehood) is an issue that needs to be addressed...," he said.

Residents Fear

Officials said the security grid along the LoC in Jammu and Kashmir has been placed on high alert. The Army and Border Security Force (BSF) are conducting round-the-clock patrols and maintaining strict vigilance. They are also deploying advanced surveillance technology, including high-tech drones and other monitoring equipment, to track any movement across the border.

The repeated ceasefire violations have caused concern among residents in border villages. Schools have started preparing students for potential emergencies by conducting mock drills and evacuation exercises.

"We are training children on how to take shelter quickly and where to gather in case of firing," said Mohammad Younis, a school principal in the Tangdhar area

Meanwhile, authorities on Tuesday announced the closure of several tourist destinations near the LoC, including Gurez, Keran, Tangdhar and Uri. These places had seen a rise in tourist footfall since the February 2021 ceasefire agreement between India and Pakistan.

"The administration has decided to shut down tourism in these areas until the situation becomes clear," a government official said.

Locals said the ceasefire pact of 2021 had brought a period of calm to the region, allowing people to resume normal life. That sense of security is now under strain.

"Since 2021, we have been living peacefully," said Nizakat Ahmad, a resident of Uri. "We fear the shelling may return. We have already lost people in the past."

Tourists are being warmly welcomed, and the local communities, along with administration and tourism stakeholders, are fully facilitating their stay," the official added.

should be initiated by the Chief Justice. However, if the Chief Minister desires to recommend

the name of any person, he should forward the same to the Chief Justice for his consideration. The Governor, as advised by the Chief Minister, should forward his recommendation along with the entire set of papers to the Union Minister of Law & Justice as early as possible, but not later than six weeks from the date of receipt of the proposal from the Chief Justice of the High Court.

If the comments are not received within the said time frame, it should be presumed by the Union Minister of Law & Justice that the Governor (i.e.

Chief Minister) has nothing to add to the proposal and proceed accordingly. The Union Minister of Law & Justice would consider the recommendations in the light of such other reports as may be available to the government in respect of the names under consideration. The complete material would then be forwarded to the Chief Justice of India for his advice. The Chief Justice of India would, in consultation with the two seniormost Judges of the Supreme Court, form his opinion in regard to a person to be recommended for appointment to the High Court.

After their consultations, the Chief Justice of India will, in the course of 4 weeks, send his recommendation to the Union Minister of Law & Justice.

Further, as per the MoP, as soon as the warrant of appointment is signed by the President, the Secretary of the Department of Justice will inform the Chief Justice, and a copy of such communication will be sent to the Chief Minister. He will also announce the appointment and issue the necessary notification in the Gazette of India.

60 Pak women, children living in J&K deported

strinagar: In the aftermath of the Pahalgam terror attack that left 26 people, mostly tourists dead, nearly sixty Pakistani women and their children, most of them married to former Kashmiri terrorists, were deported to Pakistan through Wagah border on Tuesday.

According to the details available with the news agency—Kashmir News Observer (KNO), the families, gathered from districts including Srinagar, Baramulla, Kupwara, Budgam, and Shopian, were escorted in buses to Punjab for handover to Pakistani authorities.

Many of the women had entered Kashmir under the 2010 rehabilitation policy for former terrorists.

Eleven Pakistani nationals who had entered India on valid visas nearly 45 years ago in Mendhar, Poonch, were also sent back.

Pertinently, after the Pahalgam terror attack Union Home Minister Amit Shah had directed heads of the States and Union Territories to identify and remove and deport Pakistani citizens from their respective States and UTs immediately

'Unpleasant, ghastly': Former Nepal PM condemns Pahalgam attack

NEW DELHI: Describing the Pahalgam terror attack as "unpleasant and ghastly", former Nepalese prime minister Baburam Bhattarai on Monday said "we unequivocally condemn" it, as he extended solidarity with the government and people of India.

"We are with the people (of India)," he said during an interaction with reporters in Delhi.

At the beginning of the session, a minute of silence was observed in memory of the victims.

On April 22, terrorists opened fire at tourists at a

meadow in Baisaran of south Kashmir's Pahalgam, killing 26 people. One of the victims was a Nepalese national. The horrific attack has drawn condemnation from

countries and leaders across the world.

"Afew days ago, a very unpleasant, ghastly terror attack was conducted in Pahalgam in Jammu and Kashmir....

A Nepalese citizen was also killed. We unequivocally condemn this terrorist attack. Terrorism under any cover cannot be justified, wherever it takes place. We are with the people," Bhattarai said during the interaction with reporters held at the Press Club of India.

Bhattarai later interacted with PTI Videos and shared

his thoughts on the attack.

"We unequivocally condemn this... this is a sheer terrorist attack, and one of the Nepalese nationals was also killed. Such terrorist acts are condemnable, I personally and on behalf of Nepalese people, would like to condemn it, and express our solidarity with the

government and people of India," he said.

Prime Minister Narendra Modi, in his monthly
Mann Ki Baat radio address on Sunday, said terrorists
and their backers carried out the Pahalgam attack to
destroy Kashmir again as they did not like the return of
peace and prosperity. He vowed the "harshest" response
to the "perpetrators and conspirators".

US-China tariff war opens golden opportunity for Aligarh's lock industry

LUCKNOW: The ongoing US-China tariff war has created a golden opportunity for Aligarh, which is known for its lock industry, to further strengthen its position in the global market position, official sources said here on Monday.

Sources said that boosted by Uttar Pradesh Chief Minister Yogi Adityanath's pro-business policies, Aligarh, already a hub for locks, is rapidly strengthening its global market position. "According to Volza's export data, India leads the world in lock exports, surpassing China and Vietnam, with key markets in the UK, US and Australia," they said.

Sources said that as per data till April 17, India tops the world in lock hardware exports with 40,664 shipments. "It is followed by China (30,289 shipments) and Vietnam (4,836 shipments). From October 2023 to September 2024, India exported 3,578 shipments, showing a growth of 10 percent over the previous year," they said.

Sources said that China exports locks worth 1.19 billion dollars annually to the US, holding a 66 percent

market share. "However, the US's 245 percent tariff on Chinese products has made them more expensive, creating an opportunity for Aligarh's lock industry to capture a larger share of the US market," they said.

Sources said, "The Yogi government has already taken steps, such as including Aligarh's hardware in the One District One Product (ODOP) scheme in 2018 and offering incentives to local entrepreneurs, to capitalise on this."

Sources said that Aligarh's leading lock company, Link Locks, has invested Rs 100 crore to capitalise on this opportunity. "This investment will benefit the entire lock industry and its stakeholders. The government's pro-business policies have boosted entrepreneurial confidence, positioning Aligarh to expand its share in the global lock market," they said.

Sources said that the US-China tariff war has created a significant opportunity for UP beyond the lock industry, opening doors for exports of household products like kitchenware, tableware, plastic items, lamps, hair clippers and firecrackers. "China currently holds a 72 percent share of the 148 billion dollars annual export market in these products, with India at just 2.9 percent. UP, home to the largest number of MSME units, is well-positioned to fill this gap," they said.

Sources said that the Yogi government's ODOP scheme is providing crucial support to local artisans and small entrepreneurs, strengthening both the local economy and Brand UP globally.

Sources said that the Defence Corridor in UP has opened new opportunities for Aligarh, with six nodes including Aligarh, Lucknow, Kanpur, Jhansi, Chitrakoot and Agra. "The Yogi government has invested Rs 122 crore to develop Aligarh's Defense Corridor, attracting Rs 3,300 crore in investment so far.

First-ball sixes are normal for me: Suryavanshi

he cricket world stands captivated by his audacious stroke-play but for 14-year-old Vaibhav Suryavanshi, stufflike first-ball sixes is a "normal thing" as he remains unfazed by the grandeur of the stage.

Suryavanshi lit up the IPL by becoming the youngest ever centurion in T20 cricket with his 38-ball 101 that was dotted with 11 sixes and seven fours. A staggering 94 of his



runs came in boundaries in what was only his third game in the high-stakes tournament.

This was after a whirlwind 34-run knock on IPL debut that came off 20 balls and featured the first-ball six that fixed the spotlight firmly on his cherubic face.

"It was a normal thing for me. I have played Under-19 for India and also at the domestic level, where I have hit first ball sixes. I was not under pressure to play out the first 10 balls. In my mind I was clear that if the ball comes in my radar, I will hit it," Suryavanshi told the IPLT20 website after the win over Gujarat Titans on Monday night here.

"It was not like that I was thinking it's my first game. Yes, there was an international bowler (in front of me) and the stage was big but I was just playing my game," he recalled.

The youngster from Bihar's Samastipur was born a good three years after the IPL got underway so his marauding knock makes him the first player who is younger than the league itself to score a hundred in it.

Suryavanshi expressed gratitude towards his parents -- father Sanjeev and mother Aarti -- for sacrificing their comforts for his growth.
