SRINAGAR: After the Centre cut the flow of water to Pakistan through the Baglihar Dam on the Chenab River, Ministry of Home Affairs on Monday asked several states to conduct civil defence

mock drills on May 7 (Wednesday) amid rising tensions with Pakistan following the April 22 Pahalgam terror attack, which left 26 people, mostly tourists dead.

A source told the news agency–Kashmir News Observer (KNO) the MHA directed several states to ensure that the mock drills should focus on the key actions such as operationalization of air raid warning sirens. Training of civilians, students, etc. on the civil defence aspects to protect themselves in the event of a hostile attack.

India suspends Indus treaty protocol, begins reservoir flushing on Chenab

Sluice gates at Baglihar, Salal dams closed without prior notice

SRINAGAR: Two weeks after the Pahalgam terror attack, India has significantly reduced water flow to Pakistan by suspending regular protocols under the Indus Waters Treaty (IWT) and initiating reservoir maintenance activities at key hydroelectric projects in Jammu and Kashmir

Notably, soon after the Pahalgam attack, India suspended the Indus Waters Treaty, curtailed the Chenab River's water flow to Pakistan, closed the Attari border, revoked SAARC visa exemptions for Pakistani nationals, and ordered their departure within 48 hours.

Diplomatic ties were further scaled back with the mutual expulsion of defence staff, marking a significant shift in India's policy toward Pakistan.

Official sources familiar with the development informed the news agency-Kashmir News Observer (KNO) that the government has initiated reservoir flushing operations at the Baglihar and Salal dams on the Chenab River.

These operations, previously conducted with prior notice to Pakistan under treaty norms, were carried out without any communication this time. they said.

According to officials, the decision not to notify Pakistan stems from the suspension of the IWT mechanism following the Pahalgam attack that left 26 dead.

The sluice gates at Baglihar and Salal dams were opened initially to flush sediment and later closed, temporarily holding back a significant volume of water that would otherwise flow into Pakistan's Punjab province.

Officials estimate that the downstream water flow has been reduced by nearly 90 per cent.

The National Hydroelectric Power Corporation (NHPC), which operates the dams, said the maintenance work was aimed at increasing reservoir capacity and improving power generation.

Baglihar, located in Ramban district, has a capacity of 900 megawatts, while Salal, in Reasi district, produces 690 megawatts. Both projects are classified as run-of-the-river schemes but require periodic sediment removal to maintain operational efficiency.

The current maintenance includes nearemptying reservoirs and operating adjustable spillway gates, temporarily disrupting natural river flow.India has also indicated that similar flushing work will >>SEE ON P-7

Waqf (Amendment) Act From May 15: SC

NEW DELHI: The Supreme Court on Monday said the pleas challenging the Waqf(Amendment)Act's constitutional validity will now be taken up by a bench headed by Chief Justice of Indiadesignate Justice B R Gavai on May 15 as the incumbent CJI will be demitting office on May 13.

As soon as a bench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and KVV iswanathan assembled for the hearing, the CJI said, "There are certain aspects which you (Centre) dealt with, but that require clarification. I do not want to reserve any judgment or



order at this interim stage. This matter will have to be heard on a reasonably

early date and this will not be before me." CJI Khanna will be succeeded by Justice Gavai a day after his superannuation on May 13.

"We have not very deeply gone into the counter affidavit (of the Centre). Yes, you have raised certain points in regards to registration (of Waqf properties) and have given some disputed figures, that will require some consideration," the CII said.

"We would have loved to pursue your lordship(the CJI) as every contention has an answer. But, we cannot embarrass you because there is no time," Solicitor General Tushar Mehta, appearing for the Centre, said while indicating the retirement of the CJI."It is painful to

SC Seeks Response Of Centre, 18 States On NALSA PIL For Release Of Old And Terminally III Prisoners

Monday sought responses from the Centre and 18 states, including Bihar and Uttar Pradesh, on a plea of the National Legal Services Authority (NALSA) to release on bail a group of prisoners who are terminally ill or above 70 years of age.

These prisoners, who have not come to the top court against denial of bail, require special care but it may not be possible for jail authorities to provide in view of the overcrowding in prisons, the plea said.

A bench comprising Justices Vikram Nath and Sandeep Mehta took note of the submissions of lawyer Rashmi Nandakumar, appearing for NALSA, and issued notices to the Centre and the states.

NALSA, in its PIL, said that these elderly and terminally ill prisoners are incarcerated in the states of Andhra Pradesh, Bihar, Chhattisgarh,

NEW DELHI: The Supreme Court on Haryana, Himachal Pradesh, Jharkhand, Kerala, Madhya Pradesh, Maharashtra, Punjab, Rajasthan, Tamil Nadu, Telangana, Tripura, Uttar Pradesh, West Bengal and Odisha.

> The NALSA is a statutory body in India established under the Legal Services Authorities Act, 1987 to provide free and competent legal services to weaker sections of society. It also organises Lok Adalats for amicable settlement of disputes. Earlier, the CJI-led bench sent the plea to the bench headed by Iustice Nath for adjudication.

> Nandakumar referred to the data and said many terminally ill persons, whose convictions were upheld by various high courts, were unable to move the top court to challenge their convictions and seek bail or the suspension of sentence and the matter needed an intervention.

"Petitioner urges this court to issue



necessary directions so that prisoners of advanced age and prisoners who are terminally ill are released on bail to ensure that they can be taken care of by members of their families

and can be reintegrated into society in their final days," NALSA's petition said.

The plea said terminally ill prisoners and those of advanced age required specialised

care and individual attention and it may not be possible for prison authorities to provide considering the extent of overcrowding in prisons.

The plea, therefore, urged the top court to issue directions to facilitate the release of prisoners aged above 70 years and those suffering from

terminal illnesses.Such prisoners, it said, required specialised medical care and personal attention that overcrowded prisons are often ill-equipped to provide.

NALSA said as of December 31, 2022, India's prison occupancy rate stood at 131 per cent, severely straining infrastructure and impacting the quality of medical care and dignified living conditions within jails.

The petition highlighted some recent cases, including that of a 93-year-old woman incarcerated in Karnataka whose plight prompted intervention from the District Legal Services Authority. Similarly, bail was secured for a terminally ill undertrial by the High Court Legal Services Committee before the Calcutta High Court.

The plea said the NALSA launched a Special Campaign for Old and Terminally Ill Prisoners" running from December 10, 2024, to March 10, 2025.

As part of the campaign, dedicated national, state and district units were constituted to visit prisons, identify eligible inmates, and coordinate efforts for their potential release.

Data showed 456 prisoners – including both convicts and undertrials - were identified to be within the targeted categories.

However, the plea sought relief only for prisoners who were convicted by high courts, had not moved the Supreme Court on appeal and wished for legal aid services.

Conclave to choose next pope will be most geographically diverse in history

VATICAN CITY: There is no rule that cardinals electing a new pope vote a certain way according to their nationality or region.

But understanding their makeup in geographic terms can help explain some of their priorities as they open the conclave Wednesday to choose a new leader of the 1.4-billion strong Catholic Church.

A cardinal who heads the Vatican's liturgy office might have a very different set of concerns than the archbishop of Ulaanbaatar, Mongolia. A cardinal who runs a large European archdiocese with hundreds of priests likely has other priorities than the Vatican ambassador ministering to war-torn Syria or the archbishop of Managua, Nicaragua whose church has been under siege by the government.

There are currently 135 cardinals who are under age 80 and eligible to vote in the conclave, hailing from 71 different countries in the most geographically diverse conclave in history.

Already two have formally told the Holy See that they cannot attend for health reasons, bringing the number of men who will enter the Sistine Chapel down to 133.

A two-thirds majority is needed to be elected pope, meaning that if the number of electors holds at 133, the winner must secure 89 votes.

The countries with the most electors are: Italy (17), United States (10), Brazil (7), France and Spain (5), Argentina, Canada, India, Poland and Portugal (4).

High Court Disposes Of Petition On Rahul Gandhi's **Indian Citizenship LUCKNOW**: The Allahabad High Court's

Lucknow bench on Monday disposed of a petition questioning Congress leader Rahul Gandhi's Indian citizenship and allowed the petitioner to explore other alternative legal remedies.

A bench of Justices AR Masoodi and Rajiv Singh said that as the central government is not able to give any time limit to resolve the petitioner's complaint, there is no justification to keep this petition pending.

The court told petitioner SVignesh Shishir, a BJP worker from Karnataka, that he is free to adopt other alternative legal remedies.

In the PIL, Sishir had claimed that he has documents and some emails of the British government which prove that Rahul Gandhi is a British citizen, and due to this he is ineligible to contest elections in India and cannot hold the post of a Lok Sabha member.

In the previous hearing on April 21, the court was told that the Centre had written to the UK government seeking details about claims that Gandhi had British citizenship.

After the submission, the bench had granted time to the central government till May 5 to place before it the outcome of a representation moved by the petitioner against the Leader of Opposition in Lok Sabha, seeking cancellation of his 2024 Lok Sabha election over claims that he had British citizenship.

Earlier, the petitioner had told the court that he sent complaints twice to the competent authority regarding Rahul'Gandhi's alleged dual citizenship, but no action was taken by them.



While hearing the PIL on November 25, the court sought information from the central government regarding its decision on the representation of the petitioner.

Deputy Solicitor General SB Pandey had informed the court that acting on the petitioner's representation, the ministry concerned had written to the UK Government seeking details about Gandhi's alleged British citizenship and hence the government needed more time to take a final decision on the petitioner's representation.

NEW DELHI: The BJP on Monday alleged that the Congress and its allies have become a "fifth column" working to lower the morale of armed forces after the Uttar Pradesh Congress president took a 'toy Rafale' jibe at the government over its response to the Pahalgam terror attack.

BJP national spokesperson Sudhanshu Trivedi sought to draw a parallel between Pakistani army and leaders of INDIA bloc, saying the former is bombarding the Indian armed forces from across the border by violating the ceasefire while opposition

leaders are targeting them with their comments from within.

The ruling party's fresh attack on opposition parties, especially the Congress, came following Uttar Pradesh Congress president Ajai Rai's taunting remarks for the alleged lack of action by the government against terrorists.

Rai showed a toy plane depicting Rafale fighter aircraft with lemon and chillies hanging from it and targeted the government

for not putting them to use.

Trivedi noted that it is in a series of comments from opposition leaders aimed at demoralising the armed forces.

Citing past comments of a number of Congress leaders, he said while hardly any Pakistani leader is being quoted in the Indian media for any remarks against the Pakistani army, Indian politicians are being frequently cited in the neighbouring country for their criticism of the government and allegedly lowering the more of Indian armed forces.

Congress spreading rumours about Waqf Amendment Act: Union Minister Bhupendra Yadav

NEW DELHI: The rights of Muslim groups and individuals to create, manage and regulate Waqf will remain intact, Union Minister Bhupendra Yadav said on Monday, and alleged that the Congress is spreading rumours about the Waqf Amendment Äct, 2025.

Addressing a press conference at Delhi BJP office. the Union minister said that Prime Minister Narendra Modi has come up with various reforms in the fields of social justice, economic growth. transparency and gender equality.

"The Waqf Amendment Act, 2025 recently passed by Parliament is an important milestone of this progressive journey," he asserted.





Every right-thinking Indian will commence everything he does today with a prayer on his lips and deep-set anger in his heart. The attack by Pakistan-

eyes of the population earlier, seemed to be fading. exactly what Pakistan did not want. Practiced observers like me can probably feel the change in the air, through the looks people give you and the conversations they make.

None of these alluded to anything negative. Which is why I sense danger, and not without reason. When statistics start to indicate normalcy and minds start to accept this, the point of danger becomes evident. A strange paradox, but true". This article remained unpublished in the light of the terrorist attack. However, it's not difficult to explain the premonition. Pakistan has invested just too much

To put India under intense pressure, Pakistan knows that the sometimes-tenuous communal temperature can be incendiary. That is why these terrorists specifically profiled the tourists, ensuring that Hindus would be targeted and inflammatory messages addressing India's Prime Minister would be relayed. Besides this, the current visit of US Vice President J.D. Vance to India reminds one of a similar incident in March 2000. US President Bill Clinton was on a visit to India and was to speak to India's Parliament. The night before that, the Lashkar-e-Tayyaba

internal security situation, coupled with its failed economy hardly affords Pakistan the ability to risk a serious conventional conflagration with India. Therefore, applying rationale, one would surmise smaller acts, a combination of many of these to attempt to achieve something quite similar that they wish to achieve through Pahalgam. It would be less risky too.

However, knowing the Pakistani mind, these irrational acts will continue. That is why it's up to India to ensure that it responds, but only after thinking through. The one thing we definitely need to do is to eschew every Indian becoming a strategist and proffer advice to the government. Remember, we have an elected government in place, unlike that of Pakistan. Such a government looks at the national interest from every angle. It has a set of professionals who will advise, plan and execute. We should have the fullest faith in the political and military leadership and leave it to their sense of proportion and timing. While it is a hugely sentimental moment which has shaken up India's deep-rooted psyche, we cannot afford sentiment alone to rule our judgment.

There are thousands of innocents of all communities, good loyal Indians who are the heart and soul of our nation. We must ensure unity among our people despite the gravest of provocations and this one is definitely not the last of them. The way forward is to ensure that Jammu and Kashmir's progressive normalcy is enabled at any cost. With the terrorist strength small, the flow of intelligence will also be limited. Hence there has to be greater anticipation of potential actions which can upset the applecart in favor of the adversaries. Remember there are other linkages here, and India needs to get the pro-active diplomatic domain on J&K re-activated so that our narratives are the predominant ones.

There should be no dilution in our outreach programmes resulting from the inevitable negativity that an event such as Pahalgam tends to send out. The political environment is not yet vitiated, and a certain maturity is evident all around. We can all understand how difficult it is for those who have suffered as families but the biggest neutralisation of Pakistan's Kashmir strategy will be to make sure it does not regain any of the space that it has lost over the last couple of years. As far as a response to Pahalgam is concerned, we will await the decisions of the government, which knows this best.

When Seeing Your Own **Child Becomes a Luxury**

He had already watched his wife, Sana, endure eight months of struggle-of swollen feet, daily

That his only glimpses came through others-paramedics, aides, strangers-offering him secret snapshots for a few rupees?

But how do you tell a newborn anything? Especially when you're not even allowed to see him? This wasn't a story of medical negligence. It



sponsored terrorists of The Resistance Front (TRF) on innocent Indian and foreign tourists at Basiran near Pahalgam and the loss of a large number of lives needs the severest condemnation. There has to be a response, of course, although I feel we should allow the government to consider the most appropriate one with the best national and international professional advice.

One of the prime reasons for the attack was the fast-diluting relevance of Pakistan in the Kashmir narrative. Let me explain this with the help of an unpublished draft paragraph of the article that I was writing for this very newspaper just two days ago. The paragraph read as follows: "I recently travelled to J&K's capital city and its suburbs on the banks of the Jhelum, on a quiet weekend. Besides that, I spent some time at an uncharacteristically quiet Line of Control. A calm optimism seemed evident everywhere. Hostility, which was so evident in the

time, energy, resources, lives and finances in fighting the proxy war in Jammu and Kashmir. Even with its internal situation so tenuous in Balochistan and Khyber Pakhtunkhwa, its Army chief keeps spewing out hatred instead of looking towards stabilising the borders through a better relationship with its chief adversary. What Pakistan wants is a return to its old relevance to neutralise just what I wrote in my unpublished observation reproduced above. The Deep State and the Pakistan Army (which is a part of it) found this time very relevant.

First, much attention of the security establishment was focused on Kathua. Then there was an impending bumper tourist season in the offing, with a reported eight lakh tourists visiting the Tulip Garden at Srinagar. With the coming holiday season, the numbers would have exceeded all records. With money in the pocket and peace in the streets, families looking towards Pakistan would be history. That is

in South Kashmir, killing 36 Sikhs, in an apparent message to the US President that Kashmir was not in India's control. This may be a more appropriate time in Pakistan's perception to target the current emerging normalcy and India's control over the Union territory.

While the child was rushed to one hospital, Sana remained 60 kilometers away, recovering from her surgery, the stitches across her belly still raw. She lay in a modest bed, clutching her phone like a lifeline, waiting for updates from Imran. Every ring of the phone jolted her heart. Every silence between them hurt more than the scar she bore.

And Imran—what could he say to her? That he hadn't even seen their child properly? That he hadn't been allowed to enter the NICU even once?

image as if it was a picture from God, his breath catching at the sight of two tiny legs wrapped in sterile white. He kept that photo tucked as a mobile wallpaper like a sacred relic. Because when you have not held your child, have not whispered to him, have not kissed his skin-pixels become priceless.

And so, he waited.

For twenty-three days and twenty-three nights. He waited through thunderstorms and restless nights, through sunrises that didn't warm him

Fathers who wait behind glass doors, eyes fixed, heart aching.

And in another town, in another small room, there was Sana. Her face still drooped on one side from the palsy, her body still sore from surgery. But her pain was not from the physical wounds. It was the distance. The helplessness. The inability to hold the child she had fought so hard to bring into the world.

She too waited-for the sound of a ringtone. for a text from her husband that would say, "He's better now"

But that message didn't come. Only the machines kept beeping. The baby kept breathing. And Imran kept waiting.

This is not just a story. This is a mirror-held up to every system that forgets the human behind the patient. To every parent who has stood outside a NICU door, whispering their love through glass. Ask yourself:

What would you give to hold your child?

What does it mean when seeing your own baby becomes a luxury?

And somewhere tonight, in some corridor, a father still stands-not holding his son, but holding on. For one moment. One heartbeat. One hope. He's not asking for much. Just a chance to

be a father.





Snow Flames: A Metaphysical and Existential Cartography of Majrooh Rashid's Poetic Vision

"Poetry, as Majrooh Rashid's verse exemplifies, is not ornament but ontology-a revelation of the unseen, echoing Wallace Stevens' "priest of the invisible" and Ibn Arabi's view of mystical speech as inherently poetic. It is where the soul dwells, as Heidegger puts it, and where silence speaks, as Rumi and Dickinson suggest. Rashid's metaphorssnow and flame-echo Rilke's loneliness, Shahid's longing, and Eliot's quest for transcendence beyond personality. In his lines, we witness Frost's union of thought and feeling, Adunis's poetic liberation, and Nietzsche's art against despair. His poetry is at once veiled and luminous-a metaphysical and existential cartography of being."

In every age, the finest poetry does not merely mirror the world; it reshapes the soul's perception of existence itself, unveiling hidden harmonies between suffering and splendor, mortality, transcendence and pathways to transformative experience and awakening. The interplay between stylistic nuances, thematic depth and richness, and multifaceted socio-cultural context-varying traditions, histories and worldviews underscores the enduring power of poetry to reflect and transform the human consciousness.

In Prof. Majrooh Rashid's "Snow Flames"-poetic collection and his later corpus, we find such a rare alchemy: a poetic vision where the fleeting touch of snow and the restless hunger of flame conspire to dramatize the deepest metaphysical tensions of being and becoming with existential reflection.

A luminous first edition (2025) of nearly 270 poems across 288 pages, exquisitely published by Ink Links Publishing House, Pampore, with an evocative cover design by Rouf Qayasi. Enriched by Prof. Neerja Mattoo's insightful foreword and profound reflections by scholars Prof. Bina Biswas and Prof. Santosh Bakaya, this timeless volume radiates poetic and intellectual brilliance with penetration as the key coupled with economy.

Prof.Majrooh Rashid's work rises beyond the confines of time and geography, resonating with the ancient wisdom of Rumi's dance between annihilation and subsistence, with Hafiz's sweet intoxication in the mystery of being, with Iqbal's call to creative selfhood, and with the existential courage of Camus and Heidegger. Rashid's verse transforms memory into revelation, pain into purification, and loss into luminous becoming, thereby inscribing himself into the perennial conversation of the spirit across civilizations. His poetry does not merely invite us to read-it demands that we awaken: to the miracle of impermanence, to the radiance that lies concealed within fragility, and to the soul's indomitable yearning to turn every fall into flight. In an increasingly distracted world, Rashid reorients our attention to the essential: the mystery that trembles between the melting snowflake and the leaping flame, between silence and song, between dust and divinity. In the subtle undercurrents of "Snow Flames", one senses how Majrooh Rashid masterfully reconciles the paradox of snow and flames, revealing profound emotional, philosophical, and existential forces that shape the human journey/condition through poetic realities. Majrooh Rashid's "Snow Flames" and his later poetic corpus constitute a luminous exploration of the metaphysical tension at the heart of existence-the ceaseless dance between fragility and grandeur, loss and renewal, despair and transcendence. Drawing deeply from classical and modern traditions-Kashmiri, Urdu, Persian, Arabic, English, and existential European thought-M. Rashid crafts a vision that is simultaneously rooted in personal memory and cosmic yearning. "Snow Flames" masterfully blends Modernist and Postmodernist sensibilities, juxtaposing existential despair with the celebration of paradox. It channels Modernism's search for meaning amid fragmentation, capturing the tension between suffering and transcendence. Simultaneously, it embraces Postmodernist fluidity, challenging fixed narratives and highlighting the multiplicity of truths. Rashid's poem invites readers into a world where beauty and pain, life and death coexist as inseparable forces, urging a redefinition of existence as a dynamic, ever-evolving journey. In this synthesis, "Snow Flames" transcends traditional boundaries, offering a timeless reflection on the complexities of being. Engaging resonances with Rumi's mystical dialectics, Iqbal's philosophy of selfhood, Hafiz's celebration of spiritual intoxication, Khayyam's elegies of impermanence, Heidegger's ontology of being-toward-death, Camus' revolt against absurdity, Eliot's religious-existential landscapes, Schuon's metaphysical timelessness, Whitman's democratic mysticism, and Darwish and Miłosz's witness to fragility and endurance, Majrooh Rashid's work elevates itself into the perennial dialogue of soul with existence. This humble attempt traces the deep structures of Majrooh Rashid's poetics, articulating how snow and flame emerge as twin symbols of the soul's passage through time, suffering, beauty, and illumination.

T.S. Eliot's The Love Song of J. Alfred Prufrock's existential paralysis mirrors the frozen intensity of "Snow Flames", where inner fragmentation and societal disconnection blaze within a cold, unyielding world." Snow Flames" mirrors the Dionysian and Apollonian dichotomy, fusing order and chaos to reveal the transformative beauty at the heart of existence.

Magee's "High Flight" and M. Rashid's Snow Flames both capture the soul's ascent, transcending the tempo-

His poetry becomes a cartography of existential navigation. Snow recalls the silence that pervades Arnold's Dover Beach, where "ignorant armies clash by night" against a backdrop of cosmic indifference, yet M.Rashid refuses to yield to despair. Flame rises as a protest, much like Camus' "invincible summer" that resides within the depths of winter. In this creative tension, M.Rashid echoes the Sufi tradition where "fire and light are but veils on the face of the One," as Hafiz sings. Snow may melt; flame may consume; yet both point to a reality beyond their transient forms-the eternal Logos to which Eliot alludes when he writes, "the fire and the rose are one."

Transformative poetic reflection through serendipitous selections

The poem "My Poems" distills the soul's journey from fervent creative fire to serene dissolution. Through the alchemy of elemental symbols-fire ignited by passion, water poured from a "cloudy mind," and the ashes of poetic longing scattered into the "lake of life"-it evokes the timeless transformation of self and art. It speaks to a universal truth: poetry, born of intensity, finds its ultimate peace in surrender. Profoundly resonating with global poetic traditions, My Poems captures the elemental transformation of self-fire into ash, passion into peace-mirroring Sufi annihilation (fana), Romantic transcendence, Zen stillness, and Bhakti surrender. The poet dissolves the self into the lake of life, echoing the timeless human yearning for unity, stillness, and ultimate truth.

My Poems

I was a fire, but by the eternal ardour

Profound in its metaphysical lyricism and rich in cross-cultural symbolic resonance, "Lyrical Limits" is a deeply evocative meditation on transcendence, embodiment, and the intimate dialogue between the finite and the infinite. The poem delicately blends the tangible-dance, arms, rhythm-with the intangible-eternity, emptiness, resonance-thus situating itself at the sacred threshold where aesthetic experience becomes spiritual revelation. The speaker's vision of the sun "waking early" to witness a dance suggests a cosmic yearning, reminiscent of Vedic hymns where natural elements are personified in awe of divine expression. The "eternal song" echoes the Pythagorean and Sufi notions of cosmic music-the musica universalis and sama -in which the soul becomes attuned to the divine through rhythmic, lyrical motion. The merging of form ("lyrical arms") with formlessness ("assimilating into my emptiness") recalls the mystical paradoxes in Zen haiku, Rumi's ecstatic surrender, and the Bhakti poets' longing for union through the body's surrender to divine cadence.

It resonates with the mystical insight of Meister Eckhart-that "the eye through which I see God is the same eye through which God sees me"-suggesting the dancer becomes both subject and object of divine perception.

Geographically and culturally, this poem traverses poetic and mystical traditions from Kashmir's rich aesthetic-spiritual heritage, particularly the Rishi-Sufi synthesis, to the Persian ghazal's metaphors of gaze and union, the Japanese aesthetic of y gen (mysterious grace), and the Christian mystical tradition's contemplative embodiment. It belongs to a lineage of verses where silence speaks, movement prays, and boundaries reveal the Absolute.

With its lyrical refinement, philosophical depth, and universal soulfulness, Lyrical Limits is not merely a celebration of beauty-it is a revelation of how form dances toward the formless, how the seen vibrates with

The blue sky outside, proud of its expanse, is envying your limits.

"The Gospel of Time" distills the metaphysical weight of existence into an elegant, timeless meditation on transience. The poem's portrayal of time as a "viewless chariot" quietly dismantles illusions of permanence, evoking both the existential angst of modernist poetry and the mystical awareness of impermanence found in Eastern traditions. Echoing echoes of Eliot's Four Quartets and the Sufi concept of fanaa, it offers a lucid, lyrical passage through memory, oblivion, and the soul's fading scent-ultimately leaving us with a silence more articulate than speech.

MHA Asks States

Under the Indus Water Treaty, the Western Rivers-Indus, Jhelum, and Chenab-are allocated to Pakistan, while the Eastern Rivers-Ravi, Beas, and Sutlej-are allocated to India. However, India retains limited rights over the Western Rivers, including usage for domestic, non-consumptive, agricultural, and hydroelectric purposes under strict regulations.

The April 22 terror attack in Pahalgam was linked to Pakistan-backed terrorist groups, bringing bilateral relations between India and Pakistan to a boiling point.

India has downgraded diplomatic ties, suspended trade activities, closed border gates and banned entry of Pakistani vessels into the sea waters. Pakistanis in India were deported.

Since April 22, Pakistan troops have violated LoC ceasefire in J&K and fired small arms for 10 consecutive nights which has further escalated tensions between the two nations.

India suspends

be carried out at the Kishanganga hydroelectric project on the Jhelum River.

The Kishanganga project has been at the centre of long-standing disputes between the two countries. India's recent actions signal a policy shift towards using its full entitlement of waters under the treaty without the usual bilateral engagement.

Beyond the immediate reservoir activities, India has expedited work on multiple hydroelectric projects in Jammu and Kashmir, including Pakal Dul, Kiru, Kwar and Ratle. These projects are expected to add over 3,000 megawatts of capacity by 2027-28.

The government described the current steps as part of a broader reassessment of India's approach to water-sharing with Pakistan, prioritising national interests and security concerns over treaty obligations.

"This tragic incident is a grim reminder of the growing threat of violence against women. Such acts are an affront to our collective conscience and cannot be allowed to go unpunished," reads the post. Mian Mehar Ali, MLA Kangan in a post demanded

fast track investigation into the incident and exemplary punishment to the perpetrators.

"A Bakerwal girl has been brutally assaulted and raped, leading to her death, by two men in Nishat area of Srinagar. I demand fast track investigation into the incident and exemplary punishment to the perpetrators," Mehar Ali wrote.

Peoples Democratic Party (PDP) Chief and former chief minister Mehbooba Mufti in a post expressed shock over the incident.

"Deeply shocked and heartbroken by the alleged rape and tragic death of a tribal woman in Nishat. Reports suggest she suffered brutal injuries and succumbed en route to the hospital. The police have arrested the accused, who were reportedly intoxicated during the crime. Substance abuse, particularly alcohol and drugs, is devastating our youth and fueling horrific crimes like rape and murder. This tragedy reflects a broader societal crisis. My heartfelt condolences to the victim's family. I hope the perpetrators face the full force of the law," Mehboo

KNO that the brutal killing has pointed toward the unsafe haven for a woman in Kashmir. "The slogans of Beti Bachao and Beti Padhao are falling flat when such an inhuman act is taking place" Uncle of the victim, said.

"We have nothing left. Our women, daughters are not safe. Which society we are living in. It was the land of saints, but now such an incident was gruesome. These incidents were being reported in other states, but now, the brutality has reached Kashmir as well," he said.

"We demand the police to make progress in this case swiftly like it has managed to arrest the culprits quickly. No Lawyer should plead their case," he requested, adding that the punishment to the culprits should be served within a week's time.

Maternal Uncle of the victim thanked the Police for its swift action. "We request the authorities to hang the culprits to death. If justice is not served immediately, such incidents can happen to anyone in future," he said. "The punishment should serve as an example for all."

Meanwhile, the locals demanded an immediate liquor ban in the Valley, saying that such incidents can be prevented by imposing a blanket ban on sale and purchase of alcohol.

In the meantime, Srinagar Police in a statement said that it received information regarding an attempted sexual assault on a woman (name withheld) by a group of individuals near Water Works Road, Nishat. The victim had sustained grievous injuries and was shifted to the hospital, where she was declared brought dead.

"Following the incident, FIR No. 35/2025 under relevant sections of law was registered at Police Station Nishat, and investigation was immediately initiated," police said.

start of development activities, implementation of budget announcements and efficient governance amid current challenges.

"After six months, we are back to Srinagar Civil Secretariat office. The environment in which we were hoping the offices would open, expecting normal business did not happen. It has been seen that if situation remains conducive and peaceful, it improves functioning of the government," CM said.

'We need now to focus on things that are under our control and work to ease the difficulties faced by common people," the Chief Minister said in his opening address.

He directed officers to ensure that their efforts during this working season go beyond administrative offices. "We do not have to restrict our working to the Civil Secretariat as was the case during budget session. Now is the good opportunity to see implementation of projects on the ground," he stated.

He called upon all departments to concentrate on delivery and accountability. "Let's focus on the deliverables. So that six months from now, when we have to move to Jammu, we can actually sit down with a list of all the positive developments and changes that in spite of the circumstances, we were able to make here," the Chief Minister observed.

Referring to the budget passed in the Legislative Assembly this year in March, CM Omar Abdullah said that while opinions may differ, the government's obligation lies in its execution. "But now it is our duty, that the budget that the assembly passed, the budget that this government brought to the assembly and got it approved, we will implement the budget decisions and review meetings shall be held with concerned departments and agencies," he remarked.

He underscored the importance of utilizing the budgetary allocations and implementing District Capex plan on the ground. "Because this is the works season, he said, noting the brief window available for developmental works, particularly in the winter zone.

The Chief Minister informed that a detailed review would be held with the Chief Secretary, Finance Secretary and departments. "Where there would be obstacles, we will take the necessary decisions to remove those hurdles," he said, urging development departments - including Power, R&B, PHE, Health, and Social Welfare – to accelerate their pace of work.

Touching on the broader national support for J&K's development, CM Omar shared details of his recent meeting with Prime Minister Narendra Modi, saying that the highest level in government of India wants to see that in no way should Pahalgam attack derail the process of governance and development Gavai, the CII designate.

Earlier on April 17, the Centre assured the top court that it would neither denotify waqf properties, including "waqf by user", nor make any appointments to the central waqf council and boards till May 5.

The assurance of the Centre came when the bench was informed that the waqf law was passed by Parliament with "due deliberations" and it should not be stayed without hearing the government.

The Centre also strongly opposed the apex court's proposal to pass an interim order against the denotification of waqf properties, including 'waqf by user', aside from staying a provision allowing the inclusion of non-Muslims in the central waqf councils and boards.

Later on April 25, the Union Ministry of Minority Affairs filed a preliminary 1,332-page affidavit defending the amended Waqf Act of 2025 and opposed any "blanket stay" by the court on a "law having presumption of constitutionality passed by Parliament".

The Centre urged the top court to dismiss the pleas challenging the validity of the Waqf (Amendment) Act, 2025, pointing out a "mischievous false narrative" surrounding certain provisions.

"While this court would examine these challenges when the cases are heard, a blanket stay (or a partial stay) without being aware of the adverse consequences of such an order in a generality of cases (even on members of the Muslim community itself) were the petitions to be unsuccessful, would be uncalled for, especially in the context of the presumption of validity of such laws," the affidavit said.

The Centre urged the bench not to stay the law's provisions and claimed a "shocking increase" of 116 per cent in the waqf properties since 2013

It also opposed the arguments over the necessary registration of "waqf by user" properties till April 8, saying if the provision was interfered with by an interim order, it would amount to "creation of legislative regime by a judicial order".

The affidavit rebutted the submissions that Muslims might be in the minority in the Central Waqf Council and state Waqf Boards due to the change in the law. Justifying a provision on "waqf by user" properties, it said any interference would create a "legislative regime by a judicial order".

Waqf by user refers to a practice where a property is recognised as a religious or charitable endowment (waqf) based on its long-term, uninterrupted use for such purposes, even if there isn't a formal and written declaration of waqf by the owner.

During an earlier hearing, the bench proposed

No words of solace can truly ease the pain they must be experiencing at this time," Bukhari wrote.

PDP leader, Iltija Mufti demanded that the culprits must be brought to task for this blood curdling crime.

"A tribal woman - mother to two sons while grazing her goats is tied to a tree and raped by drunk men. Her family finds her mercilessly beaten. She's rushed to a hospital where not a single doctor is present to attend to the grievously injured victim battling for her life. The culprits must be brought to task for this blood curdling crime," Iltija wrote

Nomadic mother

"The culprits should be hanged till death," she, along with her family and relatives, demanded.

Narrating the moments before the incident the daughter of the victim said that her mother was serving tea to them. "Hardly we knew that our mother was serving the last tea to us."

In the meantime, the body was shifted to Government Medical College (GMC) Srinagar for legal medico formalities and was handed over to the family for last rites this morning.

The family reached Dard Wooder, Mammer area of Kangan to bid a tearful farewell to the victim.

The brutal killing of a nomadic woman after being sexually assaulted by four persons in Nishat area of Srinagar on Sunday, has left a scar for Reasi family, who questioned the 'safe haven' for a woman folk in the Valley. The family has been visiting Kashmir every year for the last more than a decade to graze their cattle.

Every eye was numb at Kangan area when a nomadic family, hailing from Reasi, presently living in Nishat, laid to rest their beloved member. Amid tears and sobs, the family members, told

India extend dominance in white-ball formats, retain top spot in ODIs and T20Is

ndia retained their top position in the ODIs and T20Is to extend their dominance in the white-ball formats but slipped a place to fourth spot in the Test format, in which Australia reigned supreme, in the latest ICC annual men's ranking update issued on Monday.

The latest rankings rate all matches played since May 2024 at 100 per cent and those of the previous two years at 50 per cent.

In the ODI rankings, 2023 World Cup finalists India have strengthened their grip at the top on the back of a victorious ICC Champions Trophy campaign, improving their rating points from 122 to 124.

Coming in second place are the runners-up at the Champions Trophy, New Zealand, overtaking their Trans-Tasman rivals Australia, who now occupy the third spot.

Sri Lanka, who enjoyed an excellent run at home in recent months, including ODI series wins against India and Australia, are in fourth place after gaining five rating points, leapfrogging Pakistan (fifth with a gain of one point) and South Africa (sixth with loss of four points) in the process.

Afghanistan also climbed up the ladder – moving to seventh following a four-point improvement–at the expense of former world champions England, who fell to eighth after dropping four points.

West Indies, meanwhile, rose to the ninth spot after gaining five points to surpass Bangladesh, who dropped to 10th with a four-point decline. India boss shortest format

Arshdeep is happy that he could account for all three inform batters of LSG in Mitchell Marsh, Aiden Markram and Nicholas Pooran inside the Powerplay.

"I was just watching him (Nehal Wadhera's catch to dismiss Marsh) run to the ball. I was praying 'just catch it' because you know Mitch is a very dangerous player when he gets in and gets going. So, we had to take that early wicket. Credit to Nehal for that excellent catch.

"Their top three have been scoring a lot of runs. We thought if we can take their wickets as soon as possible, we will have the upper-hand. The execution was very nice."

Arshdeep's franchise coach Ricky Ponting feels that the left-arm pacer has progressively got better and has started getting those Powerplay scalps, which he has done for Indian national team in past few seasons.

"I think Arshdeep's got better and better every game. As this tournament's gone on, he's got better and better. I think he's got more confident. He's starting to get those powerplay wickets now that we know that he can with that brand new ball," Ponting said after the match.

Sri Lanka, who enjoyed an excellent run at home in recent months, including ODI series wins against India and Australia, are in fourth place after gaining five rating points, leapfrogging Pakistan (fifth with a gain of one point) and South Africa (sixth with loss of four points) in the process.

In a shocking revelation over the weekend, Rabada disclosed that he is serving a provisional suspension after testing positive for a banned recreational drug. The South African pacer had left the IPL last month after playing two games for Gujarat Titans, citing personal reasons.

"It stinks. I don't like this use around personal issues, and it being used to hide stuff that isn't a personal issue," Paine told 'SEN Radio' on Monday.

"If you have a professional sportsman that's tested for recreational drugs during a tournament in which he is playing, that doesn't fall under personal issues for me.

"That falls under you have broken your contract. That is not a personal issue, that is something that is happening in your personal life," he added.

The positive test was recorded during the SAT20 league in January.

"Taking drugs-recreational or performance enhancing- is not a personal issue that can just be hidden for a month. A guy can be taken out of the IPL, moved back to South Africa and we just let it slide under the rug. Then we will bring him back once he's already served his ban," Paine said. According to World Anti-Doping Agency (WADA) code, the quantum of punishment for usage of recreational drug could be anything between three months to four years. While there is no clarity on when the pacer games for South Africa across formats including 70 Tests.

"Notonly will play against Australia in the World Test Championship but he's available to be playing now in the IPL. No one knew about what he's taken, what he was given or who the organising body was that oversaw it.

"If he is going to take drugs and be caught doing it I think people deserve to know what he's taken, how long he is being rubbed out for and who sanctioned it. People need to be held to account for stuff like that," Paine added.

Substances such as cocaine, heroin, MDMA and cannabis fall in the category of 'Substances of Abuse'. WADA recognizes they can be taken out-of-competition for reasons unrelated to sports performance.

The use of such drugs carry a maximum of four-year ban but if a sportsperson can prove that the use occurred out-of-competition and is not related to performance enhancement, the ban could be reduced to three months with no need to further analyze the degree of fault.

The athlete's ban can be reduced to two months if he/she is willing to undertake a treatment program that is approved by South African Anti-Doping body.

If the drug is taken in-competition but the athlete can prove the use was unrelated to performance, a two-year ban will be handed out as the infringement will be considered non-intentional.
