# **India's Water Will Be Now Utilised For The Country: PM Modi**

**NEW DELHI**: In an apparent reference to the Indus Waters Treaty being put in abeyance, Prime Minister Narendra Modi on Tuesday said earlier even the water which rightfully belonged to India went outside the country but it will now flow for India's benefit and will be utilised for the country.

Addressing the ABP Network's 'India@2047' Summit, Modi asserted that for taking big decisions and achieving objectives, it is important to give primacy to national interest and believe in the country's capability.

The prime minister said that when people look at the country now, they can proudly say "democracy can deliver", and stressed that the government was moving from GDP-centric approach to progress based on Gross Empowerment of People

While speaking about the work done on the interlinking of rivers, Modi quipped



that water is a topic of intense discussion in the media lately.

"Earlier, even the water which rightfully belonged to India was going outside the country. Now India's water will flow for the country's interest and will be useful for it," he said in an apparent reference to India

putting Indus Water Treaty in abeyance as part of countermeasures against Pakistan after the Pahalgam terror attack.

Referring to the new Waqf law, Modi said the need for reforming the law was being felt for decades, but to satisfy a votebank even this noble work was

"Now the amendments have been made which in the real sense will help poor Muslim mothers and sisters and poor Pasmanda Muslims," he said.

In his address, he said the biggest dream of this changing India is to become 'Viksit Bharat' by 2047.

"The country has the capabilities, resources and the will power for it." he said. Speaking about the finalisation of the

India-UK free trade agreement, Modi said it is a historic day as this pact between two big and open market economies will mark a new chapter in the development of the two countries. "This will boost economic activity

in India and will open new ways and opportunities for Indian businesses and MSMEs," Modi said. The prime minister said India is not only carrying out reforms, but by actively engaging with the world, it is also making itself a vibrant trade and commerce hub.

According to the details available with the news agency-Kashmir News Observer (KNO) the directions to hold the nationwide exercises have been passed by the Ministry of Home Affairs.

An official said that the preparations for conducting mock drills in J&K have been finalized and tomorrow sirens will be activated at various locations in the union territory to test emergency response systems. "Public is requested to remain calm and not be alarmed," he added.



### Amid tensions, Army, BSF on high alert in J&K

SRINAGAR: Amid escalating tensions between India and Pakistan, the Army and Border Security Force (BSF) are on high alert along the Line of Control (LoC) and International Border (IB) across Jammu

Pertinently, the Pahalgam terror attack that left 26 civilians, mostly tourists dead, and its cross border linkages have led to the heightened tensions between

the two nations. India has downgraded the diplomatic ties with Pakistan, has suspended trade, closed border gates and deported all Pakistan nationals from India.

An official told the news agency—Kashmir News Observer (KNO) along with the nationwide civil de-fence mock drills to be held on Wednesday, the Army and BSF will remain on high alert along the LoC and the International Border. "Armed forces have been directed to maintain tight vigil and not to lower the guard," the official added.

Meanwhile, amid the rising tensions, Indian forces apprehended a Pakistani national near the LoC in the Poonch district. The individual was arrested at a time when relations between India and Pakistan are

already strained.

Senior officials stated that the arrested man is being guestioned to ascertain further details about

Pakistan Army once again violated the ceasefire agreement along the Line of Control (LoC), continuing

their pattern of unprovoked firing in several areas.

The latest incident occurred on the night of May 5-6, when Pakistani troops opened fire using small arms across the LoC in multiple sectors, including Kupwara, Baramulla, Poonch, Rajouri, Mendhar Naushera, Sunderbani, and Akhnoor.

This marks the 12th consecutive night of ceasefire violations by Pakistan, further aggravating the already

Talking to reporters here the Chief Minister, according to the news agency-Kashmir News Observer (KNO) said, "What happened in Kulgam shouldn't have happened, but not only Kulgam, the news of arrests, which is coming from different places in Kashmir-for the first time, the people of Jammu & Kashmir, especially Kashmir, came on the street against the attack and have shown their anger. This message shouldn't be conveyed to them

that they all are being punished." On the SDRF personnel conducting a mock drill in Dal

Lake, the Chief Minister said, "During the past few days, two boats have capsized in Dal Lake and we have asked the SDRF to



deploy their teams to prevent tragedies and loss of life.

# Rahul Gandhi should apologise as he insulted Hindus by calling Lord Ram mythological: VHP

NAGPUR: The Vishva Hindu Parishad (VHP) on Tuesday accused Congress leader Rahul Gandhi of insulting the Hindu community by calling Lord Ram a "mythological figure", and demanded an apology from him.

Addressing a press conference here, VHP general secretary (organisation) Milind Parande said the Hindu community should not let leaders like Gandhi come to power.

During an interaction at a US university last month, Gandhi rejected the BJP's idea of what constitutes a Hindu and asserted all great Indian social reformers and political thinkers - Jyotirao Phule, BR Ambedkar, Mahatma Gandhi and even Guru Nanak, Basava and Buddha – said the same thing, "Carry everybody with you, satya (truth) and ahimsa (non-violence)." "This, to me, is the bedrock of Indian tradition and history. I don't know of one person whom we consider great in India who wasn't of this type. I can't think of one. All are mythological figures. Lord Ram was of that time, where he was forgiving, he was compassionate," the Congress leader had said.

Parande said, "During his interview in US-based Brown University, Gandhi called many subjects of Indian history as mythology and even called Lord Ram



a mythological figure. By doing so, he has insulted the Hindu community and Hindu faith on foreign land." "It is not surprising as in 2007, the then Congress government had filed an affidavit in the Supreme Court in the Ram Setu case, stating that Lord Ram is a mythological figure. Hence, I feel Congress and its leaders are continuously insulting the Hindu community. VHP condemns this and demands that Rahul Gandhi should

apologise for his statements," he said. Gandhi does not know that anyone who opposes Lord Ram gets destroyed,

"And this is what will happen. I think Hindu community should not let such people come to power...people whose only aim is power. Rahul Gandhi continuously gives anti-Hindu statements. Hence, it is important that people who care for the interest of Hindus should sit in central and state governments," he said.

Talking about the Pahalgam terror attack, he said jihadist violence was on the rise everywhere.

"The way innocent people were killed

in Pahalgam, the way their religion was asked before being killed ruthlessly – it raises a question mark over the saying that terrorism does not have a religion," he said.

"The Hindu community is being attacked by those indulging in jihadist violence. If a section of Muslim think that they can scare the Hindu community through violence, then it is their misunderstanding. Certainly, the grave of jihadists will be dug in India and the Hindu community will digit," the VHP leader said.

When asked about the VHP's stand on the decision to conduct a caste census, he said, "I feel a lot of things will come to light if the census of the entire society is conducted. But I feel the subject of the caste census of the entire population has become a little different."

However, VHP believes and works towards the goal that Hindu community should rise above caste and be united. Since the government has decided and as many people have demanded, caste census will be implemented, Parande said.

The VHP is operating with the focus of keeping the Hindu society united, enhancing the nationalist character, patriotism among the community members, he said. (Agencies)

# Five Bangladeshi nationals held for illegal stay in Navi Mumbai

**THANE**: Five Bangladeshi nationals have been arrested from a locality in Navi Mumbai for allegedly staying in the country without valid documents, police said on Tuesday.

A team from the Anti-Human Trafficking Cell (AHTC) of Navi Mumbai Police raided a premises at Karanjade in Panvel on Sunday morning and found six Bangladeshi nationals, including two women, living there, a police spokesperson

He said five were taken into custody after preliminary verification of their immigration

"Three of the accused overstaved in India even after their visas had expired, while the other two had entered the country illegally without any valid travel documents or permissions," the official said.



He said investigations revealed that the accused had managed to fraudulently acquire Indian identity documents, including Aadhaar and PAN cards and voter IDs.

Three accused had even secured Indian passports, he

The official said an FIR has been registered at the Panvel Town police station against the accused, Anna Khatun Akash Gazi (35), who was caught with her six-vear-old daughter. Alo Khatun Ismail Gazi (31), Istrafil Islam Gazi (25), Kia Akash Gazi (21) and Akash Latif Gazi (40).

He said Mohammad Ismail Aminoddin Yerulkar (52), a retired Indian national, has been named as co-accused for allegedly helping the group obtain Indian identity documents and facilitating their illegal stay in the country.

"The arrested accused were produced before a magistrate on Monday and have been remanded to police custody until May 9 for further investigation," the official said.

# **Entire country** stands by Govt in wake of Pahalgam attack: Gehlot

JAIPUR: Former Rajasthan chief minister Ashok Gehlot has said that the entire country is standing by the Government in the wake of the Pahalgam terror attack.

The veteran Congress leader also said Prime Minister Narendra Modi and Defence Minister Rajnath Singh should have complete freedom over the decisions that need to be taken in the aftermath of the terror strike that has killed 26 people, mostly tourists, in south Kashmir's Pahalgam.

However, he also said that it has been 13 days since the April 22 terror attack and people are still looking for answers from the government that talks big.

Asked about the Pahalgam terror strike, Gehlot said on Monday, "I cannot comment on that because the opposition has said that we are with the government. So I believe that no one should comment on it." He said decisions will have to be taken

by the government after contemplating. "Such decisions are not taken in a hurry. Such decisions are not taken in over-enthusiasm or over-reaction. These decisions will have to be taken after think ing carefully and considering what is in the best interest of the country," Gehlot told reporters here.

# Cong Chief Kharge Writes To PM Modi, Calls For Dialogue With All Parties On Caste Census

**NEW DELHI**: Congress president Mallikarjun Kharge has urged Prime Minister Narendra Modi to draw upon the Telangana model for the caste survey, remove 50 per cent cap for reservation and immediately implement Article 15(5) providing for reservations for SCs, STs and OBCs in private educational institutions.

In a letter to Modi, Kharge also called on the prime minister to have a dialogue with all political parties soon on the issue of the caste census.

"Conducting any exercise such as the caste census which gives the backward, the oppressed and the marginalized sections of our society their rights cannot and should not be considered divisive in any way," Kharge

# SYL canal row: SC directs Punjab, Haryana to cooperate with Centre for amicable resolution allocation of water from the Ravi

Court on Tuesday directed the governments of Punjab and Haryana to cooperate with the Centre to resolve the Sutlej-Yamuna Link (SYL) canal row.

Abench of Justices BR Gavai and Augustine George Masih was informed by the Centre that it has already taken effective steps to resolve the issue amicably. "We direct both the states

to cooperate with the Union of India in arriving at an amicable solution," the bench said.

The bench said it would hear the matter on August 13 if it is not resolved by then.



"We have made efforts for mediation, but the states have to walk the talk," Additional Solicitor General Aishwarya Bhati, appearing for the Centre. told the bench.

The SYL canal was conceptualised for the effective and Beas rivers.

The project envisaged a 214km canal, of which 122 km was to be constructed in Punjab and 92 km in Haryana.

Haryana has completed the project in its territory, but Punjab, which launched the construction work in 1982, later shelved it.

The dispute between the two states has been lingering on for decades.

The top court had on January 15, 2002, ruled in favour of Haryana in a suit filed by it in 1996 and directed the Punjab government to construct its portion of the SYL canal.

# Wild Boars Return After Decades, Wreak Havoc on Bandipora's Paddy Fields

BANDIPORA: Wild Boars have resurfaced in Bandipora district after more than a decade and has wreak havoc in agricultural land destroying paddy nurseries.

Farmers told Kashmir Convener that the attacks by wild boars is turning out to be a disaster for agriculture in Bandipora this year and demand government intervention.

Reports have emerged from villages including Aragam, Garoora, Hajin, and Ajas, where farmers say wild boars are destroying paddy seedlings overnight. "We sow paddy seeds during the day, but by morning the fields are devastated by wild boars," said Hilal Ahmad, a farmer from Aragam.

Wildlife experts trace the origin of the Indian wild boar in Kashmir to the era of Maharaja Gulab Singh, who is believed to have introduced the species to the region in the mid-19th century. Historical accounts, including those of British officer Walter Roper Lawrence, mention



wild boar meat being a delicacy among Dogras the area, said, "They come at night in groups and and Sikhs. Sajad Ahmad, another farmer from destroy entire patches. We've started putting up

temporary fences, but it's not enough." With the sowing season already delayed due to erratic weather, farmers fear the crop damage could severely impact their yield this year. They have appealed to the district administration and the wildlife department for immediate intervention.

Wildlife Warden for North Kashmir, Intesar Suhail, acknowledged the reports but said the department has limited options. "Wild boars move in flocks and are difficult to control. Farmers should adopt communitybased nurseries so that they can collectively monitor and protect their crops," he advised.

The affected communities are now urging authorities to deploy protective measures and provide compensation for the damages, warning that if the issue persists, it could lead to signifi-

cant agricultural losses in the district.

# **Illegal Mining Suspected in Collapse** of Under-Construction Footbridge at **Shadipora**

**BANDIPORA/GANDERBAL**: An under-construction footbridge connecting Shadipora in Bandipora with Latti Gujd Roshan in Ganderbal collapsed into the Jhelum River late Monday night, triggering fresh concerns over unregulated sand mining in the area. Fortunately, no injuries were reported as the incident occurred during night hours.

The bridge—long awaited by locals—had been under construction since 2014 and was reportedly close to completion. The structure was meant to improve inter-district connectivity and ease access for hundreds of villagers.

Early Tuesday morning, the Executive Engineer of the Sumbal Division visited the site to assess the damage. He told Kashmir Convener that while the exact cause of the collapse is yet to be determined, illegal sand extraction in the vicinity could have compromised the structural integrity of the bridge.

"Unregulated mining can significantly weaken riverbanks and foundation supports. Though the final cause is subject to investigation, illegal mining may have contributed to the collapse," he

Residents, who have waited nearly a decade for the bridge, expressed anger over the lack of proper oversight and delays in construction. They are now demanding a time-bound inquiry and immediate reconstruction of the bridge under stricter monitoring.

Local voices also emphasized the need for stringent action against illegal mining operations along the Jhelum, warning that continued neglect could endanger more lives and infrastructure in the region.

The successful completion of the first Test Vehicle Abort Mission (TV-D1) and the preparations for the second (TV-D2) later this year, along with planned uncrewed orbital flights, reflect ISRO's methodical and safety-focused approach. The Human-rated LVM3, crew and service modules, and the Crew Escape System are undergoing rigorous final testing. The Indian Navy's involvement in recovery operations further illustrates the multi-agency coordination driving this national effort. Gaganyaan is more than a space mission. It is a bold statement of India's technological maturity, policy foresight, and strategic ambition. With astronauts already trained in Russia and undergoing missionspecific preparation in India, the nation is not only building hardware but nurturing human potential. The benefits are already tangible—spinoffs in robotics, materials science, medicine, and electronics are fueling innovation across sectors.

Crucially, this mission is democratizing the Indian space sector. Following key reforms, startups and private industry are now part of the Gaganyaan ecosystem, contributing to components, software, and systems. It has become India's mission, not just ISRO's, creating jobs, building skills, and inspiring young minds.

As India looks toward establishing a space station by 2035 and landing an Indian on the Moon by 2040, Gaganyaan is the first giant leap. It symbolizes not just a scientific achievement but a reassertion of India's capability to shape the future of space exploration on its own terms.

The countdown to 2027 has begun—not just to a launch, but to a new chapter in India's tryst with the stars.

# BOOK REVIEW

The book by Amitav Ghosh, 'In an Antique Land', is a beautifully written piece in which he explores human connection, displacement, and the fragility of cultural memory. He also emulsifies two seemingly disparate narratives. One is Amitav's ethnographic Journey in Egypt's rural part during the 1980s and also the historical quest to trace the life of Bomma, who is a 12th-century enslaved Indian and whose imprints survived in the Geniza documents of Cairo. This book by Amitav is not a simple one; it transcends the boundaries of anthropology, memoir, boundaries of genre, toughness in fieldwork, and Historical detective work into a well-defined narrative which is intellectually rigorous and emotionally resonant. Amitav's fictional writing is filled with respect for everybody's daily life. This book encourages a reader to think about the history, personal identity, and global connections like trade, migration, and the lasting effects of post-colonialism- all these are interwoven deeply.

The book fundamentally is a meditation on the fluidity of human experiences. Amitav, who is a product and an anthropologist trained mainly in the West, arrives in the villages 'Lataifa' and 'Nashawy' of Egypt, who is both an outsider and curious about the new area and who has a Scholar's discipline with rich experience of methodology and approach, but not with the context of the socio-political dynamics of villages of Egypt. Interaction of Amitav Ghosh's with Villagers figures like with Abu Ali, Introspective Ustad Mustafa, and the young restless energetic guy Nabeel reveals a world of different experiences and hardships like of religion devotion of people in Egypt, economic difficulties and how it produces the various types of emotions and attachments, and a cautious hospitality of the people towards the strangers' suspicious hidden motives. Entering any field can be challenging, and Amitav effectively illustrates this complexity. He emphasises that acquiring information is not a straightforward process; it involves more than mere "observation and experimentation" by the researcher. Instead, those you interact with—your conversational partners—act as anthropologists themselves. They



experiment with you, influencing how you interpret their responses and the information they provide. It is through this collaborative engagement that they allow you to observe and understand their lives and insights. Amitav does not romanticise rural life, but he portrays it with an Anthropologist's precision and a novelist's empathy, and he is capturing the tensions between the present modernity and the old tradition., Community life and individual aspirations. His identity as a non-muslim Indian temporary sojourner becomes a way of seeing and a lens through which he navigates these relationships, constantly negotiating the power dynamics inherent in his role as Observer and participant.

Ghosh reconstructs the story of Bomma from fragments of medieval correspondence between a Jewish Merchant, Abraham Ben Yiju, and his associates. Bomma, an enslaved or freedman, is a marginal presence in the records. Ghosh imbues him with life and imagines the journey of Bomma from India to the Middle East within the vibrant cosmopolitanism of the Indian Ocean trade. This has been a world where religious and cultural boundaries are not rigid. Still, they are flexible and are integrative, where jews, Muslims, and Hindus collaborated in commerce and coexisted in shared spaces. Ghosh's evocation of this era is meticulous. drawing on archival evidence to paint a picture of a pre-modern globalised world that feels distant and eerily familiar. Yet the sparseness of Bomma's record—a name, a few references—underscores the precariousness of subaltern voices, preserved only by chance and revived through Ghosh's imaginative labour. The past, characterised by its flexibility and integration, bears little resemblance to the current political dynamics, which lean towards nationalism. The stark difference between Egypt in the 1980s and its ancient past prompts contemplation on how colonialism and modernity have disrupted traditional cultural integration and varied identities.

If we take Sociological insight, this book, 'In an antique land,' offers a profound commentary about identity as a relational and historically contingent phenomenon. In the medieval Indian Ocean, Identities were not fixed as we witness now; networks of mobility and trade shaped them. This book shows us that in medieval times, figures like Bomma and Ben Yiju were flexible and adapted to multiple roles, such as merchant, enslaved person, and ally. Modernity and post-colonialism have significantly altered Egypt's historical adaptability and integrity dynamics. Post-colonial structures, such as the nation-state,

experiment with you, influencing how you interpret their responses and the information they provide. It its, shape the experiences of the Egyptian villagers that Ghosh encounters. These factors contribute to a decreased acceptance of multiculturalism compared to the pre-colonial era. The villagers create a nar-



row lens through which they view Ghosh, which is marked by suspicion regarding his Indianness and secular demeanour. This scepticism reflects how post-colonialism has surfaced their definitions of inclusivity and exclusivity, highlighting the increasing polarisation of differences—a legacy of colonial divisions compounded by contemporary geopolitical tensions. This shift illuminates the concept of "Othering." In this context, the "Othering" is less about social, political, or economic hierarchies and more about Ghosh being suspected as an untrustworthy source of information, thereby limiting his chances as a participant observer. This form of "Othering" indicates that individuals are classifying him as an ally of the imperialist country or someone aligned with extractive interests.

One significant sociological theme in the book is the interplay of memory and storytelling. Much like the written accounts in Bomma's life story, the oral histories of the people from Egyptian villages serve as fragile repositories of collective identity that are at risk of being erased by modernisation and globalisation. Ghosh's conversations with the villagers uncover a deep-seated attachment to local traditions about their socio-economic sustainability. However, these traditions are under pressure as young men like Nabeel are drawn to the Gulf's economic opportunities and aspire to migrate for

work, which exemplifies the unwritten stories of many who are the same as him. Similarly, Bomma's narrative endures primarily through the accidental preservation of the Geniza, which poignantly highlights how much human history can be lost over time. Ghosh's storytelling blends meticulous scholarship with creative narrative, which acts as an act of resistance against this erasure, offering a means to reclaim the agency of those who live on the margins.

Despite its brilliance, the book is not without its shortcomings. The readers who are not accustomed to scholarship will not be able to understand the context of the book; this book is not for everyone; many may find the wording easy, but will not be able to under the contextual relationship among the paragraphs. Another thing is that Ghosh has mainly highlighted the male voices in the book, which can be perceived as against not taking the gender dynamics at the surface. Additionally, the emotional resonance of Ghosh's departure from Egypt feels somewhat understated, leaving certain aspects of his journey unresolved. This unresolved thing can also be a good thing because it can bring curiosity to the reader or help the science develop, but many don't like this; they feel that what they have read is incomplete. His romanticised view of medieval Egypt's multiculturalism tends to oversimplify the historical complexities involving class, religion, and servitude. According to scholar Javed Majeed, there appears to be a lack of dialogic depth in the exchanges between Ghosh and his informants.

The book 'In an Antique Land' by Amitav Ghosh is a remarkable work that encourages readers to perceive the world through a kaleidoscope of perspectives. It offers a blueprint for navigating diverse regions and emphasises the significance of connections in our global landscape. # Snow Flames: A Metaphysical and Existential Cartography of Majrooh Rashid's Poetic Vision

The Gospel of Time

Time is a viewless chariot, racing from the Beginning, constantly along the highway, lending to absolute stillness; covertly passing by us, who are lost in contemplation of being and nothingness. It takes along: the fog in our minds, scent that wafts out from the human hearts, waking dreams denied to the seeing eyes, ultimately sinks them into oblivion, at the end of dark tunnel.

(Inspiration: Naseer Ahmad Nasir's poem)

Prof. Majrooh Rashid's "Snow Flames" distills Kashmir's spiritual and existential anguish into global resonance. "Hope" mirrors Agha Shahid Ali's poetic defiance-life blooming amidst desolation and stands as resilient like Dickinson's winged metaphor. "Darvesh" channels Rumi's mystical arc: from ecstasy to inner illumination and whirls in Blakean spiritual fire. "A Soliloquy" recalls Eliot's The Waste Land-memory's weight and time's erosion and mourns with Ghalibian introspection. "Hemlock" invokes Socratic martyrdom, echoing Neruda and Darwishwhere words risk death but redeem truth a Luminous, timeless cartography of the soul. These verses, rich in Sufi, classical, and modern echoes, universalize the Kashmiri soul's cry: poetry as resistance, remembrance, and renewal.

A Soliloquy All my life, stay busy clearing the mind of the debris from the broken promises and crumbling hopes, gathering it in the worn out palms I went by the riverside, buried it under the slopes of the great River. And you, you are there, stuck in the past, unaware of the brilliant present, soon it will be all history. Will sink into oblivion second by second. Hemlock Last poetic lines .... If only I were Socrates I would drink the words draught by draught.

Memory in M. Rashid's poetry is not nostalgic reminiscence but an existential tethering to being itself. In poems such as "Mother's Sermon" and "On Father's Day," loss is neither sentimentalized nor overcome; rather, it becomes the very site where absence calls forth the deepest forms of presence. This sensibility places M. Rashid in profound dialogue with Czesław Milosz, who wrote: "Our memory is our coherence, our reason, our feeling, even our action. Without it, we are nothing." Rashid's recovery of tenderness through remembrance is not a retreat but an affirmation-an existential act that redeems the fleeting into the luminous.

Pain, far from being an accidental intrusion, becomes in poets's vision the very forge of authentic selfhood. In "Pain Scented the Air" and "Celebrating Barrenness," suffering emerges as a spiritual alchemy, mirroring Nietzsche's intuition that "one must still have chaos in oneself to give birth to a dancing star." Majrooh Rashid neither wallows in pain nor romanticizes it; he recognizes, with Rumi, that "the wound is the place where the Light enters you." Pain, distilled through the poetic process, becomes not a dead weight but a sacred burden-a cross carried in the hope of resurrection. His flames do not destroy but purify, recalling Schuon's assertion that "to suffer in the world is to participate, however obscurely, in the universal mystery of purification."

In Snow Flames, Prof. Majrooh Rashid fuses Kashmiri mystic and revolutionary traditions, weaving snow and flames into a living symbol of silent longing/endurance.In a sense like the Sufis, he reveals inner burning beneath stillness, while his voice, defiant yet tender, carries the timeless hope of renewal and transcendence.

In his mystical poems such as "The Ladder of Mystery" and "Road to Light," Majrooh Rashid maps the arduous ascent of the soul toward the Real, yet his mysticism is stripped of escapism. As Whitman proclaimed, "I believe a leaf of grass is no less than the journey-work of the stars," so poet finds the sacred within the immanent, insisting that the ladder to heaven must be constructed with acts of compassion on earth. The "Road to Light" is paved with ethical awakenings, small fidelities to truth, beauty, and justice, rather than grandiose mystical flights. His vision recalls


Muhammad Iqbal's call for a dynamic, self-affirming spirituality wherein the ego (khudi) is not annihilated but perfected in service to the Divine.

Majrooh Rashid's later poems-"Who am I?", "The Cosmic Path," "Black Hole," "My Poems," and "Typo"-move deeper into philosophical and ontological terrains. "Who am I?" voices the fundamental existential cry, the anguished questioning that Heidegger captures in Being and Time when he speaks of Dasein's burden of existence. Rashid's self becomes a question mark inscribed against the infinite, an echo of Whitman's eternal query: "What is the grass?" "The Cosmic Path" charts the journey of the soul across the galaxies of meaning, risking the dark abysses of

that timeless fellowship of souls-Darwish singing amid ruins, Miłosz memorializing imperilled beauty, Whitman embracing the cosmos within a blade of grass, Eliot plumbing the burnt-out ends of modern days.

Majrooh Rashid's poetry offers no facile redemption, no utopian assurances; rather, it gifts us something rarer: the courage to dwell within the paradoxes of existence without losing wonder, the wisdom to embrace transience without capitulating to despair, and the faith to recognize, with Rumi, that "where there is ruin, there is hope for treasure." In his incandescent verses, the ephemeral is transfigured into the eternal, sorrow becomes a deeper form of praise, and the burning of the heart



despair while bearing the secret hope of arrival. "Black Hole" warns of the self's implosion into egotism and nihilism, a chilling affirmation of Camus' warning that the only serious philosophical question is whether life is worth living. Yet Majrooh Rashid's answer, like Camus', is a defiant yes-not through naïve hope but through courageous fidelity to beauty and truth.

In a sense Snow Flames mirrors Einstein's "theory of eternity" by collapsing time into a poetic simultaneity-where memory, loss, and longing coexist as luminous presences. Like Einstein's timeless universe, Majrooh Rashid's verses transcend temporal borders, turning snow and flame into symbols of enduring inner truths. The collection becomes a lyrical echo of eternal now-philosophical, mystical, and profoundly human.

"My Poems" and "Typo" reveal a profound humility before the mystery of language and being. Rashid's acknowledgment of himself as a "typo" in the cosmic manuscript resonates with Eliot's lament in Four Quartets that "every attempt / is a wholly new start, and a different kind of failure." Yet it is precisely through this recognized imperfection, this holy unknowing, that Rashid's poetry finds its luminous authenticity. Like Hafiz's cupbearer, he staggers but does not fall; he sings, albeit hoarsely, from the depths of the tavern of existence.

Prof. Majrooh Rashid's "Snow Flames" and later works thus emerge not only as a chronicle of individual sensibility but as a profound cartography of the human condition itself-its agonies, aspirations, bewilderments, and triumphs. In weaving the delicate textures of snow with the consuming urgency of flame, he joins

becomes the dawning of true light. His is a poetry of witness and wisdom, elegy and awakening, brokenness and beatitude. In a time thirsting for depth, M. Rashid reminds us that the soul's true home is not found in the vanquishing of suffering, but in its transmutation into love, vision, and song. And so, like snow flames melting into the fire of unseen suns, his words continue their quiet, inexhaustible work-rekindling the ancient human hope that even amidst the ash and ice, the soul may yet rise, luminous, whole, and free.

"Snow Flames" marks a luminous addition to the growing canon of Kashmiri English literature. That it springs from the pen of a discerning critic, gifted storyteller, and multilingual poet only deepens its resonance. ### J&K set

In Jammu and Kashmir, the Directorate of State Disaster Response Force (SDRF) and Civil Defence Kashmir has issued a public advisory notifying residents of the scheduled mock drill.

According to the advisory, the drill will begin at 4:00 PM on Wednesday, and sirens will be activated as part of the exercise.

It urged residents not to panic, and to cooperate fully with officials during the simulation. "This is a practice exercise to test our emergency response systems. Please remain calm and do not be alarmed," reads the official notice issued by the SDRF & Civil Defence Kashmir.

"To enhance the Civil Defence preparedness for emergencies, a Civil Defence Mock Drill will take place on Wednesday, May 7, 2025, at 4:00 PM. As part of the drill, sirens will be activated at various locations in Kashmir. This is a practice exercise to test our emergency response systems. We kindly request all members of the public to remain calm and not be alarmed. Your cooperation is essential in making this safety initiative a success," the Directorate of SDRF and Civil Defence Kashmir stated in an another public advisory.

Authorities across all states and the union territories have been instructed to ensure active public participation. Students, hospital staff, government and private sector employees, railway and metro officials, and members of the police, paramilitary, and defence forces will be part of the exercise.

The MHA has said that the civil defence framework is an important component of national preparedness, especially given "new and complex threats."

It stated that such drills improve the passive defence strategy and help safeguard civilian lives and infrastructure.

Officials have also been directed to ensure communication systems are tested, bunkers are cleaned, made accessible and designated personnel are familiar with evacuation procedures.

The government said that the civil defence drill is part of a broader initiative to improve grassroots-level readiness and empower local communities to respond effectively to emergencies.

Meanwhile, Srinagar Police, in collaboration with the Tourist Police and State Disaster Response Force (SDRF), conducted a mock drill in Dal Lake on Tuesday to strengthen emergency response capabilities.

Simulating rescue operations for boat capsizing and drowning incidents, the exercise was held to improve real-time response to such emergencies.

The drill followed recent boat accidents due to high velocity winds, resulting in death of a youth. Senior officers, including SSP Enforcement and SSP Srinagar, monitored the exercise

Extending his congratulations to the officers and his best wishes to all pensioners who will benefit from the initiative, the Chief Minister said that verification of pensioners also needs to be made pensioner-friendly as every year pensioners have to prove that they are still alive and have to submit various documents and to visit offices in person. "So this initiative, I think, is something that all employees will appreciate," he said.

Highlighting the inclusive nature of the portal, he

said it also covers ex-legislators who are pensioners. "So my suggestion would be that together with the Assembly Secretariat, some sort of briefing material can be sent out to all the ex-legislators, so that they are aware of this change and how better to utilize it," he added. Acknowledging the challenges faced by employees nearing retirement, he noted that the last few months of service are often consumed by paperwork. He emphasized that more often than not, efforts are made to post such employees close to Srinagar or Jammu to ease their transition. "With this initiative, I believe that process will be simplified. Now, going ahead, what we must always try and do is to ensure that employees get their dues on time," he said.

The Chief Minister also pointed out that timely disbursement of dues—such as GP fund—is a recurring concern among employees. "So for that, in the Finance Department, we are working closely to ensure that these sort of issues are resolved. But generally, clearly, the initiative that has been taken today, I think, is a welcome one," he remarked.

Earlier, Director General Accounts & Treasuries Fayaz Ahmad Lone presented an overview of the Pension Suvidha Portal. The portal supports the digitization of pension records for 2,40,000 pensioners under the Old Pension Scheme (OPS). He added that data collection was executed through multiple modes: treasury visits for 2,31,127 pensioners, home visits for 7,002, video calls for 1,819 pensioners residing abroad, and postal notices to 9,513 individuals. The portal captures comprehensive data including name, date of birth, service details, and photographs of pensioners.

Notably, he said, the initiative has helped identify and rectify several anomalies, including pension disbursement after death in some cases, duplicate dearness allowance payments, and premature cessation of recoveries.

He informed that the objectives of the portal include streamlining and digitizing pension processing, enhancing efficiency and transparency, reducing paperwork, reconciling pension disbursement with banks, and enabling real-time tracking of pension application status.

Key features of the portal include early SMS and email alerts issued eight months before an employee's retirement, online application submission with required document uploads, and integration with JKHRMS and JKPaySys for service and salary details. It is also linked with the offices of the Accountant General and J&K Bank for seamless electronic data exchange

The portal facilitates the issuance of PPOs, provides post-retirement services tracking, and supports online KYC updates and the use of Jeevan Pramaan for life certificate submission.

The streamlined workflow involves eight stages: registration, application submission by the employee, DDO review and approval, sanction by the Pension Authority, submission to the AC's office, authorization and PPO number issuance, payment processing by the Treasury, and final completion.

The portal engages a wide range of stakeholders. Retiring employees can initiate and monitor their pension cases, while DDOs and Pension Authorities are responsible for verification and processing. The Accountant General's office authorizes PPOs, treasuries handle payments, and pensioners can view disbursement details, request for revision, and apply for transfer of pension accounts online.

On the occasion, the Chief Minister also handed over a settled pension case to Ragubhir, a retired employee who superannuated on 30th April this year.

While reviewing the current status of population coverage under these schemes, the Chief Secretary also took stock of the compliance on earlier directions issued to financial institutions. He directed the concerned agencies to ensure saturation of all identified unbanked rural centres before the stipulated deadline of June this year.

Stressing on the need for prompt and efficient claim settlements, Dulloo observed that the success of these social security schemes should be judged not merely by the number of beneficiaries enrolled, but also by the speed and effectiveness of claim settlements.

He emphasized that financial institutions must instill confidence in public by providing full assistance in processing and settling their genuine claims, and proactively reaching out to families, especially in case of the death of insured members, to ensure timely support.

To ensure the schemes reach the most deserving, the Chief Secretary directed for the inclusion of Self Help Group (SHG) members registered with JKRLM and their families under all applicable social security schemes. He also instructed for coverage of registered building and construction workers under Atal Pension Yojana, with the premium to be borne by the Building and Other Construction Workers Welfare Board here.

Dulloo also called for formulation of a focused strategy to enhance credit flow under the priority and MSME sectors, ensuring that all banks meet the targets assigned to them. He also enquired about the progress in rolling out the 'Gramin Credit Score' system for agricultural lending on the lines of the CIBIL score used for individual borrowers.

The Chief Secretary also reviewed IT-enabled financial interventions such as the distribution of RuPay Debit Cards under PMJDY and Smart Cards for KCC beneficiaries. He assessed progress made in designing loan products to promote High-Density Plantation, rural homestays, and properties identified under the Svamitva Yojana.

Further, he sought an update on the Credit Grievance Redressal Portal, being developed for the convenience of all bank customers in the UT. He was informed that the portal is ready for launch and will soon be made operational to facilitate efficient resolution of customer grievances.

During the meeting, Principal Secretary, Finance, Santosh D. Vaidya, highlighted the noteworthy performance of J&K Bank, stating that it had achieved an 11% year-on-year growth in its business, significantly reduced its Non-Performing Assets (NPAs) to 3.37%, and brought down its cost-to-income ratio to 58% from the earlier 71%. He appreciated the bank administration for these achievements and termed the performance as satisfactory and commendable.

Managing Director, J&K Bank, Amitava Chatterjee, also shared important statistics on the implementation of social security schemes across the UT. As the lead bank and Convenor of UTLBC, he detailed the bank's efforts to popularize financial inclusion schemes and expand credit outreachto the priority sectors.

He pointed out that the latest statistics clearly reflect significant improvement over the figures presented in the previous review meeting held under the chairmanship of the Chief Secretary. He pointed out that the UT has recorded significant strides in financial inclusion and social welfare coverage as per the performance data for various centrally sponsored schemes thereby highlighting the growing participation of citizens and strong involvement by banking institutions here.

In its presentation the Convenor UTLBC, Rayees Maqbool revealed that J&K currently hosts2,197 brick-and-mortar bank branches in addition to 5,135

Banking Correspondents (BCs) and a network of 2,661 ATMs operated by 37 banks and financial institutions ensuring that one banking touch point is available per 1,227 of population.

The meeting was apprised that efforts are underway to fully cover the remaining 21 URCs identified by RBI here under tier 5 areas (population under 5,000) with banking touch points. It was given out that 150 additional Gram Panchayats are scheduled to be covered by May 15, 2025, by J&K Bank.

Regarding the implementation of Pradhan Mantri Suraksha Bima Yojana (PMSBY), an accident insurance scheme for citizens aged 18–70 years saw 6.04 lakh enrollments during FY 2024–25; reaching the cumulative coverage of 23.57 lakh beneficiaries in the UT.

About the performance J&K Bank had registered 2.29 lakh accounts, SBI (1.27 lakh), and HDFC Bank (39,096) with 285 claims settled with Rs. 5.69 Cr disbursed during the year.

With respect to Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) offering life insurance for citizens aged 18–50 years an impressive number of 2.47 lakh new enrolments were done during the previous financial year with cumulative coverage reached 9.67 lakh and settlement of 668 claims with Rs. 13.34 Cr disbursed during the previous financial year.

Atal Pension Yojana (APY) targeting unorganized workers also registered an significant progress with 24,230 new account openings, cumulatively reaching 2.48 lakh accounts since inception.

As far as the priority sector lending is concerned under the Annual Credit Plan 2024–25, J&K's banks collectively achieved 92% of the credit disbursement target, totaling Rs. 36,575 Cr. J&K Bank emerged as the top contributor, surpassing targets at 139% for physical targets and 134% in credit volume. The Micro, Small, and Medium Enterprises (MSME) sector absorbed Rs. 22,688 Cr, accounting for 62% of priority sector lending. A total of 2.96 lakh accounts were supported with J&K Bank leading the table with Rs. 5,537 Cr disbursements in this sector.

The meeting was informed that the agriculture sector too received focused attention with Rs. 6,430 Cr disbursement out of a target of Rs. 11,056 Cr, achieving nearly 58% of the set goal.

Under PM Mudra and PM Vishwakarma Yojana aiming at empowering the entrepreneurs as on March 31,2025 substantial disbursements were made under Shishu, Kishor, and Tarun categories providing support to small entrepreneurs, women, and youth-led micro businesses

It was added that under PM Vishwakarma Yojana, growing traction was observed across various trades. The RSETI performance in skilling of rural masses (since 2009) depicted training of 1,07,672 trainees, and starting of 78,059 ventures (72.5%), and nearly 50% beneficiaries availing bank credit to start their respective enterprises.

# Defence pacts with India being amended, says Maldives

MALE: The Maldives on Tuesday said existing defence agreements with India are being amended to ensure they do not compromise the Maldives' sovereignty and independence, media reports said here. Defence Minister Mohamed Ghassan Maumoon



also told Parliament members that 74 Indian soldiers stationed in the Maldives, who were repatriated under an agreement reached with India last year, were unarmed while in the Maldives.

Maumoon's statements come days after Maldivian President Mohamed Muizzu, during a marathon 15 hour press conference, said that there is nothing to worry about the agreements signed by the previous government with other countries, including with India.

Muizzu's comments had drawn criticism from the opposition leader who demanded his apology for making "false claims" during the 2023 election campaign regarding the pacts with nations such as India.

On Tuesday, while answering questions raised by

Parliament members, Maumoon said, the agreements formed with India as part of long-standing close ties between the two countries had been amended or is being amended "to ensure that they protect the sovereignty and independence of Maldives," according to a report in newsportal edition.mv.

The Public Service Media (PSM News), the staterun news agency, quoted the minister as saying that since the Maldives gained independence in 1965, more than 100 agreements were signed with India and of those, the defence ministry oversees four.

One of the key agreements under review pertained to the development of a naval dockyard at Uthuru Thilafalhu with Indian assistance, the PSM News said.

Ahead of the 2023 election and when it was in opposition, the People's National Congress (PNC) led by Muizzu, had criticised aspects of the Uthuru Thila Falhu agreement, claiming that certain provisions conflicted with national policy.

The minister said such clauses are now being amended, but did not share further details, edition. mv said.

Citing confidentiality clauses, the minister said the agreements and their amendments could not be made public but said he would disclose them if formally the parliament's Committee on National Security Services requested it.

The Maldives and India witnessed a downturn in bilateral ties since pro-China president Muizzu assumed office in November 2023. Within hours of his oath, he had demanded the withdrawal of Indian military personnel from his country.

Subsequently, the Indian military personnel were replaced by civilians in a mutually agreed manner between March and May 10.

On Tuesday, while addressing questions regarding Indian military personnel in the Maldives, Defence Minister Maumoon confirmed that no Indian forces were currently stationed in the country.

"Of the 71 Indian personnel previously deployed, all have been repatriated following bilateral discussions, with the final contingent departing on 9 May 2024. Indian soldiers had not carried weapons while stationed in the Maldives," the PSM News quoted the minister as saying.

The minister also clarified that the Indian military presence had been limited to providing operational support for Dornier aircraft and helicopters operating under India's assistance programme, he said, adding, "The withdrawal was a necessary step to ensure national sovereignty remains uncompromised."

Earlier on Saturday, Muizzu, during his marathon press conference, said he was working in line with his pledge to disclose the military agreements and blamed delays on confidentiality issues.

"Bilateral discussions are ongoing. There are no issues. However, we are trying to disclose through the bilateral discussions since I made a pledge. There are no concerns," he said.

Prior to the 2023 elections, Muizzu's PNC had expressed concerns over the agreements signed with other countries, especially India, by the previous Maldivian Democratic Party (MDP) government.

Soon after on Saturday, former foreign minister and opposition MDP chief Abdulla Shahid criticised Muizzu, saying the people of the Maldives and India deserve an apology for his false claims over the pacts during the 2023 election campaign.

"Muizzu won the 2023 presidential election on the back of a campaign that claimed these agreements threatened our sovereignty and territorial integrity," Shahid posted on X. "That narrative has now collapsed under his

own words.

The people of Maldives and India deserve an apology and a serious accounting for the harm caused."

# JMC team seizes huge stocks of banned Polythene material in Rajiv Nagar analysis to confirm its composition. "By analysis to confirm its composition."

JAMMU: In a major crackdown on the illegal storage and distribution of banned materials, the Jammu Municipal Corporation (JMC) seized approximately 40 metric tonnes (40,000 kg) of polythene from the Narwal area, specifically from a warehouse located along Rajiv Nagar Road, late Monday evening.

The operation was led by the Corporation Commissioner Devansh Yadav, who was present at the site along with a dedicated team of municipal officials. A truck fully loaded with polythene was discovered parked at the warehouse, alongside a substantial quantity of polythene stored inside the premises.

The team also uncovered a large stock of gutka packets during the raid.

Given the magnitude of the seizure, police personnel and administrative officials were called to the scene to support the operation. The team carried out a thorough inspection of the premises, including registers and equipment found within the warehouse.



Commissioner Yadav stated that the seized polythene appears to be single-use plastic, which is banned. However, the material will be sent to the Pollution Control Committee for laboratory

appearance, it seems to be single-use polythene, but we will wait for lab results to confirm," he added.

He further mentioned that individuals present at the warehouse fled the scene upon seeing the JMC team. Investigations are now underway to identify the persons involved in the storage and intended distribution of the polythene. Authorities are also looking into the origins of the consignment and its intended recipients.

"The police will investigate who owns the warehouse and to whom this polythene was being supplied. Strict action will be taken against those found responsible," Commissioner

Yadav affirmed.

This action underscores JMC's commitment to enforcing environmental regulations and curbing the use of banned plastic materials within city limits.

# Captaincy became too much in the end; stepped down to be happy: Kohli

heconstant pressure of leading India and Royal Challengers Bengaluru for nearly a decade and the relentless scrutiny around his batting "became too much in the end" for Virat Kohli, who says he stepped down from leadership to be in a "happy space".

Kohli resigned as T20 captain after the

Kohli resigned as T20 captain after the World Cup in 2021, following which he also relinquished RCB's leadership role. A year later, he quit Test captaincy following the defeat to South Africa.

Kohli said he reached a point in his career where the constant attention became unbearable.

"At one point, it did become tough for me because there was just too much happening in my career. I was captaining India for a period of 7-8 years. I captained RCB for nine years. There were expectations on me from a batting perspective every game that I played," said Kohli in an 'RCB Bold Diaries' podcast.

"I didn't have this sense that the attention was off me. If it wasn't captaincy, it would be batting. I was exposed to it 24x7. It did get very tough on me, and it did get too much in the end."

Kohli, who also took a month-long break from cricket in 2022 and did not touch a bat during that phase, added that a time had come in his life when he was struggling to by happy in the spotlight.

"That's why I stepped down because I felt like if I've decided I want to be in this place, I need to be happy.

"I need to have a space in my life where I can just come and play my cricket without being judged, without being looked at as what are you going to do this season and what's going

to happen now," said Kohli, who has been with RCB since the inaugural edition of the IPL.

# Dhoni's possible Eden swansong set to overshadow KKR's must-win clash vs CSK

ahendra Singh Dhoni's possible final hurrah at the Eden Gardens will be a captivating sub-plot when Kolkata Knight Riders square off against Chennai Super Kings in a mustwin clash in front of a crowd expected to be draped in yellow, here on Wednesday.

While five-time champions CSK are already out of the playoff race, Dhoni remains at the helm, and his presence alone is expected to turn Eden yellow, despite the match being on KKR's home turf.

For a city where Dhoni has deep personal ties - his in-laws live here, and it is where he played much of his junior cricket - Wednesday could end up being emotionally charged for both the 43-year-old and his fans.

The Eden Gardens has witnessed many of Dhoni's milestones, from his maiden first-class century to two of his six Test hundreds.

He has also played club cricket here, including a memorable P Sen Trophy final for Shambazar Club.

So, when the iconic No.7 walks out on May 7, many will wonder if it's the last time Dhoni plays at this historic venue.

Dhoni, who took responsibility for CSK's narrow two-run loss to RCB in their previous match, is no longer the dominant force he once was.

Despite being in a strong position at 172/2 while chasing 214, CSK fell short in the final over.

Dhoni was dismissed by Yash Dayal off the third ball of the last over, managing 12 runs off 8 balls. He later took the "blame" for the loss

But for the fans, Dhoni is still an emotion, and a strong one at that. While it's a do-or-die game for KKR, who must win all their remaining three matches to stay in playoffs contention, the match will be more about celebrating Dhoni's legacy than the result. KKR currently have 11 points, and winning all three of their remaining games will take them to 17. Even then.

# Didn't Say I Was Backing Aggressive Approach, Conditions At Home Weren't As We Expected: **Vettori**

unrisers Hyderabad's ultra-aggressive batting approach has been one of the most talked-about narratives over the past two IPL seasons, with many experts tipping them to be the first team to break the

But barring those two high-scoring matches, SRH's aggressive batting hasn't really helped their cause. On the contrary, batters sacrificing their wickets in powerplays to accelerate the scoring rate has been the norm.

While the former champions put up scores of 200 plus consistently last year, their batting has been lacklustre this season, despite a lineup packed with power-hitters like Travis Head, Abhishek Sharma, Ishan Kishan, and Heinrich Klaasen, which has put a question mark on their ability to sustain the attacking approach.

SRH head coach Daniel Vettori, though, asserted he never backed an "aggressive approach" every time his batters went out to bat, saying the plan was to assess the conditions and play accordingly, but unfortunately the home pitches suited the rivals more.

"I definitely didn't say after every match I was backing an aggressive approach. I said we're about assessing conditions and I think this year the conditions weren't as we expected," Vettori said after the former champions went out of playoff contention following the washout against Delhi Capitals here on Monday.

"I think if you look to last year, there were a number of high-scoring games here and these surfaces in particular have been a little bit different so it has been tricky, it hasn't been easy for the batters and all we've talked about is just assessing conditions and trying to read the game and understand what to do in certain situations," he added.

SRH started off the season with a massive 286/6 at home against Rajasthan Royals and chased down 245 runs with nine balls to spare against Punjab Kings.

but it's certainly this season has been about trying to establish what's required on the day. I think there's been two surfaces that have been the 250-plus.

"Then there's been another (wicket)... how many games we've played, I think four here that have been probably more conducive for the fast bowlers, not so much the spinners. But new ball, been a little bit sticky, hard to hit, (ball) not coming on to the bat," he added.

Vettori added that restricting Delhi Capitals to 133/7 on Monday was one of the best allround performances from his side this season, and it's a pity that the match was washed out.

"It was a really good performance, probably our best bowling and fielding performance of the tournament so far and it's something that we really talk long and hard about in training and in the meetings.

"Obviously it's disappointing (for the match to get washed out). Today was the start of a complete performance, so it's frustrating that we couldn't finish it, but that's cricket."

Praising captain Pat Cummins, who dismantled the DC top order, picking four wickets in the powerplay, Vettori said the Australian had managed to work around several team combinations superbly.

"I think if you look at his overall performance, he's been able to be a wicket taker, he's bowled a number of different roles for us and he's been able to mix and match depending on who's selected in the team
