



# Govt's Decade-Long Defence Push Edges India During Operation Sindoor

NEW DELHI: India's powerful and seamless air defence response to Pakistan's recent missile attacks has drawn global attention, with officials crediting a decade-long modernization drive under Prime Minister Narendra Modi's leadership for the nation's preparedness. Following the precision strikes of Operation Sindoor-which destroyed nine terrorist camps across Pakistan and Pakistan-occupied Kashmir (PoK)—Pakistan retaliated by attempting to target Indian military installations in Jammu & Kashmir, Punjab, Rajasthan, and

However, every single missile launched by Pakistan was inter-

cepted or neutralised before reaching its intended target. Defence experts while talking to Kashmir Convener hailed the defensive success as a testament to India's strengthened air defence ecosystem, a result of sustained investment, integration, and indig-enous development undertaken since 2014.

Official sources confirmed that systems such as the Integrated Counter-Unmanned Aerial System (UAS) Grid, S-400 Triumph squadrons, Barak-8 MR-SAMs, Akash Surface-to-Air Missiles, and DRDO's anti-drone technologies worked in perfect coordination to create an impenetrable aerial shield.

'The synergy of these technologies ensured that not one Pakistani missile could breach Indian airspace," defence sources told

"But India didn't just defend. It responded. In one of the most as-sertive postures in recent years, the Indian Armed Forces launched Operation Sindoor, targeting and destroying a Chinese-origin HQ-9 air defence unit in Lahore and damaging critical radar infrastructure inside Pakistan'

Senior officials emphasized that such swift and precise retaliation reflects a decade of strategic military preparedness. Since 2014, the Modi-led government has reshaped India's air defence architecture. Among the flagship initiatives was the Rs 35,000 crore deal for five

S-400 Triumph squadrons signed with Russia in 2018-three of which are now operational along India's sensitive western and northern

borders. India also signed a \$2.5 billion deal with Israel in 2017 for Barak-8 Medium Range Surface-to-Air Missiles (MR-SAM), which

now protect major airbases and military installations. Indigenously developed Akash missile batteries, DRDO's counter-drone systems, and Man-Portable Counter Drone Systems (MPCDS), installed in 2024, have added multiple layers of tactical defence. "This multi-tiered system came into play during Pakistan's mis-

sile launches, proving India's ability to detect, jam, and eliminate threats across multiple fronts," sources added.Defence Sources said Operation Sindoor also marked a turning point in India's offensive capabilities. For the first time,



# MHA writes to states, UTs to strengthen Civil Defence measures

**NEW DELHI**: In light of the current security environment and the threat of hostile attacks, the Ministry of Home Affairs (MHA) has urged all states and Union Territories (UTs) to augment civil defence measures under the Civil Defence Act and Rules of 1968.

Highlighting Section 11 of the Civil Defence Rules, 1968, the Ministry in a letter titled "augmentation of civil defence measures in the states/UTs" reminded that state governments are empowered to undertake all necessary actions for the protection of people and property, and to ensure the uninterrupted functioning of vital services during a hostile attack.

In the letter issued, considering the last night attacks by Pakistani forces in Jammu and Jaisalmer regions, the provision also authorizes the use of local authority funds for such emergency measures, giving them precedence over other financial obligations.

# escalating tensions Yogesh

JAMMU: Jammu is reeling under a wave of panic and uncertainty following recent escalations in the India-Pakistan conflict, triggered by the deadly Pahalgam terror attack on April 22, which claimed 26 lives, and subsequent cross-border hostilities.

Reports of explosions near the Line of Control (LoC) in Rajouri and Poonch, coupled with a Pakistani attempt



to target Jammu airport on May 8-9, have plunged the region into chaos, prompting panic buying, early market closures, evacuations, and severe traffic disruptions on key roads leading to 'safer districts'.

The residents of Jammu have rushed to stock up on essentials, with reports of long queues at grocery stores, pharmacies, and fuel stations.

Social media posts on X describe a frenzied atmosphere, with ATMs running out of cash and shops struggling to keep up with demand. "Panic in #Jammu, people are rushing to stores for grocery, medicine, and essentials," a user posted on May 9.

Local authorities have urged calm, but the fear of further escalation has led to widespread hoarding. Major markets across Jammu have begun closing early as shopkeepers prioritise safety amid reports of sirens and a complete blackout enforced in Jammu and surrounding areas.

Authorities have ordered evacuations from areas deemed vulnerable, particularly near border districts like Kathua, Jammu, Samba, Rajouri and Poonch.

The government has intensified security measures, with residents in high-risk zones being relocated to safer locations. It has issued helpline numbers to assist those affected, including emergency control rooms in all district headquarters. However, the scale of the evacuation has strained resources, with many residents expressing frustration over limited access to transport and information.



# CAT Upholds Dismissal of Kashmir University Professor on National Security Grounds

SRINAGAR: Central Administrative Tribunal (CAT) Srinagar Bench has upheld the dismissal of Dr. Altaf Hussain Pandith, a senior professor from the Department of Chemistry at the University of Kashmir.

The Professor was dismissed on May 13, 2022 under Article 311(2)(c) of the Constitution of India on the orders of the Lieutenant Governor Manoj Sinha for alleged terror links

A division bench of the CAT consisted of Justice D.S. Mahra and Administrative Member Justice Prasant Kumar, rejected Pandith's plea challenging his removal from service.

The tribunal ruled that the University of Kashmir qualifies as a "State" under Article 12 of the Constitution and that the post of a university professor constitutes a civil post under the Government of Jammu and Kashmir, thereby making Article 311 applicable.

Dr. Pandith through his counsel Advocate M Ashraf Wani had contended that the university, being a statutory autonomous body, does not fall under the ambit of "State" and that his position did not qualify as a civil post.

He had further argued that the Lieutenant Governor lacked the constitutional authority to invoke Article 311(2)(c), and that the action was devoid of substantial material However, representing the government, Advocate Waseem Gul submitted that the Univer-

The tribunal upheld this argument, pointing to the deep administrative and financial linkages between the university and the govern-



sity of Kashmir is under the financial, functional, and administrative control of the UT government, and thus falls within the definition of a "State.

ment-highlighting provisions of the Jammu and Kashmir University Act, 1969, which mandate government oversight over appointments, funding, audits, and decision-making.

The tribunal also affirmed the competence of the Lieutenant Governor to exercise powers under Article 311(2)(c) as an administrator appointed under Article 239(1) of the Constitution, especially after the Jammu and Kashmir Reorganisation Act, 2019 vested such powers in the Lieutenant Governor on behalf of the President.

The CAT further stated that the dismissal order was preceded by a recommendation of a high-level committee which, after scrutinising evidence of Dr. Pandith's alleged links with banned outfits such as Jamaat-e-Islami and Lashkar-e-Taiba, advised action in the interest of national security.

In accordance with settled legal principles laid down in landmark Supreme Court cases such as Tulsiram Patel and A.K. Kaul, the tribunal ruled that when national security is at stake, due inquiry may be dispensed with if the competent authority is satisfied that it is not expedient to hold one.

While the tribunal acknowledged that judicial review remains available in such cases, it held that the material placed on record did not suggest mala fide intentions or arbitrary use of power. Consequently, the dismissal was declared legally valid and constitutionally sustainable.

## **BJP Leader Bilal Ahmad** Wani Slams Admin Over Shadipora-Ganderbal **Bridge Collapse**

BANDIPORA: Bilal Ahmad Wani, Vice President of the Bharatiya Janata Party (BJP) in Bandipora, has voiced serious concern and resentment over the collapse of the under-construction Shadipora-Ganderbal footbridge, a long-awaited project meant to ease transportation woes in the area.

The incident, which occurred recently, has triggered anger and disappointment among locals, who had pinned hopes on the bridge to improve connectivity between Bandipora and Ganderbal. The sudden collapse, before the bridge could even be completed, has raised serious doubts about the quality of construction and the level of official oversight.

Wani criticized the administration and engineering authorities for what he termed as a "complete failure in supervision." He questioned why proper checks on the quality of materials and construction standards were not enforced throughout the project's execution.



# Five reasons why young-onset dementia is often missed

Around 57 million people worldwide have dementia. While most cases of dementia are diagnosed in older adults, about 7% of cases occur in people under 65. This number may be even higher as young-onset dementia continues to be under-recognised. This means many people may be missing out on the support they need. complex. For this reason, dementia can lead to a huge variety of symptoms – such as changes in personality and language, difficulties recognising objects, judging distances or coordinating movement and even hallucinations and delusions.

Compared to dementia in older adults, people with young-onset dementia are more likely to experience symptoms other than memory loss as the earliest signs of the condition. For instance, research shows that for around one-third of



Here are five reasons young-onset dementia remains under-recognised:

Dementia is typically associated with older age

When you hear the word "dementia" do you picture someone under 65? While dementia is usually associated with older adults, the condition doesn't discriminate based on age. In fact, anyone (even children) can be diagnosed with different forms of dementia.

But this common assumption means many younger people may not seek a diagnosis from their doctor, as many don't assume dementia could be causing any of the symptoms they're experiencing.

Doctors, too, often fail to consider the possibility of a younger person having dementia. Many people diagnosed with young-onset dementia initially had their symptoms dismissed. Some doctors even showed little concern for their experiences. It also isn't uncommon for younger adults to be told they're "too young" to have dementia.

It's not surprising then that these experiences lead to frustration, with patients and their families feeling unheard and neglected by the healthcare system.

Frontotemporal dementias only affect around one in 20 people diagnosed with dementia. These conditions affect parts of the brain responsible for personality, behaviour, language, speech and executive functioning. **OPED** | 04

For example, primary progressive aphasia is one type of frontotemporal dementia. This condition affects around three in every 100,000 people. Primary progressive aphasia mainly alters a person's ability to communicate and understand speech.

Secondary dementias are also more common in people with young-onset dementia. These are dementias that are caused by another underlying medical condition, disease (such as Huntington's disease or a brain tumour) or external factor (such as a viral infection, substance misuse or head injury).

Recognition of these rarer forms of dementia is increasing – thanks in part to celebrities such as Fiona Phillips, Pauline Quirke and Terry Jones opening up about their experiences. But there's still much less understanding around treatment options and managing symptoms when it comes to these rarer forms of dementia. Rarer dementias are also linked to atypical symptoms, which often go missed. This prolongs the diagnostic journey.

Symptoms overlap with other conditions

Symptoms of young-onset dementia have considerable overlap with those common in certain mental health conditions, such as bipolar disorder, psychosis, depression and anxiety. Symptoms might also include apathy, feelings of panic, irritability, hallucinations and delusions.

Early symptoms of young-onset dementia may also be misdiagnosed as menopause in women, as well as a period of burnout.

Of course, not everyone experiencing these symptoms will have young-onset dementia. But it's important we raise awareness about symptom overlap to make the diagnosis process easier for those who do.

Experiences differ between people

The type and severity of a person's symptoms can vary due to a variety of factors – such as their physical health, their social environment and even their stress levels. This all leads to significant variability in how dementia is experienced.

A person's cognitive reserve (the brain's ability to maintain good cognitive function despite damage or brain changes) also affects their experience of dementia symptoms and how they cope with them. Some people may adapt more effectively, drawing on strong support networks, psychological resilience or their own personal coping strategies to overcome these challenges.

All of these factors together can make it difficult to recognise symptoms of young-onset dementia, especially in its early stages.

Need for awareness

The under-recognition of young-onset dementia is significant. It contributes to the lack of resources, specialised care and advice, appropriate support and early diagnosis for people with young-onset dementia. While this is improving, greater awareness still needs to be brought to the experience of dementia in younger adults – especially given research shows that the progression of cognitive decline is more pronounced in younger adults. If you're worried about yourself or a family member showing signs of dementia, it's important to discuss symptoms and seek support early. You can also contact local dementia support organisations such as Alzheimer Scotland, Dementia UK, and Alzheimer Society, who can provide information, resources and guidance on support options.

Dementia is most often linked to short-term memory loss. However, cognition (which encompasses all of our mental processes, from thinking to perception) is very vision changes.

Dementia is an umbrella term that encompasses a range of brain disorders that all cause problems with cognition. In older adults, the most common cause of dementia is Alzheimer's disease – accounting for 50-75% of cases. Srinagar: For the third consecutive day, the authorities have decided to close three airports including Srinagar International Airport till May 14 amid heightened tensions between India and Pakistan, disrupting flight operations, including the Haj pilgrimage schedule from the Valley.

The Jammu and Kashmir Haj Committee has now cancelled the tomorrow's May 10 flight, extending the uncertainty for hundreds of pilgrims.

In an official notification, the committee announced the cancellation of Flight No. SG-5210, originally scheduled for Saturday.

"Due to the prevailing situation, the flight has been cancelled. A revised schedule will be communicated accordingly," the notification read.

"So far, four Haj flights and over 250 commercial flights have been cancelled since May 7, including 84 on Friday alone, with 42 arrivals and 42 departures, an official at Srinagar International Airport told the news agency–Kashmir News Observer (KNO). He added they are yet to confirm when normal operations will resume.

Meanwhile, Dr. Shujhat Ahmad Qureshi, Executive Officer of the J&K Haj Committee said, "We are in touch with all concerned agencies, but as of now, the situation remains unchanged and uncertain. Pilgrims and their families are requested to remain patient until we receive clearance for rescheduling.

Meanwhile, major airlines have extended flight suspensions and issued fresh advisories. IndiGo Travel Advisory: "Your safety and security remain paramount. Due to the current situation, all flights to and from Srinagar, Jammu, Amritsar, Leh, Chandigarh, Dharamshala, Bikaner, Jodhpur, Kishangarh, and Rajkot are cancelled. We are monitoring the situation closely and are in continuous coordination with all authorities.

They also wrote: "we will keep you informed through official updates and are available to support you with changes to your travel plans. Thank you for your understanding and patience."

SpiceJet Travel Advisory:"Important Travel Update: Due to the ongoing situation, our flights to and from Leh, Srinagar, Jammu, Dharamshala, Kandla and Amritsar are cancelled. We sincerely apologize for the inconvenience this may cause to our valued passengers and appreciate your understanding.

Akasa Air Advisory: Akasa Air has suspended all flights to and from Srinagar until further notice and is offering passengers full refunds or free rescheduling. "We regret the inconvenience caused and are closely monitoring the situation," the airline stated. Other airlines, including Vistara and Go First, are also expected to issue updated advisories shortly. Passengers are urged to regularly check their flight status through airline websites or customer service helplines and avoid unnecessary travel to the airport.

# Are Experts A Better Alternative Than Democratic Representatives?

A common solution explored whilst citing the flaws of the democratic system is to replace it with 'rule by experts'- also known as epistocracy. The motivation behind this is that experts, being equipped with the ability to form policies and directives, are at least objectively better at governance as compared to any other segment or entity.

Furthermore, it is argued that it is unfair for citizens who are

sion on rumors or deeply ingrained biases, such as believing a candidate is "better" simply because of their affiliation with a powerful family or local political dynasty, without considering their actual abilities or agenda.

Third, the morally unreasonable electorate: This group allows prejudice to guide their decision, for instance, voting only for a candidate from their village or community while disregarding more capable candidates from other regions of Kashmir, purely because of regional loyalties or biases.

Because in all these cases, decision-making amounts to imposing a rule on innocent individuals without possessing adequate grounds for such selection, this casts doubt on the legitimacy of the outcome. When high-stake decisions are imposed upon innocent persons, all individual decisions need to be made in a competent manner and by reasonable persons, which can be argued to be unlikely in a democracy. Even if citizens might voluntarily trust experts to manage public affairs, the trust demanded under such a system is coercive. Rule by experts risks domination, where dissent is dismissed as irrational, further entrenching inequality and limiting genuine public participation. Ultimately, such a system risks undermining the very principles of fairness and inclusion it seeks to improve.

#### Is there an ideal solution?

To enable meaningful participation that upholds the value of political inclusion, it is essential for people to be free to hold their own beliefs, express their views, reflect on issues, and develop reasons to challenge state policies. This is important because the exchange of beliefs is a way of treating others with dignity and recognizing them as autonomous individuals.

At the same time, it is also important to recognize that promoting mutual respect does not require every aspect of a

Historically, people have been unjustly barred from voting based on factors like race or gender. Hence, epistocrats assert that if voting restrictions can exist for the wrong reasons, it is

#### Is 'rule by experts' a better alternative?

While the idea of 'rule by experts' may seem appealing, especially when ordinary citizens are perceived to lack the wisdom of experts, it faces significant challenges. To begin with, access to education is often a privilege reserved for certain races, classes, and even genders; giving special consideration to these groups would only amplify existing biases. This would lead to a systematic overrepresentation of some groups and the underrepresentation of others in the electorate, likely resulting in unjust outcomes that benefit privileged groups while disadvantaged others. For example, if only individuals from affluent families in Kashmirsuch as those with access to private schools or resources to study abroad-are eligible to govern, they are likely to share similar priorities and interests, meaning that rule by experts would primarily serve those interests. Critics of this system argue that such disparities in political inclusion, whether based on class, race, or gender, are inherently unjust. In Kashmir, for instance, consider how individuals from urban areas like Srinagar often have easier access to higher education and resources compared to those in remote regions such as Kupwara or Kulgam. If policies were designed to give more electoral power to the educated, it would likely result in an overrepresentation of urban elites while marginalizing rural populations. Beyond issues of representation, another objection to epistocracy is that while experts may make reasonable decisions on behalf of the public, these decisions may not always be meaningful or acceptable to the people. This is because understanding or appreciating such decisions often requires training and intellect that non-experts may lack. Furthermore, when experts dictate what people should believe, it raises concerns about domination, undermining a key moral and political value: political inclusion. In such a system, experts impose not only an obligation to believe them but also a duty to obey, restricting individuals' ability to form their own opinions, reflect on what the state should do, or develop arguments to challenge authority.

For example, consider a public debate where certain participants resort to inflammatory or divisive language—it could silence voices offering practical, well-informed, and inclusive perspectives. In such cases, restricting such uncivil or partisan speech can be potentially justified to ensure that the focus remains on constructive dialogue and genuine problem-solving.

not unreasonable to consider that there might be valid reasons such as intellectual ability or expertise—to limit voting rights. For instance, modern democracies already prevent children, felons, and those deemed mentally unfit from voting or holding power due to their perceived lack of competence. In this sense, democracies are already somewhat epistocratic, which opens the door to arguments in favour of governance by experts, as I will explore further.

#### Is Democracy Always Just?

A system is democratic to the extent that the key political power rests equally in the hands of the people- at least at large; it is a method of decision-making that determines how a regime may use its authority, including the threat of force, to ensure compliance with its laws and regulations. The competence principle, to put it simply, holds that it is not just to deprive people of life, liberty or property or change their life prospects substantially using coercion as well as threats of coercion as a consequence of decisions that an incompetent decision-making body makes.

#### Thus, this suggests that:

i) People with poor judgement or bad moral character must not serve on a decision-making body.

ii) When it is known that certain decisions were made incompetently, they must not be enforced and people should have no obligation to submit to these.

For these reasons, it can be argued that since democracies can, in principle, allow 'ignorant', 'misinformed', 'morally unreasonable' or 'irrational individuals' to wield their political power over others, it dispenses political power in an irresponsible manner.

#### Can an Uninformed Electorate Harm Democracy?

Let us further delve into this concept by exploring three types of electorates to make this idea clearer;

First, the uninformed electorate: These voters are indifferent to the policies or the candidates' qualifications and make their choice based on arbitrary factors, such as the candidate's popularity in their constituency or simply voting because of a familiar last name such as Bhatt or Lone.

Second, the irrational electorate: These voters pay some attention to the election and key issues but base their deci-

In the context of a pure epistocracy, where experts possess specialised knowledge in both politics and morality, political inclusion may indeed be limited. However, proponents of epistocracy argue that this system has the potential to deliver better outcomes compared to traditional democracy. Moreover, they point out that democracies already impose certain exclusions, such as for children, felons, and those deemed mentally unfit, based on their suitability for political decision-making. In this sense, democracies and epistocracies are not entirely different.

Overall, an epistocracy could consider reasonable limitations while ensuring that these exclusions are grounded in fairness and necessity. While political inclusion is a key value, it may sometimes need to be balanced with the need for effective governance and informed decision-making, provided that such restrictions are implemented thoughtfully and justly. But regardless of which system of governance is in place, any restrictions must be implemented thoughtfully and justly, with clear safeguards to prevent misuse, perpetuation of systemic inequalities, or the marginalization of vulnerable groups.

#### Govt's Decade-Long

Indian-manufactured loitering munitions-suicidal drones ordered in 2021-were deployed in combat, executing coordinated strikes on enemy positions.

Harop drones, originally of Israeli origin and now being produced in India, were used to destroy key Pakistani defence assets in Lahore and Karachi. Referring to India engaging with the different countries on the diplomatic front, Misri said, "India has responded with strength and restraint. The Ministry of External Affairs has engaged directly with the US Secretary of State and the Secretary of Defence. We have also spoken with the Foreign Minister of Norway. Our partners have expressed solidarity and pledged cooperation in counterterrorism efforts. India will firmly counter any attempt to escalate the situation." Asked about the missile attack on Bhawalpur from where the journalist Daniel Pearl was abducted and then killed, Misri said, "Bhawalpur continues to be the headquarters of the proscribed Jaish-e-Mohammed (JeM) group. Its leader, Masood Azhar, is an internationally designated terrorist. We also recall the gruesome murder of journalist Daniel Pearl – JeM was directly or indirectly complicit. The British-Pakistani jihadi Omar Sheikh, who was arrested in India and then released in 2000, lured Pearl and facilitated his killing. This is the kind of extremist mindset we are confronting." He reiterated that the Indus Water Treaty is currently in abeyance. "Given the evolving scenario, I have nothing further to add at this point," he added. "At the IMF meeting scheduled for later today, India will present its position and raise concerns over Pakistan's misuse of international funds and its destabilizing behavior," Misri said

Given the situation, the people of Jammu are left grappling with fear, uncertainty, and logistical challenges. Authorities have urged residents to cooperate with security measures and follow guidelines, but with the spectre of further conflict looming, the path to stability remains fraught

He also shared a lighter moment from the visit, mentioning that some children had asked for play equipment, and "I am thankful to our minister, who brought it in his own vehicle and handed it over to them."

Later, the chief minister visited a Government Medical College Hospital in Jammu to inquire about the well-being of the injured and prayed for their swift recovery.

He also reviewed the situation following the recent drone attacks across the region.

#### **Pope Leo XIV celebrates first** Mass after historic election as **Pope Francis' successor**

VATICAN CITY: Pope Leo XIV celebrates his first Mass on Friday after his historic election as the first North American pope, meeting with the cardinals who chose him to lead the Catholic Church and follow in Pope Francis' reform-minded footsteps.

Leo, the Chicago-born Augustinian missionary Robert Prevost, surprised the world Thursday when he emerged on the loggia of St. Peter's Basilica, overcoming the traditional prohibition against a pope from the United States.

The 69-year-old wore the traditional red cape - which Francis had eschewed on his election in 2013 – and trappings of the papacy, suggesting a



return to some degree of rule-following after Francis' unorthodox pontificate.

But in naming himself Leo, the new pope could also have wanted to signal a strong line of continuity: Brother Leo was the 13th century friar who was a great companion to St Francis of Assisi, the late pope's namesake.

"Together, we must try to find out how to be a missionary church, a church that builds bridges, establishes dialogue, that's always open to receive - like on this piazza with open arms - to be able to receive everybody that needs our charity, our presence, dialogue and love," Leo said in near-perfect Italian in his first comments to the world.

Prevost had been a leading candidate for the papacy since Francis tapped him to be head of the Vatican's powerful Dicastery for Bishops, which yets bishop nominations around the world. There had long been a taboo on a US pope, given America's superpower status in the secular world, but Prevost prevailed, perhaps because he's also a Peruvian citizen and had lived for years in Peru, first as a missionary and then as bishop.

Francis, the first Latin American pope, clearly

US President Donald Trump said it was "such an honour for our country" for the new pope to be American.

"What greater honour can there be?" he said. The president added that "we're a little bit surprised and we're happy.'

An Augustinian pope

The last pope to take the name Leo was Leo XIII, an Italian who led the church from 1878 to 1903. That Leo softened the church's confrontational stance toward modernity, especially science and politics and laid the foundation for modern Catholic social thought. His most famous encyclical, Rerum Novarum of 1891, addressed workers' rights and capitalism at the beginning of the industrial revolution and was highlighted by the Vatican in explaining the new pope's choice of name.

Vatican watchers said Prevost's decision to name himself Leo was particularly significant given the previous Leo's legacy of social justice and reform, suggesting continuity with some of Francis' chief concerns. Specifically, Leo cited one of Francis' key priorities of making the Catholic Church more attentive to lay people and inclusive.

"He is continuing a lot of Francis' ministry,' said Natalia Imperatori-Lee, the chair of religious studies at Manhattan University in the Bronx. But she also said his election could send a message to the US church, which has been badly divided between conservatives and progressives, with much of the right-wing opposition to Francis coming from there.

"I think it is going to be exciting to see a different kind of American Catholicism in Rome,' Imperatori-Lee said.

Archbishop Bernard Hebda, of the Archdiocese of St. Paul and Minneapolis, told reporters he never thought he would see an American pope, given the questions of how he would navigate dealing with a U.S. president, especially someone like Trump.

"And so I just never imagined that we would have an American pope, and I have great confidence that Pope Leo will do a wonderful job of navigating that," he said.

Looking ahead

Leo was expected to celebrate Mass with cardinals in the Sistine Chapel on Friday, deliver his first Sunday noon blessing from the loggia of St. Peter's and attend an audience with the media Monday in the Vatican auditorium, Vatican spokesman Matteo Bruni said.

Beyond that, he has a possible first foreign trip at the end of May: Francis had been invited to travel to Turkey to commemorate the 1,700th anniversary of the First Council of Nicaea, a landmark event in Christian history and an important moment in Catholic-Orthodox relations. Ecumenical Patriarch Bartholomew I, the spiritual leader of the world's Orthodox Christians. welcomed Leo's election and said he hoped he would join the anniversary celebration.

The new pope was formerly the prior general, or leader, of the Order of St. Augustine, which was formed in the 13th century as a community of "mendicant" friars - dedicated to poverty, service and evangelization. Vatican News said Leo is the first Augustinian pope.

In Peru, he is known as the saintly missionary who waded through mud after torrential rains flooded the region, bringing help to needy people, and as the bishop who spearheaded the lifesaving purchase of oxygen production plants during the COVID-19 pandemic."He worked so hard to find help, that there was not only enough (money) for one plant, but for two oxygen plants," said Janinna Sesa, who met Prevost while she worked for the church's Caritas nonprofit.

### **Cross-border shelling** leaves trial of destruction across J&K villages

SRINAGAR: A fresh wave of intense cross-border shelling late Thursday night left a trail of destruction along Jammu and Kashmir's Line of Control (LoC), engulfing multiple villages in Uri, Kupwara and Poonch in chaos, fear and devastation.

The shelling, which began around midnight and continued for hours, damaged residential homes, commercial establishments, and vehicles-leaving civilians to pick up the pieces once again.

In Uri villages, residents while speaking to the news agency-Kashmir News Observer (KNO) described a night of terror. "The shelling didn't stop till 5 AM. We kept praying for our lives," said a local.

One civilian was killed, and two others were injured in the shelling, while dozens of homes were left severely damaged. "It took a whole life to build our houses, and now we are left with nothing," said one resident, standing amid the rubble of his home.

Kupwara's Keran and Chowkibal sectors also bore the brunt of the shelling. Although no casualties were reported from these areas, the damage to property was extensive. "We're not meant for this-we want peaceful lives," said a villager, breaking down in tears as evacuation teams moved them to safer zones.

Authorities swiftly launched evacuation efforts across Baramulla, Kupwara and Poonch with the government requisitioning buses from private schools and transport operators to shift affected families.

Relief centers were set up in safer areas in Uri, Boniyar and Baramulla town, where hundreds have taken shelter. "We are leaving out of fear. The government is accommodating us, but our hearts remain with our homes," said Fayaz Ahmed, a resident of Badgara, Uri.

Sentiments of fear, frustration and exhaustion echoed across the region. "We're used to the shelling, but we plead-let it end once and for all. War is not the answer," said another Uri resident. "Civilians are dying, and we're losing everything to this madness. The government must introspect and take real steps for peace."

Meanwhile, the locals renewed demands for the construction of community bunkers, citing repeated failure to provide adequate long-term safety measures despite recurrent ceasefire violations."We have nowhere to go when firing starts. Bunkers are the minimum

had his eye on Prevost and in many ways saw him as his heir apparent. He sent Prevost to take over a complicated diocese in Peru in 2014, then brought him to the Vatican in 2023. Earlier this year, Francis elevated Prevost into the senior ranks of cardinals, giving him prominence going into the conclave that few other cardinals had.

Since arriving in Rome, Prevost had kept a low public profile but was well-known to the men who count. Significantly, he presided over one of the most revolutionary reforms Francis made, when he added three women to the voting bloc that decides which bishop nominations to forward to the pope.

"Even the bishops of Peru called him the saint, the Saint of the North, and he had time for everyone," said the Rev. Alexander Lam, an Augustinian friar from Peru who knows the new pope.

The crowd in St Peter's Square erupted in cheers Thursday when white smoke poured out of the Sistine Chapel shortly after 6 p.m. on the second day of the conclave. Waving flags from around the world, tens of thousands of people were surprised an hour later when the senior cardinal deacon announced the winner was Prevost.

# We had to evacuate 25,000 people without pressing panic button: IPL chairman Dhumal

NEW DELHI: It was during the first strategic timeout when IPL Chairman Arun Dhumal realised that the clash between Punjab Kings and Delhi Capitals in Dharamsala could not have continued.

The air raid sirens had gone off in two neighbouring cities, one of them less than 100km away, and 25,000 people were in the stands unaware of the security concerns.

On one of his "most challenging days" as a cricket administrator, Dhumal had to oversee the orderly evacuation of these 25,000 people and ensure that the players were not affected by the change of circumstances.

Floodlights were dimmed and eventually turned off and a blackout protocol came into operation after Pathankot (85km from Dharamsala) and Jammu (a little over 197km away) came under a drone attack from Pakistan.

Announcements were duly made to inform  $the sizeable\,crowd\,off lood lights\,being\,switched$ off. It was blamed on a technical snag at first. a ploy to ensure that the assembled fans did not panic.

...when the announcement was made on the public address system about floodlights going off, people didn't want to leave," Dhumal recalled in an interview to PTI.

"We had to ensure that the evacuation of spectators happened without pressing the panic button. We couldn't have allowed a stampede," he added.

ll available evidence suggests that Dhumal, the Himachal Pradesh Cricket Association officials and the local police pulled off the task with elan as people dispersed in less than half an hour's time.

## Jaiswal makes U-turn, wants to continue playing for Mumbai

ashasvi Jaiswal has taken a U-turn, requesting the Mumbai Cricket Association (MCA) to let him continue with Mumbai - and not move to Goa-for the 2025-26 domestic season. Jaiswal's case will be taken up by the MCA at its apex council meeting, approximately after a fortnight.

Jaiswal has written a formal letter to the MCA, stating that he had been planning to move to Goa and play for the state as his family was relocating there, but the plan had changed. Just over a month ago, Jaiswal had asked the MCA to issue him a no-objection certificate (NOC) to move to Goa, which the MCA had given him.

"He has written a letter to us, but we are in no hurry to take a decision on this because there is time for the next domestic season," MCA secretary Abhay Hadap told ESPNcricinfo. "He has said he has not submitted that NOC either with the BCCI or Goa [Cricket Association] yet."

Jaiswal's request to move from Mumbai to Goa had "surprised" MCA at the time.

Jaiswal was in action for Rajasthan Royals (RR) in IPL 2025 but the tournament was suspended amid border tensions between India and Pakistan on Friday morning. After the IPL, his next assignment will be the five-Test tour of England, where the first Test is scheduled to start June 20. He played all 12 games for RR in IPL 2025 and was their leading scorer with a tally of 473, while averaging 43 and striking at 154.57, with five half-centuries. RR were, however, the second team to be knocked out of the playoffs race after Chennai Super Kings (CSK).

Jaiswal, 23, has played for Mumbai since his Under-19 days. He made his first-class debut for Mumbai in 2019 and has since played ten first-class games for them, scoring 863 runs at an average of 53.93, which includes four centuries, two fifties and a highest score of 181 against Uttar Pradesh in 2022.

He had played for Mumbai in the recent domestic season, too, in a Ranji Trophy game against Jammu & Kashmir, which they lost at home. He was set to play in the semi-final against Vidarbha, but was ruled out after injuring his right ankle while training ahead of the game

The original schedule would have seen four of the remaining games in Rawalpindi, one in Multan, and the final three in Lahore. An earlier update from the PCB had said the league would be rescheduled, but did not confirm at the time it would be taken out of Pakistan, with Karachi considered a likely option.

The PSL, now in its tenth season, is familiar with the UAE, having started there back in 2016. It was played there in full - barring the PSL 2017 final - for the first two seasons. Part of season six, in 2021, also had to be played in the UAE because of the Covid-19 pandemic.

Any delays to the PSL are likely to impact Pakistan's international calendar, too. Bangladesh are due to arrive in Pakistan three days after the PSL final, originally slated for May 18, with the first of five T20Is to begin on May 25 in Faisalabad. The PCB told ESPNcricinfo that no decision had yet been taken on the fate of that series.
