India in no hurry to review suspension of Indus Waters Treaty: MoJS

NEW DELHI: The Ministry of Jai Snakti (MojS) is in no nurry to dilute the decision to keep the Indus Waters Treaty (IWT) in abeyance, a stand taken by the Centre as part of tough measures announced against Pakistan after the Pahalgam attack, a top official said on Friday.

Treaty prominently in MoJS monthly report sent to the Cabinet Secretary I.V. Somanathan earlier in the week, indicating a status quo on the suspension.

Debashree Mukherjee, Secretary, Department of Water Resources, River Development and Ganga Rejuvenation, noted in the monthly report that the

NIA Raids 15 Locations In Puniab To Probe Khalistani Network

NEW DELHI: Cracking down further on the activities of the banned Babbar Khalsa International (BKI) terrorist group, the National Investigation Agency (NIA) on Friday searched 15 locations in Punjab in connection with the grenade attack on a police station in Gurdaspur district last December.

CM Omar urges centre to arrange addl flights, clear backlog

SRINAGAR: Chief Minister Omar Abdullah on Friday urged the Government of India to arrange additional Haj flights from Srinagar to address the backlog of pilgrims stranded due to recent flight disruptions.

"I have taken up with the Government of India the urgent need to arrange additional Haj flights from Srinagar to clear the backlog of 1,895 pilgrims caused by recent flight disruptions. Ensuring a smooth and timely pilgrimage for our pilgrims is the Government's priority," Omar Abdullah posted on X, as per the news agency—Kashmir News Observer (KNO).

The air travel disruptions caused by the recent tensions between India and Pakistan have left at least 1,895 Haj pilgrims from Jammu and Kashmir stranded, prompting the J&K Haj Committee to consider operating additional flights to clear the backlog. Speaking to KNO, Executive

Supreme Court Directs High Courts To Frame Rules On Court Managers

NEW DELHI: The Supreme Court on Friday directed all high courts to either frame or amend rules on the functioning of court managers and submit it to the respective states for approval within three

The concept of court managers was first proposed by the Thirteenth Finance Commission (2010-2015) with the aim of providing assistance to judges in performing their administrative duties.

Court managers were to be appointed in both district courts and high courts.

A bench of Chief Justice B R Gavai, Justices Augustine George Masih and K Vinod Chandran said the high courts should frame or amend rules taking cue from Assam Rules of 2018.

"We further direct that upon receipt of the rules framed or amendments thereof by the high courts, the respective state governments shall finalise and grant approval to the same within a further period of three months," the bench said in its verdict on the issue.

The top court said the high courts and the state governments had the liberty to make suitable modifications or changes to suit their peculiar needs.



It clarified that the minimum rank of court managers should be of a class-II gazetted officer for the purpose of basic pay, allowances and other service benefits.

"We direct that all the high courts in the country shall frame or amend the rules providing for recruitment and conditions of service of court managers, by taking the Assam Rules of 2018 as the model rules, and submit it to the state government for approval within a period of three months from the date of this judgment," the bench said.

Court managers appointed in high courts should work under the directions and supervision of the registrar general or registrars of the high court, it added.

The bench said court managers appointed in district courts should work under the supervision of the registrars or superintendents of the courts concerned.

"While determining the duties, functions and the responsibilities of the court managers, the rules committee of the high courts shall ensure that their duties, functions and responsibilities do

not overlap with that of the registrars of the high court/district courts," it said.

The bench said court managers, who are already working either on contractual or consolidated pay basis or on adhoc basis, should continue to offer services and be regularised subject to their passing the suitability test which will be provided in the proposed rules.

Those court managers are who already working would be entitled to regularisation from the date of their initial appointment, it added.

The bench directed that the process of regularisation of court managers will be completed within three months from the date of approval of the rules by the respective states.

"We clarify that the respective registrar generals of the high courts and the chief secretaries of the state governments shall be personally responsible for adhering to the aforesaid timelines," it said.

The bench referred to the apex court's August 2018 verdict which discussed about the need of sound infrastructure in $subordinate\,courts. The\,role\,and\,importance$ of court managers, the bench said, was also discussed in the verdict.

India contributing to climate action with the urgency it demands: Bhupender Yadav

NEW DELHI: India is deeply committed to contributing to climate action with the urgency it demands, despite its minimal role in the climate crisis, Union Environment Minister Bhupender Yadav said on Friday.

Addressing the first edition of 'Sagarmatha Sambaad', a global dialogue on climate change and its impact on mountainous regions, the minister said the global carbon budget is rapidly being depleted with developed nations continuing to disproportionately grab the meagre remaining

The global carbon budget is the amount of carbon dioxide that can be emitted into the atmosphere while keeping the rise in average global temperature since the industrial revolution below 1.5 degrees Celsius.

Yadav said the developed countries' commitments to providing climate finance, technology transfer and capacity building have been profoundly neglected, intensifying the climate crisis for which they bear far greater responsibility. The dialogue, he added, is not just a forum for discussion but a call for collective concerted action."India, under the visionary leadership of Prime Minister Narendra Modi ji, is deeply committed to contributing to climate action with the urgency it demands, despite our minimal role for the crisis it faces," Yadav said.He said that India is walking the talk on climate action, integrating sustainability into the very fabric of its development paradigm, guided by Mission LiFE, an initiative focusing on the sustainable and mindful use of resources. The minister said the Himalayas bear a significant part of the burden of the environmental crisis.

'We in India, with our significant Himalayan territory, witness these impacts firsthand. We share the concerns of the mountain states and their people. Our environmental futures are intrinsically linked," he said.



But, he stressed, these futures also depend on the collective action of all nations in mitigating greenhouse gas emissions, in line with the principles of equity and common but differentiated responsibilities and respective capabilities.

He said that South Asia has been responsible for only 4 per cent of global cumulative carbon dioxide emissions until 2020, despite being home to nearly 25 per cent of the global population.

The minister expressed hope that the dialogue would pave the way for enhanced scientific cooperation on climate change in mountain regions, building climate resilience and ensuring adequate and predictable climate finance for mountain nations.

Israeli strikes kill 20 people in Gaza as Trump wraps up his Middle East visit

DEIR AL-BALAH (Gaza): Israeli strikes killed at least 20 people in Gaza on Friday morning, as US President Donald Trump wraps up his Middle East visit.

An Associated Press journalist counted the bodies at the Indonesian Hospital in northern Gaza, where they were brought. Survivors said many people were still under the rubble.

The widespread attacks across northern Gaza come as Trump finishes his visit to Gulf states but not Israel

There had been widespread hope that Trump's regional visit could usher in a ceasefire deal or renewal of humanitarian aid to Gaza. An Israeli blockade of the territory is now in its third month.



The Israeli military had no immediate comment on the strikes. The strikes lasted hours into Friday morning sending people fleeing from the Jabaliya refugee camp and the town of Beit Lahiya and followed days of similar attacks that killed more than 130 people, according to Gaza's health ministry.Israeli Prime Minister Benjamin Netanyahu vowed earlier in the week to push ahead with a promised escalation of force in Israel's war in the Gaza Strip to pursue his aim of destroying the Hamas militant group, which

In comments released by

Netanyahu's office Tuesday, the prime minister said Israeli forces were days away from entering Gaza "with great strength to complete the mission ... It means destroying Hamas."It was unclear if Friday's bombardment was the start of the operation. The war began when Hamasled militants killed 1,200 people in an Oct 7, 2023, intrusion into southern Israel. Israel's retaliatory offensive has killed more than 53,000 Palestinians, many of them women and children, according to Gaza's Health Ministry, which does not say how many were combatants. Almost 3,000 have been killed since Israel broke a ceasefire on March 18, the ministry

Democrats want to focus on Trump. Instead, they're being asked about Biden's mental acuity

PHOENIX (US): Joe Biden's time in public office is now behind him, but his age and mental acuity have become a litmus test for the next leaders in his party.

A new book that alleges White House aides covered up Biden's physical and mental decline has put the questions about Biden's health back in the spotlight, months after former Vice President Kamala Harris lost to President Donald Trump.

Several potential Democratic contenders for the 2028 nomination in recent days have been asked whether they believe Biden was declining in office or whether he should have sought reelection before a disastrous debate performance led to his



withdrawal.Many Democrats would prefer to focus on Trump's second term. Trump has done his best to prevent that - mentioning Biden's name an average of six times per day during his first 100 days in office, according to an NBC News analysis - and Republicans have followed his

lead, betting that voters frustrated by Trump's policy moves will still prefer him over memories of an unpopular presidency.\In the race for Virginia governor, one of this year's highest-profile contests, Republican Winsome Earle-Sears is running a pair of television ads tying Democrat Abigail Spanberger to Biden, with images of the two hugging and the former president calling her a friend. "The stench of Joe Biden still lingers on the Democratic Party," Democratic strategist Sawyer Hackett said. "We have to do the hard work of fixing that, and I think that includes telling the truth, frankly, about when we were wrong."

Democratic Sen Chris Murphy of Connecticut told Politico this week that "there's no doubt" that Biden, now 82, experienced cognitive decline as president.

Pete Buttigieg, the former transportation secretary, wasn't nearly as blunt but still stopped short of defending Biden's decision

Russia And Ukraine Hold Their First Direct **Peace Talks In 3 Years Amid Low Expectations**

Ukraine held their first direct meeting. peace talks in three years on Friday, gathering in Istanbul for Turkish-brokered negotiations, but officials and observers expected them to yield little immediate progress on stopping the more than three-year war.

AUkrainian delegation led by Defence Minister Rustem Umerov satdown with a low-level Russian team headed by presidential aide Vladimir Medinsky, according to Ukraine's Foreign Ministry spokesperson Heorhii Tykhyi,

The officials present sat around a U-shaped table, with the Russians and Ukrainians facing each other.

A senior Ukrainian official close to the talks said that Kyiv's delegation was prepared to "achieve a lot today" and with a real mandate to resolve key

The official, who spoke to The Associated Press on condition of anonymity because he was not authorized to make official



statements, said the outcome hinges on whether Moscow is equally serious.

Both countries have tried to

persuade US President Donald Trump, who has expressed frustration over the slow progress and threatened to are eager to resolve the conflict amid extensive diplomatic maneuvering.

The latest push to end the fighting got off to a rocky start on Thursday, when Russian President Vladimir Putin spurned an offer by Ukrainian leader Volodymyr Zelenskyy to meet face-to-face. Delegations from the two countries also flew to different Turkish cities and put together teams of significantly different diplomatic heft for possible talks.



NEW DELHI: On the 50th anniversary of Sikkim's statehood, Congress leader Jairam Ramesh on Friday said India has been enriched enormously by the integration of Sikkim and the state has a number of impressive achievements to its credit.

The Congress general secretary in-charge communications said the 36th Constitution Amendment Bill was passed by the Lok Sabha on April 23, 1975, and by the Rajya Sabha three days later.

Subsequently after the President's assent, the 36th Amendment was enacted and on May 16, 1975–exactly fifty years ago-Sikkim became the 22nd state of India with special provisions for it and its people enshrined in Article 371-F of the Constitution, he recalled. "The Republic of India has been

CMO Bandipora Issues Strict Guidelines to Ensure Discipline in Health Sector

BANDIPORA: In a bid to streamline the functioning of health institutions and improve patient care, the Chief Medical Officer (CMO) Bandipora has issued a circular direct-

ing all Drawing and Disbursing Officers (DDOs) in the district's health sector to strictly adhere to a set of operational guidelines. The circular, issued on May 16, emphasizes that no officer or official shall visit the office of the Director Health Services Kashmir (DHSK) or the CMO Bandipora frequently without prior permission from the concerned DDO.

It also mandates that all employees must perform only those duties that are part of their official job roles and refrain from engaging in unauthorized assignments.

Highlighting another key concern, the CMO's

circular strictly prohibits volunteers from undertaking any task in health institutions unless they are properly qualified in the relevant field and have completed a recognized course from

an accredited institution.

"Any non-compliance found in this regard in any health institution is a violation of rules and will be the sole responsibility of the concerned DDO," the circular reads.

The directive has been circulated to the Director Health Services Kashmir, the Medical Superintendent of District Hospital Bandipora, and Block

Medical Officers of Bandipora, Hajin, and Gurez for strict compliance. It is seen as a move to enhance accountability and ensure that healthcare delivery in the district remains uninterrupted and professional.

Two Key Bridges in Sonawari Left Unfinished for Over a Decade

BANDIPORA: Two important bridge projects in the Sonawari area of Bandipora district have remained incomplete for more than ten years, causing serious difficulties for residents of

The first project is a footbridge in Sumbal town, whose foundation stone was laid in 2014. Construction began but was soon abandoned, and no work has been done since. Due to the absence of this bridge, people from nearby villages are forced to take risky boat rides or travel long detours to reach Sumbal. The second bridge, located at Shelvat Sumbal and meant

to connect parts of Sonawari with the neighbouring Ganderbal district, also started in 2014 but remains unfinished. This has cut off vital connectivity for many remote villages in the

Local residents said they have repeatedly requested the completion of these projects from successive governments, including the Omar Abdullah administration and the current Lieutenant Governor's administration, but their appeals have gone unheard.

"We suffer every day because these bridges are not a luxury, they are a necessity," said a local resident.

People are now demanding urgent government action to restart and complete the construction of both bridges to restore much-needed connectivity in the region.

Operation SINDOOR emerged as a calibrated military response to an evolving pattern of asymmetric warfare, one that increasingly targets unarmed civilians along with military personnel. The terrorist attack on tourists in Pahalgam in April 2025 served as grim reminder of this shift. India's response was deliberate, precise, and strategic. Without crossing the Line of Control or international boundary, Indian forces struck terrorist infrastructure and eliminated multiple threats. However, beyond tactical brilliance, what stood out was the seamless integration of indigenous hi-tech systems into national defence. Whether in drone warfare, layered air defence, or electronic warfare, Operation SINDOOR marks a milestone in India's journey towards technological self-reliance in military operations.

Air Defence Capabilities: Tech as the First Line of Protection On the night of 07-08 May 2025, Pakistan attempted to engage a number of military targets in Northern and Western India including Awantipura, Srinagar, Jammu, Pathankot, Amritsar, Kapurthala, Jalandhar, Ludhiana, Adampur, Bhatinda, Chandigarh, Nal, Phalodi, Uttarlai, and Bhuj, using drones and missiles. These were neutralised by the Integrated Counter UAS (Unmanned Aerial Systems) Grid and Air Defence systems.

Air Defence systems detect, track, and neutralise threats using a network of radars, control centres, artillery, and both aircraft- and ground-based missiles.

On the morning of May 8, the Indian Armed Forces targeted Air Defence Radars and systems at a number of locations in Pakistan. An Air Defence system at Lahore was neutralised.[1] PERFORMANCE OF SYSTEMS

As part of Operation SINDOOR, the following were used: Battle-proven AD (Air Defence) systems like the Pechora, OSA-AK and LLAD guns (Low-level air defence guns). Indigenous systems such as the Akash, which

demonstrated stellar performance AKASH is a Short Range Surface to Air Missile system to protect vulnerable areas and vulnerable points from air attacks. The AKASH Weapon System can simultaneously engage Multiple Targets in Group Mode or Autonomous Mode. It has built in Electronic Counter-Counter Measures (ECCM) features. The entire weapon system has been configured on mobile platforms.[2]

India's Air Defence Systems, combining assets from the Army, Navy, and primarily the Air Force, performed with exceptional synergy. These systems created an impenetrable wall, foiling multiple attempts by Pakistan to retaliate.

The Integrated Air Command and Control System (IACCS) of the Indian Air Force brought all these elements together, providing the net-centric operational capability vital for mod-

Offensive Actions with Pinpoint Accuracy

India's offensive strikes targeted key Pakistani airbases-Noor Khan and Rahimyar Khan with surgical precision. Loitering munitions were used to devastating effect, each finding and destroying high-value targets, including enemy radar and missile systems.

Loitering munitions also known as "suicide drones" or "kamikaze drones", are weapons systems that can hover or circle a target area, searching for a suitable target before attacking. All strikes were executed without loss of Indian assets,

underscoring the effectiveness of our surveillance, planning,



and delivery systems. The use of modern indigenous technology, from long-range drones to guided munitions, made these strikes highly effective and politically calibrated.

Indian Air Force bypassed and jammed Pakistan's Chinesesupplied air defence systems, completing the mission in just 23 minutes, demonstrating India's technological edge.

Evidence of Neutralized Threats Operation SINDOOR also produced concrete evidence of

- hostile technologies neutralized by Indian systems: Pieces of PL-15 missiles (of Chinese origin)
 - Turkish-origin UAVs, named "Yiha" or "YEEHAW"
 - Long-range rockets, quadcopters and commercial

These were recovered and identified, showing that despite Pakistan's attempts to exploit advanced foreign-supplied weaponry, India's indigenous air defence and electronic warfare networks remained superior.

Performance of Systems: Air Defence Measures of the

On May 12, Lt Gen Rajiv Ghai, Director General Military Operations, in the Operation SINDOOR press briefing highlighted the excellent performance of a mix of legacy and modern systems:

Preparedness and Coordination: Since precise strikes on terrorists were conducted with-

out crossing the Line of Control or International Boundary, it was anticipated Pakistan's response would come from across

- A unique blend of Counter Unmanned Aerial Systems, Electronic Warfare assets, and Air Defence Weapons from both Army and Air Force
 - Multiple defensive layers from the International

- Boundary inward: Counter Unmanned Aerial Systems
 - Shoulder-Fired Weapons Legacy Air Defence Weapons
 - Modern Air Defence Weapon Systems

This multi-tier defence prevented Pakistan Air Force attacks on our airfields and logistic installations during the night of May 9-10. These systems, built over the last decade with continuous government investment, proved to be force multipliers during the operation. They played a crucial role in ensuring that both civilian and military infrastructure across India remained largely unaffected during enemy retaliation attempts.

ISRO's contribution: At an event on May 11, ISRO Chairman V Narayanan mentioned that At least 10 satellites are continuously working round-the-clock for the strategic purpose to ensure the safety and security of the citizens of the country. To ensure the safety of the country, the nation has to serve through

its satellites. It has to monitor its 7,000 km seashore areas. It has to monitor the entire Northern part continuously. Without satellite and drone technology, the country can't achieve that.[3]

The Business of Drone Power: A Rising Indigenous Industry The Drone Federation India (DFI), is a premier industry body representing over 550 drone companies and 5500 drone pilots[4]. DFI's vision is to make India a global drone hub by 2030, and it promotes the design, development, manufacturing, adoption and export of Indian drone and counter-drone technology worldwide. DFI enables ease of doing business, promotes the adoption of drone technology, and hosts several programs like Bharat Drone Mahotsav.[5] Some companies involved in the drone space are:

- Tata Advanced Systems offers a full range of integrated solutions across Defence & Security and has served as a trusted partner to India's armed forces for over six decades[6]
- Paras Defence & Space Technologies operates within the Defence and Space segments, distinguished by Indigenously Designed Developed and Manufactured (IDDM) capabilities[7]
- IG Drones is a Drone Technology Company for manufacturing and R & D of Drones specialized in defence and other industry applications along with provider of drone related services like drone surveying, mapping & inspection by industry experts. The company has partnered with Indian Army, Government of India, multiple State Governments, among others.[8]

The Indian drone market is projected to reach \$11 billion by 2030, accounting for 12.2% of the global drone market.[9] Drones at the Centre of Modern Warfare

The integration of drone warfare into India's military doctrine owes its success to years of domestic R&D and policy reform. Since 2021, the ban on imported drones and the launch of the PLI (Production Linked Incentive) scheme have catalyzed rapid innovation. The scheme of Production Linked Incentive for drones and drone components of Ministry of Civil Aviation was notified on 30th September, 2021 with a total incentive of Rs 120 crores spread over three Financial Years (FYs), FY 2021-22 to FY 2023-24.[10] The future lies in autonomous drones with AI-driven decision-making, and India is already laving the groundwork.

Defence exports crossed the record figure of about Rs 24,000 crore in Financial Year 2024-25. The aim is to increase the figure to Rs 50,000 crore by 2029, and make India a developed nation and the world's largest defence exporter by 2047. [11]

Make in India continues to power the growth of the de-

India has emerged as a major defence manufacturing hub, driven by the "Make in India" initiative and a strong push for self-reliance. In FY 2023-24, indigenous defence production reached a record 1.27 lakh crore, while exports soared to 23,622 crore in FY 2024–25, a 34-fold increase from 2013-14. Strategic reforms, private sector involvement, and robust R&D have led to the development of advanced military platforms like the Dhanush Artillery Gun System, Advanced Towed Artillery Gun System (ATAGS), Main Battle Tank (MBT) Arjun, Light Specialist Vehicles, High Mobility Vehicles, Light Combat Aircraft (LCA) Tejas, Advanced Light Helicopter (ALH), Light Utility Helicopter (LUH), Akash Missile System, Weapon Locating Radar, 3D Tactical Control Radar, and Software Defined Radio (SDR), as well as naval assets like destroyers, indigenous aircraft carriers, submarines, frigates, corvettes, fast patrol vessels, fast attack craft, and offshore patrol vessels.

The government has backed this growth with record procurement contracts, innovations under iDEX, drives like SRIJAN, and two Defence Industrial Corridors in Uttar Pradesh and Tamil Nadu. Key acquisitions such as LCH (Light Combat Helicopters) Prachand helicopters and the ATAGS (Approval for Advanced Towed Artillery Gun System) highlight the shift towards indigenous capability. With targets of 3 lakh crore in production and 50,000 crore in exports by 2029, India is firmly positioning itself as a self-reliant and globally competitive defence manufacturing power.

Operation SINDOOR is not just a story of tactical success. It is a validation of India's defence indigenization policies. From air defence systems to drones, from counter-UAS capabilities to net-centric warfare platforms, indigenous technology has delivered when it mattered most. The fusion of private-sector innovation, public-sector execution, and military vision has enabled India to not only defend its people and territory but also assert its role as a hi-tech military power in the 21st century. In future conflicts, the battlefield will increasingly be shaped by technology. And India, as shown in Operation SINDOOR, is ready, armed with its own innovations, backed by a determined state, and powered by the ingenuity of its people.

It is the name of a station, theoretically available to everyone, attainable to the select few who travel on and on, perfectly realizing all stations until he arrives at the station of no station in which one has nothing of one's own and therefore mirrors the Real most perfectly and is not defined by any particular divine name or attribute but brings together all standpoints or stations.

Invitation to the project of theosis and Perfect Man may be understood in terms of imagining a person whom nothing earthly or imaginable can satisfy, whom no belief binds, who is perfectly open to experience, who has nothing to fear, no anxiety to reach to apprehension of losing and who symbolizes ceaseless given state or achievement or object. Muhammad (SAW) is the life and fire in every experience as all experience requires the Light of Muhammad (SAW) as an ontological ground. For those who can see, it is Muhammad's (SAW) flag everywhere. Great na't such as Iqbal's na't ("Nigaheishq-o masti main wahiawwal, wahi aakhir" or Zoaq-o-Shoaq etc.) is best understood in light of Ibn Arabi's understanding of the light of Muhammad (SAW).

Muhammedan saints give "each created thing exactly what is due to it on the basis of seeing it as a unique self-disclosure (tajallií) of the absolute Haqq." For Ibn Arabi a Muhammedan is one who realizes the innumerable perfections of all the prophets and the station of no-station which in turn presupposes disengaging oneself from all qualities, bonds, limitations, and constrictions



questions there either needs to be demonstrated access to such meta-truth claim or possibility of stating the same in clear terms. The former enterprise is obviously hard and arguably easily refutable or not possibly falsifiable ordinarily. The later enterprise is one that sages like Ibn Arabi invite us to consider when they call for polishing the mirror of heart to receive what is the case or what unveils itself. It is a call for unconditionally submitting to Truth or totality of all truths, a vision of radical innocence that is open to all experience, a humility to qualify all one's assertions or claims of access regarding anything including such ideals as Beauty, Truth, Justice and Goodness or revelations of Being or pursuit of Perfection and thus not claim absoluteness for any immanent thing or idea. And one who embodies the great Station that is not a particular station or ideological viewpoint and thus embraces the reality or truth of all stations, is Muhammad (SAW). This is how Ibn Arabi presents the underlying archetypal reality of the "supremely successful person" of secular-cum-spiritual history. Let us meditate a passage from Ibn Arabi's Naqsh al-Fusûs that sums up contents of larger work Fusûs -al-Hikm, in Chittick's translation:

God does not become determined for him according to ... various fields of knowledge, modes of perception, beliefs, visions, traditions or descriptions, because of his awareness of the Majesty of God and of the fact that He is not limited to all or any of these things.... He has shown them that He encompasses them from all of their hidden and manifest directions and that He reveals Himself to them in them, not in any one thing, direction, name or level. So they enter the Trackless Desert in His contemplation, and their bewilderment is from Him, through Him and in Him. For Ibn'Arabi, Muhammedan is, as one Ibn Arabi scholar

travel deconstructing any signpost or ideology or interpretation or form offered as an absolute on the way – and life is a wayfaring or movement without any conceievable object as end. This comprehensive, all inclusive, universal, open and daunting transformative project is what the grandeur and comprehensiveness of the Muhammedan Station of no-station connotes.


One of the supreme advocates of following the wont or sunnah of the Prophet – Ibn Arabi didn't miss a single one – The Greatest Master makes the most compelling case for understanding Muhammad as Perfect Man or exemplar whom it would be a privilege for anyone to seek to imitate. Emphasizing particularly metaphysical dimension of the Prophet, imitating him implies for Ibn Arabi, the way to perfection and "an ideal of inclusion rather than exclusion, an ideal of integral culture, not an attitude of purity in peril, not xenophobia disguised as piety, not totalitarianism, not reaction." Few jurists today are unfortunately able to approach the question of sunnah in such comprehensive terms and connect foundational elements of jurisprudence to ontology or metaphysics.

For those who wonder why and how come Muhammad is made the centre of history of salvation, let it be pointed out that when we meditate on the very etymology of word Muhammad (the praised one) and its metaphysical aspect of being/principle of manifestation or existentiating principle and consider writings of major Sufi poets and best of na't poetry, we get closer to appreciating why. For Sufi poets in wujoodi tradition, all endeavours are for realizing the station of Muhammad (SAW), all seeking is seeking of Muhammad (SAW), all roads lead to the abode of Muhammad (SAW) as we find, in all cases, ceaseless movement for reaching the unreachable Beyond rather than some resting place. Deep down, we are never satisfied with any

and standing Non-delimited Wuj di.e., to be absolutely open to the Real with no imposition or will of one's own. Ibn 'Arabî thus demands nothing less than Universal Compassion and encountering the other with infinite humility and care – an ideal which Levinas attempts to appropriate.

It is in light of the Muhammedan Station of no-station that one can critique all Fascistic, Totalitarian or Fundamentalist or Class/Gender/Identity centric exclusivist ideological projects that claim access to absolute truth or privileged position. As beliefs limit or circumscribe the Formless Freedom that constitutes the Heaven/Void we finally seek, a perfect man needs to transcend all beliefs according to Ibn Arabi and be perpetually guarded against absolutization of humanly interpreted or conceived ideas or posing as God's spokesperson. When one sees anyone too anxious to label, judge and exclude in any name, on any pretext, impatient to live in uncertainties and aspiring to impose one's view on others, recall the understanding of bewilderment according to Ibn Arabi and seek to question. All men are united in their adoration for beauty, in their thirst for joy and love, in their endeavour to pursue perfection or the Good and respect for truth; they aren't and can't be united in any particular formulation of these ideals because the highest station we all seek is no particular station. We can afford to lose ourselves or break free in bewilderment or hairah (because Being can never cease to intoxicate or we can never finish see it lifting all its veils) and not in any object "... terae samnae aasman aur bi haen." It is on the Muhammedan axis of wonder that philosophy, science, mysticism and faith meet. Wonder implies eternal youth and freshness of life or birth of Prophet (Milad) is all about.

Operation Sindoor

Certainly, a large part of IMF's one billion dollars assistance will be used to fund the terror infrastructure. Will this not be considered indirect funding by IMF, an international organisation? Any financial assistance to Pakistan is no less than terror funding. The funds India gives to IMF should not be used, directly or indirectly, to create terror infrastructure in Pakistan or any other country," he said.

Raksha Mantri commended the effective role played by the Indian Air Force (IAF) in Operation Sindoor which is being appreciated by the world. Lauding the air warriors for eliminating the terror camps in Pakistan and PoK in just 23 minutes, he said "when missiles were dropped inside the enemy territory, the world heard the echoes of India's valour and might". He added that IAF spearheaded this campaign against terrorism, and during the operation, it not only dominated the enemy, but decimated them.

Rajnath Singh highlighted that India's fighter aircraft are capable of striking every corner of Pakistan without crossing the border. "The world has witnessed how IAF destroyed terror camps and later Pakistan's airbases. IAF gave the proof that India's war policy and technology have changed. They conveyed the message of New India that we are not just dependent on weapons and platforms imported from aboard, but Made in India equipment have become a part of our military power. The weapons manufactured in India are also impenetrable," he said.

Raksha Mantri added that Pakistan has itself accepted the power of the 'BrahMos' missile. This Made in India missile showed Pakistan the light of day in the darkness of night, he said, also lauding India's air defence system, in which Akash and other radar systems made by DRDO have played a tremendous role.

On his interaction with the brave Indian Army soldiers at Badami Bagh Cantt in Srinagar yesterday, and the air warriors & soldiers in Bhuj today, Raksha Mantri stated that he is, once again, convinced that India's borders are completely safe. "I've witnessed the highest level of enthusiasm and patriotism among the soldiers on both the fronts. What our forces did during Operation Sindoor has filled the country with pride," he said.

Raksha Mantri stated that Bhuj has been witness to India's victory over Pakistan in 1965, 1971 and now. He termed Bhuj as a land of patriotism where soldiers stand tall with an unshakable resolve to protect national interests. Two counters will also be set up in the Yatri Niwas by Jammu-Kashmir Road Transport Corporation, said official.

They stated that around 120 mobile toilets will also be installed at Yatri Niwas.

"The two-storied Yatri Niwas has a capacity to accommodate 2000 pilgrims and apart from this, a prefabricated shed has also been built in the courtyard to accommodate nearly 200 pilgrims in case of heavy rush," they said.

"Along with other arrangements, 24×7 water and electricity supply will be made available at the Yatri Niwas for the pilgrims.

"Swift, coordinated

support is vital for the success of these anti-terror efforts. Sharing information can make a significant difference," he appealed.

Major General Dhananjay Joshi, GOC of the Army's Victor Force, said terrorists attempting to hide, whether in dense forests or within civilian residential areas, will be tracked and eliminated.

Regarding the Kelar operation, Joshi said, "On May 12, intelligence

indicated a possible terrorist presence in the higher reaches of Kelar. On May 13, surveillance detected movement in the area. When challenged, the terrorists fired upon our troops, leading to a swift encounter and their neutralisation.' The second operation in Tral was launched based on specific

inputs. "As our teams cordoned off the village, terrorists hiding in different houses opened fire. Despite the hostile situation, the forces managed to evacuate civilians safely," he added.

Shahid Kuttay, a high-profile terrorist involved in multiple attacks, including the assault on a German tourist, and terror funding activities, was among those eliminated.

CRPF Inspector General Mitesh said these successes would not be possible without the support of local residents. "Public cooperation and timely information are vital for such operations," he said. "Our goal is not only to neutralise terrorism but to establish enduring peace in the region."

CM Omar exchange war of words with Mehbooba on reviving Tulbul Project

SRINAGAR: What started as a war of words between Omar Abdullah and Mehbooba Mufti over the former's call to revive the Tulbul Navigation Barrage project on Wullar Lake turned into a mudslinging match, with the Jammu and Kashmir Chief Minister accusing his predecessor of taking the conversation to gutter level.

The altercation broke out after Mufti said Abdullah's call to revive the Tulbul Navigation Barrage project in view of the suspension of the Indus Waters Treaty (IWT) was "irresponsible" and "dangerously provocative".

The chief minister hit back at the PDP president, saying she refuses to acknowledge that the IWT was a "historic betrayal" with the people of Jammu and Kashmir because of her "blind lust" to score "cheap" publicity points and "please" some people across the border.

In a post on X on Thursday, Abdullah wondered if work could resume on the Tulbul Navigation Barrage project in view of the suspension of the IWT.

"The Wular lake in North Kashmir. The civil works you see in the video is the Tulbul Navigation Barrage. It was started in the early 1980s but had to be abandoned under pressure from Pakistan citing the Indus Water Treaty. Now that the IWT has been 'temporarily suspended' I wonder if we will be able to resume the project," the National Conference (NC) leader posted from his personal X handle.

He said if completed, the Tulbul project can help use the Jhelum river for navigation purposes.

"It will give us the advantage of allowing us to use the Jhelum for navigation. It will also improve the power generation of downstream power projects, especially in winter," he added.

The Centre last month put the IWT – under which India and Pakistan used to share water — in abeyance in the wake of the April 22 Pahalgam terror attack. Mufti took a dig at the chief minister on

Friday, saying his call to revive the project was "deeply unfortunate". "J&K Chief Minister Omar Abdullah's call to revive the Tulbul Navigation Project amid ongoing tensions between India and Pakistan is deeply unfortunate," she said

in a post on X. The People's Democratic Party (PDP) chief said such statements are not only "irresponsible", but "dangerously provocative" as well.

"At a time when both countries have just stepped back from the brink of a fullfledged war with Jammu and Kashmir bearing the brunt through the loss of innocent lives, widespread destruction and immense suffering such statements are not only irresponsible but also dangerously provocative."Our people deserve peace as much as anyone else in the country. Weaponising something as essential and life giving as water is not only inhumane but also risks internationalising what should remain a bilateral matter," the former Jammu and Kashmir chief minister added.

"Actually what is unfortunate is that with your blind lust to try to score cheap publicity points and please some people sitting across the border, you refuse to acknowledge that the IWT has been one of the biggest historic betrayals of the interests of the people of J&K," he said in a post on X.

Abdullah said he has always opposed the treaty and will continue to do so.

"Opposing a blatantly unfair treaty is in no way, shape, size or form warmongering, it's about correcting a historic injustice that denied the people of J&K the right to use our water for ourselves," he added.

The PDP president upped the ante and claimed that NC founder Sheikh Mohammad Abdullah had advocated Jammu and Kashmir's accession to Pakistan, but sided with India after getting power.

"Time will reveal who seeks to appease whom. However, it's worth recalling that your esteemed grandfather Sheikh Sahab once advocated for accession to Pakistan for over two decades after losing power. But post being reinstated as Chief Minister he suddenly reversed his stance by aligning with India. "In contrast the PDP has consistently upheld its convictions and commitments and

unlike your party whose loyalties have shifted dramatically according to political expediency, we don't need to stoke tensions or adopt warmongering rhetoric to validate our dedication.

Was Sad And Angry When I Was Not Picked And Then Called Up As Injury Replacement: RCB Skipper Patidar

ajat Patidar, who is leading Royal Challengers Bengaluru this IPL, revisited the 2022 season when he was left "sad" and "angry" after being ignored by the franchise despite assurances, only to be called up later as an injury replacement. Patidar also admitted that being handed over the captaincy by the inimitable Virat Kohli ahead of IPL 2025 did put him under pressure, but supportive words from the legend calmed him. Patidar has been one of RCB's middle-order mainstays this season, scoring 239 runs in 11 games as the southern franchise aims for a maiden men's IPL title.

"I had got a message (ahead of the mega auction for IPL 2022) that you be ready... that we will pick you. I had a little hope that I will get another chance (to play for RCB). But I wasn't picked in the mega auction. I was a little sad," said Patidar on an RCB Podcast.

However, the 31-year-old Madhya Pradesh cricketer didn't have to wait long to again wear the RCB colours as one of his state-mates got injured. But Patidar was not really keen on coming back to Bengaluru, knowing that he would hardly get an opportunity to play in a star-studded lineup.

"I (had) started playing in my local matches in Indore (after not getting picked in the auction). Then, I got a call that 'we are picking you as a replacement for Luvnith Sisodia', who was inured. To tell you frankly, I didn't want to come as a replacement because I knew that I won't get a chance to play there, and I always feel that I don't want to sit there (in dugout).

"I wasn't angry. It was like, if they didn't pick me (during the auction), then I won't get it (get to play). I was angry for a while but then I was normal," said Patidar, who led Madhya Pradesh

Ashwin backs Bumrah and Jadeja for India's Test captaincy role

hubman Gill might be the frontrunner to succeed Rohit Sharma as India's next Test captain, but R Ashwin feels that other experienced names such as Jasprit Bumrah and Ravindra Jadeja should not be overlooked for the role.

The India squad for their five-Test series against England, which begins on June 20 could be picked in the final week of May, and the run-up to the selection process is dominated by the talks around the possible new captain.

"First of all, everyone is saying that Gill is the captain. Everyone is going in that direction. But there is a loud option in Jasprit Bumrah, and why do we forget about Ravindra Jadeja," Ashwin said during a chat with former Tamil Nadu opener Vidyut Sivaramakrishnan on his YouTube channel. "If you are willing to go for a new person as captain, I would say why not make him [Gill] an understudy of an experienced guy for two years before handing him the job on a full-time basis."

After the retirement of Virat Kohli and Rohit from Tests, Jadeja is the most experienced player in the Indian side with 3370 runs and 323 wickets from 80 Tests. He, however, does not have any captaincy experience in Test cricket, while Bumrah has also led India in only three Tests, most recently in the first and last Tests of the 2024-25 Border-Gayaskar Trophy.

"I would say, why not get all three to four candidates and make them do a presentation and ask them each to detail the vision for the team," Ashwin said. "It happens in countries like Australia. Why won't we go down that road?"

Ashwin, who retired from all forms of cricket after the third BGT Test late last year, said Bumrah too should be considered seriously and his recent back injury should not be a hindrance.

"Look at Pat Cummins, he also had a back stress fracture. but he is now captaining Australia in Tests and ODIs," Ashwin said. "Like that, Bumrah is our national treasure and he should be in the discussion.

"He should be asked, will you be able to play five Tests? Can you be a full-time captain? I know he had a stress fracture but I am sure he will think about it. I think the hat with his name should be number one in that ring.





Ben Stokes Declares He's Ready For England Return After Hamstring Surgery

en Stokes has declared himself "very, very confident" that he can play a full role as an allrounder in England's Tests against Zimbabwe and India this summer. Stokes has spent the last five months recovering from a hamstring tear after rushing back from the same injury last year,

this kind of stuff together, how he's going to help me better, how he's going to speak to me a lot more around that kind of stuff... I'm 33, and I don't want to expose myself to being in a situation where I'm off the field when I don't have to be."

England's attitude to training has been questioned this year, most notably during



but believes he has handled his rehabilitation "a lot better" this time around.

Stokes sustained his original injury during the Hundred last August, and though he

returned to action in time for England's Test series against Pakistan in October, he suffered a recurrence while bowling in New Zealand two months later. He has taken a cautious approach to his recovery since, ahead of legacy-defining series against India (at home) and Australia (away) this year.

"I feel great," Stokes told Nasser Hussain in an interview for Sky Sports. "Training and playing are completely different; no matter what you do at training, you just cannot replicate the intensity that your body is put through in a game... As excited as I am to get back on the field, I do know that it is going to be completely different to what I've been doing in my training.

"But in terms of my role as a player, [beingl that fourth seamer, batting at No. 6, and trying to dominate every situation that I find myself in, whether I've got the bat in my hand or the ball in my hand, is what I want to get back into doing out on the field, and trying to do it on the biggest stage. I know I've done it before, and it's something that I'm very, very confident in myself that I can do.'

Stokes felt the need to "fast-track" his return last year, and later acknowledged he had "ruined" himself in the process. "This time around, the medical team and myself were like, 'We're just going to absolutely nail it this time," he said. "It was a slow and long process, particularly the first two months... [But] it's not been anywhere near as taxing, physically or mentally."

He also revealed discussions with coach Brendon McCullum around ensuring he does not push himself too hard. "We've spoken about

their white-ball tour to India. Rob Key, their managing director, subsequently said that the perception of a relaxed, carefree environment was England's "own fault" but Stokes defended his team's "incredible" work ethic and conceded that he is frustrated by their reputation.

"When you hear comments saying that we don't train hard enough, we're more bothered about golf, we don't work hard enough, it's just complete and utter [rubbish]," he said. "You're not going to be able to be an international sportsman for a long period of time if you don't have a work ethic. Everyone who walks into the Test team, into the white-ball team, their work ethic is incredible.

"There is a reason to everything that we do, because we feel it helps players, it helps the team, but it also is a way of taking the pressure of what we do off us, without adding more to it. There's enough pressure on the shoulders of everyone who walks out there with the three lions on their chest, and what we try and do is take any extra, added pressure off the shoulders of people."

Stokes was briefly considered as a stop-gap candidate to captain England's ODI team after Jos Buttler's resignation after the Champions Trophy, but suggested that it would not have made sense to add to his workload in such a busy year. "The decision that they've made there, of making Harry Brook [captain], is 100% the right one," Stokes said.

He is not part of the white-ball squads for Brook's first assignments against West Indies, but has not officially retired from either format. "If I do play more white-ball cricket for England, then great," Stokes said. "But if I don't, then I'm going to sit back and watch the incredible talent that England has go and put on a show, and hopefully win more World Cups in the future."
