Gunners Decimated Over 20 Enemy Posts Meant For Infiltration Of Terrorists **Into Poonch: Official** KC News Network

POONCH: After the Pahalgam terror attack, the Indian Army's artillery gunners turned targeted and decimated over 20 Pakistani posts meant for staging infiltration into Jammu and Kashmir's Poonch sector, a top official said.

Failing to match up to the Indian troops' assault, Pakistan targeted civilian areas, causing casualties in the Poonch sector, the official added. The Poonch sector witnessed heightened tension and artillery



shelling nearly two weeks ago. India launched Operation Sindoor. targeting terror infrastructure in Pakistan and Pakistan-occupied Kashmir after the April 22 Pahalgam terror attack that claimed 26 lives.

The wave of artillery shelling, missile, and drone strikes in the Jammu region – particularly in Poonch – killed 27 people and left over 70 injured between May 8 and 10. Thousands fled from the LoC and International Border areas to seek refuge in government-run relief camps.

"As we received orders on the 7th, 8th, and 9th of May, we fired over 600 rounds of artillery shells in three days, targeting accurately and precisely over 20 enemy posts. These posts were part of the terror infrastructure and used for infiltrating terrorists into India," an officer of the artillery unit said.

According to the army, the precision strikes crippled enemy logistics, material, and morale.

"As troops hit and destroyed the posts, we knew we had devastated their (Pakistan's) men, material, and morale," the officer said.

The Army released a video of 'target practice' of decimated Pakistani posts along LoC in Poonch sector, where guns were seen in action for three days.

A captain said intercepts from across the border suggested there were a large number of launching pads and terror administrative setups. "These have been targeted," he said, adding, "It was thunder in the sky and it landed right on their heads." Another officer, detailing Operation Sindoor and overseeing a sensitive operational area, said, "The fire after the Pahalgam attack was

BSF foiled infiltration bid of nearly 50 terrorists in Samba: DIG Mand

JAMMU: The Border Security Force (BSF) foiled an infiltration bid of nearly 50 terrorists during "Operation Sindoor" on May 8, a top official of the paramilitary force said on Wednesday.

 $Deputy Inspector General (DIG) of the {\tt BSF,SS}$ Mand, according to the news agency-Kashmir News Observer (KNO) said, "On May 8 a major infiltration attempt involving 45-50 heavily armed terrorists was thwarted by the alert BSF personnel in Samba district."

He said, "The group, attempting to sneak

into Indian territory under the cover of ceasefire violations, was met with a fierce counteroffensive. BSF retaliated with heavy mortar fire, neutralizing enemy positions and forcing the infiltrators to retreat."

"We had prior intelligence that a large group was attempting infiltration. Our alert troops identified them early, and within 1.5 hours of engagement, the group was repelled with heavy losses. Our forces responded with precision and intensity, degrading their bunkers and suppressing their firepower," DIG Mand said, according to KNO.

Kupwara (Karnah): In a gesture of goodwill and solidarity, Indian Army extended immediate assistance to residents of Chota Gaon Mohalla at Ibkot village in Karnah sector, after a local mosque suffered damage during unprovoked shelling from across the Line of Control (LoC).

The cross-border shelling, initiated by Pakistani forces, caused structural damage to the mosque. The corrugated galvanised iron (CGI) sheets on the roof were torn apart, a solar panel system was destroyed, and the prayer matting inside the mosque was damaged.

Responding swiftly, the Indian Army helped restore the mosque by repairing the roof, reinstating the solar energy system, and replacing the prayer matting, allowing the place of worship to resume its religious and community functions. The aid was part of the Army's continued

SRINAGAR: There is no letup in the heat wave conditions in Jammu and Kashmir as multiple areas, including Jammu, the winter capital of the region, recorded the season's hottest day on Wednesday.

According to the details available with the news agency–Kashmir News Observer(KNO), amidst the forecast of hot and dry weather conditions, Srinagar, the summer capital of Jammu and Kashmir, recorded a maximum temperature of 32.0 degrees Celsius.

Waqf Case: Nobody Has Right Over Government Land Even Under Waqf By User Principle, Centre To SC **NEW DELHI**: The Centre on Wednesday told the this legislation." He referred to the report of the joint

Supreme Court that nobody can claim right over government land and it is legally empowered to reclaim properties which are declared waqf by using the waqf by user principle.

Waqf by user refers to a concept where a property is recognised as waqf based on its long-term use for religious or charitable purposes, even without formal documentation.

Responding to the submissions challenging the constitutional validity of the Waqf (Amendment) Act, 2025, Solicitor General Tushar Mehta commenced advancing his arguments on behalf of the Centre before a bench comprising Chief Justice BR Gavai and Justice Augustine George Masih.

'Nobody has the right over government land," the top law officer said.

"There is a Supreme Court judgment which says the government can save the property if it belongs to the government and has been declared as waqf," he said.

At the outset, the law officer said no affected parties have moved the court and "it is nobody's case that Parliament does not have the competence to pass parliamentary committee and the fact that many state governments and state waqf boards were consulted before the Act came into being.

The bench sought response from the Centre on the pleas of the petitioners that an officer above the rank of the district collector can decide the claim over waqf properties on the grounds that they are of government. 'This is not just misleading but a false argument," the law officer said. The hearing in the case is underway.

The Centre, in its written note, strongly defended the Act, saying waqf by its very nature is a "secular concept" and can't be stayed as there is a "presumption of constitutionality" in its favour.

It addressed the issues the court had previously raised and said the law only sought to regulate secular aspects of waqf administration while safeguarding religious freedom. He said there was no "grave national urgency" calling for its stay.

"It is a settled position in law that constitutional courts would not stay a statutory provision, either directly or indirectly, and will decide the matter finally. There is a presumption of constitutionality that applies



to laws made by Parliament," the note said. The bench, on Tuesday, underscored the

"presumption of constitutionality in favour of the law and said petitioners challenging the waqf law

needed a "strong and glaring" case for interim relief. "There is a presumption of constitutionality in favour of every statute. For interim relief, you have to make out a very strong and glaring case. Otherwise, presumption of constitutionality will be there." the CJI said when senior advocate Kapil Sibal, leading the charge against the legislation, began his submissions. The Centre had urged the bench to confine the hearing on pleas to three issues. One of the issues is the power to denotify properties declared as waqf by courts, waqf by user or waqf by deed. The second issue relates to the composition of state waqf boards and the Central Waqf Council, where they contend only Muslims should operate except ex-officio members whereas the last one is over the provision stipulating a waqf property won't be treated as a waqf when the collector conducts an inquiry to ascertain if the property is government land. The Centre notified the Waqf (Amendment) Act, 2025 last month after it got President Droupadi Murmu's assent on April 5. The bill was cleared by Lok Sabha with the support of 288 members while 232 MPs were against it. The Rajya Sabha saw 128 members voting in its favour and 95 against it.

At UN, India calls maritime, anti-terror strategy vital to national security amid Indo-Pacific shifts

UNITED NATIONS: India told the UN Security Council that it views maritime security and countering terrorism as central to its national security and economic interests as it continues to evolve its strategy in response to new threats and geopolitical shifts in the Indo-Pacific region.

"India, having a long coastline, extensive seafarer community, and capable maritime forces, is actively pursuing its role as a responsible maritime power to safeguard its interests and address emerging threats," India's Permanent Representative to the UN Ambassador Parvathaneni Harish said Tuesday.

He was addressing the UNSC high-level open debate on 'Maintenance of international peace and security: Strengthening Maritime Security through International Cooperation for Global Stability' presided over by Greek Prime Minister Kyriakos Mitsotakis under Greece's Presidency of the Council for the month of May.

"India views maritime security and countering terrorism as central to its national security and economic interests. Its approach balances robust defence capabilities, regional diplomacy, international cooperation and domestic infrastructure development. It continues to evolve its strategy in response to new threats and geopolitical shifts in the Indo-Pacific region," Harish said.

India underlined that maritime security is a cornerstone of economic growth as critical trade routes, energy supplies, and geopolitical interests are tied to the oceans.

Harish said that India's maritime security strategy is broad and multifaceted, addressing both traditional threats from state actors and non-traditional threats from piracy, contraband smuggling, illegal human migration, unreported and unregulated fishing, maritime incidents, hybrid threats and maritime terrorism.

He further said that India is committed to promoting a free, open and rules-based maritime order in accordance with the principles of the UN Convention on the Law of the Sea (UNCLOS).

Furthering this objective, India is undertaking capacity-building efforts to tackle contemporary security challenges and strengthen maritime combat, strategy, and governance, he said.

UN Secretary General Antonio Guterres, addressing the high-level debate, said the

discussion underscores that the basic condition to preserve maritime security is the respect by all countries of the UN Charter and international law as reflected in UNCLOS.

Guterres said that over the years, the Security Council has sought to address a range of threats that undermine maritime security and global peace - from piracy, armed robbery, trafficking and organised crime to destructive acts against shipping, offshore installations and critical infrastructure and terrorism in the maritime domain. These, he said, pose significant threats to international security, global trade and economic stability.

Voicing concern that no region is spared, Guterres said the problem is getting worse. He said that after a modest global decrease in reported piracy and armed robbery incidents in 2024, the first quarter of 2025 saw a sharp upward reversal.

According to the International Maritime Organisation, reported incidents rose by nearly half, 47.5 per cent, compared to the same period in 2024. Guterres noted that incidents in Asia nearly doubled, especially in the Straits of Malacca and Singapore.

In the Red Sea and Gulf of Aden, attacks by the Houthis on commercial vessels have disrupted global trade and increased tensions in an already volatile region. The Gulf of Aden and the Mediterranean Sea "remain treacherously active routes" for migrant smuggling and the trafficking of weapons and human beings.

One child asked Leavitt about Trump's daily candy consumption. She characterised his intake as a "good amount" and added that "he likes pink Starburst and Tootsie Rolls."

A few questions touched on administration policy, such as the state of the US-Mexico border and what Trump is willing to do about climate change.



But even more questions were about his favourite foods and they led Leavitt to share that Trump also likes to eat a "big, beautiful steak," ice cream sundaes with chocolate sauce and some toppings, and hamburgers and fries from McDonald's.

She appeared to be stumped by a few of the inquiries, including about the president's favourite soccer player and his favourite child. Trump has five adult children.

"That is a very controversial question and I'm not going to answer it," Leavitt said after the laughter subsided. "I know he loves all of his children very much, and they're all great kids."Earlier Tuesday, the first lady joined a few dozen children whose parents work in the Executive Office of the President in decorating wooden American flags.She used a glue stick to attach two silver glittery stars to her red, white and blue flag after she took her seat at one of two tables in the Jacqueline Kennedy Garden on the South Lawn. The first lady admired the children's work and told several that their creations were "beautiful.

ED Conducts Multi-City **Raids In Money** Laundering Case



The Government of India has made significant strides in promoting sustainable mobility, placing special emphasis on affordable and eco-friendly public transportation options for the masses. A cornerstone of this initiative is the Faster Adoption and Manufacturing of (Hybrid &) Electric Vehicles in India (FAME-India) Scheme, aimed at accelerating the transition to electric mobility. Since its inception in 2015, the scheme has evolved into a robust framework for incentivizing electric vehicles (EVs) and establishing essential infrastructure, ushering in a greener and more sustainable transportation era.

The first phase of FAME was a foundational step, rolled out for two years starting April 1, 2015. Following its success, the scheme's second phase, FAME-II, was launched in 2019 with an ambitious outlay of ₹11,500 crore. Beyond financial incentives, the FAME-II scheme has supported pivotal policy measures, including reducing the GST on EVs and facilitating the formulation of state-specific EV policies. A noteworthy aspect of FAME-II is its phased manufacturing program, which encourages domestic production of EV components and reduces reliance on imports. With an expenditure of ₹8,844 crore under FAME-II—comprising ₹6,577 crore for subsidies, ₹2,244 crore for capital assets, and ₹23 crore for other expenses—the government has demonstrated its unwavering focus on fostering an EV ecosystem. The scheme's progress has positioned India as a key player in sustainable mobility, significantly reducing the nation's carbon footprint while creating new economic opportunities in the EV sector. As India accelerates its transition to green mobility, the success of FAME-II sets the stage for deeper investments in clean energy transportation solutions. However, to fully capitalize on these gains, there is a need for consistent policy support, rapid infrastructure development, and increased public awareness about the environmental and economic benefits of EVs. With the right blend of innovation, collaboration, and governance, India can pave the way for a sustainable transportation future that resonates globally.





In Judaism, redemption is equally central but often takes a communal focus. The story of the Exodus embodies the Israelites' redemption from slavery, and the yearning for messianic redemption-an age of peace and justice-is a core element of Jewish eschatology. It is not solely about personal atonement but expresses a collective longing for world renewal. Similarly, Islam presents redemption as a journey of forgiveness and divine mercy, linked to individual repentance but ultimately fulfilled in the hereafter, when justice is restored. In Hinduism, redemption is seen as liberation (moksha) from the cycle of samsara (birth, death, and rebirth), in which the individual soul(atman) attains unity with the divine (Brahman). Redemption, here, is a profound spiritual liberation, achieved through devotion, knowledge, and ethical action. Buddhism, too, seeks liberation from the cycle of samsara. However, Buddhist redemption focuses on enlightenment (nirvana), which frees individuals from suffering and ego's illusions, marking the final liberation from attachment and ignorance. Each tradition shapes redemption in ways that address both universal human longings and specific doctrinal understandings.

I have felt this within myself.

hydration facilities in public places, and restrict outdoor labor during high-heat periods.



Mystic Thoughts

Making Marriage Easy: Evolving a Joint Action Plan



Life is easy. Our basic requirements are very few. We don't need much money to live soulfully or meaningfully. We don't need to own house but can get one on rent. We are encouraged to live simple lives and not covet luxuries. We don't need government employment to sustain ourselves. Food is damn cheap. Clothes don't cost much and we can use second hand ones as well. We need to teach children to live lives gracefully, with dignity and not coveting comforts or riches which often go against higher aspirations of intellectual and spiritual life. Most of great men have lived simple lives. Even some of the richest like Warren Buffet and Ratan Tata have lived simple lives. Saints, in general, have lived lives of exemplary simplicity. Tolstoy and spiritual writers have shown deeper meaning of the Gospel to lie un choosing poverty over riches. All great traditional cultures have valorized lives that don't cost much for the environment or limited resource base. Wherefrom is interiorized the notion of riches are linked to happiness. Happy people live simply living off the inner riches. Travelling light on earth is what has been propounded by great minds. In a prophetic tradition we find markets as worst places. We haven't been told by great teachers to opt for consumerist life style. Simplicity is ultimate sophistication. A minimalist life style is what leads to greater joy or fulfillment in life. Budget for make-up of certain brides is enough for funding food for years. More money is spent and destroyed by the rich on marriage than is needed for the food and education of the poor for whole life. These deserve to be named and shammed. We need to teach children the beauty of simplicity and obscenity of extravagance.

Community kitchens would help to resolve the problem of domestic chores. The State, NGOs and local Mohalla committees or self help groups can coordinate community kitchen for five to ten families which would also generate employment for one person for two to three kitchens. Food can come prepared and cleanliness ordered for houses from community kitchens. Although ideal solution would have been families sharing meals on weekends and choosing to do chores of other families once a week, second best solution is community kitchen that feeds adjacent families. We can create near mosques/shrines such langar spaces that would feed anyone who asks and necessary resources can come from daily sadaqah/ other contributions of local community. There are steps being taken for institutionalizing the idea in different places in Kashmir and initial reports are promising.

If we could focus on teaching generations or students virtues of simple life – and simple marriage, community spirit or sharing of resources and infaq of time and skills - there would hardly be such problems as late and expensive marriages. Those who demand huge resources for marriage, for houses, for starting business generally are failures in the examination of life. It is the responsibility of guardians - here lies the real significance of this institution whose role is often perceived to be an obstruction in healthy marriage arrangement - extended family and community to marry girls at proper age (early 20s) to avoid problems on account of late marriage. Now there is no institutional or implementable moral framework to ensure this. Livelihood and marriage expenses for the bride could be planned after the birth of a daughter or after secondary education by tying up her in silent partnership agreements with local businesses or buying share certificates or helping her work on part time basis. Interest free credit cooperatives could be strengthened and accounts created for daughters by parents/guardians. Investing properly Rs 100 every month in her name for 20 years in various profitable ventures could give us some multiples of principal amount 100x12x20=24000 for basic marriage expenses and investing Rs10 daily for 20 years (73000 is principal amount only) could create good capital and profit share for livelihood support to cater for anxiety over resources that often delays marriages.



Easy Nikah Document to be prepared and sent to all friday mosque Imams who shall get it widely disseminated and explained to audience and make it a point to teach bride and groom at the time of solemnizing nikah. It should be taught in special marriage training sessions conducted for every prospective bride and groom at local levels. There should be special classes in colleges as well on model nikah nama.

It shall consist of largely ignored or forgotten ethic of marriage and shall be disseminated far and wide, in every home where marriage is expected. Model document shall summarize Islamic teachings on simplicity and avoiding extravagance and various firms of injustice that are making marriage difficult. The

Divorce the Last Option

Love makes possible all things. If we could truly love, unconditionally love we would secure our redemption and domestic peace. Isn't iHk, put love of God and neighbor at the center and find this world transform into a paradise? That is the insight of arguably the greatest novel ever written The Brothers Karamazov. 
"If we could invest our lives in love, simplify our weddings, and build institutional support like community kitchens, counseling centers, and interest-free cooperatives, marriage would cease to be a crisis. Love, humility, and attention are forms of worship. We need to build systems that prevent delays, reduce costs, and foster companionship. A model nikah document, moral pressure from the community, and financial literacy for women can make marriage a means of empowerment — not a test of endurance. Divorce should be a last resort, not an easy exit. With shared effort, we can make marriage easier, kinder, and more just."

Inheritance Share obtainable at Marriage

Given very few Muslim women receive inheritance share due to them and it is often in the name of dower that is adjusted or written off in favour of women, it is proposed to transfer her inheritance shares or consent to transfer such shares when demanded or in case of divorce. Given there has been huge failure of Muslim community to ensure Islamic inheritance law pertaining to women, massive awareness campaign regarding it that shall target every would be bride and institutions from mosque to women based groups besides courts and concerned families/relatives of the deceased at the time of distribution of shares. All shall be required to write wills for community causes in general, paying missed zakat and due shares as per guidance of Islam. Name and shame campaign against usurpers of women's rights would be part of the campaign. It should be part of marriage contract to execute due inheritance share transfer as part of payable dower. Let mehr be on lower side (in thousands or under two lacs) but associated treasure of gifts should be transferable to women from inheritance. Parents can choose to transfer share due to women as part of will before death or choose to gift this share at the time of marriage. Imams who solemnize nikah can make extracting commitment for share transfer as part of their speech at the occasion. Let every Muslim woman insist on livelihood support or post-marriage pension from investment of her share from property. Let mehr be treated as investment capital for future income support even if it is a few hundred/month.

Mehr Investment Fund

Mehr is often ample seed capital for investment to carve recurring income support from profits. If complemented by investing inheritance share in form of kind or cash gold (obtained as part of mehr-dower) through interest free loan against gold or converting gold into cash would ensure basic needful postmarriage pension. In cases where parents can't afford this much



following is proposed as rough draft for the same.

Muslims are commanded to avoid tabzir (spending on sinful things) and israf (extravagant spending). Muslims should avoid attending any gathering where these sins are shamelessly or publicly practized.

· Imams shall boycott any marriage where anything against the value system of simplicity and no to extravagance and injustic is being done. They shall not solemnize such nikah mehfils.

I suggest opening up all women seminary that sees the issue of fatwas coming from recognized but male dominated institutions like Deoband and Azhar. In this seminary should be world body of scholars trained in traditional Islamic jurisprudence and modern disciplines who frame opinions for women or at least scrutinize fatwas of men. It mayn't be difficult for Muslim women of diverse persuasions to identify with the burning passion for justice of certain die hard atheistic and we can come on common terms for securing cooperation and voluntary associations to resolve most of problems - we can frame strategic alliances with women of other faiths and even atheists to seek support for common minimum programme which would include gender equity/justice. I suggest conducting seminars not on such clichés or vague general ideas like rights of women in Islam but concrete agendas like framing model nikah nama, creating NGOs that provide legal advice or even free legal care to women suffocating under oppressive notions, both "religious" and "secular."

our inflated sense of ego or agency or power seeking complex.

Comprehensive counseling before and after marriage may prevent need for divorce or khula. There is such a failure in relations due to absence of tarbiyet at different stages. Education fails to address this problem. Other institutions have also failed to cultivate an ethic of relationships in community. As such we must create extensive counseling network and trained human resource for reaching out to future couples. Arbitration councils need to be institutionalized and create spaces for moral pressure to prevent divorce on flimsy grounds. There needs to be created a long term mechanism for choosing, solemnizing and maintaining marriages, following model ethic or advisory for the same. We need accountability of local community institutions such as Mohalla committees and engagement with Panchayats and incentivizing adherence to rights paradigm and providing assistance to those who subscribe to model Nikah namah. Wouldn't it be wise to discourage and penalize divorce by imposing some tax on initiating agent and this tax would support those who get affected, especially children and compensate for the loss of resources of community that were invested in creating a relationship.

the masters of Pakistani terrorists to their knees and the next time if they raise their eyes towards Mother India, not a single area of theirs would remain untouched by punishment," the Lieutenant Governor added.

Referring to the April 22 Pahalgam terror attack, which left 26 civilians, mostly tourists dead, LG Sinha said, "After the attack, Prime Minister Narendra Modi made it clear that the perpetrators would be taught a lesson. The Indian response was swift, strategic, and precise."

He also paid tributes to the civilians and soldiers who laid down their lives during the confrontation.

"In just three days, the enemy was brought to its knees. Pakistan was left pleading before the international community to intervene," he added.

LG Sinha emphasized that the objective of "Operation Sindoor" was not war but to dismantle the terror machinery. "Today. Pakistan and the world know that every inch of its territory hosting terror camps is within the reach of the Indian Army.'

"Dharma has won and Adharma has surrendered before your weapons and might. I am proud that in just a few days our brave soldiers broke the back of the enemy and today 140 crore citizens are remembering your valour, courage and sacrifice," the Lieutenant Governor said–(KNO)

The group will also visit African countries, including the Democratic Republic of Congo (May 24), Sierra Leone (May 28), and Liberia (May 31). This delegation includes members from the BJP, BJD, IUML, and other parties, as well as former diplomats.

Before the teams departed, Foreign Secretary Vikram Misri briefed all members on India's approach, with reference to the April 22 incident in Pahalgam, where 26 civilians were killed.

The brief was about India's recent retaliatory operations across the Line of Control and Pakistan-occupied Kashmir on May 7, followed by missile and drone attacks from the Pakistani side.

A ceasefire understanding was reached between the Director Generals of Military Operations (DGMOs) on May 10.

The delegations, comprising members from various political parties, are tasked with presenting India's case to international stakeholders. Their engagements will include discussions with foreign ministers, lawmakers, policy analysts, and representatives from multilateral institutions.

Officials involved in the outreach have stated that the delegations will seek to present credible evidence regarding Pakistan's involvement in cross-border terrorism and push for coordinated international action. The broader aim is to diplomatically isolate Pakistan while bolstering global support for India's counter-terrorism efforts.

This outreach is notable for its bipartisan nature. Leaders from both the ruling party and the opposition are participating in a unified diplomatic initiative, reflecting a shared national stance on terrorism. The effort has drawn comparisons to the 1994 campaign led by former Prime Minister A B Vajpayee, who represented India at the United Nations Human Rights Commission to counter external pressure on Kashmir. The first two delegations departed today for Japan and the United Arab Emirates, officially beginning the outreach. Over the coming days, five more teams will travel to a total of 32 countries and the European Union. Together, they will represent a coordinated effort to communicate India's security concerns and its policy of zero tolerance towards terrorism on the international stage-(KNO)

Academic Sessions Restoration: JK-BOSE notifies new academic schedule

SRINAGAR: The Jammu and Kashmir Board of School Education (JKBOSE) Wednesday notified the new academic schedule following the restoration of academic session from March to November.

According to the news agency-Kashmir News Observer (KNO), JKBOSE further clarified that due to change in academic calendar in winter Zone areas in 2024, the Annual regular 2025 examination is scheduled to be held in Oct-Nov of 2025 and in summer zone of Jammu division in Feb-March 2026 respectively.

The board further said, "Previous academic calendar is restored from the current year (2025) in Jammu & Kashmir and Ladakh Union Territories."

"The Academic session in case of Kashmir division and winter Zone areas of Jammu division and U.T of Ladakh shall be 2024-25, entailing conduct of the Annual Regular Examinations of the 10th, 11th and 12th classes in October-November 2025," it reads.

It also said that the Academic Session in case of summer zone of Jammu division shall be 2025-26, entailing conduct of annual regular examination of 9th, 10th, 11h and 12th classes in March-April 2026.

In 2024, the Council of Ministers Decision accorded the sanction to the restoration of the academic calendar from March-April to November-December for classes 1st to 9th.

The government had said that "For the session 2024-25. the restoration of the previous academic calendar (November-December session) shall be done with respect to classes 1st to 9th whose examinations shall be held during the months of November-December, 2024."

It had further said that for the students of classes 10th to 12th, the restoration of the Academic Session (to November-December session) shall be done from the academic session 2025-26.

Earlier in 2022, the Jammu and Kashmir Higher Education and School Education Department has said that the Uniform Academic Calendar shall be followed from academic year 2022-23–(KNO)

J&K Govt Orders Physical Verification Of Stores In R&B Department

JAMMU: The Jammu and Kashmir Public Works (R&B) Department has directed physical verification of all stores at the divisional level.

As per an order, Committees have been formed at the zonal level with the Chief Accounts Officer as Chairman, and Executive Engineer and Assistant Accounts Officer as members.

These committees will verify store records, assess the condition of items, and recommend disposal of surplus, obsolete, or unserviceable items within one month.

The process will be carried out under the supervision of the Chief Engineer, following GFR guidelines, and responsibility will be fixed in cases of loss due to negligence or fraud.

ngland head coach Brendon Mc-Cullum feels his players have lacked humility in their recent public utterances and he would like to see them win back respect from fans ahead of the tough home series against India and the Ashes later this year.

McCullum, while speaking to the media ahead of a lone Test against Zimbabwe starting Thursday in Nottingham, said the players need to be more attuned to public mood.

"It's not just about what you do on the cricket field. It's how you carry yourself. It's how you interact with the public. It's the messaging that you give," McCullum told the British media.

"The ability these guys have to be able to play on the biggest stage, under the brightest lights and the pressure that takes is one thing, but also the ability to be humble and show some humility and not feel out of touch with the general population is something I'd like to see us improve on."

England's players have drawn criticism for their seemingly nonchalant attitude towards on-field setbacks, the most recent being a winless Champions Trophy campaign in Pakistan. They were also lambasted by former batting star Kevin Pietersen for playing golf while skipping training during a poor limited-overs tour of India before the Champions Trophy.

England are playing a one-off Test against Zimbabwe at Trent Bridge before next month's marquee series at home against India and the away Ashes rubber in Australia.

McCullum's remarks come after comments made by some players dismissing criticism came under scrutiny, forcing England's director of cricket Rob Key to say that they need to "stop

"No, we don't obviously like being down here, but it's not a motivation. We wanted just a good performance. We're trying to string some performances together. The aim was two good performances (in last two matches).

"Now it'll be one good one to finish. It's probably fitting that we're at the bottom. We've played that type of cricket, so you can't hide away from it," Fleming said after the match.

The New Zealander said they know the road ahead and failure of top-order batters has played huge role in the ordinary run. "Our order is not right at this stage, and that is something that we are always looking to rejig. We've got some strong ideas for next year, so all those facets are covered. But that hasn't been possible this year because of the lack of runs at the top.

"A lot of the batting positions are determined by how well a start we have, and then guys can fall into line. We haven't had that. So we've been just patching innings up, really, rather than constructing good innings," he explained the reason behind the wretched run.

Pacer Anshul Kamboj has managed to impress this season with his pace and Fleming feels he will be a good asset for India after his selection in A side for the England tour.

"His speeds have been around 138, 139 (kph). He is deceptive and the ball always seems to hit the gloves harder. His big strength is his length and he just gets the ball to wobble. You saw that today on a reasonably flat wicket and he'll do well on that tour (of England) if he gets conditions that seam a bit and a little bit of swing.

"He'll be an absolute handful. He has got some real potential with both white and red ball. We're happy with his development and the opportunity he has taken this year."

ormer batting coach Vikram Rathour is expecting a tough England tour for a young Indian side that is now without three stalwarts, who left the Test arena in quick succession.

First it was veteran spinner Ravichandran Ashwin and then skipper Rohit Sharma and Virat Kohli too walked into the sunset, leaving a huge gap.

Shubman Gill will most likely be India's new Test skipper and will have a new-look top and middle order.

The five-match series will begin on June 20 at Leeds, marking the start of a new World Test Championship cycle.

"It's going to be a tough tour. It's not going to be an easy tour because the seniors have retired a lot. So, the young team is leaving. There could be a new captain. So, all these things will add a little bit of pressure," said Rathour, who spoke after Rajasthan Royals' win over Chennai Super Kings on Tuesday.

"But also it's an opportunity to showcase your talent and your ability."

Rathour, who shared a good rapport with all top Indian batters during his stint, said the fans must respect the decision taken by the senior players.

"All three of them were phenomenal cricketers who retired. So, I would have loved for them to carry on. But it's, again, a very, very personal decision. I'm close to all three of them. "So, you know, I would have, as I said, I would have loved to see them play more. But, again, it's a very, very personal decision, I think. And if they've taken this decision, we should respect that," he said.

Rathour, who is the batting coach of RR, was expectedly effusive in his praise for their find of the season, the 14-year-old Vaibhav Suryavanshi, who played a key role in the team signing off with a win against CSK.

Instead of an extravagant approach, he took some time and waited before unleashing his shots on Tuesday.

"We've been working with him for quite some time now, maybe three to four months now. We've seen all these aspects, but it's great to see when he's doing that in a game, in pressure situations, in a big game like even today. You're right, the ball was doing a bit when he went in, hardly got any balls, didn't get on strike too much in the power play," Rathour said.

"The kind of maturity he showed, the kind of temperament he showed, really good for him. And these kind of experiences will definitely make him a better player in coming time."

Rathour rued that despite having a strong batting unit at their disposal, they lost winnable games and also blamed poor fielding for their misery.

They managed to avoid last-place finish and believe that the worst is over.

"I don't think we fielded very well throughout the tournament. Bowling did let us down a few times where you let them score too many runs, 10, 15 extra runs mostly every game.
