JAMMU: Union Home Minister Amit Shah arrived here on Thursday evening on a two-day Jammu and Kashmir visit. According to the details available with the news agency-Kashmir News Observer(KNO)Shah would review J&K's security situation ahead of Amaranth Yatra, which is commencing from first week of July and reach out to shellinghit people in Poonch.

He would also meet personnel of Border Security Force (BSF) inb Poonch and "pat their backs" for thwarting the designs of the enemy, said an official.

This marks Amit Shah's first visit to the Union Territory since the launch of "Operation Sindoor' on May 7, a decisive military response to the April 22 Pahalgam terror attack that claimed 26 lives, mostly tourists.

Upon arrival, Shah was received

Pahalgam terror attackers intended to divide nation: PM Modi

"Terrorism, mass murders core operations of Pak Army"

ALIPURDUAR/NEW DELHI : Terming April 22 Pahalgam terror attack, which left 26 civilians dead, as assault on the soul of humanity, Prime Minister Narendra Modi on Thursday said that terrorists intended to divide the people of the country, but India stood united and fought with full determination to foil their nefarious designs.

Speaking at public rally in Alipurduar, West Bengal PM Modi, according to the news agency-Kashmir News Observer (KNO) said, "The attack was an attempt to tear apart India's social fabric and unity. In Pahalgam, terrorists did not just target India, they attacked the soul of humanity and brotherhood. They tried to divide Indians."

'They had the audacity to wipe away the Sindoor of our sisters, but our armed forces showed them the strength of that Sindoor," he added.

Referring to the pain and outrage the attack triggered across the country, the Prime Minister said that West Bengal, too, felt deep anger and grief. "I could see the anger in Bengal. I could feel it. I am here to say, on behalf of 140 crore Indians, that Operation Sindoor is not yet over," he said.

PM Modi said India had responded to Pakistan and the terrorists with a strong and direct answer. "We have given a decisive response" he said. "We didn't just retaliate, we entered their territory



and destroyed terror infrastructure they never thought could be touched."He said that Pakistan's frustration was evident and that India had already struck it three times on its own soil. While the Prime Minister did not name specific missions, his remarks were widely interpreted as a reference to the 2016 surgical strikes, the 2019 Balakot airstrikes, and the recent cross-border operations that were a part of Operation Sindoor."Our army went into their home and struck. We have destroyed their airbases, their terror camps, and sent a message they will never forget," PM Modi said.

Centre Sanctions 581 CAPF Companies For Amarnath Yatra

NEW DELHI: The Centre has ordered deployment of a total 581 companies, comprising about 42,000 on-ground personnel, of the Central Armed Police Forces (CAPFs) for the annual Amarnath

Yatra in Jammu and Kashmir, official sources said on Thursday. While 424 companies are being sent to the

Union Territory (UT), the rest, including about 80 companies that moved to the UT during Operation Sindoor, will be "relocated" to secure the yatra route, the pilgrims and other areas, including Srinagar, they said.

The Union home ministry, officials said, has directed that these forces move "immediately" and take position in Jammu and Kashmir by the second week of June.

The Amarnath Yatra will begin on July 3 and

end on August 9. The security deployment plan for the pilgrimage is being prepared keeping in mind the challenges emerging from the April 22 Pahalgam terrorist attack in which 26 persons. mostly tourists, were killed, they said. "The Union home ministry has decided to deploy

a total of 581 CAPF companies for the Amarnath Yatra this time. This includes about 150-160 units already present in the UT," a senior officer said. The companies are drawn from five CAPFs of

CRPF, BSF, CISF, ITBP and SSB. Each of these companies have an operational strength of about 70-75 personnel, he said.

The maximum units out of the 581 are drawn from the Central Reserve Police Force (219 companies) Border Security Force (9143), Sashastra Seema Bal (97), Indo-Tibetan Border Police (62) and Central Industrial Security Force (60), the officer said. Union Home Minister Amit Shah will also review

the security arrangements during his proposed visit to Jammu on Thursday.

CRPF Director General (DG) Gyanendra Pratap Singh had reviewed the preparations for the Amarnath Yatra over the week when he was in Kashmir.

NEW DELHI: Chief of Defence Staff (CDS) General Anil Chauhan will be on a three-day official visit to Singapore from May 30 to June 1, 2025, to participate in the 22nd Shangri-La Dialogue, the Ministry

Hosted annually by the International Institute for Strategic Studies (IISS), the Shangri-La Dialogue is regarded as Asia's premier defence and security summit. This year's edition will convene defence ministers, military chiefs, policy makers, and strategic thinkers from around the world to address regional security challenges, particularly in the Indo-Pacific.

During the summit, General Chauhan is scheduled to engage in a series of bilateral meetings with

his counterparts and senior military leadership from a wide spectrum of nations including Australia, the European Union, France, Germany, Indonesia, Japan, the Netherlands, New Zealand, the Philippines, Singapore, the United Kingdom and the United States.

"These engagements will provide a platform to strengthen defence cooperation, discuss mutual security interests and enhance India's strategic partnerships in the Indo-Pacific region," the Ministry of Defence said in a press release.

In addition to high-level military engagements, General Chauhan will deliver a keynote address to academics, strategic think

New COVID-19 Wave Kashmir reports first two cases

SRINAGAR: Kashmir has reported its first COVID-19 cases in the current wave, with two female MDS students from Government DentalCollege(GDC)Srinagartesting positive for the virus. Health officials, however, have assured the public that the current strain is behaving mildly and does not pose a serious threat.

The two students, both dentists and residents of Kerala, had recently returned to Srinagar after visiting their hometowns. Upon feeling unwell, they were advised to undergo testing at the Government Medical College(GMC)Srinagar, where they tested positive for COVID-19.

"They have been isolated as per the protocol," a health official said, adding that both are asymptomatic or experiencing only mild symptoms and do not require hospitalisation. Professor (Dr) Sandeep Kour

Bali, Principal of GDC Srinagar, told



Observer (KNO) that the students are isolated in the college hostel, with a separate washroom facility arranged for them.

She said all staff and students at the college have already received both doses of the COVID-19 vaccine, including the booster shot. "There is no need to panic. COVID-19, in its current form, is manifesting as a mild infection in many parts of the country and around the world," she added.

Dr Bali said one student is experiencing mild symptoms while

No funds diverted from other departments for Ladki Bahin, read budget rules: Fadnavis

PARBHANI: Maharashtra Chief Minister Devendra Fadnavis on Thursday clarified no funds have been diverted from other departments for the government's flagship scheme for women Ladki Bahin and said those who do not understand budget are making unsubstantiated claims.

Money disbursed for the scheme, which under eligible poor women get a monthly stipend of Rs 1,500, through Tribal Affairs and Social Justice Departments was as per budgetary norms, he insisted.

Talking to reporters here in central Maharashtra, Fadnavis explained budgetary rules stipulate funds should be reserved for Scheduled Castes (SCs) and Scheduled Tribes (STs). Maximum funds should be earmarked for personal benefit schemes and some kept aside for infrastructure development.

"The charges (by opposition that funds were diverted from other departments for Ladki Bahin Yojana) are wrong. Only those who don't understand the budget can make such a charge. Rules say funds should be reserved for SCs/STs. Maximum



funds should be reserved for personal benefit schemes and some for infrastructure who holds the finance portfolio, has already development.

"Ladki Bahin Yojana falls under the category of giving personal benefit to beneficiaries. So, if you give money to this scheme, then as per budgetary rules, it has to be shown under the Tribal Affairs Department and the Social Justice Department," the CM stated.

NAGPUR : Police in Maharashtra's Nagpur have brought back the city-based woman, who crossed over to Pakistan from Kargil earlier this month before being repatriated by the neighbouring country, officials said.

The woman, Sunita Jamgade (43), was brought to Nagpur late Wednesday night, following which she was formally placed under arrest. She was then produced before a special court during the intervening night and was remanded in police

CBI Busts 2 Illegal Call Centres, Arrests 6 For Scamming Japanese Citizens

NEW DELHI: The CBI arrested six people and dismantled two illegal call centres for allegedly cheating Japanese citizens using tech support scams, officials said Thursday.

After registering the case as part of its crackdown on cybercriminals in Operation Chakra V, the Central Bureau of Investigation (CBI) worked closely with the Japan National Police Agency and Microsoft to identify the syndicate members and their locations. "This collaborative international engagement

proved critical in identifying the perpetrators and tracing the operational structure of the syndicates, ultimately leading to the successful crackdown in India," the CBI said in a statement. Once the locations were identified, the CBI

teams swooped down on 19 locations in Delhi, Haryana and Uttar Pradesh on Wednesday during which six alleged gang members were arrested and two illegal call centres were dismantled.

The arrested were identified as Ashu Singh from Delhi, Kapil Ghakhar from Panipat, Rohit Maurya from Ayodhya, Shubham Jaiswal, Vivek Raj and Adarsh Kumar from Varanasi.

Azam said the country depends heavily on water from glaciers for agriculture and electricity generation.

At present, there is more water because of warming-driven glacier melt, but there is a threshold beyond which glaciers will start contributing less

Land-for-jobs 'scam': Former rail minister Lalu Prasad moves Delhi to quash CBI FIR

NEW DELHI: Former rail minister Lalu Prasad on Thursday sought in the Delhi High Court the quashing of the FIR filed by the CBI in the land-for-jobs "scam". Senior advocate Kapil Sibal appeared in the court on behalf of the Rashtriya Janata Dal (RJD) supremo and argued that the enquiry and the FIR as well as the investigation and the subsequent chargesheets in the matter could not be legally sustained as the Central Bureau of Investigation (CBI) had failed to obtain prior sanction under section 17A of the Prevention of Corruption Act.

The sanction under section 17A is a mandatory requirement of law to launch any enquiry or investigation against a public servant, he said.

Submitting that the trial court is slated to hear arguments on charge on June 2, Sibal urged the court to pass directions to defer the same.

He said even after an initial closure report, the FIR was registered by the CBI in 2022 for offences allegedly committed from 2004 to 2009 and the trial court took cognisance and "merged" three chargesheets on February 25.

"What will I do if the charge is framed? Please wait for a month. We will argue the matter. For 14 years, you have waited (to register the FIR). This is only mala fide," Sibal submitted.

Justice Ravinder Dudeja heard Sibal as well as senior advocate D P Singh, who appeared in the court for the CBI, and said he

would pass an order. Singh opposed the petition and said the necessary sanction under section 19 of the anti-graft law has been obtained.

HONG KONG: Chinese students studying in the US are scrambling to figure out their futures after US Secretary of State Marco Rubio announced Wednesday that some students would have their visas revoked.

The US will begin revoking the visas of some Chinese students, including those studying in "critical fields", and those with connections to the Chinese Communist Party," according to the announcement.

China is the second-largest country of origin for international students in the United States, behind only India. In the 2023-2024 school year, more than 270,000 international students were from China, making up roughly a quarter of all foreign students in the US.

This is a "new version of Chinese Exclusion Act," said Lingin, a Chinese student at Johns Hopkins University, who asked to be identified only by his first name out of fear of retaliation. He said Wednesday was the first time he thought about leaving the US after spending one third of his life here.

Chinese international students are point of tension between US and China

The issue of Chinese students studying overseas has long been a point of tension in the bilateral relationship. During Trump's first term, in 2019, China's Ministry of Education warned students about visa issues in the US, with rising rejection rates and shortening



Court Warns ACR Bandipora of Jail for 'Wilful Contempt'

Slams Admin for Years of Delay in Rs 8.4 Lakh Land Compensation

BANDIPORA: A local court in Bandipora has put Assistant Commissioner Revenue (ACR), Bandipora on notice for alleged wilful and deliberate disobedience of court orders in a longpending land compensation case.

Court has asked ACR to explain he should not be sent to jail for defying court orders and also directed his Drawing and Disbursing Officer (DDO) to withhold ACR's monthly salary until further orders.

The direction was passed by Civil Judge (Senior Division) Bandipora, Igbal Ahmad Akhoon, in the execution proceedings titled Mohammad Jamal Teli Vs State & Others, where the decree holder, Mohammad Jamal Teli of Pazalpora Mantrigam, is yet to receive compensation despite a court decree passed in his favour in 2019.

Petitioner in 2011 approached court alleging that the department of health took possession of his land measuring 8 marlas for construction of health centre at Mantrigam but had not paid the compensation. Court in 2019 directed the government to pay the land compensation to the petitioner. However the CMO Bandipora and District administration kept on passing the buck to each other and failed to pay the compensation forcing the petitioner to approach court again in 2019.

Taking serious note of the continued noncompliance, the court has directed the ACR

Bandipora to appear in person and explain why compensation for the land acquired from the he should not be committed to civil prison for contempt of court.

"The conduct of the Collector Land Acquisition and other judgment debtors reflects a wilful and deliberate disobedience of the orders passed by this Court, amounting to contumacious behaviour, which cannot be tolerated by a court of law," the court observed.

As per the records, an amount of Rs 8.40 lakh had been secured by the Health Department as

ed the Collector to disburse the amount to Teli, including clear instructions issued on November 30, 2024, and again on March 15, 2025. However, the decree holder submitted that the amount continues to be unlawfully retained in official accounts despite the decree having attained finality over five years ago.

What further agitated the court was the rev-

elation that although the compensation was deposited in the Collector's account as early as December 2024, it had not been released to the rightful recipient till date. Instead, the court was informed that the amount was instead transferred back to the Chief Medical Officer, Bandipora, against the court's express instructions.

"This Court is constrained to take coercive measures under the provisions of Order 21 of the CPC," Judge Iqbal Ahmad Akhoon ruled, issuing a notice under Order XXI Rule 37 CPC to the ACR Bandipora, calling upon him to show cause why he should not be committed to civil prison.

The court also invoked Rule 48 of the CPC, directing the Drawing and Disbursing Officer (DDO) concerned to withhold the ACR's monthly salary until further orders. The withheld amount is to be deposited in the Nazir's account of the court and appropriated towards the decretal amount.

Copies of the order have been served to the Deputy Commissioner Bandipora, Collector Land Acquisition Bandipora (ACR Bandipora) and the DDO for immediate compliance.

ACR Bandipora has also been directed to appear in person on next day of hearing on June 2, 2025. Failure to comply with the latest order, the court warned, will invite further penal consequences, including proceedings under Section 151 of the Civil Procedure Code and the Contempt of Courts Act.

The ambitious programme is expected to yield around 3,000 quintals of seed potatoes in its first year, with production projected to scale up to 30,000 quintals in the second year. 

Eating Your Brother's Flesh: The Sin We Normalized

In an age driven by social media, gossip groups, and casual conversations, one of the gravest moral sins has quietly found a seat at our daily tables—backbiting. We speak of others in their absence under the illusion of sounding well-informed, intellectual, or morally of you like to eat the flesh of his dead brother? You would detest it!"This verse does not simply condemn backbiting—it evokes a haunting image of cannibalism, showing how vile and grotesque this act is in the eyes of God. This comparison is not metaphorical hyperbole; it is a wake-up call to understand the deep moral rot that backbiting represents. This Hadith unequivocally defines the boundary: even if what we say is true, if it would hurt the person in question, it is backbiting. And if it's false, it is an even greater sin—slander.

Yet despite these clear moral and religious boundaries, backbiting has become so normalized that it now masquerades as casual talk. In our living rooms,

Backbiting, known as ghibah in Islam, is more than a minor fault—it is a spiritual disease and a corrosive act that diminishes not just the subject, but more devastatingly, the speaker. The Holy Qur'an leaves no ambiguity about the seriousness of backbiting. In Surah Al-Hujurat (49:12), Allah warns: "Do not backbite one another. Would any Equally clear are the words of the Prophet Muhammad , who said, "Do you know what backbiting is?" They said, "Allah and His Messenger know best." He said, "It is to mention about your brother that he dislikes." Someone asked, "What if what I said about my brother is true?" The Prophet replied, "If what you said is true, you have backbitten him, and if it is not true, you have slandered him." (Sahih Muslim)

offices, markets, and digital groups, conversations routinely revolve around dissecting others' lives, mocking their choices, exposing their weaknesses, and sharing their personal matters—all without their presence or consent.

The damage, however, is not just social. Backbiting is a corrosive act that hardens the heart and pollutes the soul. It creates an illusion of superiority while planting the seeds of hypocrisy. A person who indulges in it may temporarily gain attention or admiration, but in time, their credibility erodes. People begin to notice the pattern and wonder: if this is what they say about others, what must they say about me?

Even worse, backbiting is spiritually self-destructive. Islamic teachings state that on the Day of Judgment, when a person opens their book of deeds, they may find their good actions missing. Shocked, they will learn that those deeds were transferred to the very individuals they spoke against. It's a divine justice that reflects not only the weight of our words but also the sanctity of another's honor.

True character lies not in exposing others, but in protecting them. A person of integrity does not exploit someone's flaws for conversation or criticism. Instead, they cover those flaws, offer support in times of difficulty, and pray for others in their absence. Such individuals rise in both the sight of people and the sight of God.

Moreover, we must be conscious of the moral legacy we are leaving for our children. When children grow up in environments where mocking, ridiculing, or discussing others is normalized, they begin to mirror these behaviors. We must teach them that to honor someone's dignity—even when they're not around—is the true measure of strength and civility. We must demonstrate through our own example that respecting others' reputations is a non-negotiable virtue.

Change begins at the most basic level—our words. Let us be mindful that every sentence we utter either adds light or spreads darkness. Our tongues have the power to either build or break, to elevate or humiliate, to purify or poison.

In conclusion, backbiting is a quiet epidemic of character erosion that we can no longer afford to ignore. It masquerades as harmless conversation but ultimately leads to spiritual decay, fractured relationships, and social mistrust. Let us remember that true power lies not in how sharply we speak of others, but in how compassionately we protect their honor. Let us strive to be people who speak with wisdom, act with integrity, and remember that silence, when it guards someone's dignity, is a sign of strength—not weakness. The next time you're tempted to talk about

someone behind their back, ask yourself: Would I eat my brother's flesh? If the answer repulses you—as it should—then choose silence, and save your soul.



However, while wealth disparity was evident, the absence of industrial and financial innovations meant that economic inequality



systems and the political ideologies that have shaped societies. Throughout history, wealth has been a central factor in determining power, social status, and access to opportunities. From the agrarian economies of ancient civilizations to the capitalist structures of the modern global economy, wealth inequality has remained an ever-present issue, though its intensity and scope have fluctuated. At its core, the distribution of wealth is not merely an economic issue; it is deeply entwined with the philosophical, moral, and ethical questions of justice, fairness, and human potential. The historical trajectory of wealth inequality illuminates the multifaceted forces that have perpetuated the divide between the rich and the poor, remained relatively stable within those rigid structures. This paradigm began to shift dramatically with the onset of the Industrial Revolution in the 18th century.

The Industrial Revolution fundamentally altered the landscape of wealth inequality, creating a new class of wealthy industrial magnates who gained vast fortunes through the exploitation of labor and natural resources. The rapid advancement of manufacturing technologies and the birth of largescale industry fundamentally reshaped society, driving mass urbanization, the rise of capitalism, and the accumulation of wealth on a scale previously unseen. While this era catalyzed economic development, it also intensified the divide between factory workers and the urban poor. This period underscored how economic systems, while spurring progress, can also magnify inequality when wealth becomes concentrated in the hands of a few.

The twentieth century was marked by significant upheavals and a response to these stark disparities, especially in the wake of the Great Depression and the two World Wars. The first half of the century saw the implementation of progressive policies aimed at curbing the extremes of wealth inequality. In the United States, for example, the New Deal era brought about social safety nets, labor protections, and progressive taxation policies that sought to redistribute wealth and enhance economic mobility. The post-World War II economic boom, accompanied by welfare state expansions in Europe and North America, resulted in the rise of the middle class and a temporary reduction in wealth inequality. The growth of the global economy in the mid-20th century coincided with efforts to rebuild nations, regulate markets, and provide basic services to populations. This period saw a significant shift toward social democracy in many nations, as the costs of inequality and social unrest became increasingly evident.

However, this relatively equitable period began to unravel in the late 20th century. The neoliberal economic policies of the 1980s, with their emphasis on free-market capitalism, deregulation, and tax cuts for the wealthy, laid the foundation for the growing wealth inequality observed today. Globalization, technological advancements, and financialization of economies facilitated the accumulation of wealth at the top, leaving the majority of people with stagnant wages and diminishing opportunities. The consequences of this trend are now widely recognized: extreme wealth concentration contributes to the destabilization of democracies, the erosion of social safety nets, and the creation of systems that perpetuate inequality.

Recent reports highlight that wealth inequality has reached levels that mirror, if not exceed, those of earlier historical periods, even during the Gilded Age in the United States. The richest 1% now control a disproportionately large share of the world's wealth, with the top 10% of the global population holding over half of all income. In stark contrast, the bottom 50% of the global population holds only a small fraction of total wealth. This concentration of wealth has wide-ranging implications, from social unrest and political polarization to diminished economic growth and limited opportunities for upward mobility. It challenges the very notion of meritocracy, as opportunities for success become increasingly determined by inherited wealth rather than individual ability or effort.

In the context of developing nations, wealth inequality is exacerbated by historical legacies of colonialism, exploitation, and underdevelopment. Many of these nations struggle

to address these challenges. Calls for redistributive policies, fair trade practices, and debt relief have gained momentum as solutions to the systemic inequality perpetuated by historical and contemporary power imbalances.

Despite the alarming rise in wealth inequality, there are signs that the conversation is shifting toward solutions. In recent years, scholars, activists, and policymakers have begun to advocate for transformative economic models that prioritize sustainable development, social justice, and equitable growth. Progressive taxation, universal basic income, affordable healthcare and education, and labor rights are among the policy proposals aimed at addressing the structural roots of inequality. There is also a growing recognition that addressing wealth inequality is not just a matter of economics but of moral and ethical responsibility, as the widening gap between the rich and the poor undermines social cohesion, stifles human potential, and erodes democratic values.

As we look toward the future, the growing concentration of wealth in the hands of a few presents a critical challenge to global equity and social stability. The late 20th and early 21st centuries have witnessed a stark resurgence in inequality, with the richest segments of the population accumulating unprecedented wealth, while large swathes of the global population remain mired in poverty. According to recent studies, the richest 1% now control over 40% of global wealth, while the poorest 50% hold only 2%. This increasing disparity is not only an economic concern but also a profound societal issue, contributing to political polarization, undermining democratic institutions, and eroding social trust. Addressing wealth inequality requires a comprehensive, multifaceted approach that combines policy innovation, social justice, and a deep commitment to redistributing resources more equitably. Solutions such as progressive taxation, universal social programs, and labor reforms have been proposed, but systemic changes will require a shift in global values towards a more just and inclusive society. Ultimately, the challenge of wealth inequality remains one of the most pressing moral and political questions of our time, calling for urgent attention to ensure a more equitable distribution of wealth that fosters social cohesion, economic stability, and human dignity. Through a combination of historical reflection and forward-thinking solutions, humanity can seek to address the systemic roots of inequality and build a future where wealth is more justly shared, benefiting all individuals, regardless of their socio-economic background.



Reimagining Muslim Women's Role in Social Transformation





Muslim Women aren't organized even though a few of them may rise to the highest public posts. Their awareness about their own problems is so little. They are divided against one another even in the space of extended families. Even in small families it is women against women that is the rule. Mothers against daughters in law and the later against sisters in law and similar tangles are running domestic peace. It is rare to find a happy daughter in law. Women in Mohalla or larger levels aren't united. Women aren't educated in the skills of life. Muslim women teachers who are better educated are most pathological consumers spending their resources on such things as clothes, marriages and houses. Muslim women haven't, in general, understood the wisdom of saving and investing or creating wealth. As such they can be classified as poor despite possessing money. Consuming time away in gossiping or plotting against one another, vast number of Muslim women don't seem to know what to do with time especially as various works done in homes for livelihood have disappeared. Muslim women pass-outs from women madrasahs haven't, in general, been able to be of great service to themselves or to community. The virtue of work hasn't been learnt at mass scale by any group of Muslim women. Work and industry haven't been the focus of Muslim women. As such they fail to be great productive force of economy. How do we address this problem is important and its redressal would do a great good do the lives to Muslim women.

Democracy or current political order is premised on the thesis that divergent ideological currents can coexist and work together for common ends and accept the fact of difference without letting it divide unity. Communicative dialogue and ijma of elected representatives coupled with recognition of different legal positions as equally legitimate in certain areas where common stakes/interests aren't hurt as an instrument of consensus could be deployed to resolve certain nagging areas of conflict in the Muslim societies. Women representatives in Parliments need to be proactive in creating consensus on number of issues for implementing justice to women. Universal access to gender justice through special family courts for which some reputed members of civil society could be co-opted as well could be one option. Democracy at grassroots or more radical approaches to democracy could be deployed for evolving consensus and mobilizing resources to achieve needful on concrete problems faced by women.

Let us begin at the beginning. Muslim women begin organizing. Every woman must be connected to a self help group, a credit cooperative, a cooperative society, a community network that would facilitate access to as many services as possible or marketing for the product she is making. Units of fifty to hundred women would help resolve key issues besides providing fellowship or companionship and sharing of certain spaces that give meaning or fulfillment in life. Huge number of psycho-somatic cases – heath in general is largely in ruins for most women as we can see most are dependent on daily dose of number of medicines and once one day per day that Islam enjoins on all.

Resolving economic problems is easy – linking women to professional charity collection and spending platforms and to interest free credit cooperatives and tying them with small local investors who have savings for local businesses they can monitor. Panchayats and local NGOs could chip in here as could local bait al-amwal. Mosque or Mohalla management committees could help execute creation of linkages and associations for access to number of services. As such it is the task of Muslim scholarship to identify and resist every form of oppression and we need to recall tyat the last sermon of the Prophet emphasized about treating women well and kindness to them and his last words included a clause "Look after the women." Muslim scholarship on women should eternally question every power structure that contravenes justice even though it masquerades as tradition or faith. The rationalist streak in Islamic theology of Mu'tazilites, also called ahl al adl wal tawhid, had ample warrant to extol justice as the heart of Islamic idea of Divine. Units of fifty to hundred women can help resolve key issues, provide companionship, and share meaningful spaces in life."

Let women organize women to supply materials for needs for State/ community events. Let women operate hotels and restaurants and many other facilities for women and we will see no woman is underpaid or idle in home. We can organize the poor and needy and they will themselves able to solve their problems. Local Imams and baitul amwal could as well be held accountable for resources they extract from community for helping the poor and needy. It is not hard to collect 9 crore on daily basis for interest free loans or one time aid to the poor and needy from sadaqa of

Post Operation

(CRPF), Intelligence Bureau (IB), and civil administration are participating in the meeting," an official told KNO.

"The meeting will focus on the ongoing 'Operation Sindoor,' counter-terrorism measures, the antiinfiltration grid, and preparations for the upcoming Amarnath Yatra."

On May 30, the Union Home Minister will travel to Poonch district, which bore the brunt of Pakistan's retaliatory shelling between May 7 and 10.

The shelling led to the loss of lives and also damaged nearly 2,000 structures, including residential homes, commercial buildings, and religious sites such as the Singh Sabha Gurdwara.

During his visit to Poonch, the Home Minister will meet families affected by the Pakistan shelling at Dak Bungalow, distribute appointment letters to the next of kin of those killed, and assess the damage to religious sites.

He will also visit a BSF camp at Khanetar, approximately nine kilometers from Poonch town, to interact with jawans and review border security preparedness.

The visit follows Shah's earlier trips to Jammu and Kashmir on April 6 and April 22, the latter in response to the Pahalgam terror attack.

During his April 23 visit to Baisaran meadows, the site of the terror attack, Shah assessed the situation, paid tributes to the victims, and assured their families of the government's support.

Operation Sindoor, launched on May 7, targeted nine terrorist camps in Pakistan and Pakistan-occupied Kashmir(PoK) in retaliation for the Pahalgam attack.

Security has been significantly bolstered across Jammu and Poonch for the Home Minister's visit, with additional checkpoints and personnel deployed to ensure safety.

The government has already disbursed Rs 6 lakh from the MHA and Rs 10 lakh from the UT Government as ex gratia relief to the families of those killed in the shelling, though calls for increased compensation for property damage persist.

The Home Minister's visit is expected to address both immediate security concerns and long-term strategies to strengthen border management and counter-terrorism efforts in Jammu and Kashmir. Shah is scheduled to return to Delhi on Friday evening after concluding his engagements in Poonch. (KNO)

Security beefed

Security has been beefed up in Jammu and Poonch districts in view of the home minister's visit, officials said.

Additional security personnel have been deployed around the Raj Bhawan, where Shah will hold a high-level security meeting, they said.

In Poonch, hectic checking of vehicles and frisking of people is taking place, they said, adding that checkpoints have been set up at entry and exit points to keep a vigil on the movement of vehicles.

Ahead of Union Home Minister Amit Shah's visit to Poonch, Director General of the Border Security Force (BSF) Daljit Singh Chawdhary on Thursday visited shelling-hit areas of the district and reviewed the prevailing security situation.

Delhi Forest Minister Manjinder Singh on Thursday visited the border town to reach out to people affected by Pakistani shelling and oversaw the arrangements.

After an overnight stay in Jammu, Shah will fly to Poonch on Friday and interact with shelling-hit

Operation Sindoor was a military action launched by India in response to the April 22 terror attack in Pahalgam. New Delhi blames Pakistan-based terrorist groups. The operation started on May 7 and concluded on May 10 after both sides agreed to halt military actions.

The US government, however, claimed in court that Trump's use of trade incentives played a key role in easing tensions. US Secretary of Commerce Howard W. Lutnick, in a sworn declaration, defended the use of tariffs under the International Emergency Economic Powers Act (IEEPA), a law that allows the president to impose economic restrictions during national emergencies, The Financial Express reported. Lutnick argued that such tools can influence the actions of foreign governments and cited the India-Pakistan situation as an example. Lutnick stated that a ruling against the government in the tariffs case "would have ripple effects across every domain in which economic instruments are used for strategic effect," adding that the Trump administration's offer of trade access helped halt a "potentially devastating war" between India and Pakistan.

The legal filing is part of a broader case in which small businesses are challenging Trump's tariff decisions, arguing that he exceeded his legal authority.

India has consistently maintained that there was no foreign mediation in the decision to halt Operation Sindoor. The government insists that the ceasefire understanding was reached through direct military-level communication between India and Pakistan.

This is not the first time the Trump administration has claimed credit for defusing tensions between the two South Asian neighbours. However, this is the first instance such a claim has appeared in an official US court filing, rather than a public statement or social media post. Indian officials have reiterated that New Delhi rejects any suggestion of external involvement in its military decisions or diplomacy with Pakistan. (ANI)

Day not far

The Defence Minister added that terrorism has lost its relevance as a geopolitical tool and that countries nurturing it now face international and internal consequences.

"Running the business of terrorism is not costeffective. Pakistan has realised that it has to pay a heavy price for it," he said.

Singh also clarified India's position on future talks with Pakistan, saying, "Now, whenever there will be talks, it will only be on terrorism and PoK."

He said India remains committed to the vision of "Ek Bharat, Shreshtha Bharat", One India, Great India, and that PoK's eventual return is part of that national aspiration.

According to him, the emotional, cultural, and historical links between the people of PoK and the rest of India cannot be erased by political borders.

Turning to India's growing capabilities in defence, Singh said the country has transformed significantly over the last decade. India's defence exports, which were below 1,000 crore ten years ago, have now crossed 23,500 crore.

He said this development reflects not only growing technological capacity but also a shift in India's global image. He said that 'Operation Sindoor' demonstrated India's indigenous defence strength. "During Operation Sindoor, the country saw how our own systems performed on the ground. We destroyed terrorist hideouts, enemy airbases and military positions. We could have done more, but we showed a balance of power and restraint," he said. Singh said India is not only manufacturing traditional military equipment like fighter jets and missile systems but is also developing technologies for next-generation warfare. "We are preparing for next-generation warfare," he added (KNO)

Centre notifies ESZ around Tral wildlife sanctuary

SRINAGAR: The Union Ministry of Environment, Forest and Climate Change has notified an eco-sensitive zone (ESZ) around Tral Wildlife sanctuary.

In a notification, the Union Ministry notified that an area to an extent of zero to 3.26 kilometers from the boundary of Tral Wildlife Sanctuary as its ESZ.

"The extent of the eco-sensitive zone around the Tral Wildlife Sanctuary ranges from 0 kilometer to 3.26 kilometer from its boundary, encompassing an area of 127.10 square kilometers, which includes 26 villages," reads the notification.

Historically-parts of the protected area, namely Shikargah and Khangund, previously designated as Conservation Reserves- have the distinction of being among the oldest notified protected areas in the country. Their notification dates back to 1945, when they were governed by the game laws of the Maharajah of the erstwhile princely state of Jammu and Kashmir.

In 2019, these conservation reserves, along with the adjoining areas comprising territorial forest compartments, were upgraded to a Wildlife Sanctuary.

The sanctuary came into existence on October 23, 2019 through a notification issued by J&K government. The Tral Wildlife Sanctuary forms an important

corridor for the movement of Hangul. "The declaration of the eco-sensitive zone shall

help in creating a buffer around the sanctuary area leading to a secure, suitable and viable habitat for the last remnant Hangul population," reads the notification

The Sanctuary is among the few areas outside Dachigam National Park where critically endangered Kashmiri Red Deer (Hangul), a Schedule I species as per the Wildlife (Protection) Act, 1972, and designated as 'critically endangered' in the International Union for Conservation of Nature (IUCN) Red Data Book, still survives.

It is also home to other endemic species like Kashmir Musk Deer (Moschus cupreus) and Kashmir Gray Langur (Semnopithecus ajax).

Historic first: Maiden batch of 17 female cadets graduates from NDA; Passing Out Parade on May 30

PUNE: Marking a historic moment for women in Indian armed forces, the first batch of 17 female cadets graduated from the National Defence Academy (NDA) here on Thursday and were conferred degrees along with more than 300 male cadets.

The convocation ceremony of 148th NDA course was held at the academy, widely known as the "cradle of leadership", which provides officers to the Indian Army, Navy and Air Force.

NDA Commandant Vice Admiral Gurcharan Singh hailed the graduation of the maiden batch of female cadets and expressed hope that they will carve out names for themselves as exemplary leaders.

A total of 339 cadets, including the female cadets, were conferred degrees from the Delhi-based Jawaharlal Nehru University (JNU). Of them, 84 cadets were awarded with the BSc degree, 85 with Computer Science degree, 59 with Bachelor of Arts (BA) degree and 111 with BTech degree.

Prof Poonam Tandon, Vice Chancellor of the Deen Dayal Upadhyaya Gorakhpur University, who was the chief guest at the event, said, "... I have been informed that over the decade, the NDA has produced more than 40,000 officers who went on to bring glory to India, both in times of war and in peace. Govt Doctor Heard In Audio Clip Telling Colleague To 'Kill' Covid-19 Patient; FIR Lodged

LATUR: Police have registered an FIR against a senior doctor of a government hospital in Maharashtra's Latur district for allegedly instructing a colleague to "kill" a COVID-19 patient during the pandemic in 2021, officials said on Thursday.An audio clip recently surfaced on social media of the purported conversation between the accused, Dr Shashikant Deshpande, who was then additional district surgeon at the Udgir Government Hospital in Latur, and Dr Shashikant Dange, who was posted at a COVID-19 care centre. The clip, now widely circulated on social media, is purportedly of the time during the COVID-19 crisis peak in 2021 when hospitals were crowded with patients and resources were scarce. The patient, Kausar Fatima, wife of Dayami Ajimoddin Gaussoddin (53), had later recovered from the disease. In the conversation, Dr Deshpande is allegedly heard saying: "Don't allow anyone to go inside, just kill that Dayami woman."To this, Dr Dange responds cautiously, noting that oxygen support had already been reduced. Based on a complaint by Gaussoddin, the Udgir city police registered a case against Deshpande on May 24 under legal provisions for deliberate and malicious acts intended to outrage religious feelings and other offences.

Digestive health refers to the proper functioning of the gastrointestinal (GI) tract, which includes the stomach, intestines, and associated organs. A wellfunctioning digestive system ensures the body absorbs essential nutrients and eliminates waste efficiently.

"Digestive health is not just about avoiding bloating or constipation," doctors said. "It is deeply connected to immunity, mental health, energy, and even skin health. The gut houses nearly 70% of the immune system and a vast community of microorganisms known as the gut microbiome, which influences everything from mood to metabolism."

mong the title favourites but battling a loss of momentum, Shubman Gill's Gujarat Titans will be up against the mighty Mumbai Indians, who also have issues to be addressed, in the winner-takes-all IPL Eliminator here on Friday.

It is a knock-out game but both sides are used to the stage with Mumbai Indians being the five-time champions. Titans have made the play-offs thrice in the last four seasons, including the trophy-winning run on their debut in 2022.

Kusal Mendis has been roped in as Buttler's place but it remains to be seen if he can inspire the same level of confidence.

Jamie Overton returns to Adelaide **Strikers in the BBL**

ngland allrounder Jamie Overton will return to the BBL next season after Adelaide Strikers secured him as an international pre-signing ahead of the upcoming overseas draft.

Overton has played 18 matches for Strikers over the last two seasons after being initially drafted to them in 2023 and was the Strikers' MVP last season.

The BBL introduced a new rule prior to last season which allowed for one overseas player to be pre-signed ahead of the draft. That player must be available for the entire season plus the finals under league rules to mitigate against the mass exodus of overseas players in the latter stages of the BBL to other leagues in late January.

Overton has taken 27 wickets in 18 matches at an economy rate of 8.81 and has been an excellent finisher with the bat scoring 276 runs at 69 with a strike-rate of 150.81, including 32 not out off 14 in his last game against Sydney Sixers.

Strikers' coach Tim Paine was thrilled to lock in Overton ahead of the draft.

"Securing Jamie as a pre-draft signing was a top priority for us," Paine said. "His last two seasons with the Strikers have been outstanding, not just with his individual performances with both bat and ball, but also with his competitive spirit and energy he brings to the group.

"Jamie has such a big impact over the game, he can change the course of a match in just a few overs.'

Overton was excited to return to Adelaide for another BBL campaign.

"I'm absolutely thrilled to be coming back to Adelaide for another season," he said. "I've loved my time with the Strikers and the incredible support we get from the fans at Adelaide Oval. It's a fantastic Club with a great bunch of lads, and I'm determined to help us push for finals and ultimately, the BBL title in BBL | 15."

Overton's signing means Sydney Sixers are now the only BBL club without an overseas pre-signing. Colin Munro (Brisbane Heat), Chris Jordan (Hobart Hurricanes), Tim Seifert (Melbourne Renegades), Tom Curran (Melbourne Stars), Finn Allen (Perth Scorchers) and Sam Billings (Sydney Thunder) were all locked in on two-year deals ahead of last season.

Strikers will also have a slightly different looking squad next season. Free agents Brendan Doggett and Jake Weatherald have signed with Renegades and Hurricanes respectively but Jason Sangha has joined Strikers from Thunder following his success with South Australia in the last Sheffield Shield season. Strikers have picks No.2, 10, 23 and 26 in the BBL overseas draft which will be held on June 19.

"Digvesh Rathi is not my relative. He is not my friend. I don't know who he is. But I am saying ... You will scar a bowler so much that it will really affect him," Ashwin said on his YouTube channel. "But because nobody really cares about a bowler, so in front of crores of people, should we withdraw his appeal and insult him?"

The incident occurred in the 17th over of RCB's chase when Rathi took off the bails after observing that Jitesh had left the crease at the non-striker's end.

The replays showed that the batter was outside his crease, but the TV umpire deemed that Rathi had completed his delivery stride before effecting the run-out. While it all unfolded, Pant withdrew the appeal and received a hug from Jitesh. RCB went on to win the game by six wickets.

Ashwin, who has been a vocal supporter of running out batters at the non-striker's end, said Pant should have backed his bowler.

"Let me dive into the technicalities of this incident. Is Jitesh Sharma justified in being out if he stepped out of the crease before he (Rathi) got into the delivery stride? Yes, he is justified in being given out and the bowler is also welljustified," Ashwin said. "Digvesh Rathi landed at the front foot and Jitesh Sharma was inside the crease. So, in all technical possibilities, this

'he has crossed his delivery stride, the batsman is inside the crease, I have a decision, not out'.

"Now, till now, everything is fine. Bowler has hit, appealed, not out. It's just another day in the office. But what happened? After this, during the match, (the) commentators said, 'Rishabh Pant has withdrawn the appeal. What an amazing act of sportsmanship!'

"Come on, yaar. Let's grow out of this. I am asking one question. Think about it, Digvesh Rathi is your son. Whoever is watching this video, he is your son, and Digvesh Rathi's captain has criticised his decision in front of crores of people. It's actually gone over the board because, look, a captain's job is actually to back a player. Alright? A captain's job is to not make a bowler feel small.'

Ashwin suggested that Rathi was made to feel small and that he might never effect a run-out at the bowler's end again.

"We don't know if he [Pant] already spoke to them [LSG camp] or not," Ashwin said. "But let's stop this vilification of that youngster in front of crores and crores of people. Do we do that to anybody else? Why does a bowler look small? It is actually a humiliation.

"What happens is [that] a bowler feels so small that he will never do it and people will say in the comment section that he should not do it. Why? Why shouldn't he do it?'
