# **Bullets Will Be Answered** With Cannon Balls: PM Warns Pak

**BHOPAL:** Prime Minister Narendra Modi on Saturday said proxy wars by terrorists will not work and bullets will be answered with cannon balls, adding that 'sindoor' has become a symbol of valour following India's response to the Pahalgam terror attack.

He also described Operation Sindoor as the biggest and most successful antiterror operation in the country's history.

Speaking at the 'Lokmata Devi Ahilvabai Mahila Sashaktikaran Maha Sammelan' here on the occasion of the legendary queen's 300th birth anniversary, Modi said, "Through a decisive response, Bharat gave a message that proxy war by terrorists will not work. Bharat, a land of culture and values, sees sindoor as a symbol of women's power. Today, that same sindoor has become a symbol of our valour and resistance to terrorism." "If you fire bullets, then rest assured that they will be answered with cannon balls," Modi said.

"India is a country of culture and targets in Pakistan and Pakistan-Occupied



traditions, and sindoor is a symbol of women power in our tradition. Hanuman ji, who is immersed in Ram Bhakti, also sports sindoor. We offer sindoor in Shakti Puja. This sindoor has become a symbol of bravery," he said.

Earlier this month, Indian armed forces carried out missile strikes on nine terror

Kashmir under Operation Sindoor. The operation was conducted two weeks after the massacre of 26 civilians in Kashmir's Pahalgam.

Sindoor or the vermillion mark symbolises the marital status of Hindu women, and its use as the operation's name resonated powerfully in light of the April 22 Pahalgam massacre.

"In Pahalgam, terrorists not only shed the blood of Indians, but also attacked our culture. They tried to divide our society and the biggest thing is that they challenged the women power of India," Modi said. "This challenge has sounded the death

knell for terrorists and their handlers. Operation Sindoor is the biggest and most successful operation in the history of India against terrorists. While the Pakistan army could not even imagine, our army destroyed the terrorist hideouts," he added.

Talking about the Nari Shakti Vandan Adhiniyam, also known as the Women's Reservation Bill, which aims to reserve one-third of the total seats in the Lok Sabha and state legislative assemblies, the PM said, "This time, 75 women have become members of Parliament. Our effort is to increase this number." This is the spirit behind the Nari Shakti Vandan Adhiniyam. Women reservation in Parliament and state assemblies had remained pending

for a long time, but has been achieved now, he said. >>SEE ON P-7

# UN glaciers' meet "Pakistan violating IWT through terrorism"

NEW DELHI: India has said that Pakistan should stop blaming it for the breach of the Indus Water Treaty, as the unrelenting cross-border terrorism from its soil is interfering with the treaty's implementation.

Addressing the plenary session of the first UN conference on glaciers in Tajikistan's Dushanbe on Friday, Minister of State for Environment Kirti

Vardhan Singh said that Pakistan itself was violating the treaty through terrorism. "We are appalled at the attempt by Pakistan to misuse the forum and to bring in unwarranted

references to issues which do not fall within the purview of the forum. We strongly condemned such an attempt." he said.

Singh said it is an undeniable fact that there have been fundamental changes in circumstances since the Indus Waters Treaty was signed, which requires a reassessment of the treaty's obligations.

These changes include technological advancements, demographic changes, climate change and the ongoing threat of cross-border terrorism, he said. The minister said that the treaty's preamble states it was



### 'When Will PM Break His Silence?' **Congress On Trump's Truce Claims**



**NEW DELHI:** The Congress on Saturday wondered when Prime Minister Narendra Modi would respond to US President Donald Trump, who has repeatedly given more than an indication that it was he who brokered a truce between India and Pakistan during the latest armed conflict.

In a series of posts on X, Congress general secretary Jairam Ramesh tagged a video clip of Trump to say this is the 11th time in 21 days that

Modi's "great friend" claimed he had a role to play in the ceasefire between the two neighbours. 'When will the PM speak up?" he asked.

Mr. Ramesh earlier said, "This is the 9th time in 20 days, across 3 countries and 3 cities. Donaldbhai keeps repeating the same sequence of events of how he got the 4-Day India-Pakistan war to stop - US intervention and the use of the trade instrument to stop nuclear escalation. The equivalence of India and Pakistan gets reiterated yet again." Mr. Trump's Commerce Secretary made exactly the same claims in his submission to the New York-based Court of International Trade on May 23, the Congress leader said.

"But Donaldbhai's friend Mr. Narendra Modi continues to ignore his claims with absolute silence. Why doesn't the PM speak up? "Is President Trump also doing what Mr. Modi does all the time and so well (i.e., lying)? Or is he speaking even 50% truth?" Mr. Ramesh said.

The Congress has been urging the government to clarify Mr. Trump's claims and object to his hyphenation of India and Pakistan.

The government has maintained that issues between India and Pakistan will be resolved bilaterally and without any third-party intervention.



An official spokesperson of the company said the project, valued at an estimated 1,807.46 crore, is part of an Inter-State Transmission System (ISTS) initiative developed through the Tariff-Based Competitive Bidding (TBCB) route. Adani Energy Solutions Limited was selected as the Transmission Service Provider (TSP) for the project, which will be implemented on a Build, Own, Operate & Transfer (BOOT) basis. The handover took place in the presence of top officials, with Shri T.S.C. Bosh, CEO of RECPDCL, handing over the SPV documents to Shri Sanjay Arvind Johri, Vice President (Business Development), Adani Energy Solutions Ltd. Officials from Central Transmission Utility of India Ltd (CTUIL) also attended the event.

The project is slated for completion by January 1, 2028, and involves the establishment of a 765/400 kV (2x1500 MVA) substation near South of Kalamb, a LILO (Line-In Line-Out) of approximately 89.18 km of the 765 kV Pune-III to Boisar-II line, along with other associated works.

# **Digital Deceit**

Srinagar Police on Saturday said to have busted an online fraud racket involving a fake medical donation appeal on social media platform (Facebook). The exposure of this fraudulent online donation is a grim reminder of how digital platforms are increasingly being misused to exploit public empathy and tarnish innocent lives. Using personal photograph of a woman without consent, accompanied by a fabricated medical emergency to solicit donations, not only amounts to criminal fraud but reflects a deeply disturbing ethical decay.

The accused, now in custody, allegedly orchestrated the scam with a calculated plan—one as heartless as it is cunning. What makes the act especially reprehensible is its targeting of a highly sensitive and emotional context: public charity and medical distress. In places like Kashmir, where people whole heartedly support such people to meet medical expenses, such deceit undermines public trust and harms those truly in need.

The swift action by Nowhatta Police in arresting the perpetrators and launching an investigation deserves commendation. It sends a clear message that digital crimes, especially those that manipulate emotions and prey on public generosity, will not ao unchecked. But this should not end here. This incident should serve as a catalyst for wider systemic reforms—both in digital accountability and public awareness

Sensitizing the public about Social Media Usage is important. Before donating online, people must verify the authenticity of appeals through trusted sources or directly with families or institutions. A culture of responsible digital citizenship—where users think before sharing, forwarding, or donating must be cultivated, especially in vulnerable regions. This case also raises deeper questions about online iournalism and the role of unverified "citizen reporters." Misusing the label of journalism to exploit others for profit is not only criminal but damages the credibility of genuine journalists working tirelessly in difficult environments and highlighting genuine cases that need people's attention and assistance. Let this episode be a turning point in our approach to online fraud. The digital age brings with it new opportunities—and new dangers. It is our collective responsibility, as citizens, institutions, and platforms, to ensure compassion is never hijacked for crime.

# **Doing Nothing vs. Doing** A Little: The Difference Is Huge

In today's fast-paced, results-driven world, success is often associated with grand gestures, intense effort, or dramatic overnight transformation. Yet, when faced with the choice between doing nothing and making small, consistent efforts, the long-term outcomes are vastly different. While doing nothing may seem safe or comfortable in the short term, it often results in stagnation, regret, or decline. On the other hand, even the tiniest efforts, when repeated over time, can accumulate to create powerful and lasting change.

Doing nothing is often rooted in fear of failure, perfectionism, procrastination, or simply being overwhelmed. Consider someone who wishes to lose weight and become healthier. They might believe that unless they can afford a gym membership, hire a personal trainer, and dedicate an hour daily to exercise, progress is impossible. As a result, they do nothing at all. Over time, their health deteriorates, their energy levels drop, and the problem deepens. The habit of inaction becomes harder to break as time goes on.

Now imagine another person with similar health goals who begins with just a ten-minute walk each day, increases their water intake, and replaces one sugary snack with fruit. These efforts may seem insignificant at first, but after six months, they've lost weight, feel more energetic, and are more motivated to pursue further improvements. These small adjustments trigger a ripple effect, leading to better habits and sustainable outcomes.

The same pattern plays out in personal and professional growth. Someone might dream of writing a book but never begins, waiting endlessly for the "right time." Meanwhile, another person commits to writing just 300 words a day-roughly one page. At that pace, they will have a complete manuscript of over 100,000 words in a year. As James Clear wisely states in Atomic Habits, "You do not rise to the level of your goals. You fall to the level of your systems."

Career advancement follows a similar logic. One employee may feel stuck in their role and wait passively for an opportunity to come their way, while another makes small, deliberate efforts-reading one article daily, attending a webinar each month, or applying to one new role weekly. These steady actions lead to growth in knowledge, expanded networks, and possibly a better position within the year.

What makes small efforts so effective is their achievability. They don't require major resources or dramatic shifts. Their simplicity reduces mental resistance, making it easier to start. Over time, repetition builds habits and habits create momentum. Like

financial investments, small gains made consistently vield compound returns.

Psychologically, doing nothing often comes from the all-or-nothing mindset—the belief that unless something is done perfectly or completely, it's not worth doing. This rigid thinking is paralyzing. In contrast, taking even the smallest action breaks this cycle, proving to the brain that change is possible and reinforcing self-trust. Gradually, this shift in behavior leads to a shift in identity: you begin to see yourself as someone who shows up, someone who acts.

This idea is not new. The Japanese philosophy of Kaizen, meaning continuous improvement through small, incremental changes, helped rebuild industries after World War II. Companies like Toyota embraced this principle by encouraging every employee to make minor daily improvements, ultimately becoming one of the most efficient and successful automakers in the world. Another compelling example is Nelson Mandela. During his 27 years in prison, Mandela didn't succumb to despair. He read, wrote letters, stayed in touch with the outside world, and engaged

in deep reflection. These small daily acts of resilience helped him cultivate the strength and wisdom that later enabled him to lead South Africa through a historic transformation.

In the end, the difference between where you are and where you want to be isn't closed by one massive leap-it's closed inch by inch, step by step, through consistent, intentional action. Doing nothing guarantees failure. Small efforts, however humble, guarantee growth. So take the walk. Write the paragraph. Make the call. Save the dollar. Learn the word. The step may seem small, but it's a step in the right direction-and that's how everything begins to change.

Ask yourself today: What's one small thing I can do right now to move closer to my goal? Then do it again tomorrow. That is how transformation begins.

A glimpse of vegetables strung up to dry before winter-a ritual quietly sacred. The neighborhood baker, keeper of warm bread and warmer gossip. The morning prayers echoing through a local school. These are not just sounds or images; they are a homecoming. Onir has got the essence of Kashmir right. Onir's body of work has always carried a deep emotional

as Kishanganga on one side, Neelam on the other. Faheem's mother, with quiet wisdom, asks-what difference does a name make, when all the river longs for is to flow? To move, unburdened by borders or labels, carrying its song through mountains and memories alike. In another scene "Encounter? Just another thrill," the tourist shrugs-encounter ka mazza le liya. But a voice rises, steady and wounded: how can you speak of excitement when blood has soaked this soil? When lives

Perched high above the village, the main army bunker gazes down like a silent sentinel. It does not speak, yet its presence echoes the language of power-its concrete walls heavy with the weight of control, surveillance, and the quiet tyranny of watchful eyes.

The film reminded me of one of his earlier films called I AM - an anthology of four short films and I Am Megha was one of them, the film that dared to show the authentic cost that people (people; not Hindus not Muslims) have to pay to be living in a conflict zone. A gaze that isn't an outsiders perspective or a Eurocentric gaze or a Birds Eye point of view but unapologetically local. Shot on location in the breathtaking, often overlooked valley of Gurez, Onir's film pulses with authenticity-local artists, actors, singers all woven into its fabric. One actor put it simply, and powerfully: "I loved acting in this film, because for once, we weren't playing terrorists-we were just ourselves."

We Are Faheem and Karun lingers long after the credits roll-not because it shouts, but because it listens. The film is tender without being sentimental, raw without being exploitative. What struck me most was its refusal to flatten its subjects into symbols. Faheem and Karun are not case studies in resilience; they are living, breathing individuals-messy, joyful, angry, brave—insisting on their right to simply be. The camera doesn't just observe; it accompanies. More like being invited into a shared space of trust, discomfort, and unexpected grace.

The actors (Akash Menon as Karun, Mir Tawseef as Faheem, Mir Salman as Zaid, Sana Javeid as the Mother, Bashir Lone as the Father) in We Are Faheem and Karun carry the film with a quiet, grounded strength. There's no performative flair-just lived truth. Many are local, their accents, gestures, and silences deeply rooted in the soil of Gurez. Their presence doesn't feel acted but inhabited, as if they are not stepping into roles but stepping forward as themselves. It's this unpolished honesty that makes every glance and line linger.

This film is a lived experience, crafted with honesty, respect, and an unflinching gaze. It is a testament to what cinema can be when it dares to tell stories that matter, in voices that have long been silenced.

Go and watch the film if you can-it's making its way through the film festival circuit right now, carrying with it stories that deserve to be witnessed.

# Bangladesh Is Losing Its Battle With Air Pollution

In the capital Dhaka and beyond, transport and industry emissions continue to blight the 'most polluted country in the world' despite strong words from the government

Mahmuda Khatun has travelled west from her home in Bangladesh's Narsingdi district to the capital. She is fighting to breathe. The 50-year-old asthma sufferer found herself in Dhaka's National Institute of Diseases of the Chest and Hospital following a decline in her condition. "Earlier, her problem worsened only The government had therefore been focussing on phasing out bricks from governmental or government-sponsored construction by June 2025, but Haque says this has been derailed by factors including the pandemic. A new target of 2029 has now been proposed.

The Third Pole speaks to Abdus Salam, a professor of atmospheric chemistry at the University of Dhaka. He is sceptical of these government construction claims: "Let alone the private construction sites, there are a number of megaprojects [almost all backed by the government] going on across Dhaka, but how many were [subject to these regulations] during the construction works?"

Haque says ageing vehicles are another major cause of Bangladesh's poor air quality: incomplete fuel combustion, common among older vehicles, releases the dangerous air pollutant nitrogen dioxide (NO2). Salam confirms: "The older the vehicle, the more pollution it causes."

The September 2023 study "State of Global Air: South Asia, a Regional Air Quality Snapshot" says the growing concentration of NO2 in Dhaka's air (the opposite of global trends) is now a cause for serious concern. Pollution and Public Health in South Asia". The report says that due to prevailing northwest-to-southeast winds, an estimated 30% of pollution in Bangladesh's largest cities originates in north India.

To combat transboundary air pollution, four South Asian countries – Bangladesh, India, Nepal and Pakistan – agreed on the need to reduce national annual average PM 2.5 levels to 35 micrograms per cubic meter by 2030. The declaration was forged in Nepal in December 2022, during meetings facilitated by the World Bank and the International Centre for Integrated Mountain Development.

According to Haque however, this transboundary agreement has yet to garner political endorsement: "It will take time." International finance and national initiatives

According to September's "State of Global Air Quality Funding 2023" report by the NGO Clean Air Fund, Bangladesh was the third-top recipient of international funding for outdoor air quality improvements between 2017 and 2021. During this period, the country received 17% of such funding, behind China (37%) and the Philippines (20%). The report also says Bangladesh received USD 2.4 billion in international development funding for air quality improvement between 2015 and 2021.



in winter, but in recent years, it deteriorates two to three times in a year," says Mahmuda's son, Ahmed Hossain.

Chronic air pollution is shortening average life expectancy rates in Bangladesh. Rapid urbanisation, unregulated construction and the changing climate are also exacerbating acute respiratory diseases and economic losses.

According to a recent study Bangladesh has the most polluted air in the world. The Air Quality Life Index 2023 (compiled by the University of Chicago's Energy Policy Institute with 2021 data) found that the air in Bangladesh had an average PM 2.5 level of 74 micrograms per cubic meter. By contrast, levels of 58.7, 30.2 NO2 exposure can irritate airways, aggravate existing respiratory diseases, increase the risk of asthma in children, and increase the frequency and severity of asthma symptoms in children and adults. This pollutant is not only impacting human health, but it is depleting Earth's stratospheric ozone layer.

In August 2023, the government – under pressure from transport businesses – decided not to implement its own order to cap the working life of commercial buses and lorries at 20 and

These international funds appear to be supported by national actions. The government has formed a high-powered air pollution committee, headed by the cabinet secretary and populated with the senior secretaries of relevant ministries.

According to Saber Hossain Chowdhury, an environment and climate change envoy to the prime minister, clean air legislation is progressing. Following the drafting of a Clean Air Act, the government's cabinet division chose to incorporate it into 99

and 7.8 were recorded for India, China and the US respectively.

The latest World Health Organisation global Air Quality Guidelines, published in 2021, are designed as a set of air quality targets for governments to meet. When the national average pollution of Bangladesh in 2021 is measured against these targets, it is estimated that each resident of the country is losing 6.8 years of life.

The Third Pole speaks to Abul Bashar Mohammad Khurshid Alam, the head of Bangladesh's Directorate General of Health Services: "Heavy metals that the air carries mix with blood and cause various communicable diseases. There is no denying that air pollution cuts life expectancy."

Alam does not possess statistics regarding Bangladeshi death rates in relation to air quality, but the surgeon confirms that the number of patients suffering from poor air quality is rising.

Two years of relentlessly unhealthy air

According to Muhammad Ziaul Haque, the environment department's director of air quality management, the problem is particularly bad in the country's capital city. "Poor air quality in Dhaka is increasing every year," he says. "Usually, air quality improves when the rainy season comes, but this year the situation was different due to the late rainy season."

The severity of air pollution in Bangladeshi cities often makes global headlines. It is caused by an atmospheric soup of emissions from old vehicles, brick kilns, massive construction works and burning fossil fuels and biomass.

According to the environment department, which posts daily pollution data recorded in its cities, the air quality in Dhaka and the neighbouring city of Gazipur (an industrial hub) did not achieve "good" average air quality for any month during 2021 or 2022.

An Air Quality Index score between 0 and 50 is considered "good", while 151-200 indicates "unhealthy" levels and likely negative health impacts for the general public. In November last year, for example, Dhaka's average air quality rating was "unhealthy", peaking at 234 ("very unhealthy") on 23 November.

Construction and transport pollution Government officials tell The Third Pole that tackling national air pollution requires overhauling several sectors.

For example, pollution caused by Bangladesh's kiln-fired brick industry prompted a national sustainability strategy in 2017. "We are penalising the authorities, but it is not working," says Haque. "Construction companies rarely listen to us."



25 years respectively. This means tens of thousands of decadesold vehicles may remain on Bangladesh's roads.

According to data from the Bangladesh Road Transport Authority, the number of vehicles on the road without a road fitness certificate is growing. As of April, about 568,000 registered vehicles did not have fitness certificates – 60,000 more than in January 2022.

Indoor and transboundary air pollution

As people grow increasingly concerned about outdoor air quality in Bangladesh, the air is often no safer at home. Data collected by the National Institute of Diseases of the Chest and Hospital shows its admissions related to indoor air pollution are on the rise, from 11,783 admissions during 2020 to 15,942 in 2022.

According to the Bangladesh Bureau of Statistics, 77% of households still use biomass (such as leaves, wood and dry dung) for cooking fuel, which is a major source of air pollution in rural areas.

"We have to ensure clean fuel in every part of the country," says Haque. "It will take a huge amount of time to shift this vast cooking system."

Meanwhile, air pollution is drifting into Bangladesh from elsewhere; unfit road vehicles, brick kilns and cooking with biomass are all polluting the air in Nepal and India, too. Earlier this year, the World Bank published "Striving for Clean Air: Air 1995's Bangladesh Environment Conservation Act. This led to the publication of Air Pollution Control Rules in 2022. These rules form the basis for the National Air Quality Management Plan, which Haque says will be finalised in early 2024.

But there is a big issue in actually implementing these rules, especially without clear data, according to Haque. In 2018, The Third Pole reported that the environment department was running three continuous air-monitoring stations (CAMs) in Dhaka; Haque says another 13 CAMs were in place across Bangladesh at the time, but only one more has been installed in the intervening six years, at the Bangladesh University of Engineering and Technology in Dhaka. Haque adds that these stations can only measure PM 2.5 and cannot identify emission sources.

However, Chowdhury remains bullish: "We have identified sources of both indoor and outdoor pollution and it is time to act." He says monitoring cells will be established to align private construction activities with air pollution initiatives, for example. "We are on a war footing against air pollution in Bangladesh."

Rani Ahilyabai Holkar was born on May 31, 1725, at Chondi village in Maharashtra's Ahilyanagar. She ruled the Malwa region of central India from 1767 to 1795, as the queen of the Holkar dynasty in the Maratha Empire.

"When we talk of girls' marriageable age, some people in the country see secularism in danger. They think it is against our religion. But Devi Ahilyabai thought about the marriageable age of girls in those times," he said.

"She got married at an early age. She knew the way to girl's progress. In Malwa Sena, she created a special battalion of women. These people of the western world do not know. They curse us in the name of the rights of women and try to portray us in a bad light. Women were in our army even 250-300 years ago. At village level, she created safety groups for women," Modi noted.

"When the country was in shackles of slavery 250-300 years ago, it was not easy to do something so impactful that future generations would remember it. But Devi Ahilyabai did it. She never separated devotion to God from service to the people," he said.

She was a great guardian of India's heritage. When temples and pilgrimage sites were being attacked, she took the initiative to rebuild and preserve them, including Kashi Vishwanath, he added.

"I consider myself fortunate that the same Kashi has given me the opportunity to serve. When you visit Kashi today, you will find signs of Ahilyabai's work. She created a model of governance where the poor and deprived were given priority," he added.

Earlier, Modi released a commemorative stamp and Rs 300 coin to mark her birth anniversary. (ANI)

casualty evacuations, and a blackout drill at 8 PM to test coordination between civil, police, military, and emergency medical agencies.

In Srinagar city, the exercise was organized at the Amar Niwas Complex, the office of the Deputy Commissioner, where a mock evacuation, rescue operation, and emergency coordination setup were conducted to mirror real-time response to aerial threats.

The details with KNO said multiple departments, including the District Disaster Management Authority (DDMA), Civil Defence, SDRF, health services, and local youth groups participated actively in the drill.

Deputy Commissioner Srinagar, Dr Bilal Mohidin while talking to reporters as per KNO, said the aim of the drill was to prepare both the public and administration for unforeseen emergencies. "Such exercises are vital to check our preparedness levels and correct any gaps before real threats emerge," he said.

Moreover, local residents were alerted in advance and advised not to panic as sirens, emergency announcements, and power blackouts were part of the simulation.

In Anantnag and Kulgam, Civil Defence and police personnel practiced urban evacuation, medical triaging, and communications drills. In Baramulla, the scenario involved managing drone attack aftermaths with medical teams responding to mock casualties and coordinating air and ground rescue.

In the Jammu division, the drills saw similar intensity. Poonch and Rajouri, close to the Line of Control(LoC), simulated enemy drone attacks on border installations, followed by coordinated civil-military evacuation of civilians to designated relief shelters.

In Doda and Kathua, medical teams conducted mock emergency surgeries and created triage zones to demonstrate preparedness for mass casualty events. Also, the emergency alarms were tested across all districts to familiarize the public with possible future alerts.

The Operation Shield was rolled out in frontier states. On May 28, the Ministry of Home Affairs had issued a circular announcing that the second phase of Operation Shield would be conducted on May 31, today across UTs of J&K, Chandigarh and in western frontier states including Gujarat and Haryana.

The exercise aimed to simulate 'hostile military threats such as missile attacks, air raids and drone strikes' and test the response of district administrations, youth forces, medical staff, and Civil Defence wardens.

The MHA circular, revealed that one major scenario would involve an enemy drone attack on a military installation, prompting civil evacuation, medical treatment, and rapid response coordination with the Indian Air Force.

The drills also tested the ability to mobilize 30 units of blood for hypothetical mass injuries, besides communications checks between Civil Defence control rooms and military command centers.

Notably, the Civil Defence drills follow heightened national security concerns after the Pahalgam terror attack on April 22, which killed 26 civilians, mostly tourists. In response, the Government of India announced a series of preparedness measures, including Operation Shield, to assess the civil administration's ability to support defence forces during large-scale emergencies. (KNO)

"HMVs have been allowed to move from Jammu towards Srinagar. However, the entire highway stretch has witnessed heavy rain, which has made the road slippery at several points," the official said.

Regarding the Srinagar-Sonamarg-Gumri (SSG) Road and Sinthan Top Road, the official said traffic movement is stopped and the clearance operation is ongoing.

after independence due to the Constitution.



# **David Willey Haunts Yorkshire To Lead Northants To Victory**

orthamptonshire 237 for 4 (Broad 67, Willey 54) beat Yorkshire 224 for 9 (Wharton 58, Sutherland 58, Willey 3-42) by 13 runs

Captain David Willey haunted his former side as Northamptonshire's captain starred with bat and then ball in a remarkable opening night Vitality Blast win for the Steelbacks, by 13 runs, against Yorkshire at Headingley.

Willey led Yorkshire's T20 side before returning home in 2022. Here, he smashed six sixes in 54 off 24 balls in a mammoth 237 for 4 total - his county's highest ever in this format.

Justin Broad top-scored with a career best 67 off 32 balls, the pair sharing a third-wicket stand of 85 inside six overs during the second half of the innings.

Last year's quarter-finalists then reduced Yorkshire's chase to nine for three inside five balls, Willey striking twice with his left-arm pace en-route to 3 for 42. But runs kept coming as Yorkshire recovered to finish with 224 for 9.

James Wharton and Australian overseas all-rounder Will Sutherland hit 58 apiece, the latter hitting four of his six sixes in one over. He faced 30 balls.

Ricardo Vasconcelos shared an opening 73 inside six overs with South African Matthew Breetzke after the Steelbacks had been inserted.

The latter contributed 36 with three sixesone of which was pulled out of the ground over backward square-leg against under-fire New Zealand quick Will O'Rourke.

Off-spinner Dom Bess bowled Breetzke in his first over, but the Steelbacks maintained the



momentum through more measured Vasconcelos and Broad, who took the score to 105 for 1 after 10 overs on a batting paradise of a pitch.

Bess struck again to bowl Vasconcelos for 48-116 for 2 in the 12th - but that brought Willey in. He reached his fifty off 20 balls after Broad's had come up in 23. The former was brutal in favouring the leg-side.

Broad, particularly strong against spin in his 20th career appearance, hit five of 17 sixes in an innings which saw debutant O'Rourke return figures of nought for 67 from four overs. Yorkshire's hopes of reeling in what would have been their highest successful run chase in Blast

history were then hurt badly inside five balls.

New captain Dawid Malan hoisted Willey out to deep midwicket before Will Luxton edged the next ball to slip. A wide ball followed before Adam Lyth was run out at the striker's end coming back for three to deep midwicket, leaving Yorkshire nine for three.

Northamptonshire had taken three wickets in three legal deliveries. But fourth-wicket pair Harry Duke, batting for the first time in his sixth T20 appearance, and Wharton then threatened a revival with a scintillating 81-run partnership inside six overs.

Duke hit four sixes in an 18-ball 37 before

being bowled sweeping at Australian leg-spinner Lloyd Pope's third ball. Wharton continued on and reached 50 off 27 balls before playing on pulling at Willey, leaving Yorkshire 141 for 5 in the 12th over.

Sutherland then clattered compatriot Liam Guthrie - nought for 68 from three overs - for four sixes in the 13th to reach 50 off 26 balls before falling caught at long-off against Pope in the next - 174 for six.

Yorkshire continued to hang tough, taking the target to 30 off the last two overs and 22 off the last. But George Scrimshaw got his side over the line. Just. (IE)

#### **Young Indian** team capable of achieve something special on England tour if it believes: de Villiers

ndia's young guns have the talent to achieve something special in the upcoming England Test series, provided they back themselves, said AB de Villiers here on Saturday, adding that it's time for the new generation to step up.

With the 25-year-old Shubman Gill at the helm, India will start a new cycle of the World Test Championship with a five-Test tour of England next month without their seasoned campaigners in Rohit Sharma and Virat Kohli, who both announced their retirement recently.

India will also miss the services of off-spinner Ravichandran Ashwin who retired during last year's tour of Australia, and senior pacer Mohammed Shami, who was not selected for this tour owing to his lack of fitness for the conventional format.

"Yes, it's time for the younger guys to step up... Shubman Gill taking on the responsibility," de Villiers told the media on the sidelines of a NGO Project Mumbai event here.

"There's lots of talent in India and largely credit to the IPL for that, (it is) really giving great exposure to some of the youngsters at a very early age.'

"We saw Vaibhav Suryavanshi this year (and) many other youngsters, they come in their first year and they look very mature and ready to play cricket and it's a great platform for Indian cricket." he said.

The former South African skipper said the tour of England will be a tough test for the young Indian side, but keeping the belief could help them pull off a favourable result.

"They've got to take some responsibility on in England. it'll be a tough test, but they have all the talent in the world and if they believe, maybe they can achieve something special."

De Villiers, who shares a special bond with his former Royal Challengers Bengaluru teammate Kohli, said he will be missed in Test cricket.

"He followed his gut feel. I think he has done a lot for cricket around the world over the years. Luckily, we'll still see him on the cricket field. He will be missed in Test matches, there is no doubt about it, but he leaves (behind) a great legacy with the red ball," de Villiers said.

Talking about the Indian Premier League, de Villiers still backed Punjab Kings, who suffered an eight-wicket thrashing at the hands of RCB in Qualifier 1, to reach the final.

PBKS will take on Mumbai Indians in Ahmedabad on Sunday for Qualifier 2.

over in a game where the run rate across 40 overs was 11.20.

"If you want wickets, he comes and gets you wickets. If you want to stop runs, he stops runs for you. Man, what a bowler," Aaron said on ESPNcricinfo's Time Out. "And the belief he has in his ability. You have an international coach [Mahela Jayawardene] who is obviously panicking because his bowlers have suddenly started to go to the cleaners, and he just turns around and is like 'just calm down, I'll do the job for you'. Comes in, runs in, gets hit for a six and then gets that ball."

The ball Aaron was talking about was the yorker Bumrah produced in the 14th over of the chase to flatten Washington Sundar's leg stump and leave him face-down on the floor. At the time, Washington was well-set on a 23ball 48 and, in B Sai Sudharsan's company, on course to chase 229 down. While Hardik Pandya called him a "luxury" at the post-match chat on Friday evening, Tom Moody opted for "pure class".

"The challenge every opposition has to Mumbai Indians, and Jasprit Bumrah more importantly, is that the 24 balls he bowls are such a threat," Moody said. "It's not impossible but it's so difficult to get big overs against him. So you're really playing 20 overs versus 16 to a certain extent. And he is so far ahead of the rest, it's ridiculous.

"The thing with Bumrah is that he's got that genuine wicket-taking ability just through his pure class. That yorker he bowled to Washington Sundar, you just don't bowl a better ball than that. That is the absolute perfect leg-stump yorker that's gone between his legs. At pace. To a batter that's in. Set.

"You see that quite often with a new batter because they still haven't picked up the pace of the game. This is a batter that's in and he's going at 200 strike rate. It just totally blew him away." (espncricinfo)
