# **CSC Report Ready For Cabinet Nod**

SRINAGAR: The cabinet subcommittee (CSC) constituted by Omar Abdullah-led government to review the existing reservation policy has finalised its report, Minister for Social Welfare Sakina Masood Itoo said on Tuesday.

In a post on X. formerly twitter. as per news agency—Kashmir News Observer (KNO), the minister, who is also head of the CSC, said that they have drafted the report and it will be placed before the cabinet. "The Cabinet Sub-Committee constituted to examine the issue of reservations has drafted its report within the stipulated timeframe of six months. The report will be placed before the Cabinet when it meets," Itoo said. The minister made these claims a day after the panel completed its six-month time-frame. The six-month deadline for the committee came to



end on Monday.

The panel was formally constituted n December 10, 2024, almost 18 days after the cabinet approved its

The existing reservation policy. introduced during central rule in Jammu and Kashmir, has become a focal point of political discourse, with

candidates from the general category alleging that it disproportionately benefits reserved categories beyond their population share.

The issue also prominently featured in the 2024 Assembly election manifestos of all major political parties.

## **India Ready To Strike** Deep In Pak, If Provoked: EAM

**BELGIUM**: India would strike deep into Pakistan if provoked by terrorist attacks, External Affairs Minister S Jaishankar has warned, asserting that there will be retribution against the terrorist



outfits and their leaders in case of barbaric acts like the Pahalgam attack.

aishankar, who is travelling to Europe a month after India launched Operation Sindoor in response to the Pahalgam terror attack, also said that Pakistan was training "thousands" of terrorists "in the open" and "unleashing" them on India.

"We are not going to live with it. So our message to them is that if you continue to do the kind of barbaric acts which they did in April, then there is going to be retribution, and that retribution will be against the terrorist organisations and the terrorist leadership," he told Politico on Monday.

'We don't care where they are. If they are deep in Pakistan, we will go deep into Pakistan,"

Tensions between India and Pakistan escalated after the Pahalgam terror attack on April 22 which claimed 26 lives. India carried out precision strikes on terror infrastructure in Pakistan and Pakistanoccupied Kashmir on May 7.

The on-ground hostilities from the Indian and Pakistan sides that lasted for four days ended with an understanding of stopping the military actions following talks between the directors general of military operations of both sides on May 10. Jaishankar warned that the root causes of the

conflict remain unchanged. "It (Pakistan) is a country very steeped in its use of terrorism as an instrument of state policy. That is the whole issue," he was quoted as saying

When asked if the conditions that led to the outbreak of war last month were still in place, he said: "If you call the commitment to terrorism a source of tension, absolutely, it is." When asked about losses, Jaishankar said the relevant authorities would communicate on the matter when they were ready.

He said that India's fighter aircraft and missiles had inflicted far more extensive damage on the Pakistani Air Force than vice versa, forcing Pakistan to sue for peace.

"As far I'm concerned, how effective the Rafale was or frankly, how effective other systems were - to me the proof of the pudding are the destroyed and disabled airfields on the Pakistani side," he said.

"The fighting stopped on the 10th for one reason and one reason only, which was that on the 10th morning, we hit these eight Pakistani, the main eight Pakistani airfields and disabled them," he said, adding

### **Airline Body Seeks** User Charges Waiver At Srinagar Airport

**MUMBAI**: Airline industry body FIA has sought waivers on user development fee and aviation security fee for a year at Srinagar Airport to boost air travel demand to and from Kashmir, which has taken a hit in the aftermath of the Pahalgam attack.

The Federation of Indian Airlines (FIA), which has Air India, IndiGo and SpiceJet also said that financial incentives play an important role in rebuilding traffic apart from other safety and security measures, which the government is already taking. Currently every departing passenger shells out Rs 1,050 as

UDF and Rs 200 as Aviation ASF plus GST, as per FIA. Seeking the support required to boost air travel demand at Srinagar airport, FIA said, "

May we request, if the government can waive both UDF and ASF for every departing passenger from Srinagar airport for a period of one year with immediate effect. It will boost air travel demand to and from Srinagar airport." # Heatwave grips J&K as temp settles above normal

JAMMU: Jammu and Kashmir is reeling under an intense heatwave, with temperatures soaring significantly above normal, the Meteorological data revealed on Tuesday.

The blistering conditions have disrupted daily life, prompting authorities to issue advisories for residents to stay hydrated and avoid direct sun exposure. As per officials, the record-

breaking temperatures were recorded across Jammu region, with maximum temperatures in key areas of the region highlighting the severity of the heat wave.

According to the news agency—Kashmir News Observer (KNO), Jammu recorded the hottest day of the season 44.4°C, which is 5.6°C above normal, while



Banihal recorded 33.6°C, which is 5.2°C above normal.

Similarly, Batote recorded 33.3°C, which is 5.5°C above normal. Bhaderwah's maximum temperature settled at 33.4°C, which was 3.6°C above normal, and Katra recorded at 40.6°C, which was 4.9°C above normal.

Moreover, Kashmir division

also witnessed the above normal

temperature on Tuesday with Srinagar, the summer capital of Jammu and Kashmir, recording 33.5°C, which was 535°C above normal.Qazigund, a gateway of Kashmir, recorded 7.3°C above normal temperatures, while Pahalgam's maximum temperature settled at 29.2°C.

# Faith meets conservation in Mawphlang sacred forest of Meghalaya

Khasi tribals believe their deity Labasa will punish those who try to remove anything from the grove

**SHILLONG, MEGHALAYA:** Twenty-five km from Meghalaya's capital city Shillong lies the pristine forest of Hima Mawphlang (Kingdom of Mawphlang), where over 450 species of trees, herbs and wildlife, including clouded leopard, monkeys, deer and frogs of the genus Rana, thrive. This is no ordinary forest, but a sacred grove, where belief and conservation go hand in hand.

Labasa, the deity that governs the law-kyntang (the Khasi equivalent of sacred grove), can both protect and punish. Take a twig or pluck a leaf, and you are inviting the deity's wrath and bad luck. This belief in itself has thrown a ring of protection around the nearly 800-year-old forest spread across 193 acres.

Located in East Khasi Hills district, the forest belongs to the native Khasi tribe, an indigenous ethnic group found in the Northeast. Its residents still identify themselves with the ancient Kingdom of Mawphlang and even now have a king elected democratically. The present king belongs to the Lyngdoh clan.

The Office of Hima Mawphlang decides on all matters related to the sacred grove. The responsibility to protect it lies with the men of 12 clans — Lyngdoh, Blah, Kharshiing, Kharsohliya, Kharhunai, Kharnarbi, Kharsahkar, Kharmawphlang, Kharmaram, Kharlangnuih, Kharphyrnap and Kharkalong — living in villages in the vicinity.

The forest is divided into three parts: phiephandi, the central portion where all rituals take place; Laittyrkhang located near the hamlet; law nongkynrih, an extension opposite the main forest. Though an ecotourism hotspot, tourist entry is restricted to only certain portions of

Appeasing the deity is of utmost importance to Philarihun Lyngdoh (28), a local guide. Every morning, upon reaching the forest entry point, she chants in Khasi seeking permission and protection. She also pleads forgiveness, if she has wronged unknowingly.

Since time immemorial, villagers have been

the presence of an important elder or the King, before taking any major community decisions, before a major event, or during disease outbreaks. Such events used to happen inside the sacred forest, before it was shifted to a nearby hill.

Bulls were sacrificed in the last known ritual held inside the forest during a massive famine in 1959. Nowadays, only hens and roosters are sacrificed in an annual ritual held before the monoliths that dot the landscape, which also serve as route markers.

It is believed that the deity used to appear as a clouded leopard or a snake when the elders sought permission during the sacrificial ritual, standing in front of the monoliths.

"Leopards and snakes are highly regarded here. Leopard will come to the rescue in times of danger, while the snake is a mediator that shows up when something is wrong," noted ecologist Tambor Lyngdoh told 101Reporters.

Sharing some anecdotes on grove desecration, Tambor said stories about those who were punished by turning their heads backwards (shah khyrwait basa) still do the rounds in the region.

"In the 1970s, some Army personnel from Shillong went to Mawphlang to gather wood from the grove. When loaded in trucks, the engines did not start. While checking the truck's condition, the drivers began to feel uneasy and weak. Soon, they returned to the headquarters empty-handed."

"The next morning, the brigadier reached Mawphlang on inspection and met the chief of the clan, who suggested unloading of wood in the grove itself. Once his advice was heeded, the engines miraculously started functioning again."

In the distant past, the people of Mawphlang were mostly dependent on the forest for basic essentials. Even before there was a religious system, people believed in one god: Mother Nature. This practice continues even today. Residents believe that in the sacred grove resides the wisdom of their forefathers and a way to performing ritualistic worship of the forest deity in carry forward their heritage and establish a legacy.



"Nature is given the highest regard in our community. Before starting anything auspicious, we pray to nature. We know we cannot survive without nature. No one is allowed to collect even firewood from the forest. We grow everything we need, including vegetables, fruits and trees for firewood, in our farmlands," Tambor

Philarihun said every household in this place used the water from the forest springs for cooking and drinking purposes as "we think its sacred quality can cure health problems."

There are certain taboos linked to the sacred grove that the society here follows without fail. Women in Mawphlang cannot directly participate in the rituals, though the society is matrilineal in nature. Even the dorbar council meetings have only men above 18 years of age in attendance.

However, Tambor claimed that everyone, from a young child to an elderly person, was responsible for protecting the grove. lemonleng Kharshiing, a school teacher, said this responsibility is imbibed into the minds of residents at a young age both through education and environment-themed competitions.

Mawphlang village consists of five sub-villages - Nogrum Mawphlang, Dongiewrim Mawphlang, Mawkohmom Mawphlang, Mission Mawphlang and Lad-Umisain Mawphlang. In all, there are 800 households, where agriculture was once the primary occupation. The area saw a shift towards ecotourism when Tambor, in his role as the secretary of the Office of Hima Mawphlang, introduced ecotourism to the area in 1996.

Tourist influx has since opened up new avenues of income for the local youth. Most of them now earn around Rs 20,000 per month. For instance, John Starfield, who used to work as a tourist guide, has recently opened his own homestay on the forest outskirts of Nogrum.

"This sacred forest is everything to me. As a guide. I got the opportunity to meet new people and learn new things. Most importantly, I see it as a way to

showcase our rich Khasi culture and tradition in front of the world," shared Starfield, Philarihun echoed him when she said, "Many youth shift to metro cities for better opportunities. But for me, this forest is heaven."

A set of rules is in place to manage guesthouses in the area. For building homestays, permission from the village headman is necessary. Tourists should not roam around the village late in the night, or visit houses in the locality without the headman's permission.

"Conservation is not a one-person's job. Therefore, the village panchayat actively works with the Office of Lyngdoh. An annual or half-yearly general public meeting is held, where attendance of at least one person from every household is mandatory. Executive committee meetings are held frequently," said Auspicious L Mawphlang, the headman of Nogrum.

Taking note of the ecotourism activities in the area, Meghalaya Tourism has proposed to develop the David Scott Trail, a 16-km-long trekking route that starts near the sacred grove in Mawphlang.

"We plan to start a tourist information centre and ticketing counter here. Cafes, rain shelters, washrooms for travellers and signages along the trail are all part of the plan, proposed to be funded under the Meghalaya Ecotourism Infrastructure Development," CVD Diengdoh, Director of Tourism, Government of Meghalaya, told 101Reporters.He added that the government has no role in the maintenance and development of the sacred forest as "it is completely owned by the kingdom."

Diengdoh informed that the Meghalaya government has implemented the Prime Minister's Employment Generation Programme to push tourism-driven entrepreneurship. Under this, young entrepreneurs can claim a subsidy of up to Rs 7 lakh for a project worth Rs 10 lakh.

Mawphlang's love for nature has set an example for the rest of Meghalaya, with Umket and Mawtneng in Ri Bhoi district and Baghmara in South Garo Hills following suit. (Photo-Nayanjyoti Medhi; 101Reporters/ This News article is a part of 101 Reporters' series The Promise Of Commons.)

# Dr. Jitendra Singh Anchors Global Blue Economy Vision at UN Ocean Conference

**NEW DELHI:** India called for

urgent global action on ocean health at the Third United Nations Ocean Conference (UNOC3) in Nice, with Union Minister of Earth Sciences (Independent Charge). Dr. Jitendra Singh pushing for global ocean pact and unveiling major strides in deep-sea exploration, marine plastic clean-up, and sustainable fisheries.

Representing India, Dr. Jitendra Singh highlighted progress on the Deep Ocean Mission's upcoming manned submersible, a nationwide single-use plastic ban, and over \$80 billion worth of Blue Economy projects. India also backed the swift ratification of the BBNJ Agreement, advocated for a legally binding Global Plastics Treaty, and launched the 'SAHAV' digital ocean data portal, underscoring its growing leadership in global marine governance.

According to a statement issued by Press Information Bureau, an official spokesperson said while addressing the conference, which is co-hosted by France and Costa Rica under the theme "Accelerating Action and Mobilizing All Actors to Conserve and Sustainably Use the Ocean," Dr. Jitendra Singh reaffirmed India's commitment to Sustainable Development Goal 14: Life Below Water.

He outlined how India's initiatives are aimed at reversing ocean degradation through science, innovation, and inclusive

A key highlight was the progress on the Deep Ocean Mission's 'Samudrayaan' project, which is expected to deploy India's first manned submersible by 2026. The project aims to explore ocean depths up to 6,000 meters and is seen as a major leap in India's scientific capability.

Dr. Jitendra Singh also spoke of expanding India's Marine Protected Areas, which now cover 6.6% of the Exclusive Economic Zone, contributing to global biodiversity goals.

On marine pollution, the Minister pointed to tangible outcomes from the 'Swachh Sagar,



Surakshit Sagar' campaign, which has cleaned over 1,000 km of India's coastline and removed more than 50,000 tonnes of plastic waste since 2022. The draft marine litter policy has been prepared, and India continues to support negotiations on a Global Plastics Treaty aimed at a legally binding international framework.

India's Blue Economy efforts, led by the Sagarmala Programme and the Pradhan Mantri Matsya Sampada Yojana (PMMSY), were also showcased. Over 600 port-led infrastructure projects worth \$80 billion have been operationalized, and investments of \$2.5 billion

have gone into modernizing the fisheries sector. The government reported a 10% rise in fish production and the creation of over 1.000 fish farmer producer organizations since the last UN Ocean Conference in 2022. **Emphasizing** 

resilience, Dr. litendra Singh noted the restoration of over 10,000 hectares of mangroves and the implementation of shoreline management plans using nature-based solutions. India has also integrated ocean-based climate actions into its Nationally Determined Contributions under the Paris Agreement.

India's growing role in global ocean governance was evident through its co-leadership in 'Blue Talks' with France and Costa Rica, and its active participation in high-level events such as the India-Norway side session on Marine Spatial Planning. The launch of the 'SAHAV' portal during the conference further adds to its credentials in promoting transparent, science-based ocean management.

Calling for a robust 'Nice Ocean Action Plan', Dr. Jitendra Singh urged the international community to invest in innovation, ratify the BBNJ Agreement, and finalize the plastics treaty. "The ocean is our shared heritage and responsibility," he said, expressing India's readiness to work with all stakeholders—governments. private sector, civil society, and indigenous communities—to ensure a sustainable ocean future.

The Indian delegation's participation at UNOC3 signals a clear message: India is positioning itself not just as a coastal nation but as a proactive player in shaping global ocean policy. (PIB)

# Teachers Defy DSEK's Transfer Order; CEO Accused of Providing Cover

ReT staff used as stopgaps while GLTs refuse to comply with official postings

CONVENER NEWS DESK

**BANDIPORA**: The Chief Education Officer (CEO) Bandipora has come under fire yet again for allegedly defying transfer orders issued under the Directorate of School Education Kashmir's (DSEK) Annual Transfer Drive (ATD), leaving several remote schools—especially in Gurez and Bandipora zone—critically understaffed.

According to official data, About 27 teachers were transferred to remote zones, including Gurez, under the ATD order dated May 26, 2025. However, only 2 to 3 teachers have reportedly joined their new postings. The remaining teachers—many believed to be enjoying political or bureaucratic patronage—have stayed back at their preferred schools with impunity, despite

While those transferred from far-flung areas to more accessible locations were quick to assume their new roles, those posted in reverse especially to tribal belts—have largely resisted.

Zonal Education Offices and the CEO Bandipora have failed to enforce the transfer directives,

effectively defeating the purpose of the ATD initiative by DSEK Dr GN Itoo, aimed at rationalizing staffing and ensuring equitable education delivery across the district.



A glaring example includes a teacher transferred a mere five kilometers from Higher Secondary School Nadihal to Middle School Kudara.

Despite a relieving order being issued, the same was inexplicably put in abeyance within a day. CEO Office have since been scrambling to find a substitute for the Kudara posting instead of enforcing the original order.

In another incident, a Rehbar-e-Taleem (ReT)

teacher was forcibly asked to join MS Kudara as a stopgap measure. The teacher resisted, stating, "Why should I go there when the teacher officially posted under ATD is refusing to join? I'm

> not responsible for covering someone else's transfer obligations." His attendance was subsequently restored at his original post, further exposing the CEOs lack of writ over the department.

Same is the case with teachers who were transferred from BMS Gurdal to HSS Bdugaam Tulail, from GHS Nadihal to HSS Purana Tulail, BMS Gamroo to HS Kudara, from HS plan to HS kanzalwan, from BMS lankreshipora to MS Check-

bahar, from GMS Watrina to HS Buduaab, from GMS Sogamiwudar to BMS Dawar, from BMS Nathpora to GMS Badwan, from Gps Panzigam to GHS wanpora but have not joined the new places of postings. However CEO Office, instead of Implementing Director's Orders are in search of scapegoats to fill the gaps.

 $Teachers\,allege\,that\, \bar{"blue-eyed"}\, staff\,within$ the CEO office, who were themselves subject to transfer under ATD, have refused to comply with the DSEK's directives and are being protected. In what many see as a diversion tactic, the CEO office on June 1 circulated a Google Sheet to schools seeking details of General Line teachers' tenures-presumably to identify replacements under the guise of rationalization.

On June 11, CEO Bandipora is scheduled to hold a meeting at Government High School Bagh to discuss staff rationalization on the instructions of the Joint Director of School Education (North). Teachers fear this will be another move to quietly fill vacancies created by ATD defiance, thereby "hoodwinking" the higher authorities.

"ATD was meant to ensure justice and equity, particularly for underserved zones like Gurez. But it's being manipulated to shield those with influence," said a senior teacher. "This selective compliance is deeply demoralizing."

When Kashmir Convener takes up the matter with CEO Bandipora, he said it is not a reality. However when Kashmir Convener rebutted with the list of Teachers who have not joined new postings, CEO Bandipora refused to respond.

## **Court Slams Delay in Appointment** of Advocate General, Stays Takeover of Reasi Temple

Srinagar, June 10, KNT: The High Court of Jammu and Kashmir and Ladakh has expressed serious concern over the prolonged vacancy in the post of Advocate General for the Union Territories of J&K and Ladakh, observing that the absence of this statutory position has rendered a key legal provision ineffective.

Justice Rahul Bharti, while hearing a petition filed by the Nav Durga Jhaleri Mata Trust, questioned how long the UTs could function without an Advocate General. The post has remained unfilled since October 2024 after former Advocate General DC Raina stepped down following the formation of the National Conferencedelay stems from a standoff between the Lieutenant Governor's office and the new administration headed by Chief Minister Omar Abdullah.

The court emphasized that in the absence of an Advocate General. Section 92 of the Code of Civil Procedure, which enables civil suits for the better management of religious and charitable trusts, has become defunct.



"The office of Advocate General is in vacancy... leaving a live provision a dead letter of law," Justice Bharti observed.

ings in a case where the temple trust challenged the administration's decision to hand over management of the Nav Durga Ihaleri Mata Shrine in Reasi to the Shiv Khori Shrine Board. The government's move was made pending the enactment of a law to govern religious institutions in the Union Territory.

The Court stayed the transfer of control and appointed the CEO of Shri Mata Vaishno Devi Shrine Board as interim administrator of the shrine. It directed that all offerings and donations be collected and accounted for by the CEO, with no expenditures allowed without the Court's approval.

Justice Bharti held that the case raised significant constitutional concerns over executive overreach in the absence of enabling legislation, and called on the I&K government to update the court on the status of Advocate General's aplisted for the next hearing on July 16.

## Road Woes Deepen Across Kashmir, No Sign of Macadamisation Work Yet

**SRINAGAR:** With summer already underway, locals across the Kashmir Valley are expressing growing anger and frustration over the dismal condition of roads, as the government fails to kickstart the annual macadamisation and repair work traditionally carried out during this season.

From Kupwara to Anantnag and Bandipora to Pulwama, people in almost every district are complaining about potholed roads, dusty stretches, and broken pavements, with no machinery or road crews in sight.

"This is the season when we  $used \ to see \ black topping \ work \ in full \ swing. \ But \ this \ year, it \'s \ all \ silence.$ Not a single patch has been repaired," said Ghulam Nabi, a shopkeeper from Baramulla. "We have just four workable months left, and

In Budgam, commuters say the roads have become nearly undrivable, resembling craters more than highways. "We are not driving on roads anymore. These are ditches stitched together," a teacher told the news agency Kashmir News Trust. "Even ambulances struggle to

pass through. Is this the development we were promised?" Locals blame the administration for turning a blind eye to basic infrastructure needs. "It seems the authorities are in deep slumber. Every year they claim macadamisation will be done in time, and every year the promises vanish into thin air."

In Srinagar's outskirts and peripheral areas, the situation is equally grim. Roads that were damaged during the winter remain untouched, with no signs of tendering, labor, or machinery.

People have been demanding immediate intervention from higher authorities and transparency regarding the delay in the annual road restoration process. [KNT]

### **J&K Students Association Demands Immediate Release of Reservation Report**

**SRINAGAR**: The Jammu and Kashmir Students Association on Tuesday issued a strong appeal to Chief Minister Omar Abdullah and Education Minister Sakina Itoo, demanding that the Cabinet Sub-Committee's report on the rationalization of reservations be made public without further delay.

In a statement issued to Kashmir Convener, the Association's National Spokesperson Farhat Riyaz criticized the government's continued inaction, saying, "The lack of fixed timelines for the Cabinet meeting raises serious concerns about the government's intent. The 'tareekh pe tareekh' approach has now become the hallmark of this administration."

Calling for an emergency Cabinet meeting to discuss the report and implement its recommendations, Riyaz warned that the delay was causing distress among thousands of students. "The ongoing uncertainty is jeopardizing student futures and creating widespread anxiety," she said. "The people of Jammu and Kashmir deserve clarity and commitment, not vague assurances."

Echoing the same sentiment, Association Media Coordinator Krishna Saproo pointed out that the government had initially promised to resolve the issue within six months. "That timeline has expired, and yet we see no transparency, no accountability, and no public disclosure of the report," he said.

"Job notifications are being issued daily, but without clarity on reservation rationalization—especially affecting the general category students are left in limbo," Saproo said, accusing the government of using "backdoor cabinet meetings" as an excuse to delay.

He further added, "The Cabinet meeting should have coincided with the six-month deadline. Instead, it feels like a deliberate stalling tactic. We ask: What is the government hiding? Why the secrecy? The youth of J&K deserve better, and their future cannot be bartered away for bureaucratic convenience."

The Association has called for immediate action and complete transparency, asserting that students will not remain silent. "We will continue to raise our voice until justice and clarity are delivered. The government must prioritize student welfare and uphold its promises," the statement concluded.

# Dharamvir Singh: The Visionary Behind Doordarshan's Rise

Communication has always been of prime importance. With the advent of television in 1927, Indians also dreamed for this service and after independence television service was started in Delhi as a part of All India Radio (AIR) in 1959. For its expansion across the country, its management was separated from AIR and independent new body named "Doordarshan (DD)" was constituted. One of the architects of the ambitious Doordarshan service was - Shri Dharamvir Singh.

Dharamvir Singh was born on 10 June 1932 in Barh in Patna district. His native village is Simra Bilgawan on the banks of Son river under Bhojpur district. His father Shri Devsharan Singh (Former Chairman, Bihar Legislative Council) was a renowned Congress leader and freedom fighter at the national level and was an advocate at Barh Sub-Divisional Court. Dharamvir Singh graduated from Bihar National College, Patna under Patna University. He was a meritorious student from the very beginning and along with studies, he also had special interest in journalism, sports and social works. He was selected by Sarat Chandra Bose as a member of the "International Brigade" to go for the independence of Indonesia in 1947. He was a member of Bihar Lawn Tennis Council in 1952 and Secretary of Bihar Table Tennis Association from 1954-67. He was also associated with New Patna Club, Delhi Golf Club and Delhi Gymkhana for a long time.

In the company of his father, Dharamvir Singh inclined towards active politics. In 1967, he was elected for the first time from the 193-Bakhtiarpur Vidhan Sabha constituency in Patna district and became the secretary of the Congress Legislature Party. In the election held on 21 February 1967, Dharamvir Singh (20772 votes) contesting on Indian National Congress ticket defeated Independent Shri Ramlakhan Rai (18221 votes) and Shri R.S. Singh (15317 votes) of Jan Kranti Dal in a tough contest. Again in 1969, he was elected from the 193-Bakhtiarpur Assembly Constituency and became the Chief Whip of the Congress Legislature Party. In this election held on 9 February 1969, Indian National Congress candidate Dharamvir Singh (19578 votes) defeated Ram Lakhan Rai (17896 votes) of Samyukta Socialist Party and Ramchandra Singh Chouhan (15364 votes) independent. In 1970, he was inducted for the first time in the Bihar Cabinet as Minister of State for Labor, Information and Tourism.

On the special initiative of the then Prime Minister Smt. Indira Gandhi, Dharamvir Singh contested for the Fifth Lok Sabha in 1971 on Indian National Congress (R) ticket from the 34-Barh Lok Sabha constituency. Outgoing MP and former Union Minister Smt.

Tarkeshwari Sinha was contesting against him as an Indian National Congress (Organization) candidate. The Fire-brand stalwart Smt. Tarkeshwari Sinha had won four consecutive elections namely-the First Lok Sabha (3-Patna East constituency in 1951), the Second Lok Sabha (28-Barh constituency in 1957), the Third



Lok Sabha (34-Barh constituency in 1962) and the fourth Lok Sabha (34-Barh constituency in 1967). Dharamvir Singh (184484 votes) created a new history in this area by securing 48.10 percent votes defeating an invincible MP like Smt. Sinha.

After being elected to the Lok Sabha, he resigned from the membership of the Bihar Legislative Assembly, on which the flamboyant socialist leader Bhola Prasad Singh was elected in the by-election. Mrs. Gandhi was highly impressed with Dharamvir Singh and he was inducted into the Union Cabinet in 1971 as Deputy Minister of Information and Broadcasting, in his first inning as a Member of Parliament, a position he held till 1977.

Several remarkable works have been performed in the Ministry during his tenure, the most notable event was the formation of "Doordarshan". On 1 April 1976, television broadcasting was separated from the radio network and replaced by the name "Doordarshan". In 1972, television service was started in the second city of the country, Mumbai, Prior to this, the service of television broadcasting was available only in the national capital Delhi. By the year 1975, television service had expanded to seven cities of Bharatvarsha. During his tenure, he made a lot of efforts to promote artistic films as well as commercial and devotional films like "Jai Santoshi Maa". All India Radio Annual Awards were started in 1974. He led several Indian delegations abroad.

During the election of the Sixth Lok Sabha in

1977, there was a wave of Janata Party due to the student movement in the whole country. Bihar was the center of this movement. Congress could not get a single seat in Bihar due to the anger of the people stricken by the Emergency. On Indian National Congress ticket, Dharamvir Singh got only 101945 votes and lost to a newcomer Shyam Sundar Gupta (372227 votes), the Mayor of Kolkata Municipal Corporation. In 1979, a separate political party named Congress (I) was formed by Smt. Indira Gandhi, but Dharamvir Singh decided to remain in the original party.

Due to mutual tussle and personal arrogance, the Janata Party government could not survive for its full term. In the mid-term elections to the Seventh Lok Sabha in 1980, Dharamvir Singh contested from the 18-Barh Lok Sabha constituency as a candidate of the Indian National Congress (Urs) led by Shri Devraj Urs, the then Chief Minister of Karnataka. He defeated Smt. Kamla Devi (160801 votes) of Janata Party and Ramraj Pd. Singh (102566 votes) of Indian National Congress (Indira) by securing 192407 votes on his own capacity. He held many important positions in the National and Parliamentary Party of the Congress. He later aligned himself with Sharad Pawar-led Congress (S) and became the party's national general secretary. After Ram Lakhan Singh Yadav left the party to join Congress (I), Dharamvir Babu was also given the responsibility of the post of President of Bihar unit of Congress (S).

In 1984, for the Eighth Lok Sabha, Dharamvir Singh contested again from the 18-Barh Lok Sabha constituency on Indian National Congress (S) ticket. In the election, he got full support of socialists like Karpoori Thakur. But he again fell victim to the sympathy wave triggered by the assassination of Prime Minister Indira Gandhi and lost the election to a controversial figure like Prakash Chandra alias Baby, son of Ram Lakhan Singh Yadav, who was contesting on Indian National Congress (Indira) ticket. Shri Prakash Chandra got 384719 votes out of total cast of 610745, while Shri Singh had to be satisfied with only 161983 votes. The people of the Barh area continued to repent of his defeat till the end. In 1986, at the National Convention of Congress (S) in Mumbai, Dharamvir Singh proposed the merger of Congress (S) with Congress (I) in his capacity as General Secretary, which was accepted unanimously.

The entire life of Dharamvir Singh was dedicated to the nation. He wanted to see India as a great nation. The only goal of his life was to make the country self-sufficient and prosperous and to bring harmony in the society. He was constantly striving to achieve his goal. He was an articulate and fighting man. He

was a strong supporter of the politics of honesty and remained unmarried throughout his life for the fulfillment of this motto. He was a skilled politician and a strong orator. His charitable life inspired him to travel to European countries. Dharamvir Singh was no match in the field of journalism. The editorials and articles written by him on various national as well as international burning issues in newspapers and magazines like Weekly Dinaman etc. had fascinated

the public. He was the flagbearer of the communication revolution in India.

On 5 April 1989, in the midst of the discussion on his election to the Rajya Sabha from Maharashtra, Dharamvir Singh went to Mumbai where he held detailed talks with the then Chief Minister Sharad Pawar on various issues. But on 06 April 1989, he suddenly passed away in a suspicious condition in Mumbai. A wave of mourning ran across Bihar and this shining star of Indian politics disappeared from the national horizon forever.

# **Embracing the Other: A Civilizational Path to Self-Discovery**

In a world increasingly defined by boundaries-ethnic, religious, cultural, linguist, geographic, ideological, spiritual, political etc a civilizational imperative and re-awakening to embrace the Other emerges not merely as a moral gesture but

transcending itself through the experience of relationality. This perspective challenges the static and essentialist conceptions of identity and reclaims the notion that we become fully human only through sincere and courageous encounters with those who are not like us. The encounter with the Other is not the endangerment of identity but the occasion for its awakening and enrichment. It is in this space of tension and tenderness, of difference and dialogue, that we discover the most enduring truth: our capacity to grow into the fullness of being is intricately tied to how we meet what is unfamiliar, uncomfortable, and other.

Across civilizations, the prophets, poets, mystics, and philosophers have echoed a perennial truth: the self is not born in isolation but revealed in relation. Igbal envisioned khudi as a against "narrow domestic walls" dissolve boundaries that imprison the soul.

Confucius teaches that the ethical self is formed through relational virtue (ren); Ubuntu declares, "I am because we are." Ricoeur sees identity as a storied dialogue, not a sealed monologue. Cornel West calls us to prophetic love, to suffer with the Other; Morrison bears witness to wounded histories demanding recognition. Abhishiktananda shows that identity expands through surrender across traditions, not by defending rigid boundaries. Bonhoeffer insists that faith without responsibility to the oppressed is betrayal. Taylor affirms the moral need for recognition, Arendt finds dignity in plurality, and Nasr and Chittick warn: without metaphysical vision, reverence for the Other is lost. From Spivak to Said, Dostoevsky to Chittick,

of identity to one that is relational and ethical, implying that identity achieves its most authentic articulation not in isolation but in responsibility to the Other. The self, in this view,

is not annihilated by the Other-it is awakened by the Other. This reawakening finds historical resonance in the lives of those who encountered civilizational multiplicity without losing themselves. The Persian poet Rumi, deeply rooted in Islamic mysticism, found inspiration in Christian, Greek, and Hindu ideas without feeling his faith diminished. Similarly, the Indian philosopher Swami Vivekananda, while firmly grounded in Vedantic Hinduism, addressed the World Parliament of Religions in 1893 with an embrace of all faiths, stating, "We believe not only in universal tolerance but we accept all religions as true." These exemplars show that identity, when anchored in depth and spirit, is not threatened by plurality but enriched by it.

Psychological research affirms that individuals with bicultural or multicultural exposure are often more cognitively flexible and emotionally resilient. Far from suffering an identity crisis, such individuals demonstrate a more layered and complex sense of self. The phenomenon of "cultural frame-switching"-the ability to navigate and integrate different cultural schemas-reflects the profound adaptability and growth of the self when it is open to difference. Erik Erikson's work on identity development underscores that the process of individuation necessarily includes encounters with alterity-be it cultural, religious, or interpersonal.

In contemporary geopolitical contexts, where the clashof-civilizations narrative continues to rear its divisive head, it becomes crucial to recall that identity is not a monolith but a dialogical process. The tragic persistence of cultural essentialism-where cultures are viewed as sealed containers $undermines \, the \, truth \, of \, historical \, interpenetrations. \, The \, Abbasid$ Caliphate translated Greek philosophy into Arabic; medieval Jewish thought was shaped by Islamic Kalam; Andalusian Spain gave birth to cross-cultural symphonies of music, science, and architecture. Each example is a testament that civilizations, like individuals, do not lose their soul by sharing it.

This understanding holds critical relevance in our increasingly interconnected yet polarized world. The fear that embracing the Other implies self-erasure is a projection of insecurity rather than a reflection of reality. The true threat to identity is not openness but superficiality-when identity is constructed around reaction, resentment, or ideological fixity, rather than deep self-understanding. In contrast, traditions that are rooted yet expansive-such as Confucianism's ideal of ren, or the Qur'anic vision of human diversity as a divine sign ("We have created you into nations and tribes so that you may know one another"-Surah al-Hujurat 49:13)-invite us to embrace the Other without anxiety over self-loss.



as a perennial civilizational necessity and a metaphysical truth. Against the prevailing narratives of cultural defensiveness,  $identity\ politics, and\ exclusivist\ ideologies, this\ humble\ attempt$ contends that engaging with the Other does not dissolve the self but rather deepens/enriches and refines it. Contrary to the fears of cultural dilution or existential erosion, authentic encounters with the Other offer the possibility of rediscovering the self through the mirror of difference. Identity, when grounded in philosophical, spiritual, and historical depth, is not a brittle possession to be guarded from contact, but a generative process-capable of expanding, evolving, and

moral and creative self, fulfilled through love and struggle with the Other. Mulla Sadra's metaphysics of becoming reminds us that identity itself is a dynamic unfolding-deepened in communion with difference. Ibn Arabi saw every being as a unique tajalli, a face of God; to refuse the Other is to refuse the Divine. Buber's I-Thou encounter grounds the soul in reciprocity, and Levinas makes the face of the Other the very origin of ethics. Ghalib's philosophical melancholy unveils the complexity of existence, cautioning against narrow certainties, while Nazir Akbarabadi celebrates the divine in every life, high or humble. Rumi's call-"Come, come, whoever you are"-and Tagore's plea

the truth resounds: exclusion shrinks the soul-encounter redeems it. The Other is no threat-it is the mirror, the challenge, the bridge. Only a self porous to love, and capacious enough for the world, is fully human.

Philosopher Emmanuel Levinas offers a foundational insight into this phenomenon by grounding ethics in the face of the Other. For Levinas, the encounter with the Other is not a threat but the beginning of responsibility. It is through the recognition of the irreducible otherness of another human being that we are truly called into our own humanity. This view shifts the framework from a possessive or defensive understanding

# After Trump Cut Funding For Energy Transitions Overseas, Could China Step In?

On the day he became president again, Donald Trump signed an executive order to take the US out of the Paris Agreement on climate change. That was followed by a termination of US funding pledged during the Biden administration to programmes that support South Africa, Indonesia and Vietnam to shift their economies away from coal dependence.

empower work in all other fields. However, the group has not yet made any concrete plans for funding new-energy-vehicle projects, and coal phase-out plans are also behind schedule: South Africa's national electricity company Eskom has delayed the planned decommissioning of three coal power plants until March 2030, citing energy security concerns.

As of June 2024, Indonesia had only published details of how approximately USD 300 million in donations and technical assistance was to be used. This makes up just 2.6% of its total JETP funding and even that is now under threat because it included a USD 60 million commitment from the US. There is also uncertainty around the remaining 97.4% of the funding, the majority of which is made up of concessional loans, which Indonesia may struggle to pay back.

Priority coal decommissioning projects under Indonesia's JETP programme include the 660-megawatt Cirebon-1 plant and Pelabuhan Ratu. Cirebon-1, which belongs to an independent

beneficial and sustainable cooperation in the mining industry; and strengthen global partnerships for the energy transition. China and Indonesia already have a long history of successful cooperation in these fields, with China investing USD 35 billion in Indonesia over the last 17 years, mainly in the energy sector and city transport. There are also joint venture industrial parks and economic cooperation zones.

Thanks to Chinese investments, both Malaysia and Vietnam manufacture solar power components for the global market. In the future, Indonesia's advantages in raw materials and Chinese investment could be leveraged to help the country become a hub as manufacturing across Southeast Asian nations become more integrated.

In November 2023, the Cirata floating-solar power plant, built by PowerChina, was fully connected to Indonesia's power grid, and became the largest such installation in Southeast Asia. In March 2024, Chinese power company Guodian Power Development





The move brings uncertainty to the renewables transition in those countries. The US had committed USD 4 billion, according to funding documents for the programmes, which are known as Just Energy Transition Partnerships (JETP). This accounted for 12% of South Africa's initial JETP funding, 18% of Indonesia's and 13% of Vietnam's – more than any other state funder. The loss has already caused the cancellation of projects and exacerbated funding gaps.

It is worth noting, however, that the three countries are all key partners in China's Belt and Road Initiative, and so have plenty of experience in working with China on infrastructure and energy. China's expertise in energy planning, market investment

and clean-energy technology could help them redraw their plans and roadmaps for the energy transition and economic development, and in doing so deepen China's cooperation with Africa and the Southeast Asian nations.

In March, South Africa's government announced the cancellation of US-funded projects that were in the planning or implementation stages. It also said that, along with its partners, it would "evaluate the implications" of the US withdrawal. Shortly afterwards, the other main JETP funders – the UK, Germany, France, the EU, Denmark and the Netherlands – which together are known as the International Partners Group, issued their own statement. It reiterated full support for South Africa's energy transition and pointed out that South Africa's JETP now has USD 12.8 billion in funding pledges from non-US donors – higher than the USD 8.5 billion originally pledged in 2022.

Still, the US moves rocked confidence in global climate governance. Argentina was the first to say it might not stick with the Paris Agreement. Indonesia's climate envoy, meanwhile, suggested that if the world's second-largest emitter was pulling out of the agreement, it would be unfair to expect countries like Indonesia to stay; although the country's environment ministry later said it would continue to contribute to the fight against global warming. In any case, the loss of USD 2 billion in funding from the US is likely to further hamper Indonesia's already delayed JETP programme.

South Africa and Indonesia have seen some progress since their JETPs began, though. As of November 2024, South Africa's programme had spent about USD 2 billion, with specific plans for a further USD 7.3 billion. Its Just Energy Transition Investment Plan, published in 2022, had listed six priorities: electricity, green hydrogen, new energy vehicles, transitional justice, skills and capacity building, and municipal energy transitions. The International Partners Group decided to spend 27% of the USD 9.3 billion pledged so far on the electricity sector, as this would

power firm, will have its debt paid off using preferential loans and its power-purchase agreement shortened. Pelabuhan Ratu is owned outright by Indonesia's national power company PLN and plans for its decommissioning are still being worked on. At the 2024 G20 summit, Indonesia's president said the country would phase out coal by 2040, earlier than previously planned. However, given the condition of the country's existing grid infrastructure, and progress so far both on renewables and coal decommissioning, this may be overly ambitious.

Energy transitions in South Africa and Indonesia face similar problems: growing demand for electricity, reliance on coal for a large part of that power, and slow development of power networks and renewable generation. While renewables can be ramped up in short order, coal decommissioning can only take place when two conditions are met: that there will be no major impacts on regional power supplies, and that the electricity infrastructure can cope with the renewables coming online. South Africa already suffers from frequent power outages and its grid is aging. Indonesia, being an archipelago, has numerous small power grids. Both are in urgent need of grid expansions and upgrades.

#### Can China fill the gap?

South Africa, Indonesia and Vietnam are all part of China's Belt and Road Initiative. China is also their biggest trading partner, and for Indonesia the second biggest source of outside investment. Teboho Makhabane, the head of ESG (environment, social and governance) at Sanlam Investments in South Africa, said China may plug some of the gaps left by the US, which in both South Africa and Indonesia was focusing on renewable-energy development, hybrid-financing mechanisms, rail transport, energy planning, demand-side management and energy saving, and a just transition.

#### What is demand-side management?

China could use the BRICS group, South-South cooperation and the Belt and Road Initiative to provide assistance in those fields, as well as in the electric-vehicle and critical-minerals sectors.

The 2024 Forum on China-Africa Cooperation, held in Beijing, set up a CNY 5 billion (USD 690 million) "China-Africa Green Supply Chains Fund" as part of China Development Bank's China-Africa Development Fund. Work on its first project, South Africa's TFC solar farm, started in November 2024.

The China-Africa Development Fund states that as of the end of 2024 it had committed to USD 7.6 billion of investment across 39 African countries, leveraging over USD 32 billion of Chinese private investment. Almost USD 1.2 billion of that money has gone to South Africa, it added. And South Africa is just one example of China's cooperation with Africa in green sectors: by 2027, China plans to have set up 30 clean-energy and green-development projects on the continent.

As a major coal producer and exporter, and the largest economy in Southeast Asia, Indonesia is at the heart of the region's energy transition, and China is already set to play a crucial role in its transition. In November, the two countries published a joint statement agreeing to cooperate on new-energy vehicles, lithium batteries and PV solar; strengthen mutually

won a tender to build a 100-megawatt floating solar project at Karangkates, also in Indonesia. Deep strategic cooperation with China isn't just helping Indonesia realise its Golden Indonesia 2045 Vision – the country may also become the driving centre of the low-carbon transition in Southeast Asian nations.

#### Lessons from JETPs for the Belt and Road Initiative

JETPs are multilateral partnerships between governments and therefore a very political undertaking, led by developed nations vying for influence and leadership on global climate change issues. The bulk of JETPs' financial commitment is concessional or commercial loans that fall short of what is needed to match the ambitious targets for coal decomissioning and the wider transition, in countries that lack cheap and efficient electricity infrastructure. If the transition is done too quickly, developing nations already facing electricity shortages could be thrown into even more serious situations.

However, JETPs also offer valuable lessons. In particular, when it comes to market investment risk for coal decommissioning and renewable-energy development, bilateral interventions can reduce risks and barriers. These development plans, jointly produced and agreed upon, create a favourable environment for JETP investments.

China could take this approach when working with other developing countries, drawing up national plans and bilateral

cooperation frameworks with its partners, reducing investment and financing risks, and pushing actual projects forward. In Indonesia, for example, there are strict controls on the size of stake overseas investors can have in a renewable-energy project. This limits overseas investment, making it less likely that decommissioned coal-power sites will be repurposed for renewables and so reducing transition outcomes. I recommend China learns from the JETP mechanism and works with host-country governments on measures to protect the legal interests of Chinese firms, while looking for support from multilateral funding organisations, expanding financing channels and undertaking win-win cooperation on energy and electricity in Belt and Road nations.

# CS for giving solar power push to energy sector through PM Surya Ghar Yojana scheme

SRINAGAR: Chief Secretary, Atal Dulloo, Tuesday chaired a high level meeting to review the progress achieved under the PM Surva Ghar: Muft Bijli Yojana (PMSMBY), a flagship initiative aimed at promoting solar energy through rooftop installations for the households and solarization of government buildings across the country.

Taking stock of the rooftop solar installations across the districts, the Chief Secretary emphasised the need for time-bound implementation. He directed the DISCOMs, JPDCL and KPDCL, to ensure that the vendors complete installations in the shortest possible time.

Dulloo impressed upon the Deputy Commissioners to personally monitor the progress on rooftop solar projects in their respective districts and ensure timely completion, enabling the consumers to experience minimal delays.

He also reviewed the status of applications and installations district-wise and sought a strategy from each DC to fast-track

To maintain quality and efficiency, he instructed the senior officers of IPDCL and KPDCL to undertake field visits to inspect the ongoing installations.

He stressed the importance of institutional leadership while seriousness. He directed the Deputy Commissioners to verify the



rooftop solar systems themselves.

The Chief Secretary also directed that Common Service Centre (CSC) operators be empanelled to facilitate the consumer registrations at the grassroots level, ensuring ease of access for the rural and

Reviewing the solarization of government buildings, another critical component of the PMSMBY, the Chief Secretary described it as a prestigious initiative that must be executed with utmost wise status reports by June 30, after coordinating with the JAKEDA for the requisite data.

Speaking on the occasion, Principal Secretary, Finance, Santosh D. Vaidya, stressed the need to involve the local contractors in solarisation drive by registering them as vendors and incentivising their participation.

He underlined that the scheme's momentum hinges on the proactive involvement of local players, both from a developmental and entrepreneurial standpoint besides ensuring its completion

Principal Secretary, PDD, Rajesh Prasad, highlighted that consumer response to the scheme has been overwhelming in recent months. with a significant uptick in applications.

He noted that the focus must now shift to enhance the vendor capacity and on-ground execution, for which the department is actively engaging empanelled vendors.

Providing an update on the implementation status, MD JPDCL, Choudhary Yasin, reported that 6,121 Solar Rooftop Systems (SRTs) with a combined capacity of 22.51 MW have already been installed across the UT. So far, 12,206 consumers under JPDCL and 8,108 under JPDCL have selected their vendors, while 802 (JPDCL) and 690 (KPDCL) consumers have completed payments also.

He added that the cumulative application load received stands at approximately 78.51 MW (JPDCL) and 103.35 MW (KPDCL), indicating the strong public interest and demand.

Under Capex mode, 5,220 buildings (43.40 MW) have already been taken up, with work orders issued for 3,403 more buildings, expected to add another 34.39 MW into the power system of the UT. Under RESCO mode, 1,500 buildings (35 MW) will be completed by NHPC and and 8,000 buildings (175 MW) by JAKEDA itself, the meeting was informed. (DIPR)

## DC Baramulla finalizes IEC campaign action plan to empower tribal communities

**BARAMULLA:** Deputy Commissioner (DC) Baramulla. Minga Sherpa, today chaired a meeting at the DC Office and finalized the action plan for the upcoming IEC (Information. Education, and Communication) campaign for implementation of Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DAJGUA).

The IEC campaign will be kick-started with a mega camp at Dakbungalow Baramulla on the 15th, in the presence of the elected representatives from the tribal areas.

During the camp, concerned departments will install stalls to provide information on the schemes and on-the-spot service delivery to the invited eligible beneficiaries from all the tribal villages of Baramulla.

The campaign, which will last 15 days, aims to saturate 25 schemes across 17 central ministries in all 8 identified tribal villages of Baramulla. These flagship initiatives aim to empower tribal communities, including Particularly Vulnerable Tribal Groups (PVTGs), by ensuring comprehensive awareness and delivery of government services at the grassroots level.

During the meeting, DC directed widespread distribution of IEC materials regarding 25 different centrally sponsored schemes as part of DAJGUA in multiple tribal and regional languages to ensure effective outreach.

Meanwhile, strict directions were passed for holding Benefit Saturation Camps at all 8 tribal villages to provide essential services such as issuance of Aadhaar cards, ration cards, caste certificates, and Ayushman health cards directly to eligible tribal beneficiaries.

He added that a delegation of student leaders and reservation rights activists is scheduled to meet him on June 11 at 10:30 AM to discuss the issue in detail.

Earlier on Tuesday, Minister Sakina Itoo, who chaired the sub-committee, provided an update on the progress. "The Cabinet Sub-Committee constituted to examine the issue of reservations has drafted its report within the stipulated time frame of six months. The report will be placed before the Cabinet when it meets," Itoo said in a post on X.

The committee was constituted in response to widespread concerns following a March 2024 amendment to the Jammu and Kashmir Reservation Act, 2004, under the administration of Lieutenant Governor Manoj Sinha. The amendment increased reservations in government jobs from 43% to 70%, largely due to the inclusion of the Pahari community under the Scheduled Tribe (ST) category.

The policy sparked protests and opposition from several quarters, prompting then-Chief Minister Omar Abdullah to establish the Cabinet Sub-Committee to reassess the implications of the move. The panel was given six months to complete its review. (KNO)

Branding terrorism as an epidemic destined to perish, the Defence Minister stressed that the menace cannot be left to die a natural death as its existence will continue to challenge collective peace, development and prosperity. He underscored the urgent need for a permanent solution to terrorism.

Terrorists are not fighters with a cause. No religious, ideological or political reason can justify terrorism. No human objective can ever be achieved through bloodshed and violence. India and Pakistan attained independence at the same time, but today, India has been recognised as the Mother of Democracy, while Pakistan has emerged as the Father of Global Terrorism. Pakistan has always given shelter to terrorists, trained them on its soil and helped them. It always tries to justify this menace. It is important that we eliminate these terrorists and their entire infrastructure," said

Singh urged the international community to stop foreign funding to Pakistan, saying that a large part of this financial aid is spent on terrorism. "Funding Pakistan means funding the infrastructure of terrorism. Pakistan is a nursery of terrorism. It should not be nourished," he added

The Defence Minister called upon the global community and organisations such as the United Nations to think on issues like terrorism more seriously, stating that "Only when we are free from terrorism, will we be able to move towards the goal of global peace, progress and prosperity."

Further, Rajnath Singh listed out the steps taken by the Government to strengthen the defence sector, including increasing the defence budget from Rs 2.53 lakh crore in Financial Year (FY) 2013-14 to Rs 6,22 lakh crore in FY 2024-25; reserving 75% of the budget for capital procurement from domestic companies and the issuance of a total of 10 Positive Indigenisation Lists, comprising over 5,500 items.

"Today, Indian Armed Forces use state-of-the-art weapons, missiles, tanks and other systems/platforms manufactured within the country. Our indigenous missiles such as Agni, Prithvi & BrahMos stand ready to give a befitting reply to the enemy. We also have

the strength to build aircraft carriers such as INS Vikrant," he added.

He underlined that the Government's persistent efforts are bearing fruit as the annual defence production, which was around Rs 40,000 crore in 2014, has crossed the record figure of Rs 1.30 lakh crore today, and defence exports, which were Rs 686 crore in 14, has skyrocketed to Rs 23,622 crore in FY 2024-25, adding that Made-in-India defence products are being exported to nearly 100 countries.

"We have set a target of Rs 1.75 lakh crore defence production this year and Rs three lakh crore by 2029. Our defence exports should reach Rs 30,000 crore this year and Rs 50,000 crore by 2029," Singh said.

#### **Technology Must Enhance Functions Not Replace Decision Making: CJI Gavai**

NEW DELHI,: Underlining technology's "doubleedged sword" nature, Chief Justice of India B R Gavai has said such innovations must enhance judicial functions and not replace the decision making process.

Speaking at the international symposium on "The Role of Technology to Improve Access to Justice" at the University of Cambridge on June 9, the CJI, emphasised the transformative power of technology in enhancing access to justice in a vast, diverse, and complex country like India.

Justice Gavai said judiciary in India readily integrated technology in the quest for making justice more accessible.

"We must also acknowledge that technology can act as a double-edged sword, which may also lead to unparalleled divides. A primary concern is the digital divide, where unequal access to internet connectivity, devices, and digital literacy can lead to the exclusion of marginalised communities who already face barriers to justice. For technology to truly serve justice, accessibility and inclusion must be foundational to its design," he said.

Justice Gavai, however, said no revolution in the justice delivery mechanism could be achieved without policy interventions.

"The governance frameworks that ensure human oversight, algorithmic transparency, and accountability for technology-mediated decisions should be developed," he said.

The CJI continued, "The path forward demands adherence to fundamental principles. Technology must enhance rather than replace judicial functions, particularly reasoned decision-making and individual case assessment. We must ensure that automated systems support rather than supplant judicial judgment." He laid out a comprehensive vision for a more inclusive and responsive legal system, underpinned by digital innovation.

"Access to justice represents the backbone of any fair and equitable legal system. It ensures that all individuals, regardless of their socioeconomic status, geographic location, or personal circumstances, can effectively participate in and benefit from legal processes" he said

He said in a country where more than twothirds of the population lived in rural areas and over 121 languages were spoken as mother tongues, ensuring equitable access to the courts was both a constitutional obligation and a moral imperative.

He highlighted the foresight of Constitution makers, who enshrined mechanisms to guarantee access to justice, including Articles 32 and 226, which empower citizens to directly approach the Supreme Court and high courts for the protection of their rights.

"Technology has become the bridge between the constitutional promise of justice and the lived experience of citizens," he said.

The CII referred to several key initiatives that have digitally transformed the Indian judiciary, pointing out video-conferencing had become a permanent fixture in courts as it enabled lawyers from remote areas to argue cases before the Supreme Court without costly and time-consuming travel. Barriers to access to justice are now being

diluted with the help of technology, he said. "Video conferencing technology has made

the most impact on accessibility to the court. A

lawyer practising in rural Bihar or rural Maharashtra can now appear before the Supreme Court without the expense and time of travelling to Delhi," the CJI said.

With the use of technology, he said, citizens could now track case status, download court orders, and view hearing schedules through the Case Information System, eliminating the need for physical presence.

"It has democratised access to the country's highest court, ensuring that geographical location no longer determines the quality of legal representation available to citizens. Vulnerable witnesses, particularly children, can now testify without being physically present in intimidating courtroom environments," CII Gavai added.

He also referred to the SUVAS (Supreme Court Vidhik Anuvaad Software) and said the Artificial Intelligencepowered translation tool converts legal documents into nine regional languages, empowering non-English speakers with access to critical information.

CJI Gavai lauded the efforts of the National Legal Services Authority, which leverages technology to extend its services to the most vulnerable. "These innovations are not just conveniences; they are lifelines for those who would otherwise be left outside the judicial system," he said. He hailed the National Judicial Data Grid(NJDG) as a game-changer in judicial transparency and performance monitoring.

As of early 2025, the NJDG tracks more than 23 crore cases and 22 crore orders from over 18,000 courts, enabling data-backed policymaking and identifying procedural bottlenecks, he said.

The CJI, however, cautioned against technology becoming a new barrier to justice for "the digital divide is real". Without equitable access to internet connectivity, devices, and digital literacy, marginalised communities risk further exclusion, he added. (PIB)

the patient and family, persistent counselling and vigilance by Dr. Ishaq Nabi ensured a timely CECT abdomen, revealing a rare and dangerous Superior Mesenteric Artery (SMA) dissection with complete distal thrombotic occlusion and non-enhancing

Recognizing the urgency, the medical team acted swiftly within a critical 4-hour window from diagnosis to intervention. An emergency endovascular procedure was performed in the DSA lab. Dr. Irshad Ahmad Banday and his team placed a balloon-mounted stent to treat the proximal SMA dissection and executed manual mechanical thrombectomy using the Penumbra device to clear the distal thrombus.

A follow-up angiogram confirmed full restoration of blood flow to the bowel.

Subsequently, a diagnostic laparoscopy performed

by Dr. Ishaq Nabi and Dr. Irshad Ahmad Banday (Surgeon) confirmed bowel viability, revealing edema without signs of transmural ischemia. The patient was then managed in the Surgical ICU (SICU) and discharged on the 7th day in stable condition, fully relieved of symptoms. A repeat CECT scan 24 hours later showed patent stent placement with normal enhancement of the vasa recta and bowel segments.

This case represents a clinical milestone not only for Paras Health Srinagar but for the entire healthcare landscape of Jammu & Kashmir. The successful endovascular and surgical management of acute mesenteric ischemia is a testament to our hospital's growing expertise in advanced emergency care. Timely diagnosis and treatment is critical in these cases," said Dr. Irshad Ahmad Banday, Interventional Radiologist.

Dr. Ishaq Nabi, the lead surgeon, added, "Acute mesenteric ischemia has a notoriously high mortality rate if not addressed rapidly.

It was a race against time, and only through seamless teamwork and persistence were we able to achieve this outcome. This case reaffirms the value of clinical vigilance and patient-centred care.'

The success of this high-risk case was made possible by the collaboration between Emergency Medicine, Anesthesia (Dr. Nasir), Critical Care (Dr. Imran), Cardiology (Dr. Fayaz and Dr. Suhail Maqbool), Radiology, and Dietary Services. It marks a new chapter in minimally invasive and hybrid interventions for critical abdominal emergencies in the region.

tar West Indies batter Nicholas Pooran on Tuesday stunningly announced his retirement from international cricket at the age of 29 without specifying any reasons but insisted that "much thought and reflection" had gone into taking the call.

His decision came days after he opted out of selection for the T20I series against England.

The swashbuckling left-handed batter finished as West Indies' most capped T20I player with 106 matches and also its highest run-getter, with a tally of 2275 at an average of 26.14 and strike rate of 136.39. In 61 ODI appearances, he scored 1983 runs at an average of 39.66 and strike rate of 99.15.

"After much thought and reflection, I've decided to announce my retirement from international cricket," Pooran, a former West Indies white-ball captain, wrote on his social media pages.

"This game we love has given and will continue to give so much - joy, purpose, unforgettable memories, and a chance to represent the people of the West Indies," said the Trinidadian who made his international debut in 2016 in a T20 International match.

He never played Test cricket for his country.

"Wearing that maroon, standing for the anthem, and giving everything I had each time I stepped on the field... it's hard to put into words what that truly means to me. To have led the team as captain is a privilege I will always hold close to my heart," he said.

Pooran had recently opted out of selection for West Indies' T20I series against England after playing the full Indian Premier League (IPL) season for Lucknow Super Giants (LSG).

He hasn't featured in ODIs since West Indies' exit in the 2023 World Cup Qualifiers. His last match for West Indies was against Bangladesh at Kingstown in December 2024. "To the fans - thank you for your unwavering love. You

lifted me in the tough moments and celebrated the good ones with unmatched passion. To my family, friends and

He had a magnificent season in 2024, hitting the most sixes in a calendar year (170) before finishing IPL 2025 with teammates - thank you for walking the journey with me. 524 runs at a strike rate of 196.25 with five half-centuries.

He was expected to be a key part of West Indies' plans for the T20 World Cup early next year, before Tuesday's shock announcement.


