# India will never accept mediation: PM Modi tell Trump

"Hostilities between India, Pak ended on Islamabad's request"

**SRINAGAR** : Foreign Secretary Vikram Misri on Wednesday said that Prime Minister Narendra Modi has made it clear to United States President Donald Trump that India will "never accept" mediation on any issue.

The Foreign Secretary said that PM Modi in a 35-minute telephone call to the United States President stated that India will "never accept" mediation and that the discussions between Indian and Pakistani militaries on cessation of military actions last month were initiated at Islamabad's request.

PM Modi also said that India no longer views "terrorism as a proxy war, but as a war itself", and that India's Operation Sindoor is still ongoing. Pertinently, the cessation of hostilities



between India and Pakistan was first announced by President Trump on May 10. Since then, the US president has been claiming that he brokered the ceasefire

deal by threatening to stop trade with both countries if they do not agree to stop the conflict.

Prime Minister Modi declined a request

by the US president to stop over in the US on his way back from Canada, citing "prior commitments".

The May 7-10 military clashes between India and Pakistan figured prominently during the phone conversation that took place as the two leaders could not meet on the sidelines of the G7 summit following the American president's early departure.

"Prime Minister Modi clearly conveyed to President Trump that at no point during this entire sequence of events was there any discussion, at any level, on an India-US trade deal, or any proposal for a mediation by the US between India and Pakistan,' the Foreign Secretary said.

"The discussion to cease military action took place directly between India and Pakistan through the existing channels of communication

SRINAGAR: The scorching heat has once again hit Jammu and Kashmir, especially in the valley, where the mercury continued

to rise for the second straight day on Wednesday. According to details obtained by the news agency-Kashmir News Observer (KNO), J&K witnessed 26 per cent deficit rainfall during the ongoing month till Wednesday as against the normal precipitation of 39.7 mm, the region has recorded a rainfall of just 29.5 mm in the last 18 days.

The large deficit of rainfall has been recorded in Samba at 72 per cent and in Kathua at 62 per cent during the period. The majority of the stations across the region, including Srinagar. Budgam, Baramulla, Bandipora, Ganderbal, Kishtwar, Kulgam, Poonch, Reasi, Shopian and Udhampur have recorded deficit rainfall

## Amarnath Yatra Police To Set Up Additional **Checkpoints For Security In Jammu**

JAMMU: Ahead of the Amarnath Yatra, police have been asked to identify locations to set up more checkpoints in the border districts of Jammu, Samba, and Kathua for the security of pilgrims. The 38-day-long yatra is scheduled to start on July 3 from the

twin routes — the traditional 48-km Pahalgam route in Anantnag district and the 14-km shorter but steeper Baltal route in Ganderbal district - to the 3,880-metre-high shrine of Amarnath.

The first batch of pilgrims will leave for Kashmir from Bhagwati Nagar a day before the start of the yatra.

"All the officers were directed to strengthen all the nakas (checking points), especially during night hours. They were also directed to identify places where more nakas can be established for the security of the yatris," a police spokesperson said.

This was conveyed to the police officers by Deputy Inspector General (DIG), Jammu-Samba-Kathua range, Shiv Kumar Sharma, during a security audit of various police and paramilitary deployments in and around the base camp, lodgements, yatra route, CCTV installations, and parking areas.

Sharma conducted a security review of Ram Mandir Purani Mandi, Geeta Bhawan Parade, the base camp at Bhagwati Nagar, various routes, and the highway, the spokesperson said.

He also interacted with officers and security personnel of the CISF deployed at Ram Mandir Purani Mandi, in Jammu and directed them to remain extra alert at their posts, the spokesperson said.

# Weather-based crop insurance scheme by October: Minister Javed

SRINAGAR: Cabinet Minister Javed Dar on Wednesday said the current administration has been in place for six months, and is committed to implementing decisions promptly and effectively. "Whatever happened earlier is not our responsibility. Now that we are in charge, our

focus is on execution," the minister, as reported by the news agency-Kashmir News Observer (KNO), said while speaking to reporters on the sidelines of a review meeting for Muharram arrangements in Pattan.

Responding to a query on the status of the Ial Jeevan Mission (JJM), Dar said funds have been made available, with only 20 per cent pending. "This is being actively taken up with the Government of India. and the matter will be resolved in the coming days," he added.

Addressing concerns over the recent hailstorm that caused damage to crops, the agriculture minister said those affected are being compensated under the State Disaster Response Fund (SDRF).

He announced that the departments of horticulture and agriculture are now planning to roll out a weather-based crop insurance scheme.

"Unfortunately, there were fewer bidders when this scheme was conceptualised 2-3 years ago. But now we are actively working on it, and by September or October, it will be implemented on the ground," Dar said.Regarding the water crisis in several drought-hit areas, the minister said the government is taking



## **Highway Travel** FASTag-Based Annual Pass For Private Vehicles From Aug 15: Gadkari

NEW DELHI: Union Minister Nitin Gadkari on Wednesday said the government will introduce a FASTag-based annual pass for private vehicles, priced at Rs 3,000, effective from August 15, in a step towards hassle-free highway travel.

In a post on X, Gadkari said the pass is valid for one year from the date of activation or up to 200

trips, whichever comes first. The pass is designed exclusively for non-commercial private vehicles such as cars, jeeps, and vans.

The road transport and highways minister said the annual pass will enable seamless and cost-effective travel across National Highways throughout the country.

Adedicated link for activation and renewal will soon be available on the Rajmarg Yatra App, as well

as on the official websites of NHAI and MoRTH, he added.

The minister said the average cost of passing a toll plaza will

be Rs 15 from August 15, 2025. Gadkari said the policy addresses long-standing concerns regarding toll plazas located within a 60 km range and simplifies toll payments through a single, affordable transaction.

"By reducing wait times, easing congestion, and minimising disputes at toll plazas, the annual Pass aims to deliver a faster and smoother travel experience for millions of private vehicle owners, ' the minister said.

The Ministry of Road Transport and Highways (MoRTH) clarified that those who already have a FASTag will not need to purchase a new FASTag.

## **Unified Pension Scheme Employees** to Get Gratuity Benefits: Dr. Jitendra Singh

**NEW DELHI. (PIB)**: In a major relief to lakhs of Central government employees, Union Minister Dr. Jitendra Singh on Wednesday announced that employees covered under the Unified Pension Scheme (National Pension System) will now be eligible for retirement and death gratuity benefits under the Central Civil Service (Payment of Gratuity under NPS) Rules, 2021.

The move addresses a long-pending demand and brings parity in retirement benefits for all categories of government employees.

According to a statement issued by press Information Bureau, Dr. Singh, who holds multiple key portfolios including the Ministry of Personnel, Public Grievances and Pensions, made the announcement while outlining the transformational reforms undertaken by the Ministry over the past 11 years under the Modi government.

Speaking at an event held at the National Media Centre, the Minister said, "The new gratuity provision reflects the government's commitment to social security and fairness for its employees.'

Dr. Singh highlighted four key pillars of reform-repealing obsolete rules, promoting fairness in recruitment, human-centric policies, and innovation through technology.

"For the first time since Independence, a government has taken pride in doing away with over 1,600 outdated rules, many of them colonial-era legacies," he said,

## Voter ID Delivery Now in Just 15 Days After Roll Update: ECI

NEW DELHI, (PIB): Election Commission of India (ECI) has introduced a new Standard OperatingProcedure(SOP) to ensure that Electors Photo Identity Cards (EPICs) are delivered to voters within 15 days of any update in the electoral rolls. This includes new enrolments as well as changes in existing elector details.

In a statement issued to Kashmir Convener, an official spokesperson said ECI has introduced a new Standard Operating

Procedure (SOP) enabling the delivery of EPICs within 15 days of an update in the electoral rolls, including new enrolment of an elector or change in any particulars of an existing elector.

He said the initiative is in line with the various measures being undertaken by the ECI for the convenience of electors as envisaged by the Chief Election Commissioner, Gyanesh Kumar along with Election Commissioners Dr. Sukhbir Singh Sandhu and Dr. Vivek Joshi.

Spokesperson further stated that the new system will ensure real-time tracking of each stage right from the EPIC generation by the Electoral Registration Officer (ERO) till the delivery of EPIC to the elector through the Department of Posts (DoP). Electors will also receive notifications via SMS at each stage, keeping them informed about the status of their EPICs.

For this purpose, ECI has introduced a dedicated IT module on its recently launched ECINet platform. Officials said the new IT platform will replace the existing process by re-engineering the current system and streamlining the workflow

He said DoP's Application Programme Interface (API) will be integrated with the ECINet for seamless delivery.

"This initiative aims to enhance service

delivery while maintaining data security," he said, adding Providing prompt and efficient electoral services to all its electors is a major focus area for the ECI.

**AMIT SHAH-LED Committee** Clears Major Relief Package for 2023 Flood and Landslide Recovery

New Delhi (PIB): The Government of India has approved central assistance of 2,006.40 crore for Himachal Pradesh to support the state's recovery and reconstruction efforts in the aftermath of the devastating floods, landslides, and cloudbursts that occurred during the 2023 monsoon season.

According to an official spokesperson of the union government, the decision was taken by a High-Level Committee chaired by Union Home Minister and Minister of Cooperation Shri Amit Shah.

The committee, which also included the Finance Minister, Agriculture Minister, and Vice Chairman of NITI Aayog, examined the proposal submitted by the state for financial support under the Recovery and Reconstruction funding window of the National Disaster Response Fund (NDRF).

Out of the total approved amount, 1,504.80 crore will be provided as the central share under the NDRF. This support will facilitate the state in carrying out long-term reconstruction and rehabilitation of critical infrastructure damaged during the disaster.

Earlier, on December 12, 2023, the Ministry of Home Affairs had already sanctioned 633.73 crore from the NDRF for Himachal Pradesh to address the immediate aftermath

of the calamity. Under the leadership of Prime Minister Shri Narendra Modi, the Government of India has reiterated its commitment to stand shoulder to shoulder with state governments during natural disasters.

The Ministry of Home Affairs, under the guidance of Home Minister Shri Amit Shah, has undertaken several initiatives aimed at enhancing disaster risk reduction and building a disaster-resilient India. The focus has been on reducing loss to life and property through strengthened preparedness and mitigation efforts.





## File Gather Dust as J&K's Sports Quota SPOs Fight for Regularisation

Srinagar, June 18 (KDC): In a glaring case of administrative delays, hundreds of Special Police Officers (SPOs) recruited under the sports category in Jammu & Kashmir continue to await regularization as constables, despite a clear 2009 policy mandating their absorption. The issue, pending for over years according to these SPOs, has left them and their families in financial and emotional distress, with repeated postponements of key meetings adding to their woes.

A delegation of sports category SPOs told Srinagar-based news agency Kashmir Dot Com that the Home Department of J&K had issued a circular (No. Home/PB-III/62/G/2008 dated 25-09-2009) outlining the regularization/rehabilitation of SPOs under the sports quota as constables. However, implementation has been marred by bureaucratic hurdles.

They said the Range Police Headquarters, Baramulla, had forwarded the cases of eligible SPOs to the Additional Police Headquarters (APHQ) Srinagar in 2022 through multiple communications (Estt/ SPO-Sports/2022/10640-41, Estt/Reh-38/2022/15277-78, and Estt/ Reh-38/2022/15263-64). These cases, accompanied by Range Level Committee (RLC) recommendations and original documents, were later sent to the DIG Armed Kashmir for final approval.

However, according to them, a scheduled meeting to review these cases (Notice No. AROK/6339-45 dated 03-07-2024) has been postponed multiple times, leaving the SPOs in limbo.

Speaking anonymously, an SPO from Baramulla said, "We have served the department with dedication, some of us for over a decade.

## **J&K's Power Future**

Union Minister Manohar Lal Khattar on his recent visit to JK said that India will move ahead with longpending hydropower projects. With the Indus Waters Treaty (IWT) now in abeyance, a new window of opportunity has opened—one that must be harnessed with vision. speed, and sustainability. Jammu and Kashmir has been the worst hit and victim of the IWT between the two countries with JK denied to get benefited from its own resource. Pakistan's persistent objections-like those over the Wullar Barrage—created a diplomatic deadlock that froze several critical projects. Now, with the treaty effectively suspended, India has sovereign claim over these waters. This moment calls not just for celebration, but for responsible nation-building. The Centre's decision to revive stalled hydropower initiatives is a necessary and timely move, especially for a region like J&K that holds vast untapped hydro potential but suffers from unreliable power supply and developmental lag.

But merely announcing projects is not enough. The execution must be swift, transparent, and inclusive. Infrastructure must be built with environmental safeguards and local participation. Projects like Wullar Barrage and others should not only generate electricity but also create employment, enhance irrigation, and offer longterm economic benefits to locals. Moreover, reviving these projects should include rehabilitative measures for any affected communities and ecological systems. The rhetoric of "blood and water not flowing together" is a strong diplomatic signal. It underlines India's shift from passive restraint to assertive self-interest in strategic sectors. However, it also puts the onus on India to set a global example in how to utilise transboundary resources responsibly, even when agreements falter.

Chief Minister Omar Abdullah's prompt engagement with the Centre over resuming two key power projects indicates political maturity and cooperative federalism. His government's readiness to implement these projects reflects a rare alignment between the Centre and the UT—something that must be sustained through dialogue, trust, and mutual accountability. As the power sector continues to face losses due to subsidised tariffs and rising demand, the focus should simultaneously be on efficiency reforms, smart metering, and public awareness about energy conservation. India must now seize this watershed moment to turn policy intent into grassroots change, ensuring that the rivers that once symbolised restraint now power a new era of self-reliance and prosperity for Jammu and Kashmir

# Beyond the Threshold: What Breaching 1.5°C Means for India — and for Kashmir

What This Means for Kashmir

Kashmir is often described as a land of breathtaking beauty – snow-covered peaks, shimmering lakes, alpine meadows, and apple-laden orchards. But beneath this postcard image lies a fragile ecological

foundation that is now under acute stress. For regions like Kashmir, a global temperature rise beyond 1.5°C is not merely a warning – it is a turning point.

The Himalayas are warming at nearly twice the global average, and Kashmir stands on the frontlines of this accelerated change. Glaciers in the Pir Panjal and Zanskar ranges are retreating at unprecedented rates, endangering the water flow that sustains both urban settlements and rural life. These glaciers feed the Jhelum River – the arterial lifeline of the valley. As glacial melt accelerates, it creates a paradox: sudden floods in the short term and looming water scarcity in the long term.

Kashmir's distinct ecological rhythms – the timing of snow, bloom, rain, and harvest – are already being disrupted. The valley's famed horticulture sector, especially apple and saffron farming, is struggling to adapt. Shifts in flowering periods, unexpected frosts, and heatwaves are not just hurting yields; they are shaking the confidence of entire farming communities. Crops that once flourished here, nourished by centuries of tradition and local knowledge, are now at the mercy of unpredictable seasons.

Tourism, a major contributor to the region's economy, is also vulnerable. A rise in extreme weather events, forest fires, landslides, and reduced snow cover could undermine the very image of Kashmir that attracts visitors. Climate change, if unchecked, risks turning this ecological sanctuary into a zone of instability and uncertainty.

Yet the most concerning part of this unfolding crisis is not just the change itself, but our collective unpreparedness for it. Climate risks have not been central to planning in the region – not in infrastructure, not in agriculture, not even in education. As a result,

local communities are left exposed. They rely heavily on traditional coping strategies, but these are being outpaced by the speed of environmental disruption. But within this vulnerability lies an opportunity an opportunity to act, to lead, and to protect what remains. Kashmir's young people are increasingly aware of the threats facing their land. They are or-

ganizing clean-up campaigns, starting eco-tourism ventures, planting native trees, and raising awareness through education and social media. With the right support – in terms of research, climate data, funding, and policy integration – these efforts can evolve into a powerful local climate movement.

For India, prioritizing climate resilience in Kashmir is not a regional favour – it is a national imperative. The protection of this Himalayan ecosystem is critical not just for Kashmiris, but for millions downstream who depend on its water and forests. It is a question of food, energy, biodiversity, and cultural heritage - all bound up in one valley.

If we take the 1.5°C threshold seriously, then Kashmir cannot be treated as a footnote in India's climate journey. It must be seen as a model for highaltitude adaptation, a place where sustainability is not just a goal, but a necessity. The region's deep environmental wisdom, combined with new scientific insight and national solidarity, can pave the way for long-term resilience.

What Should Be Done?

The science has spoken. The temperatures are rising. The question now is not what will happen, but what we will choose to do about it. The breach of 1.5°C is no longer a distant event to avoid – it is a lived reality to respond to, with urgency and clarity. For both India and Kashmir, this means turning warnings into action and forecasts into planning.

First, India must place climate at the center of its national agenda – not just in words, but in practice. That means integrating climate risks into agriculture,

soil restoration, and localised weather forecasting. In cities, it's time to future-proof against heatwaves and flooding through better drainage systems, green buildings, and cooling centres for the vulnerable.

Development plans must no longer treat climate

change as a background variable, but as the stage on

In rural areas, we need investment in climate-

For mountain regions like Kashmir, action must be tailored. Himalayan states need a dedicated adaptation strategy, supported by science but rooted in local reality. This includes glacier monitoring, sustainable tourism models, revival of traditional water systems, and afforestation using native species. School and college curricula must embed climate awareness early, not as fear, but as responsibility.

Data matters. Accurate, region-specific climate data – especially for sensitive areas like Kashmir – must be made accessible to researchers, planners, and communities alike. Without reliable data, there can be no informed action.

Just as importantly, we must recognise that climate solutions cannot come from governments alone. Local communities, civil society, students, farmers, and entrepreneurs are already doing quiet, creative work on the ground. What they need is support - financial, institutional, and emotional. Climate resilience cannot be built through top-down directives alone. It must grow from the grassroots.

India, as one of the world's most climate-exposed countries, also has the chance to become a leader, not just in renewable energy or international summits, but in building a new climate ethic. One that prioritises equity, prepares the next generation, and listens to those living closest to the crisis.

And in Kashmir, this ethic must translate into

trust, investment, and sustained ecological care. The valley's rivers, forests, wetlands, and people deserve not just admiration but protection. Climate-resilient livelihoods - in farming, tourism, and forestry must become the foundation of a sustainable future.

We cannot afford to wait. Every policy delayed, every forest cleared, every glacier ignored, makes recovery harder. The time for pilot projects and symbolic pledges has passed. This is the era for transformative action – grounded in science, guided by justice, and driven by people.

Conclusion – A Future Still Worth Fighting For The new projection is not merely a matter of temperatures. It is a matter of thresholds – environmental, economic, social, and moral. A 1.5°C threshold is not merely a scientific benchmark; it is a point between stability and doubt, preservation and loss. And we are set to cross it.

But projections are not destinies. They are warnings – and, possibly, last opportunities.

For India, the future is as bright as it is challenging. We must reimagine what progress means. Growth that undermines the very climate systems upon which we rely is not progress – it is delaying collapse. But growth that rejuvenates, that integrates the marginalized, that honours the cycles of land and water – that is the only path that holds a hope now.

For Kashmir, it is a more personal tale. Changes are already evident – in the receding snow, the worried farmer, the glacier's silent retreat. And yet, so too is the potential for resilience: in the people's local wisdom, in the vigour of its youth, in the quiet resolve of those who have always learned to coexist with the land.

What we do in the next five years will determine not only climate results, but the character of who we are as a nation – what matters to us, whom we care for, and whether we are courageous enough to act when it is most needed.

This is not the end. However, it may be the beginning of a new climate awareness, born of action, humility, and shared responsibility. We still have time. Not much. But enough – if we make good use of it. Let that be India's promise. Let that be Kashmir's hope.

#### From listening to conversation

Once we've agreed on the importance of listening to your audience, we must move to the next level: don't just listen have a conversation with them.

Too often, when newsrooms practice listening, information stops after flowing one way. We ask people for their ideas and opinions to get the insights we need for content or a project, and that makes us feel like we're listening. But if the conversation ends there, and we don't let audiences know what we do with the information they have generously provided, that won't do much to build trust and accountability.

Real listening and conversation means being transparent about the choices you make as a result of the listening process. It means acknowledging mistakes and correcting them; it means accepting that some people in your audience will always know more than you about any given topic – and you can ask for their help; it means being open, showing how journalism is done, and even sharing the difficult choices you make on a daily basis, rather than just giving people the final product and expecting them to automatically trust you.

#### Making sense of the world, together

Let's go one step further: I would argue that healing our relationship with the people we aim to serve requires us to stop thinking of us (working in journalism) and them (the audiences) as two different breeds. Journalism might be a job for us and not for them; but journalism, intended as the process of making sense of the world through information, is a collaborative effort we are all taking part in. We are all human beings trying to understand the world – together.


Add to that that we often forget that each one of us working in journalism is also someone else's audience. Our news consumption might not be representative because we are so immersed in this journalism thing day in and day out, but that doesn't mean we should forget to bring our insights as readers and users into our work.

Some newsrooms understand that so well that they made this part of their editorial strategy: readers of Il Post(an Italian digital media founded in 2010) have heard the editorial team sharing multiple times that one of their criteria for deciding

But back to the audience side of things: let's mind our language. Over the last few months, at various industry conferences as well as on social media, I started paying attention to how we talk about the people we aim to serve with our journalism, and I found myself feeling quite uncomfortable and even a little... cringe.

We refer to audiences as eyeballs, credit cards, numbers. Rarely as people with problems and needs that is our mission to help and meet. Our obsession with page views and engagement – justified in its essence but not in how it translates into practice – leads us to dehumanize the audience, making it harder to find optimism and motivation in our sense of purpose.

I don't mean to suggest this as a silver bullet – spoiler alert: there is no silver bullet – but I strongly believe there's one thing we must be doing much more often to counter this trend toward dehumanization: meet our audiences in real life.

The good news is that this is already happening. Many brands organize events, live shows, think-ins, and other occasions to meet face to face the people they work for. We must

After a long list of "we must do" and "we must change," I feel like it's time to acknowledge the elephant in the room: change is hard. And working in journalism is often... well, not easy, to say the least.

That's exactly why I believe we should continue building spaces and support groups where we can feel "less alone in the big fight," as one of my News Alchemists friends put it. Working on changing journalism and redefining the relationship with our audiences requires serious and difficult conversations, but we can design joyful processes to guide us through them. We can be playful and continue bringing hope to the table as we shape our future, whether within our teams or with the products and experiences we create.

I also want us all to embrace what Candice Fortman wrote in an incredible post on LinkedIn a few weeks ago: "Saving journalism has never been the job." We can only go through change with hope and a positive attitude, and get out of it healthy and successful, if we free ourselves of the pressure them anymore, so be it. Let's shed the old skin and find out how beautiful the new skin can be, whatever it looks like.

So let's stop protecting old ways that don't work anymore and only exist to guarantee their own survival. Let's do what we can to help our organizations look more like what we need them to be to serve our mission, but let's also give ourselves permission to stop working for organizations that just don't want to change. Let's encourage each other to recognize when it might just be time to let them go.

I believe that journalism can and will be better. I believe that 2025 can truly be the year when we redefine our relationship with audiences and our role in society. If we continue supporting each other, with passion and care, we can really make a difference and invite more people to join arms with us. Because we all need to be involved. The change we need is systemic and it's the business of all of us. not just of a few chosen ones with "innovation," "product" or "leadership" in their job title. So let's get together. There's work to do.

#### What's next for News Alchemists

The work I started on News Alchemists has not concluded with the end of the fellowship. In 2025, I plan to continue it by:

(1) Consulting for news organizations that want to find new avenues for sustainability by optimizing their mission and value proposition for the concrete value they can offer to their communities.

(2) Continuing to facilitate important conversations about how to put people at the center of our journalism through the News Alchemists community, which is ready to grow from 15 founding members into a bigger group of thinkers and doers from across the information ecosystem.

(3) Writing a weekly newsletter featuring a list of seven things I read that make me think and give me hope: links about changing journalism, and about audience, community and sustainability. (Something that I've already been doing on LinkedIn in preparation for starting the newsletter.)

This pain doesn't always stem from betraval or anger-it grows silently from the gradual breaking of bonds that once felt unbreakable. There is nothing more painful than feeling alone in the presence of someone you love. When silence replaces conversation, and distance grows between people living side by side, the heart breaks-but quietly. No loud fights, no final words. Just the soft fading of something once vibrant and alive.

What deepens the hurt is when both people are suffering, yet neither speaks. Both want to fix things, but pride stands in the way. Both miss each other but wait for the other to speak first. We often hesitate: "What if I say too much?" "What if I look weak?" "What if they don't feel the same?" But vulnerability isn't weakness. It's strength. It takes courage to open your heart, to speak your truth, to try again when giving up feels easier.

## **Tracing the Timeless Journey of Yoga: From Ancient Roots to Global Movement**

As India marks the 11th International Day of Yoga, the 2025 theme "Yoga for One Earth, One Health" resonates deeply with the global community's collective aspiration for unity, wellness, and ecological harmony. From the icy heights of Ladakh to the lush backwaters of Kerala, millions are joining in celebration, embodying the timeless wisdom of Yoga—a discipline that has transcended geography, faith, and time.

Yoga, today, is practised by millions across the globe. Yet its origins lie deep within the spiritual soil of ancient India, where it first emerged not merely as a form of exercise but as a path to inner peace and self-realisation. "Yoga is India's enduring gift to the world—a living heritage that blends physical, mental, and spiritual well-being," said a senior official from the Ministry of Ayush, which has been instrumental in organising events for the International Day of Yoga

Historical references to Yoga appear across India's sacred texts-the Vedas, Upanishads, Smritis, Puranas, and even in Jain and Buddhist scriptures. During the Vedic period, Yoga was closely tied to Upasana (spiritual worship) and rituals. Practices

"The influence of Yoga can be traced in our epics-the Ramayana and Mahabharata-and in the teachings of theistic traditions like



Shaivism and Vaishnavism," noted Dr. Rajiv Kumar, a scholar of Indic spirituality. "Its evolution is not linear but layered, adapting itself to the spiritual needs of each era."

A pivotal moment in Yoga's history came with Maharshi Patanjali around the 2nd century BCE. Though Yoga had long existed in practice, it was Patanjali who systematically compiled its philosophies into the Yoga Sutras, laying out the foundational principles of Ashtanga Yoga-the eightfold path to enlighten-

like Pranayama (breath control) were part of daily life, conducted ment. His concise yet profound treatise transformed Yoga from scattered practices into a cohesive, universal system.

> Between 700 and 1900 CE, during the classical and pre-modern periods, Yoga continued to evolve. Hatha Yoga emerged, focusing on the physical body as a tool for spiritual progress. Foundational texts like the Hathayogapradipika, Gheranda Samhita, and Goraksha

> > Shatakam detailed specific yogic postures and techniques. Great saints such as Ramakrishna Paramahamsa, Ramana Maharshi, Paramahansa Yogananda, and Swami Vivekananda shaped the way Yoga was understood and practised, both within India and abroad.

> > Swami Vivekananda's powerful address at the Parliament of the World's Religions in Chicago in 1893 is widely seen as a defining moment in the global dissemination of Indian philosophy and Yoga. "He gave the world a glimpse of India's spiritual reservoir and made Yoga a household name in the West," said a historian of Indian philosophy.

> > In the 20th century, figures such as T. Krishnamacharya, Swami Sivananda, B.K.S. Iyengar,

Pattabhi Jois, Swami Kuvalayananda, and Sri Aurobindo further shaped modern Yoga by exploring its therapeutic, psychological, and spiritual dimensions. Their disciples and institutions helped bring Yoga into the mainstream—across clinics, classrooms, and even corporate offices.

A defining global moment arrived on September 27, 2014, when Prime Minister Narendra Modi addressed the United Nations General Assembly (UNGA), urging the international

community to adopt Yoga as a means to promote holistic health. "Yoga is an invaluable gift of India's ancient tradition. It is not about exercise but discovering the sense of oneness with yourself, the world and nature," Modi told the UN. His call was met with resounding approval.

On December 11, 2014, the UNGA, with the support of 193 member states, declared June 21-the Summer Solstice-as the International Day of Yoga. The date holds both scientific and spiritual significance: it marks the longest day of the year in the northern hemisphere and is traditionally believed to be the day Lord Shiva, the Adi Yogi, began imparting Yoga to the Saptarishis (Seven Sages).

**Training on Pension Suvidha Portal** conducted for DDOs at Baramulla



PM Modi told President Trump in clear terms that after the April 22 Pahalgam terror attack, India had conveyed its determination to take action against terrorism to the whole world.

PM Modi told Trump that India had only targeted the terrorist camps and hideouts in Pakistan and Pakistan-occupied Kashmir, adding India's actions were very measured, precise, and non-escalatory.

"India had also made it clear that any act of aggression from Pakistan would be met with a stronger response," the foreign secretary said.

'On the night of May 9, Vice President (JD) Vance had made a phone call to Prime Minister Modi. Vice President Vance had conveyed that Pakistan may launch a major attack on India," the Foreign Secretary said.

Prime Minister Modi had conveyed to him in clear terms that if such an action were to occur, India would respond with an even stronger response, he said.

'On the night of May 9-10, India gave a strong and decisive response to Pakistan's attack, inflicting significant damage on the Pakistani military," he said on the phone conversation.

"Their military airbases were rendered inoperable. Due to India's firm action, Pakistan was compelled to request a cessation of military operations," he said.

Misri said President Trump enquired if PM Modi could stop over in the US on his way back from Canada. "Due to prior commitments, Prime Minister Modi expressed his inability to do so. Both leaders agreed to make efforts to meet in the near future," he said. (KNO)

In this context, he announced the appointment of a Secretarylevel Nodal Officer-independent of the Divisional Commissioner-to coordinate inter-departmental efforts and oversee Muharram arrangements across the Union Territory.

The Chief Minister outlined key focus areas identified during the meeting:

Water Supply: CM assured uninterrupted water availability through the deployment of tankers and installation of storage tanks at key locations.

Electricity and Lighting: The Power Development Department was directed to ensure uninterrupted electricity supply and install high-mast lights at maior congregation points.

Ration and Firewood: He instructed the Food Department, in coordination with FCI. to ensure timely availability of ration. Firewood will be provided, particularly in rural areas where demand is higher.

Sanitation and Health: Municipal bodies and the Health Department was asked to intensify sanitation drives and ensure the availability of essential healthcare security, will be put in place. "This time, all kinds of arrangements will be better, whether it is ration or transportation. You will see the change," he added.(KNO)

## India Launches

4,000 Indian nationals are living in Iran and half of them are students.

The MEA said the Indian embassy in Tehran has evacuated 110 Indian students from northern Iran, assisting them in safely crossing over into Armenia on Tuesday. The students have travelled by road to the Armenian

capital, Yerevan, under the supervision of the Indian missions in Iran and Armenia. "These students departed Yerevan on a special

flight at 1455 hours on June 18 and will arrive in New Delhi in the early hours of June 19 as part of the initial stages of Operation Sindhu," the MEA said.

New Delhi said it is grateful to the governments of Iran and Armenia for the smooth facilitation of the evacuation process.

In view of the deteriorating situation as a result of the ongoing conflict between Iran and Israel, India has been taking various steps over the last several days for the safety and security of Indian nationals in Iran.

"As part of the ongoing operation, the Indian embassy in Iran has been assisting large numbers of Indian nationals in moving from areas seeing increased hostilities to relatively safer areas within the country and to subsequently evacuate them using the available and feasible options," the MEA said.

"Indian nationals in Iran are advised to stay in touch with the Indian Embassy in Tehran through its emergency helpline, and with the 24×7 Control Room established by the MEA in New Delhi," it said. (PTI)

## Heatwave returns

Srinagar, the summer capital of Jammu and Kashmir, on Wednesday recorded a maximum temperature of 32.5 degrees Celsius.

Qazigund, a gateway of Kashmir, recorded a maximum temperature of 31.4 degrees Celsius while Pahalgam recorded 27.0 degrees Celsius. In Kokernag, the mercury settled at 30.8 degrees Celsius, while Kupwara and Gulmarg, a famous ski resort, recorded 30.5 degrees Celsius and 22.8 degrees Celsius, respectively.

Jammu city, however, continued to record below normal temperatures, with the winter capital of the region recording a maximum temperature of 37.6 degrees Celsius.

Banihal recorded 29.4 degrees Celsius, Batote 27.8 degrees Celsius, Katra 35.2 degrees Celsius and Bhaderwah 30.8 degrees Celsius.

Meanwhile, the weatherman here has predicted generally dry weather with the possibility of a brief spell of rain and thundershower with gusty winds at isolated places till June 20.

Between June 21 & 22, Director MeT, Dr Mukhtar Ahmad said that generally cloudy weather with intermittent spells of rain and thundershower is expected at many places.

He added that on June 23 & 24, the weather conditions are expected to remain dry with the possibility of a brief spell of light rain and thundershower at isolated places while from June 25 to June 27, generally cloudy weather is expected with possibility of intermittent spells of light to moderate rain and thundershower at many places.

During the financial year 2024-25, the Central Government has released Rs. 20,264.40 crore to 28 States under SDRF and Rs. 5,160.76 crore under NDRF to 19 States," it said, adding, "Additionally, Rs. 4984.25 crore from the State Disaster Mitigation Fund (SDMF) to 19 States and Rs. 719.72 crore from National Disaster Mitigation Fund (NDMF) to 08 States has also been released." (PIB)

## **FASTag-Based**

"The annual pass can be activated on your existing FASTag, provided it meets the eligibility criteria (i.e., it is properly affixed on the vehicle's windshield, linked to a valid Vehicle Registration Number, not blacklisted etc)," it said.

The annual pass is valid only at National Highway (NH) and National Expressway (NE) fee plazas.

At fee plazas on Expressways, State Highways (SH), etc., managed by State Governments or local bodies, the FASTag will operate as a regular FASTag, and applicable user fee charges may apply.

The annual pass is applicable only for private non-commercial Car/Jeep/Van. Use in any commercial vehicle will result in immediate deactivation without notice, the highways ministry said

The annual pass will be activated only on FASTags properly affixed to the windshield of the registered vehicle. Each crossing of the fee plaza counts as one trip. A round trip (to and fro) counts as two trips. According to the ministry, for closed tolling fee plazas, one pair of entry and exit counts as one trip.

The ministry also clarified that the annual pass is not mandatory and that the existing FASTag ecosystem will continue to function as usual.

"Users who do not opt for the annual pass can continue to use their FASTag for regular transactions as per applicable user fee rates at fee plazas," it said.

The ministry said highway users may re-purchase the annual pass once the 200-trip limit is exhausted, even if the one-year validity period has not yet ended.

## Tharindu Rathnayake: I switch bowling arm according to weakness of batters

"When I started first-class cricket, I bowled a lot with my left arm. But later, it became about 60% right arm, and 40% left arm."

"Idon't know which arm I've taken more wickets with," says Tharindu Rathnayake of his wicket tally in domestic cricket. "I've never looked at it properly. I've bowled a lot with both my arms."

If this seems like bragging, Rathnayake continues to speak as if being able to bowl with either arm is a normal experience to which anyone could relate. It must seem natural to him, though - he has 337 first-class wickets, and 122 List A dismissals.

"When I started first-class cricket, I bowled a lot with my left arm. But later, after a couple of years, it became about 60% right arm, and 40% left arm."

Right, so why, on day one of his debut Test, against Bangladesh in Galle, did Rathnayake bowl 15.5 overs of rightarm offbreaks before he tried his first ball of left-arm spin?

"I just felt that the ball that turns into the batter is harder for them to face because this wicket is suited to the batters. When you bowl right-arm offspin against righthanded batters with the red ball, it's not easy for them to play. When I bowl offspin, I also have more options with the fields I can set. With left-arm spin, because the wicket is not behaving as we want it to, they can put the ball into gaps, and they have more scoring options."

To what extent Rathnayake knows this unusual craft is not clear yet. Unlike Kamindu Mendis, the other ambidextrous spinner in the side, Rathnayake is primarily a bowler. In the match-ups age, though, being able to bowl with either arm could be a supremely useful skill. Rathnayake seems to be aware of that potential.

"Before we come to the match, in our planning, we spin. I'm expecting it to stay good until day four." talked about what each batsman is better at facing, and which sides they hit to," he said. "So I try to create plans


around their weaknesses, and change which arm I'm bowling with according to that."

Though Rathnayake claimed two wickets-both left-handers caught at slip against his offbreaks - in his first session of Test cricket, he said the Galle pitch got better to bat on through the day. "There was a little moisture early

on, but it dried out. There wasn't much ecting it to stay good until day four."
