J&K Bets Big on Hydel Energy as India Puts Indus Water Treaty in abeyance JAKEDA floats tenders for 35 Hydel projects to generate 60 MW across JK

Shahid Choudhary stresses science-led development and local employment through green projects

SRINAGAR:: A month after India put Indus Water Treaty in Abeyance, the Jammu & Kashmir Government has taken proactive measures to tap water resources for its own benefit by floating bids for 35 small Hydro Projects Across Jammu and Kashmir with a combined capacity of 60 megawatts (MW).

Jammu & Kashmir Energy Development Agency (JAKEDA) on Wednesday invited online bids for the development of micro, mini, and small hydroelectric power projects across the Union Territory

including 17 projects under the Swiss Challenge Method (SCM) with a capacity of 30.85 MW and 18 projects under IPP mode with a total capacity of 29.20 MW.

On June 12, Union Minister for Power and Urban Affairs, Manohar Lal Khattar, during his visit to JK, said that the Centre will move ahead with new power projects in Jammu and Kashmir as there are no restrictions after the Indus Waters Treaty (IWT) being put in abeyance post Pahalgam Terror attack.

Khattar said that as India has now sovereign claim over its waters, the country will now fully utilize it. "As the IWT continues to remain in abeyance, we are moving forward with new power projects in J&K," he said.

A week after Ministers statement, JAKEDA identified 35 hydro projects in 15 districts of the Union Territory to generate about 60 MW of electricity.



Secretary Science & Technology J&K, Shahid Choudhary, who recently assumed charge said these projects will harness JK's rich

hydropower potential to deliver clean, renewable energy to the people besides fulfilling the local demands.

He said these projects are part of JAKEDA's broader strategy to tap untapped hydro resources and promote distributed renewable energy infrastructure.

He said each district is also being targeted for large scale solar energy projects making Jammu and Kashmir a leader in decentralized and sustainable energy models.

These include 17 projects under SCM including 1.5MW HEP at Narastan Pulwama, 2 MW HEP at Buddhar Kither Kishtwar, 1.8 MW at Kither, 1.0 MW HEP at Kiyar Sirchee, 2 MW HEP at Chatru-Prawra-II, 2 MW HEP at Prawra-I, 2 MW HEP Prawra-II, 2 MW HEP at Suid Dachan and 1.8 MW Upper Hori in Kishtwar district, 0.70 MW at Shutkari and 1.8 MW HEP at



SRINAGAR: Amid the forecast of an intense heatwave until Saturday, the Kashmir region has witnessed an unexpected rise in the maximum temperature, surpassing decades-old records at three stations.

According to details obtained by the news agency-Kashmir News Observer (KNO)–Srinagar, the summer capital of

Jammu and Kashmir, recorded the highest June temperature in the last two decades. The station recorded a maximum temperature of 35.2 degrees Celsius, which was the season's hottest so far.

SRINAGAR: In view of the escalating war between Iran and Israel, at least 500 students of Kashmir studying in Iran are likely to board the flights to India from Turkmenistan on Friday.

The Jammu and Kashmir Students Association (JKSA) in this regard said that around 600 Indian students, including 500 from Kashmir, have been safely relocated from Oom to Mashhad, a border city in Iran. as part of the ongoing evacuation efforts. National Convenor of Jammu and Kashmir Students Association (JKSA) Nasir Khuehami

told the news agency—Kashmir News Ob-server (KNO), "This is the second group of

students who were earlier moved to Qom, where they remained for three days. Their evacuation process is currently underway." "The students are from various institu-tions, including Islamic Azad University, Iran University of Medical Sciences, and Shahid Beheshti University. From Mashhad, they are expected to be taken to Turkmenistan, from where they will likely board flights to Delhi tomorrow," he said



Govt Launches Special Campaign 2.0 to Address Grievances of Family and Super Senior Pensioners

Under this campaign, a total of 2,210 pension grievances have been identified and forwarded to 51 Ministries, Departments, and Organizations for resolution. These bodies have been urged to not only address the cases promptly but also to share success stories and best practices through PIB releases and social media, ensuring wider awareness and transparency

To prepare for the campaign, a high-level meeting chaired by the Secretary (Pension) was held on June 11, bringing together nodal officers responsible for pensioners' grievances across departments. The DoPPW is monitoring progress on a daily basis, and as per current data, more than 25% of the identified cases have already been resolved, signaling an encouraging start even before the campaign's official launch.

CHENNAI(PIB): The Department of Telecommunications (DoT), in collaboration with the Indian Institute of Technology Madras (IIT Madras), inaugurated the three-day Telecom Technology Development Fund (TTDF) Symposium 2025 at the IIT Madras Research Park on Wednesday.

An official spokesperson said the landmark event aims to bolster collaboration between academia, startups, and industry in the domain of next-generation telecom R&D, with the goal of making India a global telecom innovation hub.

The symposium was inaugurated by Dr. Neeraj Mittal, Secretary, Telecom, alongside Prof. V. Kamakoti, Director of IIT Madras; Shri Gulzar Natarajan, Additional Secretary (Telecom); Dr. Parag Agarwal, DDG (TTDF); and Prof. R.K. Ghanti of IIT Madras. Also present were senior officials from the Department of Telecommunications and representatives from startups, MSMEs, research bodies, and academic institutions.

The TTDF, launched by DoT to foster indigenous telecom technology development and bridge the digital divide in remote and rural areas, has already sanctioned more than 120 projects with a total funding exceeding 500 crore. Over 187 crore has been disbursed so far, supporting Indian academic institutions, startups, MSMEs, and research organizations in developing critical telecom solutions.

Addressing the gathering, Dr. Mittal said the symposium marks a pivotal moment in India's innovation journey. "This is an opportunity to leapfrog in telecom innovation," he said, adding that the government's

consistent efforts over the past decade have effective deliverables from institutions and laid a strong foundation for technological researchers to complement the government's transformation. He urged stakeholders to trust and investment.

Shri Gulzar Natarajan highlighted that TTDF is not merely a funding mechanism but a strategic initiative aimed at achieving sovereign capability in telecom, which is critical to national security, economic

event was the launch of the Multicore Fiber Testbed Project, a major step towards strengthening India's optical communication infrastructure. Jointly developed by IIT Madras and STL Technologies, the testbed includes 4.07 km of underground and 1.2 km of aerial cable with both standard single-mode and multicore fibers. The facility is open to academia and industry for testing interoperability and developing use cases within the multi-core fiber (MCF) ecosystem.

Prof. Kamakoti expressed gratitude for the substantial support from the DoT, noting that IIT Madras has received numerous TTDF-funded projects over the last two years. He emphasized the need for development, and social progress. He called for harnessing collective strength and fostering a culture of co-innovation that is both impactful and execution-focused.

The symposium has brought together over 500 participants, including principal investigators, faculty members, industry experts, and government officials. Technical sessions, project showcases, and synergybuilding workshops are being conducted across key emerging areas such as 6G, AI/ML for IoT, satellite communications, and quantum networking. Senior representatives from Bharat 6G Alliance, TSDSI, C-DoT, COAI, and top telecom firms are actively participating in the deliberations.

Rajkot Turns Legacy Waste Dumpsite into 20-Acre Urban Forest

RAJKOT: In a landmark transformation under the Swachh Bharat Mission (Urban), the city of Raikot has successfully converted a decades-old dumpsite laden with 16 lakh tonnes of legacy waste into a thriving 20-acre urban forest, offering a powerful example of sustainable waste remediation and urban ecological restoration.

In a statement issued by Press Information Bureau(PIB), an official spokesperson said the shift towards scientific waste management gained momentum with the launch of Swachh Bharat Mission in 2014, followed by the Solid Waste Management Rules in 2016, which emphasized the goal of "zero waste to landfill". With SBM-U 2.0 strengthening this vision through initiatives like "Lakshya

the challenge to reclaim degraded lands and eliminate legacy waste. Among them, Rajkot stands out with its transformation of the Nakrawadi dumping site. The city, which generates around 700 tonnes

of municipal solid waste daily, had historically disposed of all its waste at this site. Over the years, this resulted in the accumulation of approximately 16 lakh tonnes of waste, posing a severe environmental and public health hazard.

In response, the Rajkot Municipal Corporation initiated a comprehensive dumpsite remediation project. A detailed waste assessment

survey was carried out, and advanced machinery was deployed to process and segregate the waste into refuse-derived fuel

(RDF), semi-compost, and inert materials. While RDF was sent to the Jamnagar waste-toenergy plant, inert components were shifted to a secured landfill facility.

Meanwhile, over 50,000 tonnes of semicompost were utilized on-site to level the land and enrich the soil.

To restore the area as a green space, approximately 2.35 lakh native and fastgrowing trees were planted using the Miyawaki afforestation technique. A 12 km pipeline was laid to connect the site to the Gauridad Sewage Treatment Plant, ensuring a consistent supply of treated wastewater for irrigation.

Additionally, water harvesting ponds were created to aid groundwater recharge, while drip and sprinkler irrigation systems were introduced to promote water-efficient horticulture.

Subsequently the undersigned issued a Charge Sheet against you vide this office NO. 3459-62, 30-07-2024, in order to explain your position within four (04) days positively, while you failed to submit the same. Again vide this office Letter No. EE/BUD/Estab/3901-03, dated: 09-08-2024, you were informed that you have failed to explain your position, however you did not respond.

On 28-08-2024, you have submitted a joining report to the office of the Assistant Executive Engineer Sub-Division Budgam duly forwarded by her vide her office No. SDB/1028, dated: 28-08-2024 wherein you submitted that you were suffering from multiple ailments for the time period from 27-06-2024 to 27-08-2024 (attaching medical prescriptions and the character certificate from the Police Station Ashmugam) and also requested to be treated on medical leave for the said period and you won't remain absent in future from legitimate duties without a pre-sanctioned leave. The same was considered and a part of pending salary was released in your favor.

Whereas again vide No. SDB/1299-1300, dated: 05-11-2024, the Assistant Executive Engineer Sub-Division Budgam called an explanation from you with an intimation to the undersigned, that you have remained unauthorizedly absent from duties for last four (04) days. Again vide her office No.s SDB/1323-24, dated 09-11-2024 & 1366-67, dated 19-11-2024 the officer called another explanation from you citing that you have continuously remained absent from your duties and once again directed you to explain your position. Subsequently, the undersigned also called explanation from you vide No. EE/BUD/Estab/8446-48. dated: 18-11-2024 and a final explanation vide No. EE/BUD/Estab/9212-15, dated: 09-12-2024. The Superintending Engineer PW(R&B) Circle Budgam also called a final explanation from you vide his office letter No. SE/BUD/Estt/5979-82, dated: 10-12-2024, directing you to explain your position and report for further duties to his office from 11-12-2024 onwards, however you did not respond to him as well and subsequently the worthy officer, vide No. SE/BUD/6117-19, dated: 16-12-2024 reported that you have not attended the office till that date.

Then on 13-01-2025, you had submitted a reply to the explanation, to the office of the Superintending Engineer PW(R&B) Circle Budgam, stating that you have developed Neurological issues and that you have been prescribed the drugs which are sleep inducing in nature, because of which your punctuality in disposing off your duties gets hit occasionally. The worthy officer vide No. SE/BUD/6770-72, dated: 13-01-2025, directed you to report to the Divisional office and to be regular in future and comply with all the duties assigned to you. However, you did not bother to report to the Divisional office till date.

Again, vide this office Letter No. EE/BUD/Estab/10694-96, dated: 22-01-2025 you were intimated that you did not join your duties despite lapse of considerable time. But you have not turned up to join back your duties or even reply to the queries till date. Whereas the Show Cause Notice was served to you vide this office No. EE/BUD/Estab/11364-68, dated: 18-2-2025 and duly published in the Daily Aftab/Shahanshah/Srinagar-Samachar/Kashmir-Aman, giving you a chance to explain your position within two days positively, but unfortunately you have failed to explain your position and did not join your duties till date. Through the medium of this notice, you are once again directed to explain your position within two days positively, failing which it shall be deemed that you are no longer interested in the government services and accordingly the undersigned will have no alternative but to recommend for your suspension from government services, to the higher authorities and duly publish the same in print as well as electronic media.



The third meeting of the Central Sanctioning and Monitoring Committee (CSMC) held on Wednesday, approving 2.35 lakh houses under the PMAY-Urban 2.0 scheme, is more than just a policy milestone—it is a significant step towards fulfilling the dreams of millions of urban poor and middle-income families yearning for dignified housing.

With this, the total number of sanctioned houses under PMAY-U2.0 stands at nearly 7.10 lakh, underscoring the government's steady commitment to the cause of "Housing for All." This vision, anchored in equity and empowerment, has evolved meaningfully since the original launch of PMAY-U in 2015. Now revamped as PMAY-U 2.0, the scheme aims to cover one crore new urban households, offering pucca homes along with financial stability, dignity, and access to basic urban amenities.

What makes this approval round especially noteworthy is its inclusive approach. Of the newly sanctioned houses, over 1.25 lakh have been allotted exclusively to women, including widows and single women—furthering gender empowerment in the housing sector. Additionally, 44 homes have been allotted to members of the transgender community, setting a rare but much-needed precedent for social equity and inclusion. The scheme also ensures representation of SC, ST, and OBC communities, with over 1.73 lakh houses earmarked for them.

As the urban housing landscape evolves, the call for States and Union Territories to frame affordable housing policies, and to study successful models like that of Maharashtra, is well placed. Encouraging a Transit-Oriented Development (ToD) model—especially near NAMO Bharat stations and metro lines—not only enhances urban mobility but also ensures smart growth and spatial equity in our cities.

However, challenges remain. Unoccupancy of constructed units, delayed beneficiary identification, and project execution lags need urgent resolution. PMAY-U 2.0 is not just about building houses—it is about strengthening the urban social fabric, enhancing quality of life, and giving aspiring families a foundation from which they can dream bigger. It's a chance to correct the urban-rural developmental imbalance, and more importantly, to offer a sense of belonging to those long ignored by the system. The government must now ensure speedy construction, transparent allotment, and robust quality checks so that these approvals translate into real roofs over real heads—without delay or dilution.

In contrast, the Arab Spring movements highlighted the tensions between modern aspirations for democracy and traditional power structures, revealing the complexity of negotiating change in culturally rooted contexts.

Religion, a cornerstone of tradition, has been particularly affected by modernity. The secularization of public spaces and the rise of scientific rationality have challenged traditional religious authority, leading to debates about the relevance and reinterpretation of sacred texts. Movements like Islamic modernism, spearheaded by thinkers such as Jamal al-Din al-Afghani,Muhammad Abduh, Sir Sayyid Ahmad Khan, Rashida Rida, Allama Muhammad Iqbal, Fazlur Rahman, Ali Shariati, Mahmoud Mohamed Taha, Amina Wadudud and scores of others sought to reconcile faith with reason, advocating for reinterpretations of Islamic jurisprudence in light of modern realities. Scholars like Al-Farabi, Ibni Khaldun, Sayyid Qutb offer a reich legacy of the synergy between modernity and tradition in Islamic thought alongside with modern thinkers that have been masterfully explored harmonious synergy like Dr. Mureinterpreted Islamic principles for modern governance, while Iqbal envisioned a revitalized Islamic thought that engaged with modern science and philosophy. Maududi's concept of an Islamic state and Zayd's contextual Quranic exegesis further demonstrate that tradition can evolve without losing its core values. Ramadan's "European Islam" emphasizes how modernity and Islamic identity can coexist. Together, these scholars illustrate that modernity and tradition are not opposites but complementary forces, where Islamic principles can offer profound solutions to contemporary problems, leading to a dynamic interplay that renews and enriches both.

While as R.Guenon, MartinLingus, Huston Smith, Fritjof Schuon ,Seyyed Hossein Nasr etc. within the perennial philosophy or tradditionalist school are instrumental in fostering a nuanced understanding of Islam that transcends geographical and cultural bounderies, resonating with seekers worldwide. While they may be not be conventional "reformers" in the modernist or political sense, their contributions profoundly impact Islamic spiritual and intellectual renewal and crosscultural understanding. They emphasize universal/metaphysical/mystical/perennial dimensions/ truths underlying Islam and other religions. However they share some parallels with reformers like responses to crises, renewal of thought, reformers of consciousness with global influence.

The interplay also manifests in the cultural sphere. Traditional art, music, and literature have been revitalized through modern mediums, reaching global audiences in unprecedented ways. Indigenous crafts have found new markets through and meaning, reducing it to a mere aesthetic or commercial product. This raises ethical questions about the preservation and authenticity of cultural heritage in a modern world.

Modernity, for all its promises of progress, has also brought about significant disruptions. Industrialization and urbanization have led to the disintegration of traditional rural communities, while globalization has homogenized cultural expressions, threatening linguistic and cultural diversity. Indigenous societies, in particular, have faced existential threats as modern development encroaches on their lands and ways of life. The struggles of the Maasai in East Africa to preserve their pastoral lifestyle amidst pressures of modernization and land privatization exemplify this tension. Debating or Dismissing Ghamidi: A Mirror to Muslim Modernity

In this backdrop of stormy turbulent weather and flood in full fury and urgent need for survival, we hear, amidst a cacophony of voices, some other voices that do merit our consideration. Ghamidi phenomenon that include path breaking work in fiqh and hadith of Ghamidi (regarding kalam, philosophy and esoteric current in Islam he has not made notable advances and instead invited strong censure from stalwarts of Islamic Tradition) a host of brilliant scholars inspired by him and critically building on him or responding to him – is one though it and moving forward to Ghamidi appears with certain proposals that merit our consideration or examination.

The best scholars from Jonatthen Brown to Wahidudin Khan have recognized significance of Ghamidi for discipline of hadith and reconstruction of legal thought respectively. no longer an individual but an institution (Al-Mawrid) that has demonstrated credentials in engaging with tradition.

He puts first things first. When asked in religion or politics that Muslims he says it is ilm that will save them. And we know the Quran asserts the link between salvation and ilm or right use of reason so categorically. He states that he wants to be remembered as one who served the cause of ilm. Man is converted when his mind is convinced and heart gives assent. You can't force conviction. Ghamidi's arguments often convince far better than those who criticize him. He has to be fought on the level of argument. Fatwas against him help only to increase his popularity.

Like Syed Moududi, he has been perhaps the most influential contemporary scholar who speaks so eloquently against modernity's error regarding God or Transcendence and helps people connect to God. If a dayi is one who presents Deen in such a way that one is hardly left with an argument against it then Ghamidi is one of the most important dayees today. He is guarding a frontier where traditional Ulama can't tread due to ignorance of modern forms of disbelief. Neither Darwin nor Freud nor Marx were in the days when classical Mutakilmoon wrote. Answers to Modernism written by major Muslim scholars do

Ghamidi is more convincing than most of the popular preachers we watch on TV or YouTube. He is less convincing on matters that concern application of methodology that he defends with far more conviction in principle. He is least convincing on Sufism and criticism of Muslim philosophers. But his enduring contribution that constitutes what we can see as the core of Ghamidi thought is taking a more objective look at modern challenges and reflecting deeply on key sources and having the courage to think and dare to differ in application of Islamic legal thought. He has little to contribute to theology or creedal formulations in general though valuable little in our understanding of religious other and salvation issue and winning over certain kinds of atheists - more sophisticated atheists would remain however unconvinced (but incidentally we have so few of them to contend with) - though much to the task lqbal thought so central to the survival of Muslims as effective dynamic force – Ijtehad in its broader understanding. Let us evaluate key ljtihads of Ghamidi and give him what the Prophet gave to anyone who exercises ijtihad - benefit of doubt. It is hard to approach some key problems modernity poses from the perspectives often rehearsed in popular press or media. Ghamidi provides a possible approach

failure to fast in Ramadhan – Islamic canon is silent on the issue of fate of those who fail to observe fasts and links any judgment to failure to observe decorum or having faith and respect in this pillar and not practice as God seems to assume that the test of hunger is hard for his frail servants. We need to engage with essential Ghamidi – the Core Idea – instead of certain corollaries or side issues. And that would help move conversation forward.

The idea of Ghamidi is engagement with modernity and modernity is there to stay in different avatars. There can be different readings of modernity but what is common to all of them is we are, to an extent, caught in it and can't escape it. We have inherited problematic times and to insist on turning the clock back is both impossible and uncalled for. Religious traditions themselves recognize the problematic nature of past times and don't take an uncharitable view of people fighting those times and even concede salvation for following one tenth of religion. Certain things seem to be gone for good or dying and irretrievable. The growth of certain ideas and institutions that seem now to be destined to last is a fact that can only be ignored at our own peril. Classical scholars wrote for their times and we have to write anew for our times. And change is not something that we should fear. God Himself grounds it, endorses it, so to speak, if it doesn't lose itself in centrifugal dispersion. Islamic thought as classically constructed or received with certain medieval framing must be reconstructed or reinterpreted at least and that doesn't mean reformed. There can't be any debate if Ijtihad is to be done or not. We have been forced to resort to it. There can be no question of sticking always to any particular theological or legal school as times have forced certain new readings or opening to other

Ghamidi critics suspect his intentions – these risks playing God who alone knows them. They think he is out there to destroy Islamic Tradition – this is too preposterous to merit even rejection. Key criticisms against Ghamidi often are in turn premised on their gross misinformation regarding or misreading of the challenge of modernity. Ghamidi is responding to a crisis of which many of his vociferous opponents aren't properly aware. His is, evidently, an attempt at engaging with certain aspects of the challenge of modernity, for thinking about what Arkoun calls unthought, for speaking for Islamic or better Abrahamic heritage in a manner that is truly contemporary. All who engage in this task are expected to falter and even some success is commendable. If Ghamidi is judged on the basis of his short beard, how would

we judge many of the front rank scholars and intellectuals that contributing to Islamic awakening - Iqbal, Ali Shariati, Syed Qutb, Nursi, Ismail Raji al-Faruqi, earlier Nasr and youthful Moududi, Hasan Askari and Shaykh Abdul Wahid Yaahya and galaxy of the most renowned scholars/Ulama in the Muslim world who didn't sport what is said to be proper beard? By this account, countless modern Muslim intellectuals, statesmen, writers, scientists who have contributed so much to the development of Islamic sciences in recent history become outsiders. Interestingly, neither Imamul Hind nor Hakeemul Ummat nor Qaidi Azam - three of the most influential personalities to whom so many Muslims attach the suffix Rahmatulahi Allaeh had properly styled or recommended attire of face/dress. If he is judged on the basis of only recommending and not mandating hijab, don't we throw to the dogs hundreds of practising Islamic women scholars well grounded in Islamic tradition whose dupatta skids permanently? If we dismiss him for his views on music we have to dismiss scores of great names in Islamic tradition from earliest times to such stalwarts as Ibn Hazm, Khawja Nizamuddin Awliya and Abul Kalam Azad and Nasr in modern times? If we dismiss his views on ijma, he has, on his side, a galaxy of scholars traditional and make significant points but leave much untouched or unengaged and as such modern sages need to be read.

Ghamidi is usually treated as a problem and certain dissolutions by way of refutations of his work constitute Ghamidi criticism. What if it could be shown that he is not a problem? He belongs to the larger Islamic intellectual tradition. He is part of a solution to many important problems. He has helped win so many to the cause of religion or faith in an age of doubt. He strengthens the faith of his readers in God, in the Quran, in the exemplary life of the Prophet. He has helped remove the flies hovering around the noble Prophet SAW. He is respectfully critical of his predecessors.

Regarding claiming of Ijmah to as a strategy of foreclosing further debate and discussion, one must point out unambiguous statements from traditionally revered authorities who cautioned against simplistic claims and plead that we say dissident opinion has not reached.

If we implement apostate's punishment today, millions, not thousands of Ex-Muslims, half Muslims, doubters should be executed. And it will make more apostates if such a move happens. And Muslims must de-register from Human Rights conventions.

Let us explore how we can move ahead and better face modernity without or with the tools and insights provided by Ghamidi. Muslim women didn't ask Ghamidi to say goodbye to veil nor did resistance leadership appoint him in any advisory council. The issue is how we remain as Muslim – authentically Muslim without being split personalities or guilt ridden or hesitant. Let us end debate over Ghamidi

Rational disagreement with Ghamidi would require deconstructing his central arguments that are unique to him/some of his illustrious predecessors. From emphasis on nazm, giving the Quran the focal rather than the only place as a source of law, methodological privileging of sunna over hadith, openness to religious and political other, interpreting the Quran with the help of other scriptures or giving Abrahamic legacy its due, more critical Ijtihadi spirit in dialogue with Imams of figh/hadith, evolving equivalent/alternative spiritual framing of key content of what is called Sufism, to advocating newer hermeneutical moves that appear more rational, more catholic, "demythologizing," "existential" more this worldly interpretations of myth/narratives in canon, we have a great tradition of debate and discussion from early period on almost all important points supposedly unique to Ghamidi. And we have, unknown to Urdu speaking scholarship and audience that has been his primary audience and critic, great often misread and caricatured currents of thought in Mutazilite, philosophical, (post)modern scholarly and other camps that constitutes the key to apparently newer or unheard of aspects in Ghamidi.

He is one of the few saner voices in the modern world, a worthy successor of Maududi minus his problematic political thought. His "counter-narrative" has yet to be successfully countered. It is too easy to criticize Ghamidi but enormously difficult to provide alternatives to him on many important issues.

Ghamidi is not to be identified with this or that particular view or position (he is ready to change them or may change them) that one may find fault with or accept but name of an idea or set of ideas that call deeper engagement and response from all the concerned. There is a person of Ghamidi who can be praised or reviled but there is an idea of Ghamidi that stares us in the face and that can only be engaged with rather than praised or reviled. Whether Ghamidi is a problem to be fought or an idea to be engaged with and whether our attitude should be writing refutations of him or critical but respectful engagement with what informs him – modern episteme and avowed timelessness and thus certain modernity itself of tradition and thus a blessing or at least blessing in disguise who is stimulating churning and creative adaptation of tradition from mainstream orthodox camp is to be seen. Perception of Ghamidi as a bull in a china house may be valid but the bull has already been there in the form of modernity and Ghamidi is an attempt to tame it, to harness it, to even use it in the field while what is perceived to be fragile china house may not be so fragile to fear the bull.

When God promises to guard the Quran from corruption it is implied, I think, tradition of interpreting the Quran as well. Tradition is much larger than any single thinker. We think in tradition; we breathe it. Islam has a history that absorbed even Ismailiees. Ghamidi, if he distorts, will fail.

Ghamidi is, generally speaking, not read in context – the context of debate and discussion in Islamic Tradition. And if read, his nuances and subtle moves qualifying his position are often missed. For instance, let me note just one point. Ghamidi pleaded for both beard and hijab on the basis of love for the Prophet (SAW)and tradition though he doesn't find, like brilliant contemporary scholars, any reason to think that God minds such things or will judge us on their basis. People often forget how wide is the net of compassion – we don't find God judging



schools in certain cases. It is impossible to restrict it to some elite group or ulama only and must include critical feedback of experts of various disciplines. We can fight individuals, refute some opinions of scholars of opposite camps, present many arguments that show why we be left undisturbed by these Socratic gadflies. But we can't fight ideas. Ideas that have intrinsic appeal don't die despite all the poisons and crucifixions and fatwas of kufr and books written in refutation. We may have various reasons to be wary of Gahmidi but we have no choice but to be wary of those that fight the idea of Ghamidi. One could afford to ignore him but I find him an echo of a strong current in our Tradition. I find him all around the serious academic environs. I find him in the pages of Muslim philosophers, theologians, jurists and even Sufis with whom he seems to have, apparently serious disagreements. I start with a few generalizations that need some but not serious qualifications to put forward my case.

What is most important in Ghamidi or what appears radically new has been better articulated in Western languages by formidable scholars. Just consider the key arguments against Ghamidi and you will note how seriously they need to be taken.

18 projects under IPP have been identified at Anantnag, Kupwara, Baramulla, Budgam, Bandipora, Kishtwar, Ramban, Reasi, Poonch and Ganderbal.

Secretary Shahid Choudhary said the mini hydel projects represent a focussed push by the government to harness clean, indigenous energy sources, generate local employment and reduce carbon dependency. "This initiative reinforces the commitment to energy self-reliance, climate resilience and rural development".

Successful bidders will sign a 40-year Implementation and Land Lease Agreement with JAKEDA, along with payment of an upfront premium and reimbursement of pre-development costs.

Bidding is open to individual firms and consortiums. Financial eligibility includes a net worth of 1.5 crore/ MW and an average annual turnover of 1 crore/ MW over the past three financial years (FY 2022–25).

Choudhary further elaborating the transformative potential of such initiatives said: "From the Himalayas to the grassroots of innovation, science and technology must lead the way in making J&K a resilient, knowledgedriven society," he stated.

He outlined the department's broader vision, including Mini hydel and solar power development, Model solar villages, Promotion of grassroots innovation and student-led science, Tech-enabled governance and sustainability and Strengthening R&D and academicindustry collaboration

"We will work with quiet determination and bold vision to ensure science becomes a movement for opportunity and progress," Choudhary said, inviting public suggestions and collaboration.

He said the hydro initiative is expected to not only strengthen localized renewable energy generation but also boost rural employment and infrastructure in far-flung areas of the UT.

Officials said the bidding process follows a mandate by the Department of Science & Technology vide Order No. 30-ST of 2021, empowering JAKEDA to implement hydro power projects of up to 10 MW capacity.

Under Clause 8.3 of the "Policy for Development of Micro/Mini Hydro Power Projects-2011," SCM allows project identifiers the right of first refusal, encouraging innovation and early-stage project development.

Technical eligibility requires prior EPC experience or commissioned capacity under the IPP mode, with clear benchmarks per MW.

The e-bidding process for 18 hydro projects under IPP mode is open from June 11 to July 10, 2025, with technical bids scheduled for opening on July 14.

For 17 Hydro Projects under SCM, last date for submission is 11 July 2025. According to the Tender, Interested parties must pay a non-refundable tender fee of 10,000 per project while the pre-development cost for each Megawatt is Rs 10 lakh.

Adil Maqbool, predicted a further rise in mercury, saying the day temperature could touch 35.5 degrees Celsius tomorrow or even 36 degrees in Srinagar and other lower areas of Kashmir. He added that mostly dry and hot weather will continue to dominate until June 21.

Furthermore, Pahalgam recorded a day temperature of 29.6 degrees Celsius, while Kupwara and Gulmarg recorded 33.1 degrees Celsius and 25.9 degrees Celsius, respectively. However, some parts of Jammu division continued to record belownormal temperatures, including Jammu city and Katra, where the mercury settled at 36.5 degrees Celsius and 33.1 degrees Celsius, respectively.

In Banihal, Bhaderwah, and Batote, maximum temperatures of 30.6 degrees Celsius, 31.6 degrees Celsius, and 28.2 degrees Celsius, respectively, were recorded today.

According to the weather forecast, Kashmir is set to witness an intense heatwave for the next two days, followed by heavy rains at isolated places. Generally dry weather with the possibility of brief spells of rain and thundershowers with gusty winds at isolated places is expected until Friday.

Between June 21 and 22, Director of MeT, Dr Mukhtar Ahmad, said that generally cloudy weather with intermittent spells of rain and thundershowers is expected at many places. He added that on June 23 and 24, the weather is expected to remain dry, with a brief spell of light rain and thundershowers at isolated places. From June 25 to 27, generally cloudy weather with the possibility of intermittent light to moderate rain and thundershowers at many places is forecasted.

The MeT has also issued an advisory urging farmers to continue farm operations until June 20. According to the advisory, there is a possibility of moderate to heavy rain with intense showers at a few places, mainly in Jammu division, on June 21 and 22. "Flash floods are expected at a few places, along with landslides, mudslides, and shooting stones," it added. (KNO

Jammu division, there is a power demand of more than 1600 MW and in the case of Kashmir division, we are getting a power demand of approximately 1350-1400 MW of power. Currently, we are catering nearly 2800 MWs of power," the official said.

Faizan said that Qazigund recorded a temperature of 34.7 degrees Celsius, the highest June temperature in 37 years. "This is the third all-time June temperature for Qazigund. The second highest is 35.3 degrees, recorded on June 27, 1988, and the all-time highest is 35.7 degrees, recorded on June 26, 1988," he added.

Kokernag has also surpassed previous figures, recording the all-time second-highest June temperature after a gap of 27 years, at 33.8 degrees Celsius. A similar day temperature was recorded on June 29, 1999. "The all-time highest temperature in Kokernag stands at 34.9°C, recorded on June 25, 2005," he said. 
