PM Modi Launches Development Projects Worth ₹5,200 Crore in Siwan, Bihar Flags Off Export Locomotive and New Vande Bharat Train

SIWAN, BIHAR | PIB: Prime Minister Narendra Modi on Thursday inaugurated and laid the foundation stone of multiple development projects worth over 5,200 crore in Siwan, Bihar.

Addressing a large public gathering, the Prime Minister reiterated his government's commitment to Bihar's development and highlighted the state's growing role in India's progress. He invoked the legacy of Dr. Rajendra Prasad and Loknayak Jayaprakash Narayan, recalling Siwan's historic contribution to India's democracy and freedom struggle.

Calling Bihar the land of resilience and potential, the Prime Minister asserted that the state would soon emerge as a key pillar of the country's prosperity. "Bihar will prosper and will also play a big role in the prosperity of the country," he said, underlining that a record 25 crore Indians have been lifted out of poverty over the last decade, with Bihar accounting for



nearly four crore among them. During the event, Prime Minister

Modi flagged off the first export-bound locomotive manufactured at the Marhowra

Locomotive Factory, marking a significant milestone under the 'Make in India - Make for the World' initiative. He stated with pride that the engine built in Bihar's Saran district would now run trains in Africa, symbolizing the state's entry into the global industrial landscape.

The Prime Minister also inaugurated the new Vaishali–Deoria railway line and flagged off a new train service on the route. He launched

the Patliputra-Gorakhpur Vande Bharat Express, which connects key regions including Muzaffarpur and Bettiah, and improves connectivity to the sacred sites of Baba Hariharnath and Baba Gorakhnath, as well as Kushinagar, associated with Lord Buddha's Mahaparinirvana. Speaking about infrastructure

development, Modi said that unprecedented investment is being made in Bihar's roads, railways, air connectivity, and urban infrastructure.

PM Modi To Participate In International Yoga Day In Vizag

AMARAVATI: Prime Minister Narendra Modi will participate in a massive International Yoga Day organised by Andhra Pradesh, on Saturday, in a 26-km-long corridor from RK Beach in the port city of Visakhapatnam that stretches up to Bhogapuram, where over 3 lakh people can perform Yoga simultaneously.

Chief Minister N Chandrababu Naidu has said the event, scheduled from 6:30 am to 8:00 am, will be organised in such a way to get recognition and set records, including a Guinness World Record.

The Andhra Pradesh government is aiming to set a string of records in Yoga by mobilising several lakh people, not just in Visakhapatnam but by organising simultaneous activities across the state on June 21.

The 11th International Yoga Day, celebrated by several countries across the world, has been themed as 'Yoga for One Earth, One Health'.

"As many as 25,000 tribal students will perform Surya Namaskars for 108



minutes. The objective is to set records for the largest group and the most people performing Surya Namaskars simultaneously," said Naidu.

The government is aiming to organise yoga sessions in one lakh centres across the state and attract five lakh people to participate in yoga activities in Visakhapatnam.

Observing that elaborate arrangements have been made across a 26-km stretch from RK Beach in Vizag to Bhogapuram, the CM said 3.19 lakh people can perform yoga

simultaneously from RK Beach. Participants from eight lakh

locations across the state, country, and the world are expected to join, he said, adding that the estimated two-crore registrations for yoga day activities participation overshot to 2.39 crores

"I've never claimed the LG has all powers." CM Omar Abdullah told reporters, as per Kashmir News Service (KNS). "The Jammu & Kashmir Reorganization Act is clear – and even the LG has said his role is limited to security and law & order. That's why we're asking that the cabinetapproved business rules be signed and returned by him, so there's no confusion or overlap."

Abdullah stressed that beyond security matters, governance should lie with the elected leadership. "Let the representatives of the people do their job. The cabinet has cleared the business rules, and it's time for them to be formally notified."

Commenting on the newly launched train service that has seen overwhelming public demand, CM Abdullah said, "When I boarded it, I thought if the service wasn't up to the mark, I'd just come back. But now, there's a rush for tickets, and waiting lists have already started. That shows the service is a success."

He urged authorities to take immediate steps to scale the operation. >>SEEONP-7



CS mandates IT deptt for swift revival of unaudited websites

SRINAGAR: Chief Secretary Atal Dulloo on Thursday chaired a high-level meeting to review the safety and restoration of government websites and digital assets.

Addressing senior officials from the IT Department and the National Informatics Centre(NIC), the Chief Secretary underlined the critical urgency of reviving government websites and applications that had been rendered offline due to pending audits and non-compliance with security protocols.

DIPR reported that the Chief Secretary directed the IT Department to expedite the restoration process and submit compliance reports from all departments twice a week every Monday and Thursday without fail.

Expressing concern over the extended shutdown of key online platforms, Dulloo made it clear that even security-related suspensions cannot justify the prolonged inaccessibility of public services.

He called for immediate remedial measures and directed the NIC and IT Department to coordinate closely for the revival of all such services.

In a stern directive aimed at strengthening data protection, the Chief Secretary instructed all government officials to use only official email addresses for communication, explicitly banning the use of private email IDs for official work.

He emphasized that the protection of government data and cyber infrastructure is of paramount importance and must remain non-negotiable.

Further, Dulloo called for the swift migration of mini data centers - currently being used

around 250 government officers. Singla revealed that around 110 government websites are currently undergoing different stages of security audits, out of which 45 are in the final stage

Pakistan-occupied Jammu and Kashmir (PoJK), asserting that India's change in policy towards terrorism is a result of their unmatched valour and dedication.

Singh described Operation Sindoor as not just a military action but a warning to the terrorists across the border and those who support them.

He defined the life of a soldier as one filled with courage and sacrifice, saying the nation will forever remain indebted to the services rendered by the armed forces in their duty for the motherland.

At a 'Barakhana' – a collective feast organised by the armed forces – held on the eve of International Yoga Day, the defence minister urged the force personnel to keep focusing on physical and mental well-being, underlining the importance of strength and wellness in a soldier's life.

"If you are strong, our borders will be strong. When the borders are strong, India will be strong," Singh said. A cultural programme was also organised as part of the event. (PTI)

It needs examination of the Law department," Omar said.

"If my intention was to buy time, I would have granted a six-month extension to the sub-committee. Do you possess any mechanism to compel me to finalize the report within six months? How many committees have finalized their report within six months?" Omar asked.

Omar lashed out at Peoples Democratic Party president Mehbooba Mufti over her stance on the issue of reservation, saying that she made a compromise over it in lieu of votes.

"With what face does the PDP speak about the issue of reservation? When Mehbooba Mufti needed votes, she imposed a ban on her party leaders from speaking on it. Should I show you records of her tweets from her official X handle, where she stated that 'nobody is authorized to speak on the issue of reservation'?" Omar asked.

Omar said that Mehbooba Mufti made a compromise on the issue of reservation in lieu of votes. "Mehbooba Mufti was then fighting elections from Anantnag-Rajouri seat and in pursuit of getting votes from Rajouri and Poonch, she preferred silence over the matter. She not only remained silent but also made a compromise over the issue in lieu of votes, "he said.

The CM also came down heavily on Peoples Conference president Sajad Gani Lone over his latest utterances on the issue of reservation, saying that he preferred silence when reservation rules were changed.

"What can I say about Sajad Lone? He was closely aligned to the government when all this happened. Our security was withdrawn and we were evicted from government houses. He was living in a government house. Why did he remain silent on the issue ?" Omar asked.

Omar said that he would not permit the use of water from the three western rivers of the Indus system in Jammu & Kashmir for Punjab.

"I will never permit this. Let us use our water for ourselves first. There is a drought-like situation in Jammu—why should I send water to Punjab? Punjab already has water under the Indus Water Treaty. Did they provide us with water when we needed it?" the CM said, when asked about the proposed 113 km-long canal aimed at redirecting surplus water from the three western rivers of the Indus system in J&K to Punjab, Haryana, and Rajasthan.

The CM said that he is hopeful that Prime Minister Narendra Modi will stand by his commitments on the restoration of I&K's statehood(KNO)

for stranded Indian nationals.

"Some routes are blocked, and ports are shut, but we're moving our citizens to safer cities before bringing them home. We hope to get everyone back safely soon," he said.

Abdullah also noted, "This bombardment should not have started. When the U.S. intelligence chief was asked about Iran's nuclear capacity, he said clearly that Iran is still far from building a bomb."

When asked about the U.S. President hosting the Pakistan Army Chief amidst ongoing regional tensions, CM Abdullah responded:

"The U.S. President can host whomever he wants — we don't dictate their guest list. But it's no secret that America always acts in its own interest and rarely prioritizes the concerns of other nations."

"Of course, we have historic ties with the U.S., and we hope they keep that friendship in mind. But we also understand realpolitik — they do what suits them first," he concluded. (KNS)

Moreover, Qazigund, a gateway of Kashmir, recorded a maximum temperature of 34.5 degrees, Pahalgam recorded 30.0 degrees while Kupwara, Kokernag and Gulmarg, a famous ski-resort, recorded a day temperature of 34.1 degrees, 33.6 degrees and 25.2 degrees respectively.

Jammu stations, however, continued to record below normal temperature today, the data reveals.

In Jammu, the mercury settled at 36.1 degrees, Banihal recorded 30.6 degrees while Batote, Katra and Bhaderwah recorded a maximum temperature of 27.8 degrees, 32.0 degrees and 32.6 degrees respectively.

Meanwhile, the weatherman here has predicted intermittent spells of rains, thundershower at many places with intense showers at few places for the next three days.

"There is a possibility of brief spells of rain, thundershower at scattered places in between June 23 and June 24," Director MeT, Dr Mukhtar Ahmad said, adding that intermittent spells of light to moderate rain and thundershower at many places between June 25 to June 27.

He added that there is a possibility of intermittent rain and thundershower at scattered places from June 28 to June 30th.

Meanwhile, the MeT in its advisory has stated that there is a possibility of moderate to heavy rain with intense showers at few places mainly in Jammu division during June 21st, June 22nd and June 25th to 27th.

On the escalating situation between Iran and Israel, CM Omar Abdullah said the administration is closely monitoring the developments and making arrangements News Observer (KNO), said he doesn't want power, but a "politics of conscience". "I am looking for those people who will walk with me to bring accountability to the system and those who will stand for credibility," he said

Rejecting the idea that his politics is about seeking power or position, Ruhullah said, "If it was about power, the people in Sopore would have known me years ago. Neither do I want a chair nor a position. All I want is change — a change that matters".

"I'm in Parliament by force, from the party side as well. I don't need positions, I don't need chairs. No, not at all", he said, adding, "What Jammu and Kashmir truly needs is not political cosmetics but a comprehensive structural change, one where God, truth, and accountability take precedence over party structures and personal gain."

In a blistering critique of current political culture, the Parliamentarian said, "Party discipline is not important, but being independent and free is more important."

He questioned the blind loyalty many leaders show to political parties, "even at the cost of ethics and truth". "People here fear violating party lines more than they fear God. They are more concerned with safeguarding their own privileges than with doing what is right", he said.

Citing a reference to the Quran, he said, "Where is it written that you can hurt God but not the party? There's a need for deep introspection. Why are we one before elections and completely different after them?"

Ruhullah, during his 50-minute speech, called for a transformation that goes beyond political faces or party labels. "Even if you change parties and leaders, nothing will improve unless the structure itself is changed. What we need is a society where the product is justice, equality, prosperity, divinity and freedom," he said.

He asserted that true reform would require "Godconscious and morally upright" individuals who are unafraid to challenge not just local institutions but also power structures at the Centre, Pakistan or anywhere else.

"Only those with self-consciousness and freedom can truly stand for the people. Otherwise, anyone can bow before any power to serve their own interests," he said.

Wrapping up his speech, the MP made it clear that his mission is not electoral, but transformational. "I envision a political framework where values outweigh vote banks, and where accountability and conscience form the bedrock of public leadership," he said. "For that purpose, if we can make anything, I am always there."
