

## Some reportage speculative, misleading: NIA

**NEW DELH**: A day after arresting two accused charged for harbouring the terrorists who carried out April 22 Pahalgam terror attack, the National Investigation Agency (NIA) on Monday said that it has taken a note of media coverage, and has seen some reportage is speculative and therefore of misleading nature.

In a statement issued to Media, NIA spokesman said, "Such reports circulating in sections of the media and on social media platforms are regarding the sketches and identities of the terrorists involved in the terror attack at Pahalgam."

He said, "It is reiterated that,



as stated in the official press release dated 22 June 2025, two accused persons have been arrested in connection with the attack. During their interrogation, they have disclosed details about the identities of the three armed terrorists involved.

"The NIA has gathered a substantial body of evidence regarding the identities of the terrorists. This includes eyewitness accounts from victims, video footage, technical evidence. and the

#### Amid heatwave, J&K braces for light to moderate rains from Wednesday

SRINAGAR: Jammu and Kashmir Cabinet Minister Sakina Itoo on Monday reaffirmed the government's commitment to ensuring fair implementation of the reservation policy and introducing wide-ranging reforms in the education sector.

Talking to reporters during her visit to Tangmarg, Itoo, as per the news agency—Kashmir News Observer (KNO), strongly defended the formation of the subcommittee on reservations. stating that it was constituted with serious intent and not in response to any social media

trend or political pressure. 'The reservation policy is for the people, and that's why the Chief Minister Omar Abdullah formed a subcommittee with a six-month mandate. It's not like someone tweeted and it was

indirectly referring to criticism from the opposition. She said that the committee submitted its report a day before the deadline, which has now been forwarded to the law department for legal vetting. "The Chief Minister himself is deeply concerned about this issue. We are very much serious about

it", she added.

## PM Modi honoured SP Mookerjee's sacrifice by abrogating Article 370: Union Minister Pradhan

**NEW DELHI**: Prime Minister Narendra Modi honoured Syama Prasad Mookerjee's sacrifice by abrogating Article 370 of the Constitution, which had granted a special status to the erstwhile state of Iammu and Kashmir, Union minister Dharmendra Pradhan said on Monday.

BJP leaders, including Pradhan and Delhi Chief Minister Rekha Gupta, paid floral tributes at the late leader's statue during a memorial meet organised by the Delhi unit of the party at the SP Mookerjee Park here on the occasion of his death anniversary.

Pradhan said for Bharatiya Janata Party (BJP) and Jana Sangh workers, Mookerjee was not merely a person or a leader, but a living ideology.

'Seventy two years ago, he entered Iammu and Kashmir opposing the concept of 'two systems in one country', which made history. His sacrifice was honoured when Prime Minister Narendra Modi abrogated

Article 370 in 2019," Pradhan said. He noted that the country had diverse



ideological groups after Independence communalists, communists and nationalists - and Mookerjee, often disagreeing with prime minister Jawaharlal Nehru's policies, chose to resign from the cabinet.

"This critical moment led him to join hands with the RSS and establish an alternative political ideology in the form of Jana Sangh,"

He recalled that once Nehru reportedly told Mookerjee, "I will crush you," to which the latter replied, "I will crush this crushing

Stressing that India is now close to being free from Naxalism, confined to just a few districts, Pradhan said Modi has steadfastly ensured national security and sovereignty over the last 10 years.

"The foundation of this governance is rooted in Dr Mookerjee's ideas," he said. Mookerjee offered original and alternative views on education, language, small industries, national security, foreign policy and the

Constitution, Pradhan noted. 'Today, the essence of governance is reaching the last person in the society, inspired by the philosophy of integral humanism of Pandit Deendayal Upadhyaya.

Together, Dr Mookerjee and Pandit Upadhyaya are considered the two wheels of the party, which has now completed 11 years of governance focussed on service and welfare," he added.

## Business Rules to be approved once sent properly to LG: BJP's Koul

Asked about the CM's statement on Business Rules, he reiterated that the rules shall be accepted only after they are



sent properly to the Lieutenant Governor.

The BJP leader further said that there was no question of conducting polls again. "The elections have been held for five years and will take place only after the present government's term is completed," he said.

Responding to the query on reports about statehood to be restored on terms and conditions. he said Prime Minister Narendra Modi and Union Home Minister

Amit Shah have promised that the statehood will be restored at the appropriate time.

On Chief Minister Omar Abdullah's rejection of providing water to Punjab for a project, Koul said, "Nobody other than Pakistan wants our water. Why should we provide water to them? Punjab doesn't need our water. Jammu people have been facing a severe water crisis. We need to ensure the drinking water supply to them first."

He added that the suspension of the Indus Water Treaty by the central government has been appreciated by the people.

About the US attack on Iran, the BIP leader said, "They don't want Iran to become a nuclear power and thus have been attacking the country."

# Rajnath Singh Releases Second Volume of President Murmu's Speeches

Over 5.000 BLOs and Supervisors have already been trained in the last three months as part of the ECI's nationwide initiative to strengthen electoral management at the grassroots.

In his address, CEC Gyanesh Kumar stressed the importance of such training programmes in ensuring that all electoral processes-including the preparation of electoral rolls and conduct of elections—are carried out in full compliance with the Representation of the People Acts, 1950 and 1951, as well as the Registration of Electors Rules (1960) and Conduct of Election Rules (1961).

'There can be nothing more transparent than law in any democracy. Elections in India are conducted strictly as per law, ensuring transparency and integrity," said Kumar. He also emphasized the critical role of BLO Supervisors in spreading awareness among electors about provisions for first and second appeals under Section 24(a) and 24(b) of the RP Act, 1950.Interestingly, no appeals were filed from the participating states and UTs-Meghalaya, Nagaland, Madhya Pradesh, Chandigarh, and Uttar Pradesh-after the completion of the Special Summary Revision (SSR) exercise between January 6 and 10, 2025.

"Our priority is that no child should lose life to a preventable disease like diarrhoea," he said, pledging continued support to grassroots health initiatives.

due to diarrhoea."

### Water Diversion for Power Dries Athwatto Stream, Endangers Fish and Livelihoods

**BANDIPORA**: In a serious ecological and economic fallout in Athwatoo area of Bandipora district, nearly one kilometre stretch of the Madhumati Nala has dried up almost completely after water diverted by a pri-

vate mini hydroelectric project operating in the Bankoot.

Locals said the depletion in water flow has caused extensive damage to the aquatic ecosystem and left local fish pond owners staring at devastating losses. "Water level was already low and that too has been completely diverted to feed mini hydel project athwatto," locals informed Kashmir Convener.

Experts warn of a mass mortality of fish in the area due to a sharp increase in water temperature and the consequent depletion in oxygen levels, that can result from the reduced inflow of fresh water. The conditions, they say, have turned fatal for trout and other sensitive aquatic species that require a cold and well-oxygenated environment to thrive.

Among the worst-hit is Basharat Hameed, a postgraduate and unemployed youth who invested his savings into developing a trout fish pond as a means of livelihood.

Speaking to reporters, Hameed said he is facing immense losses as fish continue to die

in large numbers daily.

He blamed the hydroelectric project authorities for not releasing
sufficient water back
into the stream.

"Istarted this project with hope and hard work. But every day is heart-breaking, Despite reaching out to the Di-

rector of Fisheries, Deputy Commissioner Bandipora, and even the Lieutenant Governor's office, no remedial steps have been taken so far," he said, warning that if the situation persists, he will have no option but to approach the National Green Tribunal (NGT) for justice.

He said the situation has sparked alarm among environmentalists, who warn of irreversible damage to the natural ecology of

Madhumati Nala. "The stream, once known for its rich aquatic life, has witnessed a drastic decline in biodiversity due to the near absence of flowing water".

Locals have expressed anger over what they call a reckless and unregulated operation of the hydel project, which they allege is compromising the ecological integrity of the region for power generation.

"It's extremely unfortunate that a pristine natural resource is being pushed to destruction in the name of development. The government must ensure that such projects adhere to strict environmental norms and ensure not all water is diverted but leave some eater for aquatic life," said a local resident.

People in the area have urged the administration to take immediate corrective measures and ensure the release of adequate ecological flow in the stream to restore both aquatic life and the livelihoods that depend on it. As the silence from relevant authorities continues, pressure is mounting for a full-fledged review of the mini hydel project's operational protocols and its compliance with environmental safeguards.

## LADC Team Inspects Police Post Nowgam to Ensure Custodial Rights

**Bandipora**: A team of Legal Aid Defense Counsels (LADCs) from the District Legal Services Authority (DLSA) Bandipora conducted an official inspection of Police Post Nowgam at Sumbal Sonawari on June 23 as part of the implementation of the LADC Modified Scheme 2022.

An official spokesperson of DLSA Bandipora said the visit was conducted under the supervision of Mr. Khalil Ahmad Choudhary, Principal District and Sessions Judge Bandipora and Chairman DLSA Bandipora, and under the guidance of Mr. Sheikh Babar, Secretary DLSA Bandipora.

He said the inspection aimed to assess the functioning of the police post, ensure compliance with legal safeguards, and monitor the treatment of individuals held in custody. The LADC team held discussions with the Officer Incharge of the police post regarding administrative functioning, the condition of lockups, and the protection of detainees' rights. Assistant LADCs also interacted with the detainees to evaluate their access to legal representation, inquire about their legal status, and ensure that procedural safeguards are being upheld.

#### Usman Majid Raises Concern Over Absentee Lecturer, Slams Edu Deptt for Negligence

**BANDIPORA**: Former legislator Usman Majid has expressed serious concern over what he described as "gross negligence" in the Education Department, following the non-joining of a transferred Biotechnology lecturer at the Government Boys Higher Secondary School (BHSS) Nadihal in Bandipora district.

In a strongly worded tweet on Sunday, Majid highlighted that Nisar Ahmad, a Biotechnology lecturer who was officially transferred from BHSS Ganderbal to BHSS Nadihal after serving 14 years at his previous post, has failed to join his new place



of posting. The former MLA said that despite the transfer order, the lecturer has not reported for duty at BHSS Nadihal to date.

"This gross negligence has left the poor students of BHSS Nadihal without a subject teacher, directly affecting their education and academic progress," Majid tweeted.

He further questioned the lack of accountability in the Education Department, asking, "How long will the future of these students be held hostage to such blatant irresponsibility?"

held hostage to such blatant irresponsibility?"

The tweet has sparked fresh debate on transparency and enforcement of transfer orders in the education sector, especially in rural areas where students already face a shortage of specialized teaching

staff.
Local residents and parents have echoed Majid's concerns, urging the authorities to take immediate steps to ensure the lecturer joins his assigned post without further delay. Several students, preparing for competitive exams, have reportedly been left without proper

guidance in the subject due to the lecturer's absence.

Officials from the Education Department have not issued any statement on the matter so far.

## Hypercentrality of English language in the world of Globalization

The Enlightenment and its avatars like modernity, postmodernity and globalization have 'invaded' all arenas of the world known to man. It has affected all arenas of society differently. Like everyone else, languages which are considered to be one of the components that constitute the identity too have been caught up in the effects of what we call globalization. In this borderless world, indigenous languages have been confronted by many post-enlightenment challenges. Even indigenous languages are no longer immune to globalization.

The processes of globalization thereby erode the social foundations of socio-linguistic fabric. It poses threats in the wake of a strong emphasis on economic values inherent in globalization processes, and through the dominance of certain languages and cultural practices, implying an accelerated trend towards a loss of languages (especially among indigenous communities), and the extinction of certain practices. All these trends favour the emergence of a uniformity of expressions (but not necessarily of identities) and approaches, impinging on (especially the more intangible aspects of) cultural diversity.

Does globalization heighten or diminish "our aesthetic awareness or are we drowning in a tidal wave of superficial, global pop culture easily sold and instantly digestible everywhere"? (Richard Tomkins, Financial Times, 23 April 2004) Globalization is increasing rapidly in the contemporary world: this increase in globalization has affected language. This impact in turn affects the culture of the language. One way through which globalization has affected language is by spreading one language globally, where that language is considered as the dominant language, it tends to overshadow other native languages.

The English language has emerged as the dominant language due to the onslaught of globalization which has connected every part of the world into a global village. As a result, this dominant language has penetrated into the indigenous cultures of the various societies thus threatening the very existence of native languages of indigenous people and by implication their social fabric because language is an important component of any social system. With the rapid advancement of science and technology,

the world is gradually losing its diversity. It is getting globalized. People's attitudes, the way they dress, their foods, the way they eat, the way they do their daily chores, the way they travel, the way they enjoy and get entertained etc are getting globalized.

The diversity, the traditions, rituals, customs are getting drifted away. Does this not impact language and communication? Of course it does, language too is getting globalized gradually. Language is changing into a simpler, faster communication mode that fits



with the electronic communication methods and dissemination of information. Facebook English, SMS English are getting popularized among the new generation, especially because it is free of many complicated grammar rules and spelling rules, thereby people can easily grasp it and they will like it absolutely.

Language reflects culture, and in this case the power of English reflects the power of certain countries. Until relatively recently, the United Kingdom held the reins to the world's largest empire, with colonies scattered across the globe. Their superior industrial capacity meant that they were able to conquer new territories and impose their own cultural norms, laws, religion and language. As a result, English found its way into nearly every corner of the earth (Matthew, 2004).

Although some are arguing that globalization is positive for language and people, there are some that are arguing it will have negative effects on language. The biggest argument is that globalization and the dominance of a few languages will force some languages into extinction (Malloy & Thomas, 2006). The Endangered Languages Project reports that 40% of the world's languages will disappear, directly related to globalization and its effects. To elaborate more, Ethnologies suggests that 25 percent of the world's languages are in danger of permanently disappearing in the near future, Indigenous people's today stand at the crossroads of globalization (Richard, 2006).

In many ways, indigenous peoples challenge the fundamental assumptions of globalization. They do not accept the assumption that humanity will benefit from the construction of a world culture of consumerism. Indigenous peoples are acutely aware, from their own tragic experience over the past 500 years, that consumer societies grow and prosper at the expense of other peoples and the environment.

Today, with the rapid advance of globalization, the loss of intangible cultural heritage once seen in Japan can now be observed throughout the world. The threat of extinction to intangible cultural heritage is particularly noticeable in developing countries in Asia, Africa and the Middle East, today. Therefore, while modernization and industrialization remain urgent issues, it is at the same time essential to preserve and transmit these traditional cultures. The various ways in which intangible cultural heritage is being preserved and transmitted require special attention.

The disappearance of languages as a result of the impact of globalization is bound to have negative effects, both direct and indirect, on identities and intangible cultural heritage – especially as these languages are vectors of traditional manifestations and celebrations of community life. The term globalization of languages is also defined by Steger (2003) as "the process of the spread of some languages that are used as international languages, and the disappearance of other languages that lack speakers"

Man has been using language as a medium of communication for ages, today due to Globalization English language has become the most prized possession of communication. In this Global village, the English language acts as a repository of wisdom and wit. The English language is a propeller for advancement of career and a machine to mint money. And it is a telescope to view the vision of the future

In this Global world, communication in English is now recognized as an inseparable part rather than the life blood of every activity which occurs in our day to day life. Nowadays every organization functions through a communication process, wherein mutually independent persons create and exchange messages to articulate and achieve commonly held objectives and goals. World languages through colonization, more powerful, industrialized countries were able to force their languages on weaker populations (Alastair, 1994). Since these countries were dictating the terms of any potential economic exchange, it was necessary for

widely-spoken languages like English or French in order to communicate and participate in this exchange. While this inevitably led to the loss of much smaller, regional dialects, colonization kicked off the start of the globalization process (Malcom, 1993).

On a global scale it has led to extinction of other languages and culture, thus endangering them. Endangered languages are no longer spoken by children. Only few elders speak it and extinction occurs when the language is no longer spoken as a result of globalization. It is evident from the secondary sources that almost 5000-6000 languages have been endangered due to globalization (Kachru& Nelson, 1996). In today's globalized world English is perceived as an advantaged language and many parents push their children to learn English over their native language in order to bring them at par with global developments.

When a culture dies along with a language, the connection between perception and action is forever changed. Using our native language is a very important way to protect it from extermination. But usage of the language is not only about speaking it. There is no doubt that Globalization has changed the life style of human beings altogether, the English language has given a new life to the modern man. Because of Globalization Communication in English is the major requirement in the day-to-day selection process.

"English" is a language before Globalization and "English" is the language after globalization .English and Globalization are inseparable, living one on another in the present day world like the body and soul of a human being. To make the richness of the language survive, it must be used in literature such as poetry, dramas, films and so on. remembered our names, our stories, our challenges, and our I am proud to be one of them. But more than our professions, in our lives. He was a constant presence. A friend. A guide.



## The late pope and the Paris Agreement

On the final Saturday of April 2025, the 266th pope was given a "low-key" funeral and laid to rest in Rome. That it be low-key was one of Francis' last wishes. He wanted a simpler process incurring lower costs, with The Holy See's coffers untroubled. The choice of final resting place as the Basilica Santa Maria Maggiore in Rome, rather than Saint Peter's Basilica in the Vatican, also reflected the man's modesty.

Of course, a truly low-key funeral may be unrealistic for any pontiff. Around 250,000 people attended the funeral mass, amongst them delegations from 130 countries, 50 of which were led by heads of state. We saw President of Ukraine Volodymyr Zelenskyy sitting knee-to-knee with his United States counter-

part, Donald Trump, in St Peter's Basilica, followed by Trump shaking hands outside with the French president, Emmanuel Macron. In the front row sat President Milei of Argentina, Pope Francis' homeland

In the Chinese-language world, coverage of the pope's death and funeral was muted – certainly low-key. But as we prepare to celebrate the 10-year anniversary of the Paris Agreement and hail the importance of continued multilateralism, I think we in the Chinese-language world must remember the vital contribution that Pope Francis made to that deal.

Pope Francis became head of the Catholic church in 2013. In May 2015, he published an encyclical (a papal letter to the church's bishops) titled Laudato Si (Praise be to you). Its subtitle, "On care for our common home", signalled its environmental focus. That year was an important one for climate negotiations. By the end of it, the world was due to agree on new climate change cooperation arrangements "applicable to all parties". Though this was the pope's second encyclical, his first had primarily continued his predecessor's work. The 2015 encyclical was not only the first to represent Pope Francis' own views, but the first ever to focus on the planet rather than just humanity. This decision made a big impact.

Responses came in from around the world. Scientists were particularly welcoming. In October of that year, the scientific journal Nature Climate Change paid tribute to the pope in a special issue. Science and religion, as the pope had advocated, set aside their differences and started to talk.

The encyclical, which is 184 pages long, gets stuck into the environmental crisis immediately after the preamble. It also covers air and water pollution and biodiversity loss, but gives the climate crisis a special focus. The letter does not reference the UN's Intergovernmental Panel on Climate Change (IPCC) by name, but paragraphs 23 and 24 mention the "very solid scientific consensus" that the climate is changing unnaturally

quickly, primarily due to human activity. This alludes to the IPCC's Fifth Assessment Report (AR5) published a few months prior. The encyclical goes on to look at the impacts and risks of global heating, and the implications for global justice. It emphasises the disproportionate harms to the poor and the Global South, the risk of forcing people into migrating, and of war over access to resources.

The letter is also clear on the climate being a global common good. There is therefore a moral duty to take strong action in response to climate change, it argues. Let us think back to the 2014 debate over the wording of AR5's Mitigation of Climate Change

and metrics, the role of culture, social norms and behaviour change, sharing and the circular economy, and policy measures to promote sustainable lifestyles.

#### 2023: Exhortation on climate change

In October 2023, with the climate crisis worsening and the COP28 round of talks about to start in Dubai, Pope Francis spoke out again. His apostolic exhortation, Laudate Deum (Praise God) was subtitled "To all people of good will on the climate crisis". This update on the 2015 encyclical was 17 pages long and focused



Summary for Policymakers. There was fierce disagreement over whether or not the climate could be called a "global commons problem". In the end, the term was moved from the main text into a footnote, with a clarification that this was unrelated to any "effort-sharing". The pope, however, does not need to take the opinion of others into account. Francis could say what he thought, directly.

Chapter 2 of the encyclical refers at length to the Bible as it discusses the intrinsic value of all forms of life. And the pope was not entirely unaware of practical concerns; chapters 3 to 6 review the roots of the climate crisis and our response in terms of political economy, technology, society and culture. Much ink is spent criticising the "technocratic paradigm" – a mindset that views technology and human control over nature as the primary means of progress. For the pope, this belief forgets what is essential, and drives endless extraction of the earth's resources in pursuit of limitless growth.

On the economy, the pope criticised the maximisation of profit driven by instrumental reasoning. On the contrary, the pope recommended "decreased growth in some parts of the world, in order to provide resources for other places to experience healthy growth." He considered growth without advances in social justice and morality inappropriate. He also criticised the merit of market forces in solving environmental problems, arguing we can never truly know the value of the environment.

On lifestyles, the pope's heartache over the immoderate "buy and throw away" consumption driven by capital and manufacturing – and the associated individualism – can be sensed in every chapter. Not all economists will agree and technological experts may be opposed. But it speaks to me.

Critics said the pope's hopes of encouraging moral reasoning and cultural transformation to tackle climate change were unrealistic. Huge political and social mobilisation would be necessary, they said. Nor did the encyclical discuss the links between sustainable development and demographic growth.

My own reading found many words of wisdom and a strong philosophical basis, but perhaps a slight hollowness and lack of pragmatism. This gave the document somewhat limited policymaking value. It did, however, go a long way towards bringing morality – something technologists and scientists overlook in their research – back into the debate. That was a huge contribution.

The encyclical, the Paris Agreement and the IPCC In late September 2015, Pope Francis attended the UN Summit on Sustainable Development in New York, giving an important speech that restated the spirit of his encyclical. Humanity's endless pursuit of power and material pleasures was causing the misuse of natural resources and the exclusion of the poor and the vulnerable, he said, and it was time for us to acknowledge

the "rights of nature".

In December 2015, the UN climate conference COP21 passed the Paris Agreement, which came into effect the following year. This was another milestone for global climate governance. For the first time, the emotive idea of "Mother Earth" appeared in a legal UN text. Pope Francis is said to have acted as a mediator during negotiations on key issues, such as long-term goals. That may or may not be true, but the impact of his encyclical is undeniable. Since then, the post-Paris climate story has been a complex and unpredictable one, but Pope Francis' voice was always clearly heard.

The encyclical was a powerful part of a growing awareness of the social aspect to climate change mitigation. Its impact on the IPCC's scientific assessments is also clear to see. From the start of work on the IPCC's next Assessment Report, AR6, sociological science was embedded into policy research. The AR6 Mitigation of Climate Change report included a whole new chapter, titled "Demand, Services and Social Aspects of Mitigation". It covers sustainable production and consumption, development models

more particularly on the climate.

After an introduction lamenting the increasing frequency of climate disasters, Pope Francis regretfully pointed out that the "technocratic paradigm" was only worsening – artificial intelligence being the prime example – and there was still no limit to the growth of human power. The point of no return was close. He went on: the existing multilateral mechanisms were not strong enough to tackle climate change and new decision-making and implementation mechanisms were needed.

While the 2015 encyclical did not refer to the UN Framework Convention on Climate Change, the newer message dedicated two chapters (4 and 5) to a review of milestone COPs and an expression of solemn hopes for COP28: that it would see a change of direction (paragraph 54) and in particular act on the energy transition (54 and 59), and encourage parties to make rapid and powerful responses and stick to their commitments.

Pope Francis had intended to be at COP28, but illness prevented his attending. Instead, a message was read out for him. He hoped attendees would move beyond national and business interests and think about the planet and future generations, showing political foresight rather than conservatism.

COP28 successfully completed the first global stocktake under the Paris Agreement, with a particular emphasis on the energy transition, where the content was very encouraging.

In July and September 2022, the Vatican ratified the UN Framework Convention on Climate Change and the Paris Agreement, respectively. Its first climate action plan, or Nationally Determined Contribution, was to reduce emissions by 20% from its 2011 level by 2030, and to hit net-zero emissions by 2050.

In late 2024, the Vatican and other parties to the Paris Agreement submitted their first biennial transparency reports, as required. According to its report, the city state's greenhouse gas emissions in 2022 were 15,890 tonnes of CO2-equivalent, a per capita average of 16 tonnes. Down 17.8% on 2011, this was achieved mainly through electrification, big drops in the use of fossil fuels and cleaner air conditioning.

An unusual pope

Pope Francis was known as the "green pope" or the "climate pope", but the New York Times also described him as a "dividing line", who made key contributions to modernising the Catholic church. Before becoming pope, he was archbishop of Buenos Aires, where he was known for remaining close to the ordinary people, and often seen on public transport. After becoming a contender for the papacy, his "election" pitch was simple: the Catholic church had to do more than just open doors and windows to let fresh air in – it had to go out to where it was needed.

The papal name he chose was after Saint Francis of Assisi, who was known for his humility. Alongside being a sustained voice on climate change, Pope Francis worked hard to help the poor and migrants, and to end war. He also showed more tolerance and acceptance of homosexuals than previous popes.

He was a reformer too, giving more decision-making power to priests from Africa, Asia and Latin America. Much of this was opposed by traditionalists within the Catholic church, but Pope Francis's status and influence remained strong. This speaks to his leadership skills. The Catholic church's hierarchy is an aweinspiring thing, and those who climb it will be tested. Not all are able to retain their principles during their ascent.

I hope the new Pope will carry on the work of his predecessor and use the voice of the Catholic church to speak out on climate change.

Calls for awareness camps in district hotspots to combat drug menace

30 NDPS, 10 PIT-NDPS cases lodged in FY 2025-26; poppy cultivation on 3 kanals and 3.5 marlas of land also destroyed

**BUDGAM:** Deputy Commissioner (DC) Budgam, Dr. Bilal Mohi-ud-Din Bhat on Monday conducted the 36th meeting of District Level Committee of Narco Coordination Centre (NCORD) at the DC Office Complex here to review the action taken by the concerned departments with regard to decisions held in previous meetings.

During the meeting, a future course of action to uproot the drug menace and destruction of Narco crops was also formulated.

 $At the \, outset, DC \, took \, detailed \, feedback$ from each concerned department regarding the measures taken for combating illicit trafficking of narcotic drugs and psychotropic substances and its consumption in the district to save youth from the dangerous effects of the drugs.

He said that drug abuse is a serious problem that not only affects individuals, but also their families and communities. He stated that it is essential to tackle the issue from multiple perspectives, including deterrence, treatment and enforcement.

DC reiterated that the district administration is committed to create a drug-free environment in the district and will continue to take all necessary steps to achieve this goal.

94.000 SHGs formed: over 1.84 lakh women become Lakhpati Didis in 6 months

**SRINAGAR:** Secretary, Rural Development Department and Panchayati Raj (RDD&PR). Mohammad Aijaz Asad, today chaired a comprehensive review meeting of Jammu and Kashmir Rural Livelihoods Mission (JKRLM), assessing the implementation status and progress on various key initiatives

The meeting focused on financial progress, recruitment, capacity building, institutional strengthening and the ongoing implementation of flagship Lakhpati Didi initiative.

Mission Director, JKRLM, Dr. Shubhra Sharma, Joint Director Planning, Kamal Kumar Sharma and State Programme Managers were present during the deliberations.

The Secretary was informed that the Mission has successfully formed 94,000 Self-Help Groups (SHGs), covering 7.55 lakh rural households across the Union Territory. Notably, I&K ranks among the top-performing States/UTs in key parameters such as LOKOS profile capturing and Cluster Level Federation (CLF) transactions, securing 1st position in CLF profiling, 2nd in Village Organization profiling and 4th in SHG profile capturing.

Commending the progress made, the Secretary urged the Mission team to intensify efforts in lagging areas and leverage the full potential of SHGs to improve rural livelihoods. He stressed the importance of strong linkages between SHGs and financial institutions to enhance access to gainful employment and sustainable income opportunities for

Under the Lakhpati Didi initiative, the

Secretary noted that over 1.84 lakh women have already achieved the Lakhpati Didi



status in the past six months. He stated that efforts are underway to support a cumulative total of 2.3 lakh women in achieving this milestone by the end of the current month.

These women are engaged in diverse sectors including agriculture, animal husbandry, manufacturing, services and trade, with support from convergence departments such as Agriculture, Animal Husbandry, Fisheries and MSME.

The Secretary also enquired about the additional interventions, beyond routine SHG-bank linkages, being undertaken to enable sustainable income generation for rural women.

He also asked to ensure timely provisioning of essential infrastructure. including training halls, kitchens and laboratories.

analysis of self-sustaining SHGs and underlined the need to increase their share across the UT. He reviewed the performance of both farm and non-farm livelihood interventions under JKRLM.

## Weekend rush signals hope for revival of tourism in Pahalgam

Hotels see decent occupancy

**PAHALGAM**, Jun 23: In a welcome turn of events, the renowned tourist destination, Pahalgam in south Kashmir, witnessed a good rush over the weekend—the first such revival since the terror attack in April that had cast a shadow over the region's tourism prospects.

Tourists from various parts of the valley made their way to the picturesque valley on Saturday and Sunday.
Officials and tourism stakeholders, speaking to the news agency—Kashmir News Observer (KNO),

said the area saw significant footfall, leading to traffic jams in several stretches and a notable uptick in hotel occupancy.

Sunday, in particular, saw the tourist hotspot

abuzz with life. Families, picnickers and adventure lovers thronged the Lidder banks, markets and parks, enjoying the cool climate and intermittent drizzle.

"The atmosphere was dull and uncertain over the

last few weeks, but this weekend brought a wave of positivity," said Fayaz Ahmad, a hotelier in Pahalgam. "We had close to 70% occupancy by Sunday evening. With schools on summer break and weather favouring travel, we expect more such weekends ahead."

Local vendors, too, expressed cautious optimism.
"After the attack, people were scared, and the business was hit badly. This weekend felt like a new beginning," said Asma Jan, who runs a handicraft stall near the park.

The renewed activity even prompted a reaction from political quarters. J&K Chief Minister Omar Abdullah took to the social media platform X (formerly Twitter) on Sunday to share his observations:

"The last time I was in Pahalgam I cycled through a market that was all but deserted. Today I came back to a Pahalgam that was bustling with activity. Tourists from various parts of the country competed for space with local picnickers who were enjoying the cool climate & rainy weather. It's very satisfying to see the efforts my colleagues & I have been putting in slowly bearing fruit," he wrote.

Tourism department officials say they have been working to instil confidence among visitors and promote Kashmir as a safe and vibrant destination.

"Security has been beefed up, and all departments are working in coordination to ensure a smooth tourist experience," said an official. "This weekend was a good sign, and we expect more such a rush in the coming weeks."

The Pahalgam Development Authority (PDA) and traffic police were seen actively managing the growing rush, ensuring order despite the sudden spike in visitors.

With stakeholders banking on the upcoming Amarnath Yatra and continued favourable weather, hopes are high that the iconic valley will soon return to its pre-attack tourism numbers. Photos and videos from this bustling weekend went viral on social media—(KNO)

## Russian attacks on Ukraine kill at least 10, injure dozens

**KYIV:** Russian drones and missiles killed at least 10 civilians in Ukraine in nighttime attacks, local officials said Monday, with seven deaths reported in the capital, Kyiv, where emergency crews raced to find people believed trapped under the rubble of a partially collapsed apartment building.

Russia fired 352 drones and decoys overnight, as well as 11 ballistic missiles and five cruise missiles, Ukraine's air force said. Air defences intercepted or jammed 339 drones and 15 missiles before they could reach their targets, a statement said.

The strikes came nearly a week after a combined Russian attack on Ukraine last Tuesday killed 28 people in Kyiv, 23 of them in a residential building that collapsed after sustaining a direct missile hit.

Russian forces have for several months been trying to drive deeper into Ukraine as part of a renewed summer push along the roughly 1,000-kilometre front line, though the Institute for the Study of War said their progress has been limited.

"Russian forces have failed to make significant gains during this period of intensified offensive operations, however, due in part to the fact that Russian forces are largely relying on poorly trained infantry to make gains in the face of Ukraine's drone-based defence," the Washington-based think tank said late Sunday.

At the same time, Russia has pounded civilian areas with long-range strikes in an apparent attempt

to weaken public morale.

Ukrainian leader notes role of Iran, North Korea Ukrainian President Volodymyr Zelenskyy said preliminary data indicated that Russian forces used North Korean missiles in the Kyiv strike. He called Russia, North Korea and Iran, which has provided drones to Russia, a "coalition of murderers" and warned of a potential spread of the "terror" if their alliance continues.

Zelenskyy said Ukraine's defence and new ways to pressure Russia will be the two main topics in his visit to the United Kingdom on Monday. Zelenskyy was to meet with Prime Minister Keir Starmer in London ahead of this week's NATO summit in The Hague, Starmer's office said.

French Foreign Minister Jean-Noël Barrot said the latest strikes demonstrated Russia's "unlimited cruelty," by deliberately taking aim at civilian targets, and promised more European sanctions on Moscow.

Drones and missiles hit residential areas, hospitals and sports infrastructure in numerous districts across Kyiv in the early hours of Monday, emergency services said.

The most severe damage was in the Shevchenkivskyi district of Kyiv, where a section of a five-story apartment building collapsed.

Six people were killed in that district, Kyiv Mayor Vitali Klitschko said. Ten others, including a pregnant woman, were rescued from a nearby high-rise that also sustained heavy damage in the blast.

Dozens of vehicles, some burned out and others mangled by flying debris from the blast, formed a snarl in the courtyard in front of the partly demolished building, which had collapsed down to the second floor.

Onlookers, some wrapped in blankets, watched tearfully as the cleanup operation took place. Dozens of volunteers worked to remove broken glass, downed tree branches and other debris.

Oleksii Pozychaniuk, 29, who lives in the building next to the one struck in the attack, said he heard the whistle of the rocket approaching from inside his apartment and "froze in terror" before feeling the impact.

"Windows burst out, glass was flying everywhere," he said. "We barely made it downstairs with my child, everything here was on fire. We didn't see the neighboring building yet because everything was covered in smoke, the cars were smoldering, tires were bursting from the high temperature which was also scary."

Klitschko told reporters that rescue workers were still searching the collapsed building for survivors.

The Russian attack also damaged the entrance to the Sviatoshyn subway station in Kyiv, slightly injuring two people, said Timur Tkachenko, the head of Kyiv's military administration. He said more than 30 people were injured across the city.

Since the early days of Russia's invasion, underground subway stations have served as shelters for those seeking protection from aerial attacks. During almost nightly strikes, stations across Kyiv are often filled with people waiting out the danger. Elsewhere in Ukraine, a Russian short-range drone attack killed two people and wounded 10 more in the Chernihiv region late Sunday night, authorities said. Three children were among the wounded, according to the regional administration head, Viacheslav Chaus. Another person was killed and eight wounded overnight in the city of Bila Tserkva, around 85 kilometers (53 miles) southwest of the capital.

Meanwhile, Russia's Defence Ministry said its air defences shot down 23 Ukrainian drones overnight into Monday. (**The Print**)

#### PM Modi's dynamism, willingness to engage remains 'prime asset' for India on global stage: Tharoor

**NEW DELHI**: Prime Minister Narendra Modi's energy, dynamism and willingness to engage remains a "prime asset" for India on the global stage but deserves greater backing, Congress MP Shashi Tharoor said on Monday, in remarks that are likely to irk his party and widen the growing cracks in his ties with its leadership.

Tharoor's praise for the prime minister comes at a time when the Congress has been consistently attacking the Modi government over its foreign policy, alleging that Indian diplomacy is being "shattered" and the country stands "isolated" globally.

In an article published in The Hindu, Tharoor said the diplomatic outreach following "Operation Sindoor" was a moment of national resolve and effective communication.

"Prime Minister Narendra Modi's energy, dynamism and willingness to engage remains a prime asset for India on the global stage but deserves greater backing.

"The diplomatic outreach following 'Operation Sindoor' was a moment of national resolve and effective communication. It affirmed that India, when united, can project its voice with clarity and conviction on international platforms," said the Congress leader, who led a multi-party delegation to the US and four other countries to convey India's stand following the Pahalgam terror attack and the military operation.

Tharoor said the lessons learned — the power of unity, the efficacy of clear communication, the strategic value of soft power and the imperative of sustained public diplomacy — will undoubtedly serve as guiding principles as India navigates an increasingly complex international landscape, leveraging its three Ts — tech, trade and tradition — and always striving for a more just, secure, and prosperous world.

In his article, Tharoor said the aftermath of the April 22, 2025, Pahalgam terror attack and India's resolute response through 'Operation Sindoor'

presented a critical juncture for the nation's foreign

"While the immediate military action was decisive, the subsequent diplomatic outreach was equally, if not more, vital in shaping global perceptions and consolidating international support," he said.

"Leading one of the seven all-party parliamentary delegations to five countries in the Western Hemisphere — Guyana, Panama, Colombia, Brazil and the United States — offered me a unique vantage point to reflect on the lessons learned from this intensive period of public diplomacy," Tharoor said.

One of the most striking takeaways is the power of national unity in projecting a strong foreign policy voice, he said.

The very composition of the delegations, featuring Members of Parliament (MPs) from diverse political parties, different states and varied faiths, was a potent message in itself, Tharoor said.

"It underscored that when it comes to national

security and confronting terrorism, India speaks with one voice. This transcended domestic political differences, imbuing our message with greater credibility and gravitas in the eyes of our international interlocutors.

"Whether engaging with the President of Guyana or the US Vice-President, the collective resolve of India, represented by its varied political spectrum, resonated deeply," he asserted.

The delegations' primary objective was to provide clarity on 'Operation Sindoor', its rationale, the targeted nature of India's initial strikes against terrorist infrastructure, its calibrated and measured nature, and its avoidance of any harm to civilians and even to Pakistani military facilities, he said.


