Shukla's Space Sojourn Marks Beginning Of New Era For India: PM Modi

NEW DELHI: The 'Bharat Mata ki Jai' slogan reverberated on the International Space Station as Prime Minister Narendra Modi told astronaut Shubhanshu Shukla that his space travel marked the beginning of a new era and was the first step towards Mission Gaganyaan, India's own human spaceflight project.

"Shubhanshu, today you are the farthest from the land of India, but the closest to the hearts of every Indian,"

the prime minister told Shukla in an interaction through a video link from the International Space Station, which is orbiting the earth at an altitude of 400 km.

Modi said Shukla's name carries the word 'shubh' (auspicious), and that his journey marked the auspicious beginning of a new era.

'Bharat Mata ki jai' chant filled up the space station as the prime minister raised the slogan towards the end of the 18-minute conversation, which was reciprocated by Shukla.

Shukla told the prime minister that his space sojourn was "not my journey alone but also our country's", and that he was absorbing these "new experiences like a sponge".

"Everything is different here." the astronaut said, sharing his experience in micro-gravity conditions on the space station.

about different systems... but after coming here, everything changed... Here, even small things are different because there is no gravity in space... Sleeping here is a big challenge... It takes some time to get used to this environment," he told the prime

The astronaut said that the space station orbits the Earth 16 times a day and that he was privileged to witness 16 sunrises and 16 sunsets every day.

"Right now, we are travelling at a speed of 28,000 kilometres per hour. This speed reflects how fast our nation is progressing and now, we must go even beyond this," Shukla said.

Article 370 Was Against Dr Ambedkar's Idealogy Of One Constitution: CJI Gavai

NAGPUR: Chief Justice of India BR Gavai on Saturday said Dr B R Ambedkar envisioned one Constitution for the country to keep it united



and never favoured the idea of a separate constitution for a state.

Speaking at the inauguration of the Constitution Preamble Park here, the CJI said the Supreme Court drew inspiration from Dr Ambedkar's vision of a united India under a single constitution while upholding the Centre's decision to abrogate Article 370 that granted

special status to Jammu and Kashmir.

Gavai was part of a five-judge Constitution bench, headed by then Chief Justice DY Chandrachud, that unanimously upheld the Centre's decision to abrogate Article 370, which bestowed special status to the erstwhile state of Jammu and Kashmir.

"When Article 370 was challenged, it came before us, and when the hearing was underway, I recalled Dr Babasaheb's words that one Constitution is suited for a country... If we want to keep the country united, we need only one Constitution," he said, while addressing the gathering in Marathi.

On August 5, 2019, the Centre decided to strip Jammu and Kashmir of special status and divide it into two Union Territories.

Gavai said Dr Ambedkar had been criticised. saying the Constitution provides for too much federalism, and in times of war, the country may not remain united.

However, he had responded, saying the Constitution would suit all the challenges and

VP Jagdeep Dhankhar Calls Preamble Changes a 'Nasoor', Urges Respect for Constitution's Soul

NEW DELHI, (PIB): In a strongly-worded address during the launch of the book Ambedkar's Messages at the Vice-President's Enclave, Vice-President of India Shri Jagdeep Dhankhar denounced the changes made to the Preamble of the Constitution during the Emergency, calling them a "nasoor" (festering wound) and a "sacrilege to the spirit of Sanatana."

According to a statement issued by press Information Bureau (PIB), the Vice-President criticized the 42nd Constitutional Amendment of 1976, which introduced the terms 'Socialist', 'Secular', and 'Integrity' into the Preamble, calling the move unconstitutional and executed during a time when democracy was under siege.

"What a travesty of justice! First, we change something which



is not changeable or alterable – and that too during the Emergency, when 'We the People' were behind bars," he said. "Except Bharat, no other nation has altered its constitutional preamble. These words were added as a nasoor – and they've inflicted existential challenges upon the soul of our Constitution.'

The Vice-President invoked Dr. B.R. Ambedkar, architect of

the Indian Constitution, asserting that such changes would have been against his vision and the

ethos of the Constituent Assembly. "Dr. Ambedkar lives in our hearts, he dominates our minds, and touches our soul." Dhankhar said. "His message must reach every family, every child. The founding fathers gave us a preamble rooted in timeless Indian civilisational values — one that

should not have been 'farcically and casually' changed."

Referring to landmark Supreme Court judgments, the Vice-President cited opinions from Kesavananda Bharati and Golaknath cases, where the judiciary held that the Preamble is not just a symbolic preface but the soul and guiding light of the Constitution.

"Judges like Justice H.R. Khanna, Justice Sikri, and others emphasized that the Preamble is unalterable, embodying the grand and noble vision of the Constitution. Tampering with it, especially in the dark times of Emergency, is nothing short of sacrilege," he stated.

The VP further quoted Ambedkar's emotional final address to the Constituent Assembly, where he warned about caste divisions, religious lovalties.

MNRE Notifies Key Revisions in Biomass Programme Guidelines

NEW DELHI (PIB): In a major move to strengthen India's bioenergy ecosystem and facilitate ease of doing business, the Ministry of New and Renewable Energy (MNRE) has notified revised guidelines under Phase-I of the National Bioenergy Programme. The updated norms apply for the period from FY 2021-22 to FY 2025-26 and mark a significant shift in how biomass energy projects will be implemented, monitored, and supported.

According to Press Information Bureau (PIB), the revised guidelines aim to simplify administrative procedures, encourage clean energy solutions, and support India's net-zero emission targets by 2070. Notably, the Ministry has eased approval requirements and reduced documentation burdens, particularly benefiting Micro, Small and Medium Enterprises (MSMEs). These changes are also expected to enhance stubble management efforts across key agricultural states.

One of the most notable revisions is the technological upgrade that now permits the use of Internet of Things (IoT)-based monitoring systems or quarterly data submissions in place of costly SCADA systems. This shift promotes cost-effective, digital monitoring and increased accountability, especially for smaller businesses that previously found compliance with expensive systems a financial burden.

In another welcome change, developers of briquette and pellet manufacturing plants are no longer required to submit multiple clearance documents, significantly reducing red tape and saving crucial time during project setup. Moreover, the earlier mandate of having a two-year briquette or pellet sale contract has been replaced with a general sale agreement.

Smart Governance

The JK Government has launched an ambitious initiative to create unique Family IDs for every household in a bid to streamline public service delivery and enhance beneficiary targeting across departments. Chief Secretary Atal Dulloo yesterday laid out the vision with clarity: to build a unified system that brings efficiency, accuracy, and inclusivity into the governance framework. For decades, citizens especially families living in remote villages have faced the exhausting burden of repeatedly submitting the same documents across departments—from ration cards and domicile certificates to income proofs and Aadhaar. This redundancy has not only caused delays and frustration but also led to inefficiencies, leakages, and missed entitlements. The proposed Family ID system seeks to break that pattern. By serving as a singular digital repository of verified household data, it will enable departments to seamlessly coordinate, verify eligibility, and deliver services without forcing citizens to run from pillar to post. It marks a serious move toward "citizen-centric governance" where the state reaches the people—not the other way

The use of reliable databases such as the Public Distribution System (PDS) and Ayushman Bharat (AB-PMJAY) as anchors for the Family ID design shows strategic foresight. These schemes already contain granular family-level data and can provide a strong foundation for building a comprehensive, dynamic, and updateable system.

Equally commendable is the government's acknowledgment of evolving demographics—births, deaths, migration—and the emphasis on mechanisms to keep the Family IDs current. A digital ID is only as useful as its accuracy, and the inclusion of BISAG-N and technical support teams on the pattern of hiring of professionals (DPMUs) for the implementation of IPDS to ensure backend strength is vital. Existing staff can't deal with it but the professionals of the field will do the job better.

The success of this ambitious project will also hinge on transparency, public trust, and data protection. The Family ID could be a game-changer in Kashmir where targeted welfare, development planning, and monitoring have often been hampered by fragmented data and logistical gaps. If implemented sincerely, this initiative can lay the foundation for intelligent policymaking, efficient welfare, and digital empowerment. J&K is clearly positioning itself as a model for future-ready governance, and the Family ID could be the backbone of that transition. It's a mission worth watching—and supporting.

Five Challenges for South Korean President Lee Jae-Myung

Lee Jae-myung became the 21st President of South Korea on 4 June 2025 after a tumultuous six months for South Korean politics, which began with the sudden announcement of emergency martial law by the previous President Yoon Suk-yeol on the night of 3 December 2024. Although martial law was withdrawn within six hours as the National Assembly rejected the decision, the process of President Yoon Suk-yeol's impeachment and the election of a new leader were cumbersome. Once the Constitutional Court of South Korea approved the impeachment on 4 April 2025, the whole process of choosing a new leader was completed within two months.

The Democratic Party of South Korea, which enjoys a comfortable majority in the National Assembly, was swift in choosing its candidate for president, but the People's Power Party (PPP) took longer to get it done. In post-martial law South Korea, the People's Power Party hasn't been able to decide if it should fully distance itself from Yoon Suk-yeol or not. The dilemma has created a gap between their formal pronouncements and their actual behaviour.

However, election results show that despite martial law, factionalism in the PPP, and the late announcement of the presidential candidate, PPP candidate Kim Moon-soo was able to get 41.15 per cent of the votes. This means that most of the support bases of the PPP remain loyal. The election results also show that South Korean men in their 20s and 30s are feeling discontented with the Democratic Party along with the older generation which generally supports the conservative party.

After assuming the president's post, Lee Jae-myung has talked about the need to unite a divided South Korean society. He has promised to communicate more with opposition party leaders and people, and has also promised greater cooperation and transparency in the making and implementation of policies. However, the task ahead is not easy. His pledges of constitutional reform and reforming the judiciary and the prosecutor's office as well as instituting a two four-year term limit on the presidency will be challenging. The Democratic Party, because of its comfortable majority in the National Assembly, will

try to take up all these issues, leading to political contestation with the opposition PPP. Uniting the Korean people and political reform will be the first challenge for Lee Jae-myung.

The second challenge for Lee Jae-myung will be revitalising the sluggish economy. He said that he considers it the most important task ahead. South Korea's growth rate in 2025 is projected to be 0.8 per cent. For several years, the country's growth rate has

cost-sharing for American soldiers stationed in South Korea. The US may demand more active participation from South Korea in areas of contestation with China and Russia. Lee Jae-myung may do so, but he will likely be less loud than his predecessor.

The fourth challenge for Lee Jae-myung will be to determine his approach towards North Korea. His party and he have been in favour of engagement with North Korea, but at present North Korea doesn't appear

tactfulness, and sincerity.

The fifth challenge will be to maintain and improve relations with Japan. Usually, under progressive presidents in South Korea, except Kim Dae-jung, South Korea's relations with Japan have deteriorated. Lee Jae-myung has to show he is a leader like Kim Dae-jung, who can build good relations with Japan as well as with other regional countries.

In brief, the new president of South Korea faces



been slow and the 'citizen economy' needs to be dealt with urgently. Lee has already created a task force to address it. It remains to be seen how he will bring back economic vitality to South Korea's export-led economy when many regions of the world are facing military conflict.

The third big challenge for Lee Jae-myung will be to determine how to engage with China in the economic domain while moving closer to South Korea's military ally, the US. With the US, Lee Jae-myung has to resolve tariff issues that are looming large. He also has to convince Trump to maintain the status quo in

keen. North Korea has a more sophisticated missile and nuclear inventory than in the past, is relatively less isolated after the mutual defence agreement with Russia last year, has also officially abandoned the goal of unification, and designated South Korea as a "hostile state." Immediately after coming to power, Lee put a stop to the broadcasting of propaganda loudspeakers at the border and also wanted to stop sending propaganda balloons to North Korea. North Korea responded positively to his moves by also stopping North Korean loudspeakers, but moving forward would be a test of the president's resolve,

formidable domestic and foreign policy challenges. That said, Lee Jae-myung is considered a pragmatic, sharp, decisive, and hardworking leader, and he will certainly try to deal with these challenges positively.



As India's Groundwater Runs Dry, Calls For Reform Grow

Last month, the southern Indian city of Bengaluru faced an early start to the monsoon and experienced its wettest May ever. Beneath the heavy rains and floods, water shortages may seem a far cry. Yet they are a common problem. Just last year, a long been overlooked in policy debates.

Reliance on and overexploitation of groundwater

Groundwater accounts for more than 60% of India's irrigation and over 80% of rural drinking water needs. The country uses more groundwater than any other. In rural areas, it is the primary source of drinking and domestic water, and also helps to meet many urban demands. Northern states like Punjab, Haryana, Rajasthan and Uttar Pradesh are particularly hard hit by widespread groundwater extraction, with a large proportion of their populations involved in agriculture.

According to a 2024 government report by the Central Groundwater Board, India is using up groundwater faster than it can be naturally refilled. On average, the country extracts just over 60% of the water available underground. Out of nearly 7,000 areas they studied, 11% are considered "over-exploited" – where people are water availability and environmental sustainability, according to my research.

India's discriminatory groundwater laws

The groundwater regulatory framework in India adds to the challenges of managing its groundwater development. The framework is rooted in an outdated "land-water nexus", a concept developed during Britain's industrial era and later adopted in Indian law through colonial-era court rulings. Under this system, enshrined in the Indian Easements Act 1882, groundwater is treated as an extension of land, giving landowners the right to use such water that is beneath their property.

This framework fails to reflect India's social, economic, environmental and climate realities. By linking groundwater rights to land and property ownership, it has reinforced historical inequalities in land distribution, which disproportionately benefit

Current groundwater laws in most Indian states follow a uniform pattern that does not consider important local factors, such as variations in aquifers, climate patterns, rainfall distribution and the social and economic realities of each region. Existing laws do not address the diverse groundwater situations in different parts of the country, particularly in eastern and southern states where there is less groundwater development and exploration than the agricultural belts of the northern states. They also fail to address the continued challenges arising from climate change, such as higher aquifer depletion rates during droughts and dry conditions caused by weak monsoon rains.

Environmental concerns – particularly groundwater recharge, water-source sustainability and ecosystem water needs - receive inadequate attention in these bills. As courts and policymakers increasingly discuss the rights of nature, it is crucial to include environmental protection and ecosystem water needs in ground-

This legal framework must be reconceptualised, especially in the light of growing impacts of climate change. We need to move towards greater state control over groundwater access and allocation, reducing the dominance of private ownership and control. Groundwater should be regulated as a "public trust" resource, meaning it belongs to the public, is for their use, and the government has ultimate responsibility for looking after it. Additionally, there should be greater emphasis on subsidiarity giving local authorities primary control of such resources – along with decentralisation and public participation in groundwater management, as suggested by the Groundwater Model Bill 2016. These could help create more responsive and equitable groundwater management. Such a bottom-up approach would allow local water users to have more say in day-to-day water decisions.

Equity and inclusiveness in water management are essential. Enabling broad participation in "water-user associations" - farmer organisations responsible for managing and distributing water resources - alongside eliminating caste- and gender-based discrimination, will support fairer and more informed decisionmaking. The voices and choices of women, who often assume the role of water collectors and make up a significant part of the agricultural workforce, must be recognised and encouraged.

There also needs to be a paradigm shift from supply sustainability - focusing solely on getting enough water for immediate use - to source sustainability, or protecting the natural water sources themselves. This means treating aquifers, rivers and ecosystems as living systems that need to be conserved and restored, especially in the context of climate change. Many participants of water conservation initiatives have noted that current efforts often only aim to meet short-term irrigation needs and lack a long-term vision for sustainable water management. India's policies for addressing summer water crises also reflect this short-term mindset, and they do not go far enough to deal with the challenges posed by climate change.

Our water laws, policies and conservation efforts must focus on equity and inclusiveness to achieve water justice for all users. At the same time, they should also foreground the needs and rights of water resources themselves, ensuring their protection and sustainability for future generations.

Such scenes reflect a wider issue across the country, with water scarcity deepening and population needs rising. Tensions are mounting - both within urban areas and in broader

In response to depleting surface water resources, Bengaluru and many other regions are increasingly turning to aquifers to quench their thirst and meet their daily needs. This race to extract groundwater is intensifying the crisis. Calls for an urgent rethink of water governance models are intensifying too – particularly regarding groundwater management and regulation, which has

taking out more water than nature can replace. Another 3% are in a critical situation, using nearly all the available groundwater, while 11% are at risk ("semi-critical"), and 73% are still considered safe, with an extraction rate of under 70%.

This crisis is being driven by a growing population, the intensification of farming, rapid industrialisation and unsustainable urbanisation. The main drivers are agriculture, industrial water demands and drinking water needs.

Government subsidies for power, credit and market access – first introduced during the Green Revolution in the 1960s and 1970s to boost agricultural productivity and address poverty and food security - have also had unintended consequences. While these measures helped ensure enough food for the country, they also encouraged over-extraction of groundwater, undermining upper-caste, male landowners. Meanwhile, many lower-caste communities and women, who make up a significant part of India's agricultural workforce, have far less access to land – and therefore to the groundwater it holds.

This system perpetuates social and economic injustices and violates constitutional principles of equality, distributive justice and the fundamental right to water, recognised by India's courts.

The state has tried to address these problems through laws and regulations, including the Model Groundwater Bills of 1992 and 2005. But these statutes largely preserve the old land-based framework. They take a "curative" approach, only stepping in to regulate areas already in crisis, rather than proactively protecting groundwater resources.




